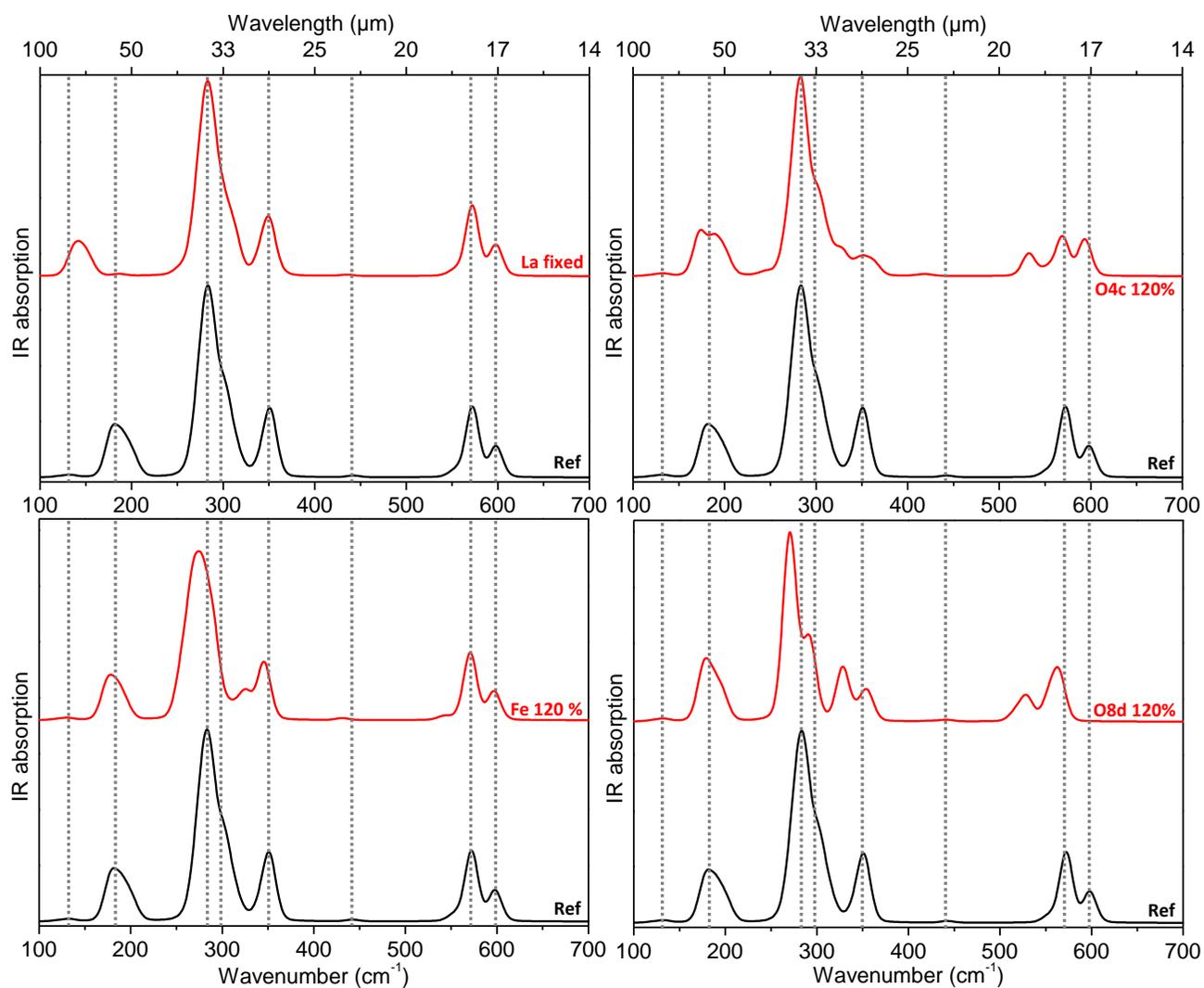

Although being indexed in  $\text{Pnma}$  space group ( $n^\circ 62$ ), to model the spin ordering in  $\text{ReFeO}_3$  systems, the symmetry of these compounds has been reduced to  $\text{P2}_1/\text{c}$  ( $n^\circ 14$ ) for the calculation of their vibrational properties. The number of active modes is then increased to 33 with the irreducible representation:  $\Gamma = 17 A_u + 16 B_u$ . However, since the structure remains very close to the one in  $\text{Pnma}$  only 25 of those modes possess non null IR intensities ( $> 0.1 \text{ km.mol}^{-1}$ ). These 25 modes have been reported in the table to ease the comparison with the other compounds although some of them display very small IR intensities.  $\text{LaCoO}_3$  is indexed in  $\text{R}\bar{3}\text{c}$  space group ( $n^\circ 167$ ) with the irreducible representation:  $\Gamma = 3 A_{2u} + 5 E_u$ .



**Figure S1.:** Influence of isotopic substitution on the simulated IR spectrum of  $\text{LaFeO}_3$ . Each panel corresponds to a particular isotopic substitution, where the atomic mass of the considered element is increased by 20% (except for La, which mass is fixed at 10 000 u, in order to remove all coupling with other modes and thus reveal its participation in those modes). The IR spectrum is then reconstructed from the same Hessian matrix than the former calculation.
