Ion Temperature Gradient Instability (ITG) and trapped ion modes (TIM) (1)

→Low frequency ion-temperature-gradientdriven instabilities responsible for ion turbulence in tokamaks.

→Trapped particles have unfavorable magnetic drift leading to the trapped particle instability i.e. a low-frequency interchange-type instability







Ion Temperature Gradient Instability (ITG) and trapped ion modes (TIM) (2)

→Instabilities characterized by frequencies of the order of the trapped particle precession frequency and radial scales of the order of several « banana » widths.

→Because of their large scale and in spite of their low-frequencies, these instabilities could lead to a huge transport corresponding to a Bohm-like confinement.








Ion Temperature Gradient Instability (ITG) and trapped ion modes (TIM) (3)

 $\rightarrow$ It is well known that turbulent transport can be greatly reduced in the presence of a negative magnetic shear

→Magnetic shear describes the dependence of field line direction on the coordinate accross closed flux surfaces


Where q is the safety factor  $dr r_0$ 








#### Hamiltonian formalism in angle-action



• Classic phase space  $(\mathbf{x}, \mathbf{p})$  may be described by a system of three action variables  $(J_1, J_2, J_3)$  and their three corresponding angular variables  $(\phi_1, \phi_2, \phi_3)$

- The motion of trapped ion is thus characterized by three invariants:
- •For cyclotron motion at frequency  $\omega_1 = \omega_c$
- •For bounce motion at frequency

$$\omega_2 = \omega_b$$

$$\mu = \frac{mv_{\perp}^2}{2B(\mathbf{x}_G)}$$
$$E = \frac{1}{2}mv_{G/\prime}^2 + \mu B(\mathbf{x}_G)$$

For precession motion at frequency

 $\omega_3 = \omega_d$ (toroidal kinetic momentum)

$$M = e\psi(x_G) + mR(x_G)v_{G\varphi}$$





#### TIM model

• Trajectory of trapped particle may be described by (Garbet et al JCP 87, 249 (1990) )

$$\theta_{G} = \widehat{\theta}(\mathbf{J}, \phi_{2})$$
  

$$\varphi_{G} = \phi_{3} + q(r_{0})\widehat{\theta}(\mathbf{J}, \phi_{2}) + \widehat{\varphi}(\mathbf{J}, \phi_{2})$$
  

$$r_{G} = r_{0} + \widehat{r}(\mathbf{J}, \phi_{2})$$

• Functions  $\hat{\theta}(\mathbf{J}, \phi_2)$  and  $\hat{\varphi}(\mathbf{J}, \phi_2)$  are periodic and represent respectively the bounce motion and the deviation from the regular precession motion.







# TIM model

• The low frequency response of ion plasma is usually obtained by gyroaveraging the Vlasov equation over the cyclotron phase  $\phi_1$ :

 $\mu = \frac{mv_{\perp}^2}{2B(\mathbf{x}_G)}$  becomes then an adiabatic invariant

• For trapped particles, it is also possible to make a second average over now the bounce motion. Finally we have transformed a Vlasov problem of six independant variables into a 2D where the precession phase is (divided by ).  $2\pi$   $\psi_3 = \varphi - q\theta$  and  $\psi_3$ , is the poloidal flux  $\psi_3 = \varphi - q\theta$

# TIM model

 Each adiabatic invariant reduces the dimentionality by a factor two and a trapped particle is fully described by the position of the « banana center »

$$\omega_{k} = \frac{d\phi_{k}}{dt} = \frac{\partial H}{\partial J_{k}}$$
$$\frac{dJ_{k}}{dt} = 0 \quad for \quad k = 1, 2$$

• The system is then described by an ensemble of distribution functions of type  $f = f_{\mathcal{K}_{\mathcal{E}}}(\psi, \phi_3, t)$ , which numerically allows a parallelization along the direction of adiabatic invariants (indeed simple parameters)







#### Bounce motion

• For a trapped ion, as  $\frac{d\phi_2}{dt} = \omega_b$ , the revolution of the banana motion is completed within a time  $T_b = \frac{2\pi}{\omega_b} = \int_{-\theta_0}^{+\theta_0} \frac{q_0 R_0 d\theta}{\sqrt{2E/m}\sqrt{1-\lambda b(\theta)}}$ where  $mv^2$  with uR

The bounce frequency is then

$$\lambda = \frac{\mu B_0}{E}$$
$$\omega_b = \sqrt{\frac{2E}{m}} \frac{1}{q_0 R_0} \overline{\omega}_b(\kappa)$$

#### Toroidal precession motion

• The precession frequency  $\frac{d\phi_3}{dt} = \omega_d$  is determined by the average over the bounce motion, we have:

$$\omega_d(\kappa;s) = \frac{q_0 E}{e B_0 r_0 R_0} \overline{\omega}_d(\kappa;s)$$

with

$$\overline{\omega}_{d}(\kappa;s) = \frac{2E(\kappa)}{K(\kappa)} - 1 + 4s\left(\frac{E(\kappa)}{K(\kappa)} + \kappa^{2} - 1\right)$$

is the « trapping » parameter

$$\kappa^2 = \sin^2\left(\frac{\theta_0}{2}\right) = \frac{1-\lambda}{2\varepsilon\lambda}$$





# Bounce-averaged Vlasov model (1)

• In the gyrokinetic approach, the evolution of an ensemble of particles is described by the distribution function  $y_{(\phi, f, f)}$  beys the Vlasov equation:

$$\frac{Df}{Dt} = \frac{\partial f}{\partial t} + [f,H] = 0 \quad \text{where} \quad [f,H] = \frac{\partial f}{\partial \phi} \frac{\partial H}{\partial J} - \frac{\partial f}{\partial J} \frac{\partial H}{\partial \phi}$$

 In a first approach, let us assume that the Hamiltonian is the sum of the equilibrium Hamiltonian plus a perturbation term:

 $H(\mathbf{\phi}, \mathbf{J}, t) = H_0(\mathbf{J}) + \sum \delta H_{\mathbf{n}, \omega}(\mathbf{J}) e^{i(\mathbf{n}.\mathbf{\phi} - \omega t)}$ 

and

 $f(\mathbf{\phi}, \mathbf{J}, t) = F_0(\mathbf{J}) + \sum_{\mathbf{n}, \omega} \delta f_{\mathbf{n}, \omega}(\mathbf{J}) e^{i(\mathbf{n}.\mathbf{\phi} - \omega t)}$ 

And using a local equilibrium

$$T_0(\mathbf{J}) = \frac{n_0(J_3,t)}{(2\pi m T_0)^{3/2}} e^{-\left(\frac{H_0(\mathbf{J})}{T_0}\right)}$$



• It is then possible to write the perturbation term in the form

$$\delta f_{\mathbf{n},\omega}(\mathbf{J}) = -\frac{F_0(\mathbf{J})}{T_0} \delta H_{\mathbf{n},\omega}(\mathbf{J}) + \frac{F_0(\mathbf{J})}{T_0} \frac{\omega - \mathbf{n}\omega^*}{\omega - \mathbf{n}\Omega(\mathbf{J}) + io^*} \delta H_{\mathbf{n},\omega}$$
Adiabatic part resonant wave-particle contribution  
where  $\omega^* = T_0 \left[ \frac{1}{n_0} \frac{dn_0}{dJ_3} + \frac{1}{T_0} \frac{dT_0}{dJ_3} \left( \frac{H_0}{T_0} - \frac{3}{2} \right) \right]$  is the diamagnetic frequency  
·We have use
$$\frac{d\mathbf{J}}{dt} = -\frac{\partial H_0}{\partial \mathbf{\varphi}} = 0$$

$$\frac{d\mathbf{\varphi}}{dt} = \frac{\partial H_0}{\partial \mathbf{J}} = \Omega(\mathbf{J}) = (\omega_c, \omega_b, \omega_d)$$

# Bounce-averaged Vlasov model (3)

• The term  $\mathbf{n}.\Omega(\mathbf{J})$  is reduced to  $n_3\omega_d(\kappa;s) = n\omega_d(\kappa;s)$ 

•In tokamaks, we have

$$\boldsymbol{\omega} \approx n_3 \boldsymbol{\omega}_d \approx \boldsymbol{\omega}^* \approx \frac{\rho_c}{a} n_2 \boldsymbol{\omega}_b \approx \left(\frac{\rho_c}{a}\right)^2 n_1 \boldsymbol{\omega}_c$$

This procedure of reduction (by suppressing the high-frequency terms) may be generalized by introducing the distribution function at the requester order  $\begin{pmatrix} \delta H \end{pmatrix}$ 

$$f = F_0(\mathbf{J}) \left( -\frac{\delta H}{T_0(J_3)} + \delta g \right)$$

The gyro-average leads to « smooth » quantities

$$\overline{\delta H}(-\omega_{d0}t,\phi_3,\mathbf{J}) = \oint \frac{d\phi_1}{2\pi} \oint \frac{d\phi_2}{2\pi} \delta H(\phi,\mathbf{J})$$





# Bounce-averaged Vlasov model (4)

The expression of the « particle density » may be obtained via

$$n_i(\mathbf{x},t) = -\frac{n_0}{T_0} \delta H(\mathbf{x},t) + \int d^3 p F_0(\mathbf{x},\mathbf{p}) \{J_0 \overline{\delta g}\}$$

 $\overline{\delta g} = J_0 \delta g$  introduces an operator which transform  $\delta g$  into its global gyro-average (bounce motion plus cyclotron motion).

The gyrokinetic equation can be simplified in the case where the density gradient vanishes and the temperature diamagnetic frequency

$$\omega^* = n_3 T_0 \frac{dn_0}{n_0 dJ_3}$$

is much smaller than the precession frequency





# Bounce-averaged Vlasov model (4)

It is then to write the ion distribution function in the form

$$f = \frac{1}{T_0^{3/2}} e^{-\frac{E}{T_0}} \{1 + \overline{\delta g}\} \quad \text{with} \quad \overline{\delta g} = J_0 \delta g \quad \text{Gyro-average operator}$$

Normalizing the energy to the equilibrium temperature, the gyroaveraged Vlasov equation becomes:

$$\frac{\partial f_{\kappa,E}}{\partial t} + \omega_d(\kappa;s) E \frac{\partial f_{\kappa,E}}{\partial \phi_3} + \frac{\partial J_0 U}{\partial \psi} \frac{\partial f_{\kappa,E}}{\partial \phi_3} - \frac{\partial J_0 U}{\partial \phi_3} \frac{\partial f_{\kappa,E}}{\partial \psi} = 0$$

Which is coupled with

$$C\left\{U-\left\langle U\right\rangle_{\psi}\right\}-C\alpha\nabla^{2}U=\overline{n}_{i}(\phi_{3},\psi,t)-1$$





# Bounce-averaged Vlasov model (4)

• Gyro-average operator  $J_0 = j_0(k_\perp \rho_c) j_0(k_\psi \delta_b)$ 

The present implementation of this operator is based on a Padé approximation of the Bessel function

$$J_0 = \left(1 + \frac{E\delta_b^2}{4}\partial_\psi^2\right) \left(1 + \frac{E\rho_c^2}{4}\partial_{\phi_3}^2\right)$$

The « banana center » particle density is then given by

$$\overline{n}_{i}(\phi_{3},\psi,t) = \frac{2}{\sqrt{\pi}} \int_{0}^{+\infty} dE \sqrt{E} \int_{0}^{1} d\kappa \kappa K(\kappa) J_{0}f_{\kappa,E}$$

Consequently we have reduced the 6D Vlasov equation into a sert of 2D Vlasov equations (indeed  $N_E \times N$  equations), acting on a 2D phase space:  $\phi_3 = \varphi - q\theta'$ , the precession angle and poloidal flux





#### Linear analysis (1)

Dispersion relation for TIM is obtained by linearizing the reduced
 Vlasov equation with :

$$f_{\kappa,E}(\phi_3,\psi,t) = F_0(\psi) + \sum_n \widehat{f}_n(\psi) e^{i(n\phi_3 - \omega t)}$$

and

$$U(\phi_3,\psi,t) = \sum_n \widehat{U}_n(\psi) e^{i(n\phi_3 - \omega t)}$$

where the equilibrium distribution function and potential are taken as

$$F_0(\psi) = e^{-E} \left[ 1 + \Delta \tau \omega_d(\kappa; s) \left( E - \frac{3}{2} \right) \psi \right] \quad \text{and} \quad U_0(\psi) = 0$$

$$\Delta \tau = \frac{\Delta \psi}{T_0} \frac{dT_0}{d\psi}$$

is the normalized temperature gradient

# Linear analysis (2)

Following standard Landau analysis of Vlasov equation

yields 
$$\widehat{f}_{n} = \frac{\Delta \tau \ n\omega_{d}(\kappa;s) \left(E - \frac{3}{2}\right) e^{-E}}{n\omega_{d}(\kappa;s) E - \omega} J_{0}\widehat{U}_{n}$$

The quasi-neutrality condition (assuming the polarization contribution Negligible gives (with the usual Landau prescription on the imaginary part of frequency):

$$C\widehat{U}_{n} = \frac{2}{\sqrt{\pi}} \int_{0}^{+\infty} dE \sqrt{E} \int_{0}^{1} d\kappa \kappa K(\kappa) \frac{\Delta \tau n \left(E - \frac{3}{2}\right) e^{-E}}{E - \frac{\omega}{n\omega_{d}(\kappa;s)}} J_{0}^{2} \widehat{U}_{n}$$

# Linear analysis (3)

• Resolution in the case of a marginal solution (corresponding to real frequency) leads to the determination of the threshold of ITG instability for TIM:

$$\Delta \tau_s = \frac{C}{\zeta}$$

with

$$f = \frac{2}{\sqrt{\pi}} \int_{0}^{+\infty} dE \sqrt{E} \int_{0}^{1} d\kappa \kappa K(\kappa) e^{-E} j_{0}^{2}(\pi \delta_{b} E) j_{0}^{2}(\pi \rho_{c} E)$$

We have thus for frequencies:

$$\omega = \frac{3}{2} n \langle \omega_d(\kappa; s) \rangle_{\kappa}$$

The potential term obeys

$$\widehat{U}_{n} - \frac{\Delta \tau}{C} \frac{2}{\sqrt{\pi}} \int_{0}^{+\infty} dE \sqrt{E} \int_{0}^{1} d\kappa \kappa K(\kappa) e^{-E} J_{0}^{2} \widehat{U}_{n} = 0$$





# Linear analysis (4)

• The marginal solution for pertubation term for potential is

$$\widehat{U}_n(\psi) = U_0 \sin(l\pi\psi)$$
 with  $l = 1, 2, 3, ...$ 

The case *I=1* corresponds to the lowest gradient and the dispersion relation can be expressed as follows (with a frequency shift given by

$$\Delta \omega = \frac{\omega}{n} - \frac{3}{2} \omega_d(\kappa; s) \quad \text{and assuming} \quad J_0^2 = 1$$


$$\frac{1}{2} \left( \frac{\Delta \tau_s}{\Delta \tau} - 1 \right) = \int_0^1 d\kappa \frac{\kappa K(\kappa)}{\omega_d(\kappa; s)} \left[ 1 + \sqrt{\frac{3}{2} + \frac{\Delta \omega}{\omega_d(\kappa; s)}} Z \left( \sqrt{\frac{3}{2} + \frac{\Delta \omega}{\omega_d(\kappa; s)}} \right) \right]$$

Z being the function of Fried and Conte

# Vlasov simulations (1)

• The code solves, in a self-consistent way, the gyrokinetic Vlasov equation, together with the quasi-neutrality condition:

$$\frac{\partial f_{\kappa,E}}{\partial t} + \omega_d(\kappa;s)E\frac{\partial f_{\kappa,E}}{\partial \phi_3} + \frac{\partial J_0 U}{\partial \psi}\frac{\partial f_{\kappa,E}}{\partial \phi_3} - \frac{\partial J_0 U}{\partial \phi_3}\frac{\partial f_{\kappa,E}}{\partial \psi} = 0$$

$$C\left\{U-\langle U\rangle_{\psi}\right\}=\frac{2}{\sqrt{\pi}}\int_{0}^{+\infty}dE\sqrt{E}\int_{0}^{1}d\kappa\kappa K(\kappa)J_{0}f_{\kappa,E}-1$$

The numerical method is based on a standard semi-lagrangian scheme Allowing a very fine resolution in phase space and the start-up of the ITG instability from the roundoff errors.







#### Vlasov simulations (2)

• We used normalized quantities: the time is normalized to the inverse drift frequency  $\omega_{d^0}^{-1}$ , the poloidal flux is given in  $\Delta \psi = r_0 R_0 \frac{B_0}{q_0}$  units, and the potential is expressed in  $T_0/e$  units.

The initial condition is described by:

$$f_{\kappa,E}(\phi_3,\psi,t=0) = e^{-E} \left[ 1 + \Delta \tau \omega_d(\kappa;s) (E - \frac{3}{2})\psi \right] + e^{-E} \Delta \tau J_0 U_0 \sin \pi \psi \cos 10\phi_3$$

We introduce a perturbation on the toroidal number n=10


He simulation was carried out with a temperature gradient chosen just above the threshold of ITG:  $\Delta \tau - \Delta \tau_s = 0.0075$ 

With a ITG threshod of  $\Delta \tau_s = 0.100075$ 







• we choose to increase the magnetic shear to value s=+0.50







#### Phase space representation of U(1)



 Full-developped turbulence by increasing the magnetic shear parameter





# Conclusion

• ITG driven Trapped Ion Modes (TIM) are studied by solving a Vlasov equation averaged over the cyclotron and bounce motions in presence of a magnetic shear

•Kinetic effects as resonant ave-particle interactions are accurately described

•The magnetic shear appears to play a major role in the stabilization process of the ITG instability as predicted by Kadomtsev and Pogutse (Nuclear Fusion 1971)

The introduction of the magnetic shear allow us to study the different Regimes of turbulent transport from state described by a small number of toroidal modes till large band for full-developped turbulence
