

26 27	12	inactivation, permeability to RNases, and availability of hydrophobic domains within the capsid

26 ABSTRACT

Enteric viruses and bacteriophages are exposed to various inactivating factors outside their host, and among them chlorine and heat are the most commonly used sanitizer in water industry and treatment in the food industry, respectively. Using MS2 phages as models for enteric viruses, we investigated the impact of free chlorine and heat on their physicochemical properties. Free chlorine was first evaluated alone. No increase in either capsid permeability or hydrophobicity was observed. The negative surface charge slightly increased suggesting molecular changes in the capsid. However, a weakening of the capsid by chlorine was suggested by differential scanning fluorimetry. This phenomenon was confirmed when chlorination was followed by a heat treatment. Indeed, an increase in the inactivation of MS2 phages and the permeability of their capsids to RNases was observed. More interestingly, an increase in the expression of hydrophobic domains at the phage surface was observed, but only for phages remaining infectious. The chlorine-caused weakening of the capsid suggested that, for an optimal use, the oxidant should be followed by heat. The increased permeability to RNases and the expression of hydrophobic domains may contribute to the development or improvement of molecular methods specific for infectious enteric viruses. **KEYWORDS:** free chlorine, heat, MS2 bacteriophage, surface properties, hydrophobicity, charge 

#### **INTRODUCTION**

Enteric viruses and phages are exposed to various inactivating factors in water, in foodstuffs, and on surfaces. Among them, heat and chlorine are one of the most cost-effective and easy-toapply treatments and sanitizers in the food and water industries. The level of inactivation of enteric viruses by heat has been widely monitored in food and environmental matrices in which it is considered as one of the main inactivating factors (Hirneisen et al. 2010; Bertrand et al. 2012). Chlorine is a major disinfection treatment of water and food for its broad-spectrum antimicrobial activity (Hirneisen et al. 2010; Boudaud et al. 2012; Girard et al. 2016; Meireles et al. 2016). Although virus inactivation by heat or chlorine has been evaluated in numerous studies, the mechanisms leading to non-infectious virus particles still remain partially understood. Comparison of the impact of different inactivating treatments on virus functions (i.e. host cell binding, genome injection and replication), using MS2 phage as model of pathogenic enteric viruses, has revealed differences in the mechanisms of inactivation between physical treatments such as heat and chemical oxidants such as free chlorine, but also within treatment groups (Wigginton et al. 2012). Heat induces structural and conformational changes of the capsid proteins leading to at least inactivation through alteration of the binding capacity to host cells, modification of surface properties, and increase in permeability to enzymes and intercalating dyes. These findings have been reported for poliovirus, hepatitis A virus, feline calicivirus, and MS2 phage (Breindl 1971; Nuanualsuwan and Cliver 2003; Pecson, Martin and Kohn 2009; Wigginton et al. 2012; Brié et al. 2016). Heat has been shown to have, if any, only a very low impact on the virus genome (Wigginton et al. 2012). Hydrophobicity seems to be the surface property the most affected by heat treatment. Indeed, the expression of hydrophobic domains has been reported for MS2 phages exposed to heat but for remaining infectious particles only (Brié et al. 2016). An increase in hydrophobicity has also been observed for poliovirus exposed to 50°C, which has been linked to the externalization of the N-terminal region of viral protein VP1 (Fricks and Hogle 1990; Curry et al.

1996). Heat-induced modification of the electrostatic charge is less obvious. Indeed, a decrease in
the isoelectric point (IEP) has been observed for poliovirus heated at 56°C and linked to the loss of
viral RNA genome and capsid protein VP4 (O'Brien and Newman 1979; Breindl 1971). Only a
slight decrease in the global negative charge has been reported for MS2 phages after exposure to
60°C (Brié *et al.* 2016). The structural changes in the capsid proteins caused by heat seem to alter
the structure specifically involved in host cell binding, and to be linked to modification of
hydrophobic domain expression.

Free chlorine has been shown to alter both genome- and protein-mediated functions of MS2 phage, more specifically genome injection and replication, but not its binding capacity to host cells (Wigginton et al. 2012). Free chlorine has also been shown to affect proteins of pathogenic enteric viruses such as picornaviruses (Nuanualsuwan and Cliver 2003) and adenovirus (Page, Shisler and Mariñas 2010). Moreover, the loss of genome replication has been shown to coincide with extensive genome damage (Wigginton et al. 2012). The reaction of free chlorine with amino acids constituting the capsid proteins leads to the formation of numerous products such as carbonyl groups resulting from the oxidization of lysine, arginine, threonine, and proline. A relationship between the number of carbonyl groups and the rate of free chlorine-induced inactivation has been reported for enteric viruses belonging to Astroviridae, Reoviridae, Caliciviridae, and Picornaviridae (Sano et al. 2010; Tojo et al. 2013; Sano et al. 2015). The oxidization of amino acids by chlorine could also result in modifications of the electrostatic charge, which, together with hydrophobicity, is the major component of the surface properties of virus particles. To our knowledge, the electrostatic charge has not previously been explored for enteric viruses exposed to free chlorine. Concerning the hydrophobicity of chlorine-exposed viruses, a recent study has shown that exposure to sodium hypochlorite modified the profile of the hydrophobic probe SYPRO Orange in Qß phage belonging to F-specific RNA phage genogroup III. Indeed, an increase in hydrophobicity was observed at the beginning of the experiment; this meant that sodium

hypochlorite revealed some hydrophobic parts of the capsid or increased the permeability of the 96 capsid allowing the probe to reach inside hydrophobic regions (Loison et al. 2016). 97 The study of the impact of heat and free chlorine on enteric viruses requires methods suited for 98 99 the specific detection of infectious viral particles, which are the only ones that pose a risk to human 100 health. Indeed, studies performing a simultaneous and quantitative comparison between infectivity 101 loss and genome degradation have showed a higher persistence of viral genome after heat treatment 102 (Bertrand et al. 2012) and chlorination (Pelleieux et al. 2016). Thus, the detection of viral genomes 103 by molecular methods used alone does not provide information about infectivity (Girones et al. 104 2010). Human noroviruses (NoV) and hepatitis A virus (HAV) are considered as the main pathogenic enteric viruses. However, the detection of their infectious particles remains challenging 105 106 although cell culture methods have been very recently proposed for noroviruses (Jones et al. 2015; Ettayebi et al. 2016). Various methods which could be combined with molecular approaches have 107 108 been evaluated in order to favor the detection of only infectious viruses. Most of them are based on the increased permeability of the capsid to enzymes or intercalating dyes such as RNases, ethidium 109 110 monoazide (EMA), or propidium monoazide (PMA) (Prevost et al. 2016; Randazzo et al. 2016), or on the specific detection of oxidative damage (Tojo et al. 2013; Sano et al. 2015). However, their 111 112 optimal conditions of use such as the type of treatment (i.e. physical and/or chemical) and the matrices (i.e. food and/or environmental matrices) still need to be defined. 113 114 F-specific RNA phages (FRNAPH) belong to the family Leviviridae and are classified in two 115 genera, Levivirus and Allovivirus, each divided into two genogroups. These phages exhibit 116 numerous similarities with NoV and HAV in terms of size (20 - 30 nm), genome (positive-sense single-stranded RNA), and overall capsid structure (Valegård et al. 1990; King et al. 2012). These 117 phages infect bacteria with F pili, such as Escherichia coli, in the gut of mammals and are released 118 119 in environments exposed to fecal contamination similarly to enteric viruses. Their physicochemical and biological characteristics and the easy-to-apply methods available for the quantification of their 120

121	infectious particles and genome have led to their use as models to assess pathogenic enteric virus
122	behavior in water (Boudaud et al. 2012), in food (Deboosere et al. 2012; Bozkurt et al. 2015), and
123	on surfaces (Morin et al. 2015; Pelleieux et al. 2016) during treatment. Due to their structural
124	similarity with the main waterborne pathogenic viruses they have also been proposed as relevant
125	indicators of viral contamination in water (Cole, Long and Sobsey 2003; Ogorzaly et al. 2009;
126	Vergara et al. 2015) and shellfish (Hartard et al. 2017) using molecular and/or cell culture methods.
127	MS2 phage belonging to Levivirus genogroup I is the most studied of these FRNAPH, particularly
128	its physicochemical characteristics (Valegård et al. 1990; Langlet et al. 2008a; Dika et al. 2013a)
129	and the mechanisms of its inactivation (Pecson, Martin and Kohn 2009; Wigginton et al. 2012;
130	Sigstam et al. 2013). Thus, MS2 seems to be a relevant model for pathogenic enteric viruses,
131	especially for studying the mechanisms of inactivation by different factors, and it can be produced
132	in high concentrations, an essential prerequisite for some experimental methods focusing on
133	physicochemical characteristics such as electron microscopy.
134	Thus, it appears that even treatments commonly used on enteric viruses such as free chlorine
135	and heat need to be improved. Molecular-based methods allowing a more specific detection of
136	infectious enteric viruses after such treatments are also needed. Such improvements require a better
137	knowledge of the damage that occurs in enteric viruses during loss of infectivity. In such a context,
138	the present work aimed to optimize the conditions of use of free chlorine and heat for the
139	inactivation of enteric viruses and to evaluate their impact on the surface properties of MS2. The
140	impact of free chlorine used alone was first evaluated on MS2 phages because of the poor
141	knowledge about its effects on the surface properties of enteric viruses. After verification of the
142	preservation of the capsid of inactivated phages, we examined in greater detail the thermal stability
143	and the surface properties of MS2 phages exposed to chlorine. The weakening of the capsid
144	observed in the present work when free chlorine was applied alone and the increase in
145	hydrophobicity previously described for MS2 phages exposed to heat (Brié et al. 2016) led us to

perform further experiments focusing on hydrophobicity, in which heat treatment was applied to
MS2 phages previously exposed to chlorine. Since both free chlorine and heat have been shown to
act on the capsid, it might therefore be expected that their combination would increase their impact.

150 MATERIALS AND METHODS

## **Production and purification of MS2 phage**

Replication of MS2 phage (ATCC, 15597-B1) was done according to the standard procedure (ISO
10705-1 1995) (without the chloroform step) using *Escherichia coli* Hfr K12 (ATCC, 23631) as
host cells.

The phages were then concentrated and purified as previously described (Brié *et al.* 2016). Briefly, the phages were centrifuged twice (8,000 g, 20 min, 4°C) and the supernatant ( $\approx 1$  L) was filtered using a 0.22 µm filter unit (Stericup-GP Millipore Express Plus, 0.22 µm; Merck Millipore, Merck KGaA, Darmstadt, Germany). After an ultracentrifugation step (Thermo Scientific A-621 fixed rotor, 42,500 g, 18 h, 4°C; Thermo Fisher Scientific, Waltham, MA, USA), the pellets containing the concentrated phages were resuspended in iodixanol solution (20% final, Optiprep; Axis-Shield, Dundee, Scotland) and laid on a 40% iodixanol layer in a tube (Cone-Top PA tube  $14 \times 47$  mm, Thermo Fisher Scientific). The density gradient was formed upon centrifugation at 160,000 g for 7 h at 15°C (Thermo Scientific TH-641 swing rotor). After centrifugation, the MS2 phages were gently removed with a syringe and dialyzed twice (one overnight, the other for 7 h) against 10 L of PBS solution with a concentration of 1 mM (1 mM Na<sub>2</sub>HPO<sub>4</sub> and 14 mM NaCl), pH 7.4, using a Float-A-Lyzer G2 dialysis device (MW100 kD; Spectrum Laboratories, Inc., Rancho Dominguez, CA, USA). These working suspensions were kept at 4°C before use. Three working suspensions were produced for this study in order to perform the experiments in triplicate on independent suspensions.

3	171	Free chlorine and heat treatments
4 5 6	172	Three independent suspensions of purified phages at a concentration of $10^{14} \text{ PFU} \cdot \text{mL}^{-1}$ (250 µL in
7 8	173	1 mM PBS solution) (PFU: plaque-forming units) were exposed either to free chlorine alone, to heat
9 10	174	alone or to free chlorine followed by heat. To prepare our free chlorine stock solution, concentrated
11 12	175	sodium hypochlorite solution (5%, Acros Organics, Thermo Fisher Scientific) was diluted using
13 14	176	ultrapure water (> 18 M $\Omega$ ·cm <sup>-1</sup> ). Determination of free chlorine concentration was performed
15 16	177	according to the DPD (N,N-diethyl-p-phenylenediamine, Acros Organics) colorimetric method (ISO
17 18 19	178	7393-2 1985). For exposure to free chlorine alone, the working concentrations of free chlorine were
20 21	179	100 and 200 mg.L <sup>-1</sup> with a contact time of 10 min at 4°C. Residual free chlorine was immediately
22 23	180	quenched by adding two moles of sodium thiosulfate equivalent to one mole of free chlorine. The
24 25	181	heat treatments were performed at 55°C or 60°C for 10 min in pre-warmed Protein LoBind tubes
26 27	182	(Eppendorf, Hamburg, Germany) in a water bath. Samples were immediately placed on ice after
28 29	183	heat treatment to avoid further inactivation. When free chlorine was followed by heat, the phages
30 31 32	184	were exposed to 100 mg.L <sup>-1</sup> of free chlorine for 10 min at 4°C and then to heat at 55°C or 60°C for
33 34	185	10 min. For each replicate, a part of the MS2 phage suspension was not exposed to free chlorine,
35 36	186	heat or to free chlorine followed by heat and was named control phages. Thus, there were nine
37 38	187	(n=3x3) control populations in this study.
39 40	188	
41 42	189	Enumeration of infectious MS2 phages
43 44 45	190	Infectious MS2 phages were counted after treatment (I) and without treatment $(I_0)$ by the plaque
45 46 47	191	assay method using the double-agar-layer method (ISO 10705-1 1995) with E. coli K-12 Hfr as host
48 49	192	cells. Three to five decimal dilutions of the MS2 phage suspensions were dropped in duplicate onto
50 51	193	agar plates in order to have a dilution resulting in the enumeration of 10 to 100 plaques per Petri
52 53	194	dish. Infectious concentration was expressed in PFU·mL <sup>-1</sup> . The final concentration of purified MS2
54 55	195	phages was $\approx 10^{14} \text{ PFU} \cdot \text{mL}^{-1}$ . The loss in infectivity due to each treatment was estimated by log $\frac{I}{I_0}$ .

4 5	197	Viral genome extraction and quantification
6 7 8	198	The Reverse Transcription-quantitative Polymerase Chain Reaction (RT-qPCR) method was used
9 10	199	for the detection of potential degradation of the viral genome by free chlorine and/or heat. Thus, the
11 12	200	genome of MS2 phage was quantified after each treatment (C) and without treatment ( $C_0$ ). The
13 14	201	genome degradation by the treatment was estimated by $\log \frac{c}{c_0}$ . Prior to the RT-qPCR assays,
15 16 17	202	extractions of viral RNA (50 $\mu$ L) were performed using the QIA amp viral RNA kit (Qiagen,
18 19	203	Hilden, Germany) according to the manufacturer's recommendations. The extracts (100 $\mu$ L) were
20 21	204	immediately stored at -80°C before quantification. Quantification of the phage genome was
22 23	205	performed by specific a RT-qPCR assay targeting a genome fragment of $\approx 150$ nucleotides as
24 25 26	206	previously described (Ogorzaly and Gantzer 2006). Two negative controls and one positive control
27 28	207	(i.e. known quantity of MS2 genome) were added to each RT-qPCR analysis. RT-qPCR efficiency
29 30	208	ranged from 80% to 95%. Determination of MS2 genome copies per mL (gc·mL <sup>-1</sup> ) used for the
31 32	209	standard curve was performed as previously described (Brié et al. 2016). The final concentration of
33 34	210	purified MS2 phages was $\approx 10^{15} \text{ gc} \cdot \text{mL}^{-1}$ .
35 36 37	211	purified MS2 phages was $\approx 10^{10}$ gc·mL <sup>+</sup> .
38 39	212	Transmission electron microscopy
40 41	213	Transmission electron microscopy (TEM) was used to visualize virus disruption or major structural
42 43	214	modifications. The samples were adsorbed onto grids and negatively stained for 1 min with $2\%$
44 45	215	phosphotungstic acid at pH 7.4 previously filtered with a 0.22 $\mu$ m membrane filter. The
46 47	216	examination was carried out using a CM200 transmission electron microscope (Philips, Andover,
48 49 50	217	MA, USA) operating at 200 kV accelerating voltage and with a ×38,000 magnification.

2 3 4	220	An RNase assay was used to evaluate if the capsid had maintained its integrity and was still able to
5 6	221	protect the virus genome (Nuanualsuwan and Cliver 2003). Suspensions of MS2 phage, with a final
7 8	222	concentration of $10^7 \text{ gc} \cdot \text{mL}^{-1}$ , were treated with RNase A at a final concentration of 1 $\mu$ g·mL <sup>-1</sup>
9 10	223	(AppliChem GmbH, Darmstadt, Germany) at 37°C for 60 min as previously described (Brié et al.
11 12	224	2016).

15 16	226	Binding of MS2 phages to <i>E. coli</i> host cells
17 18	227	The impact of free chlorine on the binding capacity of MS2 phage to its host cell E. coli Hfr K12
19 20 21	228	was evaluated as previously described (Wigginton et al. 2012; Brié et al. 2016). The binding
22 23	229	capacity of MS2 phage to <i>E. coli</i> was estimated by $\log \frac{Q}{Q_0}$ where Q is the viral RNA found on the
24 25 26	230	bacteria after free chlorine treatment and Q <sub>0</sub> without treatment.

29 30	232	Size and electrophoretic mobility measurements
31 32	233	Size and electrophoretic mobility ( $\mu$ ) measurements were performed in order to evaluate the impact
33		
34 35	234	of free chlorine on the overall structure and charge density of MS2 phage, respectively. The
36 37	235	experiments were achieved in disposable capillary cells (Malvern Instruments, Worcestershire, UK)
38 39	236	at $23^{\circ}C \pm 0.1^{\circ}C$ and pH 7.0 using a Zetasizer Nano ZS instrument (Malvern Instruments, He–Ne
40 41	237	red laser, wavelength 633 nm) driven by Dispersion Technology Software (Malvern Instruments) as
42 43	238	previously described (Langlet et al. 2008a). The slope of the electrophoretic mobility as a function
44 45	239	of the logarithm of ionic strength (1.95, 19.5 and 195 mM) reflects the ratio between the density of
46 47	240	electric charges located within the particle and that of charges distributed at the outer virus
48 49	241	periphery. A decrease in the slope value shows a decrease in the charge density of the virus (Langlet
50 51 52	242	et al. 2008a). The experimental conditions were identical to those previously described (Brié et al.
53 54	243	2016). For each condition, measurements were obtained by means of three independent experiments
55 56 57	244	with triplicate measures in each to ensure repeatability of the measurements.

4 5	246	Binding of MS2 phages to hydrophobic or positively charged beads
6 7	247	These assays were performed to study the variation in hydrophobicity or negative charge at the

13 14	375	The effect of free chlorine on the hydrophobicity of MS2 phage was then evaluated by DSF and by
15 16 17	376	its adhesion capacity to hydrophobic beads. The DSF profile (Fig. 2) showed the same fluorescence
18 19	377	intensity of SYPRO Orange at the beginning of the experiment for control and chlorinated phages,
20 21	378	meaning that free chlorine did not modify the overall expression of hydrophobic domains of the
22 23	379	capsid proteins. The expression of hydrophobic domains on the surface of MS2 particles was

DISCUSSION	

# The purpose of this study was to explore the impact of free chlorine alone or followed by heat on the loss of infectivity and the modification of the physicochemical properties of MS2 phage used as model of the main pathogenic enteric viruses. The impact of free chlorine on capsid proteins has been previously described in a few studies focusing on their altered functions. However, modification of the overall structure of viral particles may lead to modification of their surface properties which govern their behavior in the environment. Moreover, the study of surface properties may contribute to the understanding of the mechanisms involved in the inactivation process and may also help in the development of detection methods specific for infectious viruses. MS2 phage was first exposed to free chlorine alone. The loss of infectivity of MS2 phage observed in our experiments after exposure to 100 and 200 mg.L<sup>-1</sup> of free chlorine was similar to that reported by Loison *et al.* (2016) for a $Q\beta$ phage suspension. Indeed, by applying sodium hypochlorite at 1 mM (i.e. 74.4 mg,L<sup>-1</sup>) for 10 min at room temperature on a Q $\beta$ phage suspension at an initial concentration of $\approx 10^{12}$ PFU·mL<sup>-1</sup>, these authors observed a $-1.7 \log_{10}$ reduction in infectivity. In the present work, we observed that the binding to host bacteria was altered after

420	exposure to 200 mg.L <sup>-1</sup> of free chlorine only. Thus, the loss of infectivity was not due to the
421	alteration of the binding capacity after exposure to 100 mg.L <sup>-1</sup> of free chlorine and was slightly due
422	to the alteration of this function after exposure to 200 mg. $L^{-1}$ of free chlorine. Our observation of a
423	high concentration of free chlorine needed to observe an impact on binding to host cell was in
424	agreement with a previous study published by Wigginton et al. (2012). Indeed, these authors
425	applied a concentration of 2-3 mg.L <sup>-1</sup> of free chlorine to an MS2 phage suspension of $10^{11}$ PFU·L <sup>-1</sup>
426	and observed alteration of the genome injection and extensive degradation of the maturation protein
427	(MP). This protein, which is present as a single copy in the capsid of MS2 phage, is clearly
428	involved in the binding of MS2 phage to the F-pilus of host bacteria and probably in the injection of
429	the genome into host cells. Dent et al. (2013) have proposed that the natural retraction of the F-pilus
430	could pull the MP from its location in the attached capsid, leaving a pore through which the phage
431	genome could exit into the cell. Thus, alteration of the MP by free chlorine may impact these two
432	functions depending on its intensity. The sensitivity of the capsid to oxidants has also been observed
433	for $Q\beta$ phage with the loss of its infectivity due either to capsid destabilization or to the
434	modification of capsid proteins especially the MP and the readthrough protein (Loison et al. 2016).
435	Considering the capsid of FRNAPH, the MP appears as one of the targets of free chlorine. Thus,
436	free chlorine weakens the capsid of MS2 phage and may alter the role of the MP in the genome
437	injection into host cells even at low concentrations. High concentrations of free chlorine seem to
438	further alter the MP with a reduced ability to bind to host cells.
439	In our experiments, the genome of MS2 phage was quantified using an RT-qPCR assay which
440	targets a fragment of $\approx 150$ nucleotides and the RT-qPCR signal was found to be affected only after

targets a fragment of  $\approx$  150 nucleotides and the RT-qPCR signal was found to be affected only after exposure to 200 mg.L<sup>-1</sup> of free chlorine. A few studies have shown that some regions of the viral genome could be more sensitive than others to damage caused by free chlorine with significant differences depending on the virus type (Li *et al.* 2002; Xue *et al.* 2013). Free chlorine was shown to induce genome damage on MS2 phage at levels comparable to singlet oxygen and UV. However,

145	the loss of replication function played a lesser role in the overall inactivation than in the other two
146	inactivation treatments (Wigginton et al. 2012). For these authors, this suggested that the virucidal
147	effect due to genome damage was linked to the type of modification rather than its location.
148	No modification of the shape of MS2 phage was observed by TEM after exposure to free
149	chlorine. The mean size of MS2 phage before and after chlorination was similar to that previously
450	described (Valegård <i>et al.</i> 1990; Dika <i>et al.</i> 2013a). Q $\beta$ phage particles exposed to chlorine under
451	similar conditions were also demonstrated by TEM observations to maintain their shape (Loison et
452	al. 2016). Disruption of MS2 phage occurring after exposure to 72°C for 10 min has previously
453	been shown to be related to a significant increase in RNase sensitivity (Brié et al. 2016). In our
454	case, the limited effect of RNase treatment on RT-qPCR signal confirmed that the integrity of the
455	capsid was preserved after exposure to free chlorine under our experimental conditions. DSF was
456	then used to explore conformational modifications of the capsid that could not be revealed by TEM.
457	We observed a similar DSF profile to that obtained in our previous study (Brié et al. 2016) with
458	only one Tm peak (66°C) before exposure to chlorine. The decrease in the Tm value after exposure
459	to free chlorine corresponded to a reduction in the denaturation temperature and suggested a
460	weakening of the capsid of MS2 phage by the oxidant by comparison to a previous study performed
461	on poliovirus (Robinson, Jesudhasan and Pfeiffer 2014). The weakening of the capsid might be
462	linked to the site-specific cleavage showed on the capsid protein of MS2 phage following exposure
463	to chlorine (Wigginton et al. 2012).
164	The reactions of hypochlorous acid with amino acids result in a wide variety of products such

The reactions of hypochlorous acid with amino acids result in a wide variety of products such as sulfinic/sulfonic acids, methionine sulfone, and *N*-chlorinated species (Pattison, Davies and Hawkins 2012) which may modify the electrostatic charge of viral particles. In our study, the charge density was evaluated by measuring the electrophoretic mobility as a function of ionic strength which suggested a decrease in the negative charge density of MS2 phage exposed to free chlorine. On a qualitative level, it meant that free chlorine could change the negative charge density Page 21 of 68

470 of MS2 phage particles by increasing their external negative charge and/or by decreasing their 471 internal negative charge (Langlet et al. 2008a). The binding to positively and negatively charged beads at different pH showed that the IEP of MS2 phage was between 3 and 4, which was in full 472 473 agreement with literature data in the field (Langlet et al. 2008b; Dika et al., 2011). MS2 phage 474 exposure to chlorine led to an increase in its adhesion capacity to positively charged beads at pH 475 above the IEP. Thus, the increase in the negative charge density of MS2 phage observed after 476 exposure to free chlorine resulted mainly from an increase in the external negative charge. 477 Hydrophobicity was the other surface property monitored after exposure to free chlorine. The 478 lack of adhesion to hydrophobic beads before exposure to free chlorine was in agreement with 479 previous studies performed with MS2 phage (Dika et al. 2013b; Brié et al. 2016). No adhesion to 480 hydrophobic beads was also observed after exposure to free chlorine. The DSF profile showed the 481 same fluorescence intensity of SYPRO Orange at the beginning of the experiment for control and 482 chlorinated phages. Thus, the results obtained with these two methods suggest that few hydrophobic domains are naturally expressed on the surface of MS2 particles and that free chlorine does not 483 484 change the expression of hydrophobic domains of the MS2 capsid proteins or the permeability of the capsid to the probe. An increase in hydrophobicity by chlorine has previously been described for 485 486  $Q\beta$  phage (Loison *et al.* 2016) and for specific proteins such as  $\alpha$ 2 chaperone (Wyatt *et al.* 2014) and Bovine Serum Albumin (Ashrafi Kooshk et al. 2012). This suggests that the expression of 487

488 hydrophobic domains induced by chlorine depends on the composition and environment of the489 protein.

490 Overall, the most significant effect we observed on MS2 phages exposed to free chlorine
491 alone was the decrease in the Tm in the DSF profile suggesting the weakening of the capsid. This
492 led us to explore the impact of free chlorine followed by heat on MS2 phages. Indeed, we had
493 previously shown that heat significantly impacts the structure of the capsid with disruption of MS2

494 phage particles at high temperatures (72°C) and transient expression of hydrophobic domains at
495 lower temperatures (60°C) (Brié *et al.* 2016).

An increased effect on the inactivation of MS2 phage and on the permeability of its capsid to RNase was observed when the 60°C heat treatment was applied after chlorination. To our knowledge, the virucidal effect of the combination of free chlorine and heat on enteric viruses and phages has not been studied before. Indeed, chlorine-induced inactivation of enteric viruses and phages in suspension in water has only been studied for temperatures below 30°C. The combined effect of temperature and chlorination in foodstuffs has been more closely studied on bacteria, showing an increase in inactivation compared to chlorine applied alone (Klaiber et al. 2005; Choi et al. 2016). Moreover, these authors have shown that warm water (50°C) or dry heat (80°C) and chlorine can be combined without altering the organoleptic quality or the viability of vegetables or seeds.

Since hydrophobicity is known to be the main surface property affected by exposure of MS2 phages to heat (60°C) (Brié *et al.* 2016), a significant change in this parameter was expected when free chlorine was followed by heat. As previously described by Brié et al. (2016) for MS2 phages exposed to the 60°C heat treatment alone, the initial fluorescence of the DSF profile increased after exposure to free chlorine followed by heat. The highest initial fluorescence value was observed using free chlorine followed by a 60°C heat treatment. The increase in the initial fluorescence showed that chlorine followed by heat led to the expression of hydrophobic domains and/or increased the permeability of the capsid allowing the probe to reach inside hydrophobic regions. The adhesion test to hydrophobic beads showed an increase in the expression of hydrophobic domains at the surface of MS2 phages exposed to free chlorine followed by 60°C heat treatment. Remarkably, this increase in the adhesion capacity to hydrophobic beads appeared to be specific to viral particles remaining infectious as previously observed for MS2 phage exposed to heat alone (Brié et al. 2016). After exposure to heat and free chlorine, infectious MS2 phages accounted for a

small part of the total MS2 phage particles. Thus, our results showed that the permeability of the
capsid to the probe increased for both infectious and inactivated phages, whereas the increase in the
expression of hydrophobic domains at the surface was specific to phages remaining infectious after
treatment.

523 Overall, our results showed that free chlorine weakens the capsid of MS2 phage and alters the 524 functions of the MP at least for the highest concentration tested. The combination of heat and 525 chlorine has not been evaluated before for enteric phages or pathogenic viruses, but it has been 526 previously reported to be interesting for bacteria in foodstuffs. We observed that free chlorine 527 followed by heat increased the inactivation of MS2 phage and the structural modifications of the capsid by comparison with these treatments applied separately. Our results suggested that the 528 529 oxidant should be applied before heat to have an optimal effect. Concerning the specific detection of infectious viruses, the increase in permeability to enzymes such as RNases for inactivated phages 530 531 could offer new opportunities for such methods. In our opinion, the most important result concerning free chlorine followed by heat is the specific increase in the expression of hydrophobic 532 533 domains at the surface of infectious MS2 phages. Indeed, this result suggested that hydrophobic 534 surfaces could be used to capture specifically infectious viruses before their detection using 535 molecular methods. Finally, the modifications observed on the capsid with our treatments underline 536 the need for further studies focusing on the structural modifications that occur during the viral life 537 cycle and also during inactivation treatments in order to better understand the mechanisms of virus inactivation resulting from capsid damage. 538

# 26 ABSTRACT

Enteric viruses and bacteriophages are exposed to various inactivating factors outside their host, and among them chlorine and heat are the most commonly used sanitizer in water industry and treatment in the food industry, respectively. Using MS2 phages as models for enteric viruses, we investigated the impact of free chlorine and heat on their physicochemical properties. Free chlorine was first evaluated alone. No increase in either capsid permeability or hydrophobicity was observed. The negative surface charge slightly increased suggesting molecular changes in the capsid. However, a weakening of the capsid by chlorine was suggested by differential scanning fluorimetry. This phenomenon was confirmed when chlorination was followed by a heat treatment. Indeed, an increase in the inactivation of MS2 phages and the permeability of their capsids to RNases was observed. More interestingly, an increase in the expression of hydrophobic domains at the phage surface was observed, but only for phages remaining infectious. The chlorine-caused weakening of the capsid suggested that, for an optimal use, the oxidant should be followed by heat. The increased permeability to RNases and the expression of hydrophobic domains may contribute to the development or improvement of molecular methods specific for infectious enteric viruses. **KEYWORDS:** free chlorine, heat, MS2 bacteriophage, surface properties, hydrophobicity, charge 

# 46 INTRODUCTION

Enteric viruses and phages are exposed to various inactivating factors in water, in foodstuffs, and on surfaces. Among them, heat and chlorine are one of the most cost-effective and easy-toapply treatments and sanitizers in the food and water industries. The level of inactivation of enteric viruses by heat has been widely monitored in food and environmental matrices in which it is considered as one of the main inactivating factors (Hirneisen et al. 2010; Bertrand et al. 2012). Chlorine is a major disinfection treatment of water and food for its broad-spectrum antimicrobial activity (Hirneisen et al. 2010; Boudaud et al. 2012; Girard et al. 2016; Meireles et al. 2016). Although virus inactivation by heat or chlorine has been evaluated in numerous studies, the mechanisms leading to non-infectious virus particles still remain partially understood. Comparison of the impact of different inactivating treatments on virus functions (i.e. host cell binding, genome injection and replication), using MS2 phage as model of pathogenic enteric viruses, has revealed differences in the mechanisms of inactivation between physical treatments such as heat and chemical oxidants such as free chlorine, but also within treatment groups (Wigginton et al. 2012). Heat induces structural and conformational changes of the capsid proteins leading to at least inactivation through alteration of the binding capacity to host cells, modification of surface properties, and increase in permeability to enzymes and intercalating dyes. These findings have been reported for poliovirus, hepatitis A virus, feline calicivirus, and MS2 phage (Breindl 1971; Nuanualsuwan and Cliver 2003; Pecson, Martin and Kohn 2009; Wigginton et al. 2012; Brié et al. 2016). Heat has been shown to have, if any, only a very low impact on the virus genome (Wigginton et al. 2012). Hydrophobicity seems to be the surface property the most affected by heat treatment. Indeed, the expression of hydrophobic domains has been reported for MS2 phages exposed to heat but for remaining infectious particles only (Brié et al. 2016). An increase in hydrophobicity has also been observed for poliovirus exposed to 50°C, which has been linked to the externalization of the N-terminal region of viral protein VP1 (Fricks and Hogle 1990; Curry et al.

1996). Heat-induced modification of the electrostatic charge is less obvious. Indeed, a decrease in the isoelectric point (IEP) has been observed for poliovirus heated at 56°C and linked to the loss of viral RNA genome and capsid protein VP4 (O'Brien and Newman 1979; Breindl 1971). Only a slight decrease in the global negative charge has been reported for MS2 phages after exposure to 60°C (Brié *et al.* 2016). The structural changes in the capsid proteins caused by heat seem to alter the structure specifically involved in host cell binding, and to be linked to modification of hydrophobic domain expression.

Free chlorine has been shown to alter both genome- and protein-mediated functions of MS2 phage, more specifically genome injection and replication, but not its binding capacity to host cells (Wigginton et al. 2012). Free chlorine has also been shown to affect proteins of pathogenic enteric viruses such as picornaviruses (Nuanualsuwan and Cliver 2003) and adenovirus (Page, Shisler and Mariñas 2010). Moreover, the loss of genome replication has been shown to coincide with extensive genome damage (Wigginton et al. 2012). The reaction of free chlorine with amino acids constituting the capsid proteins leads to the formation of numerous products such as carbonyl groups resulting from the oxidization of lysine, arginine, threonine, and proline. A relationship between the number of carbonyl groups and the rate of free chlorine-induced inactivation has been reported for enteric viruses belonging to Astroviridae, Reoviridae, Caliciviridae, and Picornaviridae (Sano et al. 2010; Tojo et al. 2013; Sano et al. 2015). The oxidization of amino acids by chlorine could also result in modifications of the electrostatic charge, which, together with hydrophobicity, is the major component of the surface properties of virus particles. To our knowledge, the electrostatic charge has not previously been explored for enteric viruses exposed to free chlorine. Concerning the hydrophobicity of chlorine-exposed viruses, a recent study has shown that exposure to sodium hypochlorite modified the profile of the hydrophobic probe SYPRO Orange in  $O\beta$  phage belonging to F-specific RNA phage genogroup III. Indeed, an increase in hydrophobicity was observed at the beginning of the experiment; this meant that sodium

96	hypochlorite revealed some hydrophobic parts of the capsid or increased the permeability of the
97	capsid allowing the probe to reach inside hydrophobic regions (Loison et al. 2016).
98	The study of the impact of heat and free chlorine on enteric viruses requires methods suited for
99	the specific detection of infectious viral particles, which are the only ones that pose a risk to human
100	health. Indeed, studies performing a simultaneous and quantitative comparison between infectivity
101	loss and genome degradation have showed a higher persistence of viral genome after heat treatment
102	(Bertrand et al. 2012) and chlorination (Pelleieux et al. 2016). Thus, the detection of viral genomes
103	by molecular methods used alone does not provide information about infectivity (Girones et al.
104	2010). Human noroviruses (NoV) and hepatitis A virus (HAV) are considered as the main

116	numerous similarities with NoV and HAV in terms of size (20 - 30 nm), genome (positive-sense
117	single-stranded RNA), and overall capsid structure (Valegård et al. 1990; King et al. 2012). These
118	phages infect bacteria with F pili, such as Escherichia coli, in the gut of mammals and are released
119	in environments exposed to fecal contamination similarly to enteric viruses. Their physicochemical

121	infectious particles and genome have led to their use as models to assess pathogenic enteric virus
122	behavior in water (Boudaud et al. 2012), in food (Deboosere et al. 2012; Bozkurt et al. 2015), and
123	on surfaces (Morin et al. 2015; Pelleieux et al. 2016) during treatment. Due to their structural
124	similarity with the main waterborne pathogenic viruses they have also been proposed as relevant
125	indicators of viral contamination in water (Cole, Long and Sobsey 2003; Ogorzaly et al. 2009;
126	Vergara et al. 2015) and shellfish (Hartard et al. 2017) using molecular and/or cell culture methods.
127	MS2 phage belonging to Levivirus genogroup I is the most studied of these FRNAPH, particularly
128	its physicochemical characteristics (Valegård et al. 1990; Langlet et al. 2008a; Dika et al. 2013a)
129	and the mechanisms of its inactivation (Pecson, Martin and Kohn 2009; Wigginton et al. 2012;
130	Sigstam et al. 2013). Thus, MS2 seems to be a relevant model for pathogenic enteric viruses,
131	especially for studying the mechanisms of inactivation by different factors, and it can be produced
132	in high concentrations, an essential prerequisite for some experimental methods focusing on
133	physicochemical characteristics such as electron microscopy.
134	Thus, it appears that even treatments commonly used on enteric viruses such as free chlorine
135	and heat need to be improved. Molecular-based methods allowing a more specific detection of

137	knowledge of the damage that occurs in enteric viruses during loss of infectivity. In such a context,
138	the present work aimed to optimize the conditions of use of free chlorine and heat for the
139	inactivation of enteric viruses and to evaluate their impact on the surface properties of MS2. The
140	impact of free chlorine used alone was first evaluated on MS2 phages because of the poor
141	knowledge about its effects on the surface properties of enteric viruses. After verification of the
142	preservation of the capsid of inactivated phages, we examined in greater detail the thermal stability
143	and the surface properties of MS2 phages exposed to chlorine. The weakening of the capsid
144	observed in the present work when free chlorine was applied alone and the increase in
145	hydrophobicity previously described for MS2 phages exposed to heat (Brié et al. 2016) led us to

perform further experiments focusing on hydrophobicity, in which heat treatment was applied to 146 147 MS2 phages previously exposed to chlorine. Since both free chlorine and heat have been shown to act on the capsid, it might therefore be expected that their combination would increase their impact. 148

#### MATERIALS AND METHODS 150

#### Production and purification of MS2 phage 151

Replication of MS2 phage (ATCC, 15597-B1) was done according to the standard procedure (ISO 152 153 10705-1 1995) (without the chloroform step) using Escherichia coli Hfr K12 (ATCC, 23631) as 154 host cells.

155 The phages were then concentrated and purified as previously described (Brié *et al.* 2016). Briefly, the phages were centrifuged twice (8,000 g, 20 min, 4°C) and the supernatant ( $\approx 1$  L) was filtered 156 using a 0.22 µm filter unit (Stericup-GP Millipore Express Plus, 0.22 µm; Merck Millipore, Merck 157 158 KGaA, Darmstadt, Germany). After an ultracentrifugation step (Thermo Scientific A-621 fixed rotor, 42,500 g, 18 h, 4°C; Thermo Fisher Scientific, Waltham, MA, USA), the pellets containing 159 the concentrated phages were resuspended in iodixanol solution (20% final, Optiprep; Axis-Shield, 160 161 Dundee, Scotland) and laid on a 40% iodixanol layer in a tube (Cone-Top PA tube  $14 \times 47$  mm, 162 Thermo Fisher Scientific). The density gradient was formed upon centrifugation at 160,000 g for 163 7 h at 15°C (Thermo Scientific TH-641 swing rotor). After centrifugation, the MS2 phages were 164 gently removed with a syringe and dialyzed twice (one overnight, the other for 7 h) against 10 L of 165 PBS solution with a concentration of 1 mM (1 mM Na<sub>2</sub>HPO<sub>4</sub> and 14 mM NaCl), pH 7.4, using a 166 Float-A-Lyzer G2 dialysis device (MW100 kD; Spectrum Laboratories, Inc., Rancho Dominguez, 167 CA, USA). These working suspensions were kept at 4°C before use. Three working suspensions 168 were produced for this study in order to perform the experiments in triplicate on independent suspensions. 169 170

#### 171 Free chlorine and heat treatments

Three independent suspensions of purified phages at a concentration of  $10^{14}$  PFU·mL<sup>-1</sup> (250 µL in 1 mM PBS solution) (PFU: plaque-forming units) were exposed either to free chlorine alone, to heat alone or to free chlorine followed by heat. To prepare our free chlorine stock solution, concentrated sodium hypochlorite solution (5%, Acros Organics, Thermo Fisher Scientific) was diluted using ultrapure water (> 18 M $\Omega$ ·cm<sup>-1</sup>). Determination of free chlorine concentration was performed according to the DPD (N,N-diethyl-p-phenylenediamine, Acros Organics) colorimetric method (ISO 7393-2 1985). For exposure to free chlorine alone, the working concentrations of free chlorine were 100 and 200 mg.L<sup>-1</sup> with a contact time of 10 min at 4°C. Residual free chlorine was immediately quenched by adding two moles of sodium thiosulfate equivalent to one mole of free chlorine. The heat treatments were performed at 55°C or 60°C for 10 min in pre-warmed Protein LoBind tubes (Eppendorf, Hamburg, Germany) in a water bath. Samples were immediately placed on ice after heat treatment to avoid further inactivation. When free chlorine was followed by heat, the phages were exposed to 100 mg.L<sup>-1</sup> of free chlorine for 10 min at 4°C and then to heat at 55°C or 60°C for 10 min. For each replicate, a part of the MS2 phage suspension was not exposed to free chlorine, heat or to free chlorine followed by heat and was named control phages. Thus, there were nine (n=3x3) control populations in this study. 

#### 189 Enumeration of infectious MS2 phages

190 Infectious MS2 phages were counted after treatment (I) and without treatment (I<sub>0</sub>) by the plaque 191 assay method using the double-agar-layer method (ISO 10705-1 1995) with *E. coli* K-12 Hfr as host 192 cells. Three to five decimal dilutions of the MS2 phage suspensions were dropped in duplicate onto 193 agar plates in order to have a dilution resulting in the enumeration of 10 to 100 plaques per Petri 194 dish. Infectious concentration was expressed in PFU·mL<sup>-1</sup>. The final concentration of purified MS2 195 phages was  $\approx 10^{14}$  PFU·mL<sup>-1</sup>. The loss in infectivity due to each treatment was estimated by log  $\frac{I}{I_0}$ .

6 7	198	The Reverse Transcription-quantitative Polymerase Chain Reaction (RT-qPCR) method was used

#### 220 An RNase assay was used to evaluate if the capsid had maintained its integrity and was still able to protect the virus genome (Nuanualsuwan and Cliver 2003). Suspensions of MS2 phage, with a final 221 concentration of $10^7$ gc·mL<sup>-1</sup>, were treated with RNase A at a final concentration of 1 µg·mL<sup>-1</sup> 222 (AppliChem GmbH, Darmstadt, Germany) at 37°C for 60 min as previously described (Brié et al. 223 224 2016). 225 226 Binding of MS2 phages to E. coli host cells The impact of free chlorine on the binding capacity of MS2 phage to its host cell E. coli Hfr K12 227 228 was evaluated as previously described (Wigginton et al. 2012; Brié et al. 2016). The binding capacity of MS2 phage to *E. coli* was estimated by $\log \frac{q}{q_0}$ where Q is the viral RNA found on the 229 bacteria after free chlorine treatment and Q<sub>0</sub> without treatment. 230 231 Size and electrophoretic mobility measurements 232 Size and electrophoretic mobility $(\mu)$ measurements were performed in order to evaluate the impact 233 234 of free chlorine on the overall structure and charge density of MS2 phage, respectively. The experiments were achieved in disposable capillary cells (Malvern Instruments, Worcestershire, UK) 235 at $23^{\circ}C \pm 0.1^{\circ}C$ and pH 7.0 using a Zetasizer Nano ZS instrument (Malvern Instruments, He–Ne 236 237 red laser, wavelength 633 nm) driven by Dispersion Technology Software (Malvern Instruments) as previously described (Langlet *et al.* 2008a). The slope of the electrophoretic mobility as a function 238 239 of the logarithm of ionic strength (1.95, 19.5 and 195 mM) reflects the ratio between the density of 240 electric charges located within the particle and that of charges distributed at the outer virus 241 periphery. A decrease in the slope value shows a decrease in the charge density of the virus (Langlet 242 et al. 2008a). The experimental conditions were identical to those previously described (Brié et al. 243 2016). For each condition, measurements were obtained by means of three independent experiments 244 with triplicate measures in each to ensure repeatability of the measurements.

stock or after treatment  $(5.10^{14}-10^{15} \text{ gc}\cdot\text{mL}^{-1})$ . The temperature was increased for all replicates from 270 20°C to 95°C on a 1% stepwise gradient corresponding to  $\approx 1$ °C·min<sup>-1</sup> with fluorescence 271 measurements. The sum of the fluorescence intensities obtained with all the filters was plotted 272 against temperature (Excel software) to obtain the maximum fluorescence intensity of SYPRO 273 274 Orange. The Tm was determined by plotting the first derivative of the previous curve; it appeared 275 then as a peak (Loison et al. 2016). This method is also known to allow the expression of 276 hydrophobic parts of the capsid and/or the permeability of the capsid to be investigated by the 277 fluorescence intensity of SYPRO Orange at the beginning of the DSF experiment (Loison et al. 278 2016).

280 Data analysis

The analysis was performed using the values obtained for the three independent suspensions of 281 282 phages. Since the experimental values were not normally distributed, non-parametric tests were performed using StatEL 2.7 (Ad Science). The explanatory variables were the exposure to free 283 284 chlorine alone, heat alone, and free chlorine followed by heat. For free chlorine alone, Mann-Whitney tests were performed to evaluate its effect on the infectivity (i.e. loss of infectivity, binding 285 286 capacity to host bacteria), structure (i.e. genome degradation, capsid permeability to RNase, thermal 287 stability), and hydrophobicity (i.e. initial adhesion of hydrophobic probe SYPRO Orange, binding 288 to hydrophobic probes), and the adhesion to positively charged beads by comparison between 289 control and chlorinated MS2 phages. A Kruskal-Wallis test was performed to compare the 290 electrophoretic mobility between control and chlorinated MS2 phages. The effect of free chlorine 291 followed by heat on the loss of infectivity, structure (i.e. genome degradation, capsid permeability 292 to RNase) and hydrophobicity (i.e. initial adhesion of hydrophobic probe SYPRO Orange, binding 293 to hydrophobic beads) was evaluated by comparison with free chlorine alone and heat alone using 294 Kruskal-Wallis tests. For all these tests, a p value of <0.01 was considered as significant.

7 8	297	Impact of free chlorine applied alone or followed by heat on the infectivity and structure of
9 10	298	MS2 phage
11 12	299	The effects of free chlorine applied alone on MS2 phage were evaluated for 100 and 200 mg.L <sup>-1</sup>
13 14 15	300	(Table 1). Infectivity decreased by $-1.2 \pm 0.3 \log_{10}$ for 100 mg.L <sup>-1</sup> ( $p < 0.01$ , Mann-Whitney test)
16 17	301	and by $-3.5 \pm 0.9 \log_{10}$ for 200 mg.L <sup>-1</sup> ( $p < 0.01$ , Mann-Whitney test). The binding capacity of MS2
18 19	302	phage to <i>E. coli</i> K12 Hfr was not altered after exposure to 100 mg.L <sup>-1</sup> ( $-0.1 \pm 0.1 \log_{10}$ ) ( $p > 0.01$ ,
20 21	303	Mann-Whitney test), whereas it decreased by $-0.8 \pm 0.1 \log_{10}$ after exposure to 200 mg.L <sup>-1</sup> ( $p < 0.01$ ,
22 23	304	Mann-Whitney test). The free chlorine treatment at 100 mg.L <sup>-1</sup> did not affect the detection of the
24 25	305	genome fragment of $\approx$ 150 nucleotides targeted with our RT-qPCR assay since the RT-qPCR signal
26 27	306	was not modified ( $p > 0.01$ , Mann-Whitney test). However, the genome detection decreased by –
28 29 30	307	$0.5 \pm 0.2 \log_{10}$ for 200 mg.L <sup>-1</sup> ( $p < 0.01$ , Mann-Whitney test). No modification of the shape of MS2
31 32	308	phage was observed by TEM for these two concentrations of free chlorine (Fig. 1). The mean size
33 34	309	of chlorinated MS2 phage was $20 \pm 2$ nm for 100 mg.L <sup>-1</sup> (n=3×3) and $21 \pm 1$ nm for 200 mg.L <sup>-1</sup>
35 36	310	(n=3×3) which was similar to control phages ( $p > 0.01$ , Mann-Whitney test). Moreover, the limited
37 38	311	effect of RNase treatment on RT-qPCR signal which decreased by less than $-0.3 \pm 0.1 \log_{10}$ with
39 40	312	the two concentrations of free chlorine ( $p > 0.01$ , Mann-Whitney test) confirmed that the integrity of
41 42	313	the capsid was preserved under our experimental conditions. DSF was then used to explore
43 44 45	314	conformational modifications of the capsid that could not be revealed by TEM and to compare the
46 47	315	Tm (i.e. denaturation temperature) value of MS2 phages before and after exposure to free chlorine.
48 49	316	We observed only one Tm peak of $66.0 \pm 0.1$ °C (n=3) before exposure to chlorine (Fig. 2). After
50 51	317	exposure to free chlorine for 10 min, a decrease in the Tm to $62.8 \pm 0.1$ °C (n=3) for 100 mg.L <sup>-1</sup> (p
52 53	318	<0.01, Mann-Whitney test) and $60.9 \pm 0.7^{\circ}$ C (n=3) for 200 mg.L <sup>-1</sup> ( $p < 0.01$ , Mann-Whitney test)
54 55	319	was noticed. This reduction in the denaturation temperature suggested a weakening of the capsid of
56 57 58		

MS2 phage by the oxidant. Although there was a decrease in the thermal stability of the capsid we did not find any changes in shape, size, and binding capacity, nor did the permeability to RNase increase thus suggesting that the capsid of MS2 phage maintained its integrity after exposure to free chlorine alone.

The decrease in the thermal stability after exposure to chlorine led us to expose MS2 phage to chlorine (100 mg.L<sup>-1</sup>) and then to heat (55°C or 60°C). The infectivity decreased by  $-1.9 \pm 0.3 \log_{10}$ for chlorine followed by heat treatment at 55°C and by  $-3.2 \pm 0.6 \log_{10}$  for chlorine followed by heat treatment at  $60^{\circ}$ C. For each treatment applied separately, the loss in infectivity reached –  $1.2 \pm 0.3 \log_{10}$  after exposure to free chlorine (Table 1),  $-0.7 \pm 0.1 \log_{10}$  after heat treatment at 55°C (data not shown) and  $-1.1 \pm 0.1 \log_{10}$  after heat treatment at 60°C (Brié *et al.* 2016). The highest loss in infectivity was obtained when free chlorine was followed by heat treatment at 60°C (p<0.01, Kruskal-Wallis test). This loss in infectivity was also higher than the sum of the decrease values obtained with free chlorine and heat treatment at 60°C applied separately (p < 0.01, Kruskal-Wallis test). This suggested that free chlorine improved the inactivation of MS2 phage by heat treatment at 60°C. The RT-qPCR signal decreased only by  $-0.1 \pm 0.4 \log_{10}$  for chlorine followed by heat treatment at 55°C and by  $-0.3 \pm 0.4 \log_{10}$  for chlorine followed by heat treatment at 60°C. The concentrations in genome observed after these treatments were similar to those observed for MS2 phage exposed to 100 mg.L<sup>-1</sup> free chlorine alone and also for control MS2 phage (p > 0.01, Kruskal-Wallis test). Thus, the detection of the MS2 genome was not affected when free chlorine was followed by heat. As observed for free chlorine alone, no modification of the shape of MS2 phage was noted by TEM after exposure to free chlorine followed by heat (Fig. 1). The RNase treatment applied after exposure to free chlorine (100 mg. $L^{-1}$ ) followed by heat decreased the RT-qPCR signal by  $-1.1 \pm 0.2 \log_{10}$  for 55°C and  $-1.7 \pm 0.4 \log_{10}$  for 60°C. The log removal of genome copies by RNase treatment reached  $-0.3 \pm 0.1 \log_{10}$  (Table 1) for free chlorine alone,  $-0.1 \pm 0.1 \log_{10}$  (data not shown) for 55°C heat treatment alone and  $-0.8 \pm 0.2 \log_{10}$  (Brié *et al.* 2016) for 60°C heat

345	treatment alone. The reduction in genome after chlorine followed by heat (55°C and 60°C) was
346	higher than the sum of the log removal obtained with free chlorine and heat applied separately ( $p$
347	<0.01, Kruskal-Wallis test). Moreover, the highest log removal of genome copies by RNase
348	treatment was observed for MS2 phage exposed to free chlorine followed by heat treatment at 60°C
349	( $p < 0.01$ , Kruskal-Wallis test). Overall, the increased effect of free chlorine followed by heat
350	treatment at 60°C on the loss in infectivity and on the capsid permeability to RNase was in
351	agreement with the free chlorine-induced weakening of the capsid suggested by DSF experiments.
352	
353	Impact of free chlorine on the charge of MS2 phage particles
354	The electrophoretic mobility ( $\mu$ ) was represented as a function of the logarithm of ionic strength
355	(1.95, 19.5 and 195 mM) at pH 7.0 before and after exposure to free chlorine (100 and 200 mg.L <sup>-1</sup> )
356	in order to estimate the impact of free chlorine on the charge density of MS2 phage (Fig. 3A). A
357	decrease in the electrophoretic mobility was observed after exposure to free chlorine at ionic
358	strengths of 1.95 and 19.5 mM ( $p < 0.01$ , Kruskal-Wallis test). On the other hand, no modification
359	of the electrophoretic mobility was observed after exposure to chlorine at an ionic strength of 195
360	mM ( $p > 0.01$ , Kruskal-Wallis test). Therefore, a lower slope value was observed for chlorinated
361	phages than for control phages suggesting a decrease in the negative charge density of MS2 phage
362	exposed to free chlorine. The negative surface charge of total particles (i.e. RT-qPCR results) was
363	then estimated by binding to positively charged beads at different pH (i.e. 7.0, 4.0, 3.0, and 2.5) for
364	control and chlorinated phages (Fig. 3B). The lowest adhesion capacity of both control and
365	chlorinated phages on positively charged beads was obtained at pH 2.5 and 3.0 which are below the
366	IEP of MS2 phage. Conversely, the highest adhesion capacity was obtained at pH above the IEP
367	(i.e. 4.0 and 7.0). Thus, the IEP of MS2 phage was shown to be between 3 and 4. Interestingly, an
368	increase in the adhesion capacity to positively charged beads was observed for MS2 phages exposed
369	to the two concentrations of free chlorine in comparison with control phages ( $p < 0.01$ , Mann-

Whitney test). Thus, the increase in the negative charge density of MS2 phage after exposure to freechlorine seemed to be mainly linked to an increase in the external negative charge.

# 373 Impact of free chlorine applied alone or followed by heat on the hydrophobicity of MS2 phage 374 particles

The effect of free chlorine on the hydrophobicity of MS2 phage was then evaluated by DSF and by its adhesion capacity to hydrophobic beads. The DSF profile (Fig. 2) showed the same fluorescence intensity of SYPRO Orange at the beginning of the experiment for control and chlorinated phages. meaning that free chlorine did not modify the overall expression of hydrophobic domains of the capsid proteins. The expression of hydrophobic domains on the surface of MS2 particles was compared between control and chlorinated phages using the adhesion ability to hydrophobic beads. The experiments were performed at pH 7.0 and high ionic strength (10 mM Na<sub>2</sub>HPO<sub>4</sub> and 150 mM NaCl) in order to minimize the influence of the global charge. No adhesion to hydrophobic beads was observed for control phages and those exposed to chlorine (Fig. 4). Thus, the results obtained using these two methods suggested that free chlorine did not change the expression of hydrophobic domains of the MS2 capsid proteins or the permeability of the capsid to the probe. Since we have previously described an increased hydrophobicity of MS2 phage after heat treatment (Brié et al. 2016), DSF experiments were carried out after exposure to free chlorine (100 mg.L<sup>-1</sup>) followed by heat (55°C or 60°C) and were compared to 55°C and 60°C heat treatments applied alone (Fig. 5). Similar DSF profiles with low initial fluorescence were obtained for both control MS2 phages and those exposed to the 55°C heat treatment alone. The initial fluorescence increased for MS2 phages exposed to the 60°C heat treatment alone and for those exposed to free chlorine followed by heat treatment at 55°C and 60°C. The highest initial fluorescence value was observed using 100 mg.L<sup>-1</sup> free chlorine followed by 60°C heat treatment (p < 0.01, Kruskal-Wallis test). The decrease in the fluorescence of the DSF profiles observed between 20°C and 60°C could

have been due to probe quenching by water (Cimmperman and Matulis 2011; Loison et al. 2016). The increase in the initial fluorescence showed that free chlorine followed by heat led to the expression of hydrophobic domains and/or increased the permeability of the capsid allowing the probe to reach inside hydrophobic regions. The adhesion level on hydrophobic beads increased after exposure to free chlorine followed by heat treatment at 55°C or 60°C (Fig. 4); thus showing an increase in hydrophobic domains on the surface of MS2 particles. The highest adhesion level on hydrophobic beads was observed after free chlorine followed by heat treatment at 60°C ( $-2.4 \pm 0.5$ , Fig. 4) (p < 0.01, Kruskal-Wallis test). Remarkably, this increase in the adhesion capacity to hydrophobic beads appeared to be specific to viral particles remaining infectious.

#### **DISCUSSION**

The purpose of this study was to explore the impact of free chlorine alone or followed by heat on the loss of infectivity and the modification of the physicochemical properties of MS2 phage used as model of the main pathogenic enteric viruses. The impact of free chlorine on capsid proteins has been previously described in a few studies focusing on their altered functions. However, modification of the overall structure of viral particles may lead to modification of their surface properties which govern their behavior in the environment. Moreover, the study of surface properties may contribute to the understanding of the mechanisms involved in the inactivation process and may also help in the development of detection methods specific for infectious viruses. MS2 phage was first exposed to free chlorine alone. The loss of infectivity of MS2 phage observed in our experiments after exposure to 100 and 200 mg.L<sup>-1</sup> of free chlorine was similar to that reported by Loison *et al.* (2016) for a  $Q\beta$  phage suspension. Indeed, by applying sodium hypochlorite at 1 mM (i.e. 74.4 mg.L<sup>-1</sup>) for 10 min at room temperature on a Q $\beta$  phage suspension at an initial concentration of  $\approx 10^{12} \text{ PFU} \cdot \text{mL}^{-1}$ , these authors observed a  $-1.7 \log_{10}$  reduction in infectivity. In the present work, we observed that the binding to host bacteria was altered after

2 3	420	exposure to 200 mg.L <sup>-1</sup> of free chlorine only. Thus, the loss of infectivity was not due to the
4 5 6	421	alteration of the binding capacity after exposure to 100 mg.L <sup>-1</sup> of free chlorine and was slightly due
7 8	422	to the alteration of this function after exposure to 200 mg. $L^{-1}$ of free chlorine. Our observation of a
9 10	423	high concentration of free chlorine needed to observe an impact on binding to host cell was in
11 12	424	agreement with a previous study published by Wigginton et al. (2012). Indeed, these authors
13 14	425	applied a concentration of 2-3 mg.L <sup>-1</sup> of free chlorine to an MS2 phage suspension of $10^{11}$ PFU·L <sup>-1</sup>
15 16	426	and observed alteration of the genome injection and extensive degradation of the maturation protein
17 18 10	427	(MP). This protein, which is present as a single copy in the capsid of MS2 phage, is clearly
19 20 21	428	involved in the binding of MS2 phage to the F-pilus of host bacteria and probably in the injection of
22 23	429	the genome into host cells. Dent et al. (2013) have proposed that the natural retraction of the F-pilus
24 25	430	could pull the MP from its location in the attached capsid, leaving a pore through which the phage
26 27	431	genome could exit into the cell. Thus, alteration of the MP by free chlorine may impact these two
28 29	432	functions depending on its intensity. The sensitivity of the capsid to oxidants has also been observed
30 31	433	for $Q\beta$ phage with the loss of its infectivity due either to capsid destabilization or to the
32 33 34	434	modification of capsid proteins especially the MP and the readthrough protein (Loison et al. 2016).
35 36	435	Considering the capsid of FRNAPH, the MP appears as one of the targets of free chlorine. Thus,
37 38	436	free chlorine weakens the capsid of MS2 phage and may alter the role of the MP in the genome
39 40	437	injection into host cells even at low concentrations. High concentrations of free chlorine seem to
41 42	438	further alter the MP with a reduced ability to bind to host cells.
43 44	439	In our experiments, the genome of MS2 phage was quantified using an RT-qPCR assay which
45 46	440	targets a fragment of $\approx$ 150 nucleotides and the RT-qPCR signal was found to be affected only after
47 48 49	441	exposure to 200 mg.L <sup>-1</sup> of free chlorine. A few studies have shown that some regions of the viral
50 51	442	genome could be more sensitive than others to damage caused by free chlorine with significant
52 53	443	differences depending on the virus type (Li et al. 2002; Xue et al. 2013). Free chlorine was shown
54 55	444	to induce genome damage on MS2 phage at levels comparable to singlet oxygen and UV. However,

the loss of replication function played a lesser role in the overall inactivation than in the other two inactivation treatments (Wigginton et al. 2012). For these authors, this suggested that the virucidal effect due to genome damage was linked to the type of modification rather than its location. No modification of the shape of MS2 phage was observed by TEM after exposure to free chlorine. The mean size of MS2 phage before and after chlorination was similar to that previously described (Valegård *et al.* 1990; Dika *et al.* 2013a).  $Q\beta$  phage particles exposed to chlorine under similar conditions were also demonstrated by TEM observations to maintain their shape (Loison et al. 2016). Disruption of MS2 phage occurring after exposure to  $72^{\circ}$ C for 10 min has previously been shown to be related to a significant increase in RNase sensitivity (Brié et al. 2016). In our case, the limited effect of RNase treatment on RT-qPCR signal confirmed that the integrity of the capsid was preserved after exposure to free chlorine under our experimental conditions. DSF was then used to explore conformational modifications of the capsid that could not be revealed by TEM. We observed a similar DSF profile to that obtained in our previous study (Brié *et al.* 2016) with only one Tm peak (66°C) before exposure to chlorine. The decrease in the Tm value after exposure to free chlorine corresponded to a reduction in the denaturation temperature and suggested a weakening of the capsid of MS2 phage by the oxidant by comparison to a previous study performed on poliovirus (Robinson, Jesudhasan and Pfeiffer 2014). The weakening of the capsid might be linked to the site-specific cleavage showed on the capsid protein of MS2 phage following exposure to chlorine (Wigginton et al. 2012).

The reactions of hypochlorous acid with amino acids result in a wide variety of products such as sulfinic/sulfonic acids, methionine sulfone, and *N*-chlorinated species (Pattison, Davies and Hawkins 2012) which may modify the electrostatic charge of viral particles. In our study, the charge density was evaluated by measuring the electrophoretic mobility as a function of ionic strength which suggested a decrease in the negative charge density of MS2 phage exposed to free chlorine. On a qualitative level, it meant that free chlorine could change the negative charge density

470	of MS2 phage particles by increasing their external negative charge and/or by decreasing their
471	internal negative charge (Langlet et al. 2008a). The binding to positively and negatively charged
472	beads at different pH showed that the IEP of MS2 phage was between 3 and 4, which was in full
473	agreement with literature data in the field (Langlet et al. 2008b; Dika et al., 2011). MS2 phage
474	exposure to chlorine led to an increase in its adhesion capacity to positively charged beads at pH
475	above the IEP. Thus, the increase in the negative charge density of MS2 phage observed after
476	exposure to free chlorine resulted mainly from an increase in the external negative charge.
477	Hydrophobicity was the other surface property monitored after exposure to free chlorine. The
478	lack of adhesion to hydrophobic beads before exposure to free chlorine was in agreement with
479	previous studies performed with MS2 phage (Dika et al. 2013b; Brié et al. 2016). No adhesion to
480	hydrophobic beads was also observed after exposure to free chlorine. The DSF profile showed the
481	same fluorescence intensity of SYPRO Orange at the beginning of the experiment for control and
482	chlorinated phages. Thus, the results obtained with these two methods suggest that few hydrophobic
483	domains are naturally expressed on the surface of MS2 particles and that free chlorine does not
484	change the expression of hydrophobic domains of the MS2 capsid proteins or the permeability of
485	the capsid to the probe. An increase in hydrophobicity by chlorine has previously been described for
486	$Q\beta$ phage (Loison <i>et al.</i> 2016) and for specific proteins such as $\alpha$ 2 chaperone (Wyatt <i>et al.</i> 2014)
487	and Bovine Serum Albumin (Ashrafi Kooshk et al. 2012). This suggests that the expression of
488	hydrophobic domains induced by chlorine depends on the composition and environment of the
489	protein.
490	Overall, the most significant effect we observed on MS2 phages exposed to free chlorine

490 Overall, the most significant effect we observed on MS2 phages exposed to free chlorine
491 alone was the decrease in the Tm in the DSF profile suggesting the weakening of the capsid. This
492 led us to explore the impact of free chlorine followed by heat on MS2 phages. Indeed, we had
493 previously shown that heat significantly impacts the structure of the capsid with disruption of MS2

494 phage particles at high temperatures (72°C) and transient expression of hydrophobic domains at
495 lower temperatures (60°C) (Brié *et al.* 2016).

An increased effect on the inactivation of MS2 phage and on the permeability of its capsid to RNase was observed when the 60°C heat treatment was applied after chlorination. To our knowledge, the virucidal effect of the combination of free chlorine and heat on enteric viruses and phages has not been studied before. Indeed, chlorine-induced inactivation of enteric viruses and phages in suspension in water has only been studied for temperatures below 30°C. The combined effect of temperature and chlorination in foodstuffs has been more closely studied on bacteria, showing an increase in inactivation compared to chlorine applied alone (Klaiber et al. 2005; Choi et al. 2016). Moreover, these authors have shown that warm water (50°C) or dry heat (80°C) and chlorine can be combined without altering the organoleptic quality or the viability of vegetables or seeds.

Since hydrophobicity is known to be the main surface property affected by exposure of MS2 phages to heat (60°C) (Brié *et al.* 2016), a significant change in this parameter was expected when free chlorine was followed by heat. As previously described by Brié et al. (2016) for MS2 phages exposed to the 60°C heat treatment alone, the initial fluorescence of the DSF profile increased after exposure to free chlorine followed by heat. The highest initial fluorescence value was observed using free chlorine followed by a 60°C heat treatment. The increase in the initial fluorescence showed that chlorine followed by heat led to the expression of hydrophobic domains and/or increased the permeability of the capsid allowing the probe to reach inside hydrophobic regions. The adhesion test to hydrophobic beads showed an increase in the expression of hydrophobic domains at the surface of MS2 phages exposed to free chlorine followed by 60°C heat treatment. Remarkably, this increase in the adhesion capacity to hydrophobic beads appeared to be specific to viral particles remaining infectious as previously observed for MS2 phage exposed to heat alone (Brié et al. 2016). After exposure to heat and free chlorine, infectious MS2 phages accounted for a 

519 small part of the total MS2 phage particles. Thus, our results showed that the permeability of the 520 capsid to the probe increased for both infectious and inactivated phages, whereas the increase in the 521 expression of hydrophobic domains at the surface was specific to phages remaining infectious after 522 treatment.

Overall, our results showed that free chlorine weakens the capsid of MS2 phage and alters the functions of the MP at least for the highest concentration tested. The combination of heat and chlorine has not been evaluated before for enteric phages or pathogenic viruses, but it has been previously reported to be interesting for bacteria in foodstuffs. We observed that free chlorine followed by heat increased the inactivation of MS2 phage and the structural modifications of the capsid by comparison with these treatments applied separately. Our results suggested that the oxidant should be applied before heat to have an optimal effect. Concerning the specific detection of infectious viruses, the increase in permeability to enzymes such as RNases for inactivated phages could offer new opportunities for such methods. In our opinion, the most important result concerning free chlorine followed by heat is the specific increase in the expression of hydrophobic domains at the surface of infectious MS2 phages. Indeed, this result suggested that hydrophobic surfaces could be used to capture specifically infectious viruses before their detection using molecular methods. Finally, the modifications observed on the capsid with our treatments underline the need for further studies focusing on the structural modifications that occur during the viral life cycle and also during inactivation treatments in order to better understand the mechanisms of virus inactivation resulting from capsid damage.

Figure 3. Electrostatic charge of control MS2 phages (before treatment) and those exposed to free chlorine (100 and 200 mg.L<sup>-1</sup> for 10 min). (a) Electrophoretic mobility ( $\mu$ ) as a function of the ionic strength (mM) at pH 7.4. (b) Binding assay to positively charged beads. Blue is the control MS2 phages, red is the phages exposed to 100 mg.L<sup>-1</sup> for 10 min, and green is the phages exposed to 200 mg.L<sup>-1</sup> for 10 min. The dotted lines are only guides to the eye. Three independent experiments were performed, each time with three measurements for electrophoretic mobility only. Error bars indicate standard deviations. For adhesion experiments on positively charged beads: C<sub>X</sub>, concentration after binding assay; C<sub>0</sub>, initial concentration.


Figure 4. Binding to hydrophobic, magnetic beads at pH 7 in 10 mM PBS (10 mM Na<sub>2</sub>HPO<sub>4</sub> and 150 mM NaCl) for control MS2 phages (before treatment) and those exposed to free chlorine alone (100 and 200 mg.L<sup>-1</sup> for 10 min) or to free chlorine (100 mg.L<sup>-1</sup> for 10 min) followed by heat (55°C or 60°C for 10 min). Three independent experiments were performed. Error bars indicate standard deviations.  $C_X$ , concentration after binding assay;  $C_0$ , initial concentration.














