38 ABSTRACT

Curcumin is a natural polyphenol that has strong antioxidant, anti-inflammatory and 39 anti-carcinogenic properties, however, it is sensitive to light, oxygen and heat, and also 40 41 presents very low solubility in water. Several studies have focused on curcumin preservation and bioavailability due to its health importance, especially by 42 encapsulation. Milk may constitute a good matrix for the encapsulation of curcumin, 43 44 because it contains a significant proportion of casein micelles which are amphiphilic and porous, making them suitable for carrying hydrophobic substances such as 45 curcumin. This work aims at evaluating the efficiency of milk for encapsulating 46 curcumin, releasing it in an aqueous medium during powder reconstitution, and 47 improving its preservation during storage. Curcumin was encapsulated by spray-drying 48 at pilot scale, extracted by different solvents, and quantified by UV/Vis. 49 spectrophotometry. Physicochemical characteristics (particle size distribution, water 50 content, water activity, and color) and rehydration properties (wettability, dispersibility, 51 52 and solubility indices) of curcumin-loaded milk powder were characterized. A powder storage study was also conducted to evaluate the stability of curcumin over time at 53 different temperatures (10, 25 and 50 °C). Drying conditions were set to obtain a 54 product of water activity close to 0.2. A method for curcumin extraction and dosage was 55 also validated using diethyl ether as extraction solvent. Milk powder loaded with 56 57 curcumin showed no significant differences in most characteristics compared to raw milk powder, except that its wettability was decreased by the presence of curcumin. 58 Moreover, the good encapsulation yields and the stability of curcumin antioxidant 59 activity during storage showed the suitability of skim milk for curcumin encapsulation. 60 61 **Keywords:** curcumin; antioxidant activity; encapsulation; skim milk; storage stability;

64 **1. Introduction**

Curcumin is a bioactive polyphenol extracted from turmeric rhizome (Curcuma 65 longa) [1] that has anti-inflammatory, antimicrobial, anti-amyloid, and antitumor 66 properties. Polyphenols present antioxidant activity, hence they are prone to induce 67 beneficial effects on human health [2]. Curcumin is known to present a very low 68 solubility in water $(2.99 \times 10^{-8} \text{ M})$, a characteristic that limits its use in food products, 69 especially in aqueous solutions [1, 3]. Besides, its sensitivity to environmental 70 conditions, including elevated temperatures, light, extreme pH, moisture, and oxygen, 71 makes curcumin susceptible to degradation during processing and storage [2]. Thus, 72 73 several studies have been carried out aiming at developing techniques for its protection 74 in food products [2, 4, 5, 6, 7, 8, 9]. Microencapsulation is a commonly used technique 75 to stabilize and protect bioactive compounds in microscopic particles. With this 76 technique, a micro/nano environment is created, incorporating unstable ingredients 77 within a carrier matrix and developing a protection to the external environment [10]. Encapsulation provides protection against degradation reactions and prevents the loss of 78 79 flavor, nutrients, and/or bioactive compounds. In addition, it can be used to limit the release of components during food processing and storage, while controlling the release 80 81 rate in physiological (gastric, intestinal) conditions [7, 11, 12, 13, 14, 15, 16]. Numerous 82 methods of microencapsulation exist: spray-drying, spray chilling/cooling, coacervation, extrusion, fluidized bed coating, liposome entrapment, and molecular 83 inclusion [2]. Spray-drying surely represents the most commonly used encapsulation 84 85 technique, owing to its many advantages:

- it is economical: around ten times cheaper than the lyophilization process;

versatile: various configurations of air and spray flows exist (co-current,
counter-current, or combined flows), and the spray can either be produced by a
centrifugal atomizer or an atomizing nozzle;

- and it is suitable for meeting the quality and efficiency constrains of various industrial fields such as pharmaceuticals, cosmetics, and food.

Generally, spray-dried powders have good techno functional properties like 92 93 good rehydration ability, high flowability and long shelf-life [17, 18]. Spray-drying is especially useful for encapsulating various heat-sensitive food ingredients such as 94 polyphenols, flavonoids, anthocyanins, prebiotics, phytosterols and polysaccharides, 95 because the temperature increase in the matrix remains limited throughout the drying 96 97 process [2, 10, 19]. Indeed, during most of the drying time, the surface of the particle remains wet and the local temperature of the surrounding air does not exceed its wet 98 temperature that is around 50 °C in classical spray-drying conditions [18]. 99 Consequently, the alteration of heat-sensitive compounds remains limited [20]. 100

Milk is an interesting matrix candidate for encapsulation by spray-drying [7], 101 102 owing to its structural and physicochemical properties: binding of ions and small 103 molecules, surface-active and self-assembly properties, possibility of gelation, pH-104 dependent gel-swelling behavior, possibility to control matrix rehydration kinetics and 105 thus bioactive release, interactions with macromolecules to form complexes and 106 conjugates with synergistic combinations of properties, various shielding capabilities that are essential for protecting sensitive encapsulated compounds, biocompatibility and 107 108 biodegradability, possibility to control the bioaccessibility of the bioactive and promote 109 its bioavailability [7, 8].

110 The protection efficiency of milk powders towards encapsulated bioactive 111 compounds is mastered by their main physicochemical properties, such as chemical 112 composition, particle size distribution, and particle shape factors. In particular, 113 granulometric characteristics (that can be deduced from particle size distribution) of a powder is an important parameter because it influences many functional properties suchas flowability and rehydration capacity [17, 18, 21, 22, 23].

The ability to reconstitute milk from powder is an essential property for industrials and consumers using powdered dairy ingredients or products. The International Dairy Federation has defined three reconstitution indices, namely solubility, dispersibility, and wettability indices [24, 25], that describe different steps of powder rehydration and depend on powder composition and affinity between water and its components, but also on particle size, shape, and structure (porosity) [18, 26, 27].

During the storage of dairy powders, several changes can be observed mainly depending on storage temperature and powder water content. Dairy powders are susceptible to undergo agglomeration and caking, which are known to alter various powder characteristics like particle size distribution, rehydration ability, and color [26, 27, 28]. When employed as an encapsulation matrix, physicochemical and techno functional properties of powdered milk must be kept as much as possible in order to ensure and maintain maximum protection of the active material [2, 28, 19].

129 The objective of the current work was to produce a milk powder encapsulating curcumin and study the evolution of degradation of curcumin power during storage at 130 different temperatures. Then, spray-drying was performed to produce milk powders in 131 132 which curcumin is encapsulated. Physicochemical characteristics (particle size distribution, moisture content, colorimetric properties) and rehydration behavior 133 (accessed by the wettability, dispersibility, and solubility indices) were evaluated for the 134 135 fresh powder. Encapsulation efficiency was also determined just after spray-drying. 136 Last, curcumin-loaded milk powder was stored at different temperatures (10, 25, and 50 137 °C) to determine the stability of curcumin upon aging.

139 **2. Material and methods**

140 2.1. Material

141 Skim milk powder "Lait spray 0 %", used to prepare concentrates to be spray142 dried, was purchased from Ingredia (Arras, France); its moisture content was 3.5 %
143 (w/w). Curcumin powder (≥ 94 % purity) was purchased from Sigma-Aldrich (Saint144 Quentin Fallavier, France). All other chemicals, of analytical grade, were provided by
145 Carlo Erba (Milan, Italy).

146

147 2.2. Production of milk powders by spray-drying

The production of milk with and without curcumin was conducted by spray-148 drying 810 g skim milk concentrates at 30 % dry extract. Curcumin was solubilized in 149 ethanol at maximum concentration (1 mg.mL⁻¹). The curcumin concentration in skim 150 151 milk concentrates was set at 0.083 mg/g milk powder (dry basis, d.b.) as the concentration of ethanol in spray-dried concentrates should not exceed 2 % (w/w) 152 153 according to the spray-drying pilot specifications. The employed spray-dryer was a 154 Micra Spray MS150 (Anhydro, Soeborg, Danemark) with a co-current flow single tower equipped with a bi-fluid nozzle (60 100 + Buffer Air Fluid 120, Spraying 155 System). The operating parameters were defined according to Perrone et al. [29] that 156 157 have studied the influence of drying parameters on water activity. The objective is to obtain powders with a water activity lower than 0.2, which makes them less sensitive to 158 biochemical alterations during storage [29]. In this work, spray-dried skim milk 159 powders with curcumin and without curcumin will be noted LC and LS respectively. 160 161 Immediately after spray-drying, powders were stored at 10 °C in sealed polypropylene 162 bags. The spray-drying yield (%) was calculated by dividing the dry mass of produced powder by the dry mass of spray-dried milk (810 g). 163

In order to regulate the outlet air temperature at 90 °C, the inlet air temperature and the product flow rate needed to be adjusted, depending on weather conditions, as inlet air humidity was not regulated (Table 1). A fan power of 70 % and a spray pressure of 1 bar were maintained for all drying experiments.

According to Table 1, even if spray-drying conditions were close, significant differences were denoted between the two spray-drying assays. Globally, the inlet air temperature and the concentrate flow-rate of the second assay (LS2 and LC2) were a little higher. In general, when the inlet flow is higher, the outlet temperature tends to be lower, which could be seen in the second assay.

174 2.3. Curcumin extraction and dosage

First, it was found in preliminary studies (data not shown) that ethanol is the best solvent for curcumin extraction; moreover, it is readily available and less dangerous than other organic solvents. A wavelength of 425 nm was chosen for performing curcumin quantification by UV-visible spectrophotometry.

179 Curcumin extraction was achieved according to the following procedure: 0.1 g curcumin-loaded skim milk powder was solubilized in 5 mL distilled water using a 180 Stuart SB3 rotator for 50 min at 40 rpm at 25 ± 1 °C. Then, 10 mL diethyl ether was 181 182 added, and the mixture was allowed to stir in the same conditions. The mixture was then centrifuged at 5 088 x g for 5 min with a Hereaus Megafuge 8R centrifuge (Thermo 183 Fisher Scientific) and the supernatant was recovered and placed under a dinitrogen 184 185 atmosphere until complete evaporation of diethyl ether. Finally, 1 mL ethanol was 186 added. The curcumin solution was diluted hundredfold before analysis by UV-Visible 187 spectrophotometry at 425 nm. Curcumin ethanolic solutions up to 0.1 mg/mL were 188 analyzed in the same conditions for calibration purposes.

189 The results are given in milligrams of curcumin per gram of skim milk powder190 (d.b.) (mg/g), according to the following equation:

192 And the proportion of spray-dried curcumin found in analyzed powder was

193 calculated according to:

Where m_p designates the mass of skim milk powder (d.b.) (g), m_c the mass of detected
curcumin (mg), [Curc]_{conc} the curcumin concentration in the feed concentrate (0.083
mg/g dry mass of skim milk concentrate), and [Curc]_{powder} the curcumin concentration
found in powders (in mg/g dry mass of skim milk powder).

- 200 2.4. Physicochemical properties of powders
- 201 2.4.1. Particle size distribution

The particle size distribution was measured using a Mastersizer 3000 laser diffraction granulometer (Malvern Instruments), supplied with the Aero S dry dispersion unit. To obtain a correct obscuration (1 %), samples were dispersed at 1.8 bar air pressure, 100 % air pressure, 40 % feed rate, and 2.7 mm hopper length. The particle size estimator was chosen as the volume mean diameter and the mean particle size d50 was defined as the diameter for which 50 % of analyzed particles have lower size [30].

- 209 2.4.2. Moisture content and water activity
- The moisture content was determined by the AOAC method 925.10 [31]. The water activity was determined with the water activity analyzer HygroPalm apparatus
- 212 (HP23-AW-A, Rotronic, Croissy-Beaubourg, France).

214 2.4.3. Colorimetry

Powder color was characterized with a Microflash 200D apparatus (Data color 215 216 International, Lawrenceville, USA). For each sample, 10 g powder was poured in a Petri dish (leading to a powder layer of approximately 1 cm high) and color measurement 217 was performed according to the three colors coordinates L, a*, b* of CIEL*a*b* 218 system. The L* value represents sample luminosity, varying from black (0) to white 219 (100), the a* value represents the color varying from red (+) to green (-) and the b* 220 221 value represents the color varying from yellow (+) to blue (-) [28]. The chrorma, that defines the degree of color saturation, was calculated with the following formula: $C^* =$ 222 $\sqrt{(a^{*2}+b^{*2})}$. Also, the hue angle (H*), derived from the two coordinates a* and b*, was 223 determined as arctan(b*/a*). All measurements were taken as the average of at least 224 three points on the center and the periphery of the Petri dish filled with powder samples. 225

226

227 2.5. Powder functionalities

The rehydration properties of milk powders are essential techno-functional properties for application purposes. The rehydration behavior and kinetics of spraydried skim milk powders were characterized.

231

232 2.5.1. Rehydration behavior

The water solubility index was determined by the methodology described in [25, 18]. The wettability and dispersibility indices were measured according to [18]. The solubility was calculated from the volume of sediment (mL) remaining after two centrifugations. The procedure consists in adding 10 g powder in 100 mL distilled water, stirring the mixture during 90 s at 3 800 rpm, letting it at rest for 15 min, then stirring it briefly with a spatula and pouring it into the centrifuge for 5 min at 160 x g. Fill the tube with water up to the 50 ml mark. Disperse the sediment in the water and centrifuge again at 160g for 5 min. Note the quantity of sediment (ml). The insolubility index (II) is equal to the volume of sediment (ml) remaining after the second centrifugation from 50 ml of

reconstituted liquid. The solubility index (SI), expressed as a %, is equal to:

Wettability analysis consists in measuring the time required for a powder sample to cross water surface in given conditions: 100 mL distilled water was added into a 400mL beaker and then 10 g skim milk powder was gently poured at the water surface.

The dispersibility index is the percentage of powder mass which can pass through 200- μ m mesh size sieve. 10 g skim milk powder was added to 100 g distilled water, then the mixture was vigorously stirred with a spatula for 15 s. After that, the mixture was sieved, and the dry extract of the filtrate was determined after drying at 105 °C for 7 h in an oven. The dispersibility index (DI), expressed as a %, is equal to:

Where w is the weight of the powder used, X_{RW} is the residual free water content of the powder (% w/w), X_{DM} is the dry matter of the filtrate after sieving (% w/w). Express the result to one decimal place.

258 2.6. Powder aging during storage

The stability of encapsulated curcumin during storage was also evaluated. Powder samples were stored at 10, 25, and 50 °C for 2 months in hermetically-sealed plastic pots at 0.43 water activity by using a saturated solution of potassium carbonate [32]. Qualitative analysis of curcumin by UV/visible spectrophotometry at 425 nm was performed on aged powders after the extraction step.

265 2.7. Statistical analysis

Spray-dried powders were produced in duplicate and all the analyses were triplicated. Statistical analysis (ANOVA to check the occurrence of significant differences among samples and Tukey's HSD test to identify what samples were significantly different) was carried out with STATISTICA 7.0 software (StatSoft) at p < 0.05.

- 272 **3. Results and discussion**

273 3.1 Spray-drying

274 Spray-dried powder amounts and yields obtained in the first and second spray-275 drying assays were represented in table 2.

Powder yields were higher in the first spray-drying assay. In the second spraydrying, environmental conditions led to a little reduction of the outlet air temperature, which favored powder adhesion to spray-dryer walls [20, 27, 33]. Most losses during spray-drying were due to particles adhering to the spray-dryer walls, but there was also a proportion of very small particles that were not retained by the cyclone. In fact, there is a relationship between the size of the particles and losses in the exhaust air: the smaller the particles, the harder they can be recovered with a cyclone [33, 34].

284 3.2 Physicochemical properties

Physicochemical characteristics mean particle size, moisture content, water activity, and colorimetric parameters (lightness L*, chroma C* and hue angle h*) of skim milk powders with and without curcumin were determined (Table 3).

Mean particle diameters of spray-dried powders were smaller than those found in the literature for milk powders, even on the same pilot-scale plant [18, 21, 25, 30]. This could result from the presence of ethanol in skim milk concentrates, which was used to solubilize curcumin. Indeed, viscosity of concentrates containing a small proportion of ethanol is expected to be lowered, which is known to enhance the liquid jet breakup, leading to smaller droplets and thus smaller particles [30, 32]. All spraydried powders presented very close mean diameters, showing that the presence of curcumin did not impact the size of spray-dried particles.

All produced powders presented water contents close to 5 % (w/w), which is a sign of a good storage ability of powders [18]. No significant difference was denoted among powders with or without curcumin, whatever the spray-drying assay. Fang [2] found that spray-dried powders present lower moisture content at higher temperatures, which was also observed in the present study. The atmospheric conditions during the second atomization were warmer and wetter, which also contributed to produce a wet and adherent powder.

The spray-drying conditions significantly influenced the water activity of the samples, as the powders produced during the first spray-drying assay had a slightly lower water activity (0.12) than those of the second spray-drying assay (0.14). This difference can be attributed to the higher feeding flow-rate of concentrate of the second spray-drying assay, which led to lower temperature and probably a higher relative humidity of outlet drying air [33, 34].

The introduction of curcumin in food powders is expected to change their color by increasing their yellowness [35]. This was checked by colorimetric analysis (Table 310 3). Powder luminosity was significantly different for skim milk with and without curcumin and for the two spray-drying assays. The presence of curcumin increased powder lightness but also its chroma (representing the degree of color saturation), showing that powders with curcumin were brighter and more colored. The main color of

all powders was greenish-yellow, even in the absence of curcumin. For skim milk
powders free from curcumin, this can be explained by the presence of riboflavin, a
yellowish-green colored milk compound.

318

319 3.3. Powder functionalities

Most food additives and ingredients are presented in powder form and must be rehydrated before use; hence, water-powder interactions and more generally the ability to reconstitute a powder in water are essential properties for the formulation of many food products [18, 33]. Rehydration indices of produced skim milk with and without curcumin are displayed in Table 4.

Skim milk powder in the absence of curcumin was poorly wettable (wettability 325 times ranging between 30 and 35 min), but upon curcumin addition, powder became not 326 327 wettable (wettability times superior to 45 min). Wettability was the only factor that 328 showed significant difference between skim milk powders with and without curcumin 329 whatever the spray-drying assay. Dispersibility and solubility of LS and LC differed in the first spray-drying assay but were similar in the second one. This shows that a small 330 change in spray-drying conditions may have a tremendous impact on powder 331 functionalities. Indeed, it can be guessed that modifying the evaporation rate (mainly by 332 333 changing concentrate feed rate, drying air temperature or flow-rate) may have an impact 334 on the location of curcumin within skim milk particles, as more curcumin at the surface of particles may affect their rehydration capacity, owing to the hydrophobicity of this 335 336 bioactive compound. This explanation is in accordance with the results of the first 337 spray-drying assay, where skim milk powder without curcumin exhibited lower 338 wettability and solubility but a better dispersibility. Moreover, it can be guessed that 339 curcumin addition modified powder surface structure. According to Murrieta-Pazos et al. [27], the surface of skim milk powders is mainly covered by proteins. Due to the
interaction of curcumin with casein, modification of casein micelle conformation
probably occurred [34, 35, 36], which induced a change of the interaction sites of
caseins at the surface of particles and affected interactions of powder with water.

It is considered that a powder is dispersible when dispersibility index exceeds 344 85 % [18]. Therefore, spray-dried powders of the current study had low dispersibility. 345 Generally, a soluble powder is not very dispersible because it dissolves easily when 346 347 being in contact with water, so it does not separate into small particles but solubilizes quickly in water [18, 33]. The high solubility of spray-dried powders is thus consistent 348 349 with their poor dispersibility. Also, producing powders at pilot scale results in low mean particles size (see the d50 values around 15 µm, which is relatively small for food 350 powders) [37], and powders constituted by small particles have a tendency to be 351 352 cohesive [38] and thus hard to disperse.

354 3.4 Storage study

Sample color was followed during storage (Table 5 and Figure 1) with a view to correlate colorimetric changes to the evolution of curcumin content in powders (Figure 2). Indeed, curcumin is yellow, and its alteration leads to color loss [39] or the formation of degradation products having a more brownish/reddish color [40, 41].

As previously discussed from table 1 results, for all spray-dried powders, the lightness at time zero was high. Furthermore, color saturation was higher in skim milk powders containing curcumin, due the yellow color by curcumin. Also, the main color of all powders was similar: greenish-yellow.

During storage, a decrease in powder lightness was observed for all samples and this darkening phenomenon was more intense at 50 °C. At 10 and 25°C, the color

saturation remained unaffected in the course of storage, but at 50 °C color saturation 365 366 increased for powders without curcumin, while it slightly decreased for powders with curcumin. Moreover, the hue angle showed a decrease at 50 °C, indicating a shift of 367 368 powders without curcumin to orange-yellow, while it remained similar all along the storage for powders with curcumin. It can be guessed that at 50 °C, the decrease in 369 luminosity, increase in saturation and increase in angle hue corresponds to the formation 370 of brown pigments, due to the occurrence of the Maillard reaction. In fact, Maillard 371 372 reaction corresponds to a group of chemical reactions initiated by the condensation of an amino group with a reducing sugar and resulting in the formation of brown 373 374 compounds [33].

The formation of brown pigments is evidenced by photographs displayed in Figure 1: after 60 days storage at 50 °C, the color change was more pronounced for skim milk powder without curcumin, hence the limitation of color change for LC powders may be attributable to the presence of curcumin. This observation should be put in relation with the antioxidant power of curcumin that improved powder preservation during high-temperature storage, presumably by decreasing the kinetics of the Maillard reaction.

382 Skim milk powders with curcumin tended to remain a little more yellow than 383 powders without curcumin [42], due that a significant proportion of curcumin was still 384 present after 60 days storage at 50 °C, as evidenced by curcumin quantification (Figure 385 2).

During storage, curcumin was more altered when stored at high temperature, as expected for this thermolabile compound: about 83 %, 72 %, and 58 % residual curcumin were found after 60 days storage at 10, 25, and 50 °C, respectively (Figure 2). This demonstrates the importance of adequate conditioning and storage conditions to

avoid changes in powder characteristics and the amount of residual bioactive material
[26, 27, 28, 38, 39]. Encapsulation in dairy matrices may be a way to limit its
alteration, owing to the interaction with casein micelles [36] that can improve curcumin
stability [43].

394 The decrease in curcumin content was correlated to the decrease in yellow color: 395 indeed, the Pearson correlation coefficients between residual curcumin content and color saturation were 0.64, 0.79, 0.82 for powders stored at 10, 25, and 50 °C, 396 respectively, showing a marked positive correlation whatever the storage temperature. 397 398 Thus, the variation in concentration of curcumin explains a large part of the evolution of 399 powder color during storage. The stronger correlation for powders stored at 50 °C may be derived from the increase in curcumin degradation rate at this higher temperature 400 401 [44].

402

403 Figure 3 illustrates the link between chroma (C*) and curcumin content. It can be noted that, whatever the storage temperature, both chroma and curcumin 404 405 concentration tended to decrease with storage time. Besides, storage temperature had a negative effect on curcumin-loaded skim milk powder chroma and this can be put in 406 407 relation with the fact that low temperatures help maintain curcumin color [43, 44]. For 408 all temperatures, from 14 storage days, the decrease in curcumin content was 409 accompanied by a decrease in powder chroma and this phenomenon was more evident 410 at 10 °C. For all temperatures, between 28 and 42 days, the decrease in powder chroma 411 was more significant compared to the other storage times. It may be guessed that curcumin alteration during storage begins with curcumin located at the powder surface, 412 413 which strongly affects powder color. Then, at longer storage times, curcumin hidden in the powder bulk starts to be degraded, but without much affecting powder surface 414

appearance. Hence, the link between powder surface color saturation and curcumin 415 content may be more relevant at relatively short storage times. At 25 °C and especially 416 417 at 50 °C, for the higher storage times (approximately from 42 days), the positive correlation between chroma and curcumin content became less evident, as at these 418 419 temperatures the powders were expected to undergo Maillard reaction, which results to the formation of brown pigments, thus affecting powder color independently from the 420 degree of curcumin alteration. It can then be concluded that the relation between chroma 421 422 and curcumin content was not linear due the existence of other factors affecting powder color. 423

This correlation between powder color and curcumin content is very interesting for industrials, as they can use powder color as an indicator to easily and quickly evaluate the degree of curcumin alteration upon storage.

427 This study permitted to show that the presence of curcumin in spray-dried skim 428 milk powders did not significantly affect their main physicochemical characteristics, 429 except color, which was obviously more yellow in curcumin-loaded powders, and color 430 stability, which was improved by curcumin. Differences found among investigated powders were more related to small changes in spray-drying conditions. It was also 431 suggested that Maillard reaction could be limited during storage (even at temperature as 432 433 high as 50 °C) by addition of a small curcumin proportion in dairy powder formulation. 434 Also, it was noted that curcumin alteration upon storage at high temperature remained limited and this can be explained by the protective role of the dairy matrix against 435 436 curcumin oxidation. Previous studies with milk proteins have shown that milk proteins (especially casein micelles) can substantially contribute to the protection of bioactive 437 438 compounds like curcumin by forming complexes with these molecules through hydrophilic and/or hydrophobic interactions [7, 13, 40, 43]. 439

441 **4.** Conclusion

This study dealing with encapsulation of curcumin in skim milk powder by 442 443 spray-drying permitted to evidence the impact of small changes in spray-drying conditions, as well as the presence of curcumin on physicochemical and functional 444 properties of resulting powders. Spray-drying yield was slightly affected by minor 445 variations of spray-drying conditions. In the second spray-drying assay, the air outlet 446 447 temperature was a little lower, which increased particle adhesion to the spray-dryer walls and slightly decreased process yield. This also impacted powder water activity: 448 powders of the second assay had a slightly higher water activity, consistently with the 449 lower air outlet temperature. Variations in spray-drying conditions between the two 450 451 assays were so close that other physicochemical (mean particle size, span, moisture 452 content) and functional (wettability, dispersibility, solubility) properties were similar.

The presence of curcumin in milk did not affect the spray-drying yield. 453 454 Physicochemical characteristics (mean particle size, span, moisture content, and water 455 activity) were also unchanged due to the presence of curcumin with the notable exception of powder color. Indeed, curcumin-loaded powders were more bright (higher 456 luminance L*) and had a higher saturation of yellow color (higher chroma C* for a hue 457 458 angle h* corresponding to yellow). As regards powder functional properties related to reconstitution properties, solubility and dispersibility were unaltered by the presence of 459 460 curcumin, contrarily to wettability which was markedly lowered in the presence of curcumin. Indeed, this hydrophobic compound may be found at powder surface, 461 462 decreasing interactions between powder surface and water, thus making it less wettable.

463 During storage, changes in color were observed: color saturation decreased, 464 indicating a decrease in powder yellowness. The color loss was enhanced when storage temperature was increased. Color loss was correlated with the decrease in curcumin concentration, hence powder color may constitute an indicator for following the degree of alteration of curcumin encapsulated in dairy powders. For all studied temperatures, the decrease in curcumin content during storage was low (28 % loss after 6 months storage at 25 °C), showing the suitability of skim milk as an encapsulation matrix for protecting curcumin.

This study allowed verifying the possibility of relating, during storage, the evolutions of curcumin content and powder color saturation (chroma). It permitted to highlight the negative effect of storage temperature on curcumin content. As a perspective of this study, it would be interesting to evaluate the evolution of antioxidant activity of curcumin-loaded milk powders upon storage in order to investigate if curcumin keeps its antioxidant power when encapsulated in milk powders and stored.
