INTRODUCTION & OBJECTIVES

Synthetic amorphous silica nanomaterials (SAS) are used in many industrial sectors. However, we have previously found that SAS (namely, NM-200, NM-202 and NM-203) led to cell transformation in the cell transforming assay developped by Sasaki et al (2015). Among them, NM-203 was the most active in triggering Bhas 42 cell transformation (Fontana et al., 2015) (Seidel et al., 2017).

In order to gain insight into the molecular mechanisms involved in the early stages of the SAS-induced cell transformation, we carried out a global and unsupervised transcriptomic analysis after a 48h-treatment with NM-203, Min-U-Sil 5® (a carcinogenic crystalline silica microparticle), **DE** (Diatomeous Earth, an amorphous silica microparticle) and **TPA** (12-*O*-Tetradecanoylphorbol-13-acetate, a tumor promoter) (Table 1).

Genes regulated by NM-203, Min-U-Sil 5®, and TPA-induced cell transformation were validated by RT-qPCR. Finally, we analyzed whether similar changes were also found after cell exposure to NM-200 and NM-202.

Figure 1: Bhas 42 cell transformation assay and experimental strategy: The Bhas 42 cell line is a fibroblastic murine cell line derived from Balbc / 3T3 cells transfected with the viral oncogene v-Ha-ras (Sasaki et al., 2015). Bhas 42 cells are then considered to be "initiated" cells. This cell line was used to study the effect of diverse SAS.

MATERIALS & METHODS

The Bhas 42 cell transformation assay was carried out as followed: Cells were seeded at high density and treated for 48 h with NM-203 at 1 and 2 μ g/cm² (non cell transforming doses) and at 5 μg/cm² (a cell transforming dose), DE at 5 μg/cm², Min-U-Sil 5® at 20 μg/cm² and TPA at 0.05 µg/ml (**Figure 1**). Characteristics of tested chemicals are presented in Table 1.

RESULTS

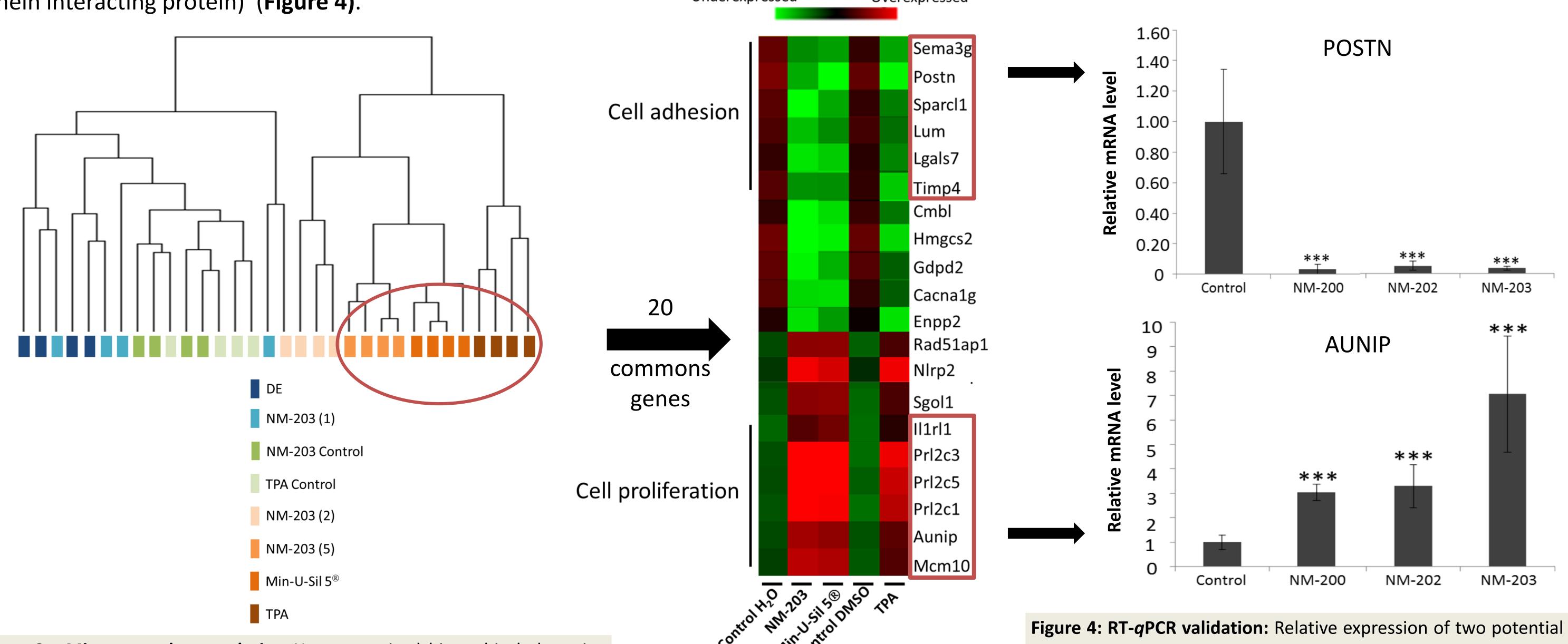


Figure 2: Microarray data analysis: Non supervised hierarchical clustering was obtained after filtration of microarray data (clustering was performed using a Gene Cluster 3 software and visualized with Treeview). Red circle show similar signature of three compounds NM-203, Min-U-Sil 5® and TPA.

Hierarchical clustering showed that non cell transforming treatments (NM-203 at 1 or 2 μg/cm², DE and controls) are closed and interestingly cell transforming treatments (NM-203 at 5 μg/cm², Min-U-Sil 5® and TPA) induced similar changes in gene expression (Figure 2). Several genes were differentially expressed after treatment with NM-203, Min-U-Sil 5® and TPA, while we did not find any differentially expressed genes with DE. Furthermore, IPA analysis showed that the main pathways common to NM-203, Min-U-Sil 5® and TPA treatments were involved in cell proliferation. Finally, twenty genes are common to all three conditions and among them, twelve relevant genes were selected (Figure 3). The expression of these genes was validated by RT-qPCR. In addition, deregulation of selected genes were also found with NM-200 and NM-202 as shown for two selected genes POSTN (Periostin) and AUNIP (Aurora kinase A Underexpressed and ninein interacting protein) (Figure 4).

CONCLUSIONS

- For the first time, 20 common genes potentially involved in cell transformation were identified by a transcriptomic analysis after a 48h-treatment of Bhas 42 cells with NM-203, Min-U-Sil 5® and TPA.
- Deregulation of common genes has been found for two other SAS (NM-200 and NM-202).
- A set of 12 genes could be used as potential biomarkers of the early stages of Bhas 42 cell transformation for other SAS or other transforming nanomaterials.
