20 ABSTRACT

This study sought to use concentration-time-response surfaces to show the effects of 21 exposure to toxic (semi-)metals on peroxidase activity in higher plants as a function of 22 23 exposure-concentration and exposure-time. Maize (Zea mays L.) seedlings (i.e., leaves and roots) were exposed to arsenic (as  $As^{3+}$ ) or aluminium (as  $Al^{3+}$ ) under hydroponic 24 conditions, and their biomass and peroxidase enzyme responses were assessed at 25 different concentration-time-exposures. The 3D ecotoxi-profile generated with these 26 27 data showed two distinct regions: the first region is formed by exposures (i.e., points for time-concentration pairings) that were not statistically different from the results of the 28 29 control points (i.e., zero toxicant concentration and all exposure-times), whereas the second region is formed by exposure pairings with results that were statistically 30 different to those obtained from control pairings. Overall, the data show that enzyme 31 32 activity increased over a shorter exposure-time when there was an increase in the exposure-concentration of the toxicant, which can be seen on a 3-D toxicity profile. We 33 34 propose that quantitative relationship ratios from different assessed endpoints (e.g., 35 biomass and enzyme activity) and enzymatic concentration-time-response surfaces could be helpful in the field of environmental-policy management. 36 37 Keywords: Ecotoxi-topology; Phytotoxicity; Maize; Arsenic; Aluminium; Peroxidase. 38 39 40 41 42 43 44

45 **1. Introduction** 

46 Biological responses to toxins result from complex and dynamic cascades of events occurring between the initial exposure and the measured endpoints, and these 47 responses may be reversible or irreversible, depending on the concentration-time-48 exposure (Byrne and Maher, 2019; Cho et al., 2016). Nevertheless, most experimental 49 data generated in ecotoxicology studies assess biological responses over a specific 50 exposure time under diverse toxicant concentrations, and the exposure time is 51 represented only in the form of the measured endpoint (e.g., 72-h EC50) (Brooks et al., 52 2019; Mancini, 1983; OCDE, 1997; Van den Brink et al., 2019). It is possible that 53 54 different conclusions on the effect of the same toxicant concentration could be derived for different exposure durations (Barata et al., 1999; Byrne and Maher, 2019; Hickey et 55 al., 1991; Ragas, 2011). In this respect, concentration-time-response surfaces could 56 57 provide a more complete presentation of the available data, and could reveal crucial information in environmental studies, including risk management, where the aim is to 58 59 determine precise quantitative ecotoxicity values (Barata et al., 1999; Lee et al., 1995; Paumgartten, 1993; Sun et al., 1995). 60

Enzymatic activity responses can be easily measured over a short temporal scale, 61 and peroxidase enzymatic activity in higher plants is a well-known experimental 62 parameter for assessing the response of an organism exposed to a non-biodegradable 63 toxicant (Jouili et al., 2011; Stegeman et al., 1992). Moreover, the study of biochemical 64 parameters associated with more classical parameters (e.g., biomass yield) may help in 65 organism quality assessment although it may be difficult to distinguish between 66 adaptive responses from natural evolution and responses to temporary stress (Bijlsma 67 and Loeschcke, 2005; Calow and Berry, 1989; Forbes et al., 2006). Peroxidases are a 68 group of oxidoreductase enzymes utilizing hydrogen peroxide as an electron acceptor 69

molecule. An example of their action in higher plants is the peroxidase transformation 70 71 of phenolic compounds into phenolic radicals that are then polymerized to give rise to lignin (Polle et al., 1994; Tobimatsu and Schuetz, 2019). Peroxidase activity is very 72 73 important for regulating plant growth, asthis enzyme degrades, for example, the phytohormone indoleacetic acid (Rama-Rao et al., 1982). However, if this enzyme is 74 used as a biomarker in environmental studies, it is important to remember that this class 75 of enzymes is very susceptible to variations inenvironmental conditions, and is 76 77 implicated in the oxidation of reactive oxygen species, and thereby help to avoid the damage resulting from oxidative stress (Bela et al., 2015; Gaspar et al., 1982; Gill and 78 79 Tuteja, 2010; Sies, 1991).

Anthropogenic emissions of (semi)metals into the natural environment from a 80 variety of sources (e.g., metallurgy, agriculture, energy production, and waste disposal) 81 82 can result in these elements being a stress-causing factor in plants and other living organisms, and they may disrupt entire ecosystems (Seregin and Ivanov, 2001; Verkleij 83 84 and Schat, 1990). Arsenic is well-known to be one such plant-growth limiting contaminant, disrupting photosynthetic and respiratory systems and stimulating 85 secondary metabolism (De Gara et al., 1993; Majumder et al., 2020; Panda et al., 2009). 86 Aluminium phytotoxicity appears as a rapid inhibition of root elongation due to damage 87 toroot apex cells, with plants showing a reduced and atrophied root system as a 88 consequence (Chandran et al., 2008; Awasthi et al., 2017). Cellular metabolic 89 disturbance in roots reduces water and mineral uptake, affecting the physiology of the 90 91 whole plant, which leads to an imbalance in ROS production entailingan oxidative stress process (Darkó et al., 2004; Sharma and Dubey, 2007). 92

In a general way, metal toxicity effects in plants include inhibition of the mitotic index 93 94 (Gzyl et al., 2015), increased tissue permeability (Sen and Mondal, 1987), promotion of metal accumulation, increased energy expenditure to cope with high metal 95 96 concentrations (Israr et al., 2006), reduced photosynthesis or chlorophyll-a synthesis (Dube et al., 2003), inhibition of root apex growth by inhibition of DNA synthesis (Liu 97 and Jiang, 2001), disruption of enzymatic activity (Cakmak and Horst, 1991; Jaworska 98 and Lemanowicz, 2019), and oxidative stress caused by reactive oxygen species (Jouili 99 et al., 2011; AbdElgawad et al., 2020). 100

Within the ecological context of (semi-)metal phytotoxicity, the goal of this 101 102 study was to use 3-D response surfaces to show peroxidase activity in the higher plant 103 Zea mays (L.) as a function of time-concentration exposure to arsenic or aluminium ions while under hydroponic conditions. Using such 3D topological responses, a broader 104 105 vision of the ecotoxicity profile can be obtained, which could be helpful in the field of 106 environmental policy management. For example, sewage sludge can provide a large part 107 of the nutrients required byplants, but aluminium coagulant-flocculant compounds used in wastewater treatment can be phytotoxic (Kluczka et al., 2017). Thus, it is necessary 108 to understand the phytotoxic relationships between time and concentration responses of 109 pollutants to evaluate the risks related to theapplication of sewage sludge to land used 110 fornon-human edible culture (e.g., maize used for animal nutrition). 111

- 113 2. Materials and methods
- 114 2.1. Contaminants

Sodium arsenite (NaAsO<sub>2</sub>) and aluminium sulfate Al<sub>2</sub>(SO<sub>4</sub>)<sub>3</sub> (Anidrol, Diadema,
SP, Brazil) were used as the experimental toxins in this study. In this study, the ranges

128 2.2. Plant species

The seeds selected for the tests were obtained from genetically unmodified and pesticide-free plants of *Z. mays* purchased at the Organic Market in the city of Brumadinho (MG, Brazil). The tests were performed using only one ozone-sterilized seed batch, to eliminate possible problems with variations between different batches.

#### 134 2.3. Phytotoxicity tests in solution media

135 Toxicant solution phytotoxicity tests were performed on 10-day-old Z. mays

136 plantlets germinated in pots containing 1 kg of commercial autoclaved garden soil.

137 Assays were performed according to the ISO (1995) guideline, with some slight

138 modifications, i.e., fewer replicates per test series (three instead of four). The following

is a summary of the adopted procedures.

140 Three series of tests were performed at different exposure times of 0, 20, 45, 90,

141 180, 360, 720, and 2880 minutes. For each series of test plants, three pots (disposable

| 161 | The protein content in the Z. mays leaf and root samples was determined using                                     |  |  |  |  |

#### 171 2.4.3. Peroxidase enzyme activity (EC 1.11.1.7)

Enzyme activity was measured using a slightly modified version of the published 172 method (Byl et al., 1994). Briefly, 0.5 g of the fresh aerial and root parts were weighed, 173 174 homogenized separately using a mortar and pestle, and maintained at 4°C in 4 mL of 50 mM potassium phosphate buffer (pH 7.6). The samples were centrifuged (3000 g, 10 175 minutes,  $4^{\circ}$ C) and the supernatants were stored at  $-20^{\circ}$ C awaiting subsequent analysis. 176 After defrosting, the supernatant (0.1 mL) was placed in a 1.5-mL glass cuvette, and 0.7 177 mL of solution A (prepared by adding 810 mg phenol to 25 mg 4-aminoantipyrene in 50 178 179 mL of distilled water) was added just before the assay. Then, 0.75 mL of solution B 180 (prepared by adding 0.01% of hydrogen peroxide in 0.01 M Phosphate buffer, pH 7.1) 181 was added to start the reaction, and the absorbance was monitored for 5 minutes at 510 182 nm. The measured variation in absorbance was reported according to the dry weight of the sample, and was compared with the protein content of each sample. The enzymatic 183 unit of the peroxidase forms 1.0 mg of purpurogallin from pyrogallol in 20 s at pH 6.0 184 185 and 20°C (equivalent to ~18 µM units per minute at 25 °C), and was defined by a calibration curve using horseradish POD (SIGMA, 10670U). The commercial enzyme 186 stock solution (1067 EU mg<sup>-1</sup>) was prepared by dissolving 10 mg of the enzyme in 10 187 mL of 0.01 M phosphate buffer (pH 7.1). A dilution range was used to prepare the 188 189 calibration curve utilised to express the results obtained from the samples. The dilutions 190 used to create the calibration curve were: 1/4, 1/6, 1/8, 1/10, 1/12, 1/14, and 1/16. The mean linear regression equation for the three curves was:  $Y = -49.92 X + 13871 (R^2 =$ 191

192 0.9992). The values obtained from the calibration curve were divided by the protein193 content of the sample (dry weight basis).

195 *2.5. Graphical* 

196 The graphic drawings shown in this study were made with Origin software197 (OriginLab Corporation, Washington, USA).

199 2.6. Statistical analysis

Three test series were performed at three different periods (20-day intervals 200 201 between the series). For each test series, data on enzyme activity, biomass, and protein 202 content were generated in triplicate (three pots) for each treatment (or control; n = 9). 203 After checking the data for normality (Shapiro–Wilk's test) and homogeneity of variances (Hartley's test), analysis of variance (ANOVA) was performed, followed by 204 generation of the lowest observable effect concentration (LOEC) and no observable 205 effect concentration (NOEC) values using Williams' test ( $p \le 0.05$ ) (Williams, 1971). 206 TOXSTAT 3.0 software (University of Wyoming, Laramie, WY, USA) was used for 207 these calculations. 208

#### 211 **3.** Results and discussion

It is difficult to predict how the toxicity of a specific concentration of a toxin varies as a function of the exposure duration. A possible method to alleviate this problem is to use a 3D topological profile of the measured endpoint response, such as enzyme activity. In this type of data representation, the relationships between time and concentration-exposure can be seen from different perspectives, as the representation

Two different regions are of particular interest in Fig. 1. The first region (the white
region or NOEC region) is formed by exposures (i.e., points for time-concentration
pairings) that were not statistically different from the results of the control points (i.e.,
zero toxicant concentration and all exposure-times), whereas the second region (the grey

region or LOEC region) is formed by exposure pairings with results that were

statistically different to those obtained from control pairings.

The two profiles shown at the bottom of Fig. 1 represent diametrically opposed views of the exposure conditions. Thus, it is possible to obtain an ecotoxi-topological view of the time when a given concentration of the toxicant begins to cause significant adverse effects on the exposed maize plantlets. A more detailed analysis of Fig. 1 shows that at the point of the greatest exposure values (i.e., the longest exposure duration time and greatest toxicant concentration), peroxidase activity showed a decrease, just at the point where a significant decrease in leaf biomass began.

Quantitative sensitivity relationships (QSR) between biomarkers and classical 250 endpoints have received little attention, despite their importance. These responses try to 251 numerically link lower and higher levels of biological responses, for example, the 252 253 LOEC value for enzyme activity variation and "catastrophic" EC50 or LC50 values. 254 Thus, QSRs could be useful for regulatory purposes in the environmental management 255 domain, because there are a lack of studies that could facilitate establishment of a 256 numerical relationship range for chemical exposure among the responses observed at different levels of biological organization in the same or different species (Corrêa et al., 257 258 2006; Silva et al., 2013).

It is important to note that in our experiments, the quantitative relationships among the different assessed endpoints are not subject to medium interference, because distilled water will not generate different LOEC values; this is not the case with data obtained for soil exposure (as an example), where different soil properties will generate different ecotoxicity values (Martins et al., 2019). In our experiment, where *Z. mays* 

leaves were exposed in solution to different arsenic concentrations and exposure-times,the LOEC dry biomass/enzyme activity ratio was 8.

The same endpoints (i.e., LOEC values for peroxidase activity and dry biomass) measured in the roots of maize plantlets exposed to arsenic are presented in Fig. 2 that shows the 3D profile of peroxidase activity as a function of concentration-time-

The data presented in Table S2 indicate that the  $LOEC_{2880 min}$  for the dry biomass of Z. mays roots exposed to As<sup>3+</sup> was 0.04 mg L<sup>-1</sup>. A LOEC<sub>720 min</sub> of 0.0025 mg.L<sup>-1</sup> was found for peroxidase activity in roots, while a LOEC of 0.04 mg.L<sup>-1</sup> exposure-

concentration was found after an exposure time of 45 minutes. In the case of Z. mays

roots, the LOEC dry biomass/enzyme activity ratio was 16.

Again, it is possible to observe two different regions in Fig. 2, with these showing similar profiles to those observed in Fig. 1, including the profile of the point of greatest exposure values (i.e., the longest exposure duration and the greatest concentration), where peroxidase shows a tendency to decrease its activity, just at the point where a significant decrease in root biomass begins.

These similarities were expected, as both figures represent the same plant species exposed to the same conditions, despite the sensitivities of the two plant parts (i.e., leaves and roots) being different. Previous studies have also shown alterations in the activity of peroxidase enzyme due to the influence of different concentrations of arsenic in different plant species (Armendariz et al., 2016; Khan et al., 2009). A significant synergistic effect on antioxidant enzyme activity was noted in *Lemna minor* 

(L.) when these macrophytes were exposed to different time-concentrations of As(III)and As(V) ions under hydroponic conditions (Duman et al., 2010).

Fig. 4 profile is quite similar to Figs 1 - 3 and previous comments made also apply 317 318 here. Comparison with Fig. 3 reveals that the significant responses observed in the roots occurred at lower aluminium concentrations than those observed in maize leaves. 319 In relation to the variation in peroxidase activity response, it is well-known that 320 (semi-)metals generally promote the formation of reactive oxygen species, oxidative 321 stress (AbdElgawad et al., 2020; Ahmed et al., 2018;; Tang et al., 2016), and 322 323 consequently oxidative damage (Gill and Tuteja, 2010; Hassan et al., 2005; Tiryakioglu 324 et al., 2006), before they affect the biomass of plant species. However, oxidative 325 damage could be counterbalanced by the anti-oxidative defence system (Foyer, 1993; 326 Sies, 1991), and the equilibrium point between these processes can be seen at the limit points of Figs. 1-4 (i.e., near the longest duration and greatest concentration exposures), 327 precisely where biomass begins to decrease significantly. An overview of the data pool 328 329 measured in this study is shown in Table 1. 330 Table 1 331 332 333 If we compare sensitivity between the different parts of the plantlets for the same 334

endpoints, the roots of Z. mays can be seen to be more sensitive to hydroponic solution

exposure than the leaves, with this being the case for both toxicants. In a similar manner, it was reported that shoots of Indian mustard (*Brassica juncea* L. Czern.) seemed to be less efficient than roots at scavenging reactive oxygen species, as indicated by different responses to Cd stress shown by peroxidase and catalase activities (Mohamed et al., 2012). A similar observation was made on the peroxidase response of roots and primary leaves of bean seedlings as a part of the defence mechanism against copper- and zinc-imposed oxidative stress (Cuypers et al., 2002).

343 The two regions of the 3D ecotoxi-topology plots shown in all figures (i.e., with and without statistical significance or NOEC and LOEC) are dependent on the level of 344 345 significance used. In this sense, environmental toxicological studies relate statistical significance with biological relevance (or significance) of a toxic effect, but this does 346 not always represent the real ecological consequence (e.g., in the case of reversible toxic 347 effects). Therefore, in the 3D graphical interpretation shown above, we must bear in 348 349 mind that the statistical NOEC/LOEC values are very dependent on the range of tested 350 concentrations, generated data variability, and level of statistical significance applied in 351 the analysis (Newman and Clements 2008). However, from a practical point of view, the management of pollution issues can be greatly enriched when 3D ecotoxi-topology 352 353 profiles are used as a complementary ecotoxicity approach.

#### 355 4. Conclusions

In this study, measured toxicity endpoints (i.e., dry biomass and peroxidase enzyme activity) in *Z. mays* showed different sensitivities, with biomass showing a response only at the highest exposure-concentration and highest exposure-duration, whereas peroxidase activity responses generally occurred at lower exposure-

concentrations and highest exposure-durations for both the toxicants As<sup>3+</sup> and Al<sup>3+</sup>. 360 361 However, peroxidase also responded to lower exposure-durations at higher exposureconcentrations. The highest (semi-)metal exposure-concentration and highest exposure-362 363 duration produced a less intense increase in enzymatic activity, just at the point where a significant decrease in biomass was beginning. For peroxidase activity, a 3D ecotoxi-364 topological view can be obtained to indicate the time at which a given concentration of 365 the toxicant begins to cause significant adverse effects on the exposed organism. These 366 367 ecotoxi-topological views based on concentration-time-response surfaces can be used to predict ecotoxic concentration levels at different exposure durations, which can be very 368 369 useful in setting regulatory goals to enhance, protect, and preserve ecosystems. However, this ecotoxi-topology approach must be considered as an approximate 370 approach for now, because additional studies are necessary to improve and validate the 371 372 methodology.
