- 23 Objectives: The main objective of this study was to assess the induction-to-delivery
- interval with or without the use of osmotic dilators for induced abortion. As secondary
- objectives, women outcomes were assessed.
- 26 Study design: This retrospective single-center observational before and after study
- 27 reviewed records from a university hospital maternity unit from 2002 through 2016
- and included all women undergoing abortion for medical reasons at and after 14
- 29 weeks of gestation. Two groups were compared: group "no dilators", which used first
- 30 misoprostol without dilators, and group "dilators", which used osmotic dilators before
- 31 misoprostol administration. The main outcome was the induction-to-delivery interval.
- Results: The study included 491 women: 383 in group "no dilators" and 108 in group
- 33 "dilators". The induction-delivery interval was significantly lower in the group
- "dilators" compared to "no dilators" (427.7 min vs 639.7 min, P<0.001), as was the
- cumulative misoprostol dose (990 μ g vs 1449 μ g, P<0.001). The delivery rate within
- 36 6 hours was significantly higher in the "dilators" group compared to "no dilators"
- 37 group (50.0% vs 29.8%, *P*=0.002).
- 38 Conclusion: The use of osmotic dilators for cervical ripening before administration of
- 39 misoprostol for induced abortion appears to be effective in reducing the induction-
- 40 delivery interval.

Introduction

In France, when a multidisciplinary medical committee has determined that incurable fetal abnormalities or a serious threat to the mother's health exist, parents can request a late abortion.[1] Two principal techniques are used for abortion.[2–5] The first is dilatation and evacuation, using instruments. Some teams, especially in English-speaking countries, use it as late as 24 weeks of gestation.[4,6] The second technique is induction of labor and delivery, which is possible as early as 14 weeks and thereafter, regardless of the term of the pregnancy.[3,7,8] This is the method most frequently used in France.[9,10] There are currently no guidelines for the choice of a method of induction for medical abortion. In this psychologically difficult context for the couple, the ideal method should be as effective, rapid, and safe as possible. Although the use of osmotic dilators for the cervical ripening needed for induction in abortion has been reported, the value of this technique has not yet been demonstrated.[3,7,11–13]

Material and methods

In 2010, our obstetric department modified the protocol we use for induction of labor for abortion. In the two groups, labor induction was preceded by orally administration of mifepristone 200mg 36 hours before. Before 2010, labor was induced by the administration of vaginal misoprostol alone; since then, osmotic dilators (Dilapan-S[®]) are routinely used before misoprostol administration. The dose of vaginal misoprostol was the same before and after 2010 and was 400µg every 3 hours for women with no history of cesarean and reduced at 200 µg every 3 hours in case of history of cesarean delivery. A feticide was performed for pregnancy over 22 gestational weeks by cordonal injection of alfentanil (Rapifen®) 2mL follow by lidocaïne 2% 10 to 20mL. Epidural analgesia was performed just before feticide and/or the first administration of misoprostol. The cervix evaluation was performed systematically before dilators placement. The osmotic dilators placement occurred in hospitalization, twelve hours before the first dose of vaginal misoprostol, with administration of oral analgesics in prevention of pain. This single-center retrospective before-and-after study reviewed all cases of induced abortion in our level 3 university hospital maternity ward between January 2002 and June 2016. All women with singleton pregnancies who underwent induction of labor for abortion after 14 weeks during the before and after study periods were included. We then excluded women with a favorable cervix that enabled immediate amniotomy (Bishop score ≥6) and those with a contraindication to the use of osmotic dilators (signs of chorioamnionitis, rupture of the membranes). To limit the potential biases associated with the change in protocol in 2010, deliveries during 2010 and 2011 were also excluded.

Two groups were defined by the method of their induction, which differed by study period: group 1, named "no dilators" group, included women with an abortion from 2002 through 2009, whose induction involved misoprostol alone; group 2, named "dilators" group, included women with an abortion from 2012 through 2016, whose labor was induced by osmotic dilators and then misoprostol. The principal endpoint was the duration of labor, defined by the interval between the first administration of misoprostol and delivery, expressed in minutes. The secondary outcome measures were: the interval between the administration of misoprostol and the amniotomy, the cumulative misoprostol dose, the rate of delivery within 24 hours, duration of hospitalization, the correlation between the duration of labor and both fetal weight and gestational age, and complications, such as failure of induction (defined by failure of vaginal delivery), total or partial early placental retention (defined by the total absence or incomplete placental delivery diagnosed by systematic ultrasound exam), severe hemorrhage (defined by woman blood loss exceeding 1000 mL), or infection (defined by the onset of pelvic pain associated with fever, laboratoryconfirmed inflammation, identification of the microorganism, or antibiotic therapy). The other data collected concerned woman age, parity, uterine scars, number of vaginal deliveries, gestational age at abortion, and obstetric condition (defined by the Bishop score) at dilator placement or at first misoprostol for the group "no dilators". The first stage of the statistical analysis was a descriptive analysis of the indicators collected, by calculations of the means, standard deviations, and range for the continuous variables and of the percentages for the categorical variables. The different outcome measures were compared by univariate analysis. Significance was set at 5%. The quantitative variables were compared by Student's t test and the

qualitative variables by a Chi² or Fisher's exact test, as appropriate. A multivariate

analysis with a logistic regression model was performed to determine if the use of dilators was an independent factor associated with a delivery within 24 hours after labor induction. All confounding factors highlighted in the univariate analysis (p<0.1) were included in the logistic regression model. The Kaplan-Meier curves (induction-delivery intervals) were compared by log-rank tests. Pearson's correlation coefficient was used to assess the correlation between the duration of labor and both gestational age and fetal weight. The analyses were performed with Stata software© version 11, 2009 (Statacorp, College Station, TX).

The National Data Protection Authority approved this study (CNIL n° R2017-01) and all women included gave their written consent.

Results

Between January 2002 and June 2016, abortion was performed after 14 weeks of gestation for 706 women and was always medically indicated. After application of the exclusion criteria, 383 women were included in the "no dilators" group and 108 women in the "dilators" group (Figure 1).

Table 1 summarizes the women's characteristics. The Bishop score was more frequently 0 in the "dilators" group compared with the "no dilators" group (58.3% vs 46.7%, P=0.02). There was no significant difference in the distribution of the women in the third trimester (\geq 28 weeks) (22.2 vs 29.8 %, P=0.07).

Women outcomes are reported in Table 2. The use of osmotic dilators ("dilators" group) was associated with a significantly shorter induction-delivery interval (427.7 min vs 639.8 min, P<0.001), for a mean reduction of 33.2%. This reduction of induction-delivery interval was significant between the two groups only before 28 gestational weeks and in case of unscarred uterus. The rates of deliveries within 6, 12, and 24 hours were all significantly higher in "dilators" group compared to "no dilators" group (Figure 2). Half the women who had osmotic dilators placed have delivered in the first 6 hours, compared with only 29.8% in the "no dilators" group (P<0.001) and all women in "dilators" group have delivered in the 24 hours compared to 95.6% in the "no dilators" group (Figure 2). After multivariate analysis, the use of dilators was an independent factor associated with delivery in 24 hours after labor induction (Odds ratio= 8.1 [2.3 – 28.9]).

There was significant difference regarding the rate of hemorrhage which is more frequent in the "dilators" group. One case of failed induction and one of uterine rupture were found in each group. One uterine rupture occurred in "no dilators" group, in a woman with an unscarred uterus, and another in "dilators" group, in a woman with two previous cesareans (Figure 2).

In our study, the use of osmotic dilators appears to be an independent factor associated with a shorter induction-delivery interval and with higher rates of delivery within 24 hours. All women have delivered in 24 hours in the "dilators" group. The six cases of infection were all observed in the "no dilators" group and could be explained by their longer time in labor. We also found a higher rate of severe immediate hemorrhages in the "dilators" group. Quantification of blood loss after vaginal deliveries is difficult, and visual assessment of bleeding is known to underestimate it substantially. Recent changes in practices include the use of graduated collection bags and the weighing of used compresses. The difference observed here can probably be explained by better quantification of blood loss during the second period ("dilators" group). The principal strength of our study is its before-and-after design, which enables us to limit the biases due to the lack of randomization and to its retrospective nature, by having only one factor vary between the groups: the use (or not) of osmotic dilators. Moreover, our study has a large sample size; to our knowledge it is currently the only study that combines so large a size with good control for potential bias. The limitations of this study are associated with its single-center and retrospective nature and with the absence of randomization. Its results are consistent with those of Vincienne et al. and Chodankar et al., who have reported that time to delivery is shorter for management by dilators+misoprostol than for misoprostol only.[13,14] We have exactly the same results with Chodankar et al. in terms of time to delivery and the difference is only the gestational age (13 to 24 weeks only) and the sample size which is more important in our study.[13] On the

other hand, our study differs from that of Vincienne et al. in two major ways that may affect the result.[14] The first is that the misoprostol dose was different in the two groups that they studied (200 micrograms every 3 hours regardless of gestational age in the misoprostol-only group compared to 400 micrograms before 32 weeks and 50 micrograms after 32 weeks, every 3 hours in the dilators+misoprostol group). In our study, besides the obstetric characteristics (Bishop score), only the absence of osmotic dilators differentiates the two study groups; this makes it possible to study the specific interest of their use. The second difference is the use of oxytocin to replace misoprostol after amniotomy, while misoprostol administration continued until delivery in our study. The passive and active phases of the first stage of labor that take place in the delivery room are the longest stages and those the most at risk of infectious and hemorrhagic complications.[7] The replacement of misoprostol by oxytocin during labor can therefore influence the intervals studied. In our study, the rate of women with an unfavorable Bishop score was higher during the second period, a finding that further underlines the effect of osmotic dilators. The global rate of complications found in our study is consistent with the results of the literature. Nonetheless, because the onset of complications was relatively rare, it is difficult to draw a definitive conclusion on this point because we cannot rule out the possibility that our study lacked the power to show a difference.[11,15] We observed one case of uterine rupture in each group, one of a woman with an unscarred uterus and the other in a woman with two previous cesareans. It is difficult to attribute these complications to the use of osmotic dilators. The uterine rupture rate observed in our study (0.26% vs 0.93% respectively in the before and after groups) corresponds to known risks of the induction of labor by prostaglandins, on the order of 1% among

207 women with no history of cesareans and up to 4.8% among women with previous 208 cesareans.[3,7,8,10–12,16–18] 209 Randomized, controlled comparative studies are necessary to confirm the interest of osmotic dilators with misoprostol for induction of labor for women with medical 210 211 abortion. Such a multicenter study is currently underway in France, and we are one of the participating centers. 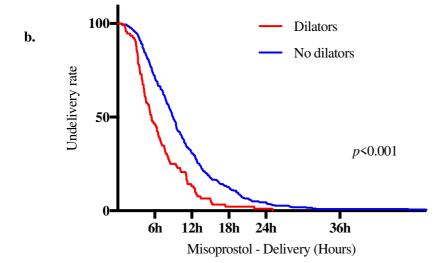

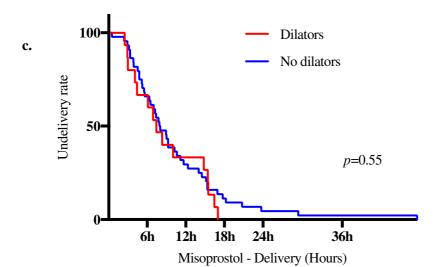
