# A review on DC microgrid energy management systems dedicated to residential applications

Abstract: The fast depletion of fossil fuels and the growing awareness for environmental protection 11 have led us to the energy crisis. Positive development has been achieved since last decade by the 12 collective effort of scientists. In this regard the renewable energy sources (RES) are being deployed 13 in the power system to meet the energy demand. The microgrid concept (AC, DC) is introduced in 14 which distributed energy resources (DERs), energy storage system (ESS) and loads are intercon-15 nected. DC microgrids are suitably appreciated due to their high efficiency, and reliability perfor-16 mance. Despite of its significant growth, DC microgrid is still relatively novel in terms of grid archi-17 tecture and control system. In this context, an energy management system (EMS) is essential for the 18 optimal use of DERs in secure, reliable, and intelligent ways. Therefore, this paper strives to shed 19 light on DC microgrid architecture, control structure, and EMS. With an extensive literature survey 20 on EMS part, different methods, and strategies about microgrid energy management is covered in 21 this article. More attention is centered on the EMS for DC microgrid in terms of size and cost opti-22 mization. A very concise analysis between multiple optimization methods and techniques has been 23 presented exclusively for residential applications. 24

Keywords: DC microgrid; Energy management system (EMS); Renewable energy sources (RES); Distributed generators (DG); Hybrid energy storage system (HESS); Residential applications.

## 1. Introduction

The global energy demand exponentially increases as the world population rises. 29 Since a few decades, an accelerated effort has been made for the development of renewa-30 ble energy sources (RES). Many countries have taken the initiative to deploy the renewa-31 ble energy technologies on a large scale. The European Commission has set the objectives 32 by 2030 for the promotion of RES inside the European Union (EU). The main goals are to 33 achieve at least 40 % reduction in greenhouse gas emissions compared to 1990 levels, 32 34 % of EU energy from renewables, and 32.5 % improvement in energy efficiency [1]. 35

Today, many countries have started to generate power through the RES. According 36 to renewable 2020 global status report, more than 200 GW of new renewable power gen-37 erating capacity was installed worldwide in 2019, raising the global total to 2588 GW by 38 year's end [2], as shown in Figure 1.

The Covid-19 crisis has greatly harmed the global growth in renewable power capacity. Despite of this, according to international energy agency (IEA), renewable power installations will increase worldwide in 2021 as compared to previous year. The major reason is that most of the delayed projects which were not completed because of unprecedented Covid-19 crisis are expected to come online [3].

The concept of microgrid is introduced to overcome environmental depletion by harvesting distributed energy from RES, such as photovoltaic (PV) and wind energy which 49 are playing a major role in the clean energy production. Microgrid technologies have 50 demonstrated three principle beneficial properties such as reliability (physical, cyber), 51 sustainability (environmental considerations), and economics (cost optimizing, effi-52 ciency). 53

Microgrid is defined as a low-voltage distribution network, interconnected DERs 54 with the loads. As can be seen in Figure 2, various RES (e.g., PV panels, wind turbine), 55 energy storage system and loads are connected to the main grid via power converters, 56 with proper protection, communication, monitoring, and control systems. It can operate 57 either in grid-connected mode or islanded mode subject to the operational characteristics 58 of the main grid. 59

Microgrids present both AC and DC distribution lines. Each type has their own trans-63 mission and distribution levels. Points of common coupling (PCC) constitute the gateway 64 between the main grid and microgrid. The protection mechanisms guarantee an 65 operation, which is designed by different principles and parameters according to the sys-66 tem. Following parameters such as voltage, frequency and power quality are continuously 67 supervised and controlled by means of proper monitoring systems and control strategies. 68 Thus, power converters are the essential components of grid system for AC/DC or DC/AC 69 conversions. In distributed generation systems, two types of generation technologies are 70 applicable for microgrid, i.e., renewable distribution generation systems from RES (e.g., 71 solar thermal, PV, wind, fuel cell and biomass), and systems from non-renewable ones 72 (e.g., diesel engine, stream turbine and gas engine) [5]. Among them, solar and wind tech-73 nologies have rapidly increased and become significant energy sources in microgrid. Stor-74 age system has a great importance for the stability, reliability, and the overall performance 75 in a microgrid system. An overview of the different storage technologies, which can be 76 separated in chemical, electrical, electrochemical mechanical and thermal systems are dis-77 cussed in [6]. Some key energy storage technologies used for microgrid applications are 78 discussed in [7]. A microgrid system has various kinds of loads (AC, DC). The load clas-79 sification is important in terms of operating strategy for the overall microgrid manage-80 ment [8]. 81

Considering the nature of the voltage and current, microgrids are sub-categorized 82 into three types, i.e., AC, DC, and hybrid. Each alternative has distinctive features, which 83 imply different advantages and disadvantages that need to be contemplated. Comparison 84 between each type of microgrids in terms of control, protections and power losses were 85 discussed in [4]. AC microgrid has the benefit of using power from the main grid. AC 86 microgrid structure is based on AC bus and all sources (e.g., wind turbine) with variable 87 frequency and different voltages are connected to the bus through AC/AC power convert-88 ers. Sources with DC output (e.g., photovoltaic panels) are connected to the AC bus 89 through DC/AC converters. However, an AC microgrid needs a relatively complex con-90 troller for importing and exporting power while maintaining the system stability and re-91 liability. While in DC microgrid structure, sources with DC output are directly connected 92 to the bus, whereas sources with AC output are interfaced to the DC bus through AC/DC 93 converters. Thus, DC microgrid has advantage over AC microgrid in terms of system ef-94 ficiency, and size which also result in an advantage considering the investment and oper-95 ating cost. Indeed, in DC system, a lesser number of power converters are required yield-96 ing to a possible optimization of the size and an improvement of the overall efficiency. 97 Nevertheless, the protection system of DC distribution is not mature enough compared to 98 the AC system. More research is needed to implement such as its protection system, ar-99 chitecture design, control strategies and stabilization techniques in future power system 100 [8]. A hybrid microgrid can supply both AC and DC loads due to its hybrid AC and DC 101 buses. 102

In general, RES are integrated with energy storage devices to form a hybrid system 103 to satisfy a given load demand. The PV and wind turbine (WT) combination provides 104 more reliable power compared to individual systems. Wind and solar has a strong de-105 pendency on the environmental conditions, which is considered as a drawback of the sys-106 tem. Nevertheless, this problem can be solved by combining energy storage units as a 107 backup. These additional elements usually increase the overall cost of the system. There-108 fore, optimal sizing and energy management system are essential to decrease the system 109 cost and attain the system reliability. 110

Due to the increase of RES in microgrid system, the significant role of EMS has been 111 seen in the literature. The researchers have concentrated on solving energy management 112 problems to achieve a high level of operational efficiency while satisfying certain system 113 constraints, to realize an economical, sustainable, and reliable operation of microgrid [9-114 12]. Different energy management strategies have been proposed in the literature to 115 achieve an efficient and optimal operation of microgrid. Extensive research has been done 116 by using search filters to find the literature related to certain subjects, including EMS, DC 117 microgrid and residential application. The analysis of search filters was conducted in web 118 of science, google scholar and Scopus. In total, 103 article and 2 handbooks has been 119 consulted. 74 articles are related to the general EMS, among them 56 articles are about 120 microgrid EMS which are published in high impact journals. The representative publications in previous years are further classified and analyzed in section 3.

In [13], authors proposed an EMS model based on machine learning algorithm. The 123 EMS here formulated in such a way that real-time prosumer energy demand is calculated 124 and fulfilled. Additionally, a novel graphic tool is proposed in this article to better repre-125 sent, observe, and analyze microgrid energy flow. The paper [14] reviews the system com-126 ponents, modeling, and control of microgrids for smart buildings. Various data-driven 127 forecasting methods for the building integrated microgrids control are discussed. In [15], 128 a comparative and critical analysis on decision-making strategies and their solution meth-129 ods for microgrid EMS was performed. The authors in [16] presented a multi-agent system 130 (MAS) for the stability, security, and reliability of microgrid system. A comprehensive 131 review on size optimization methodologies, and critical comparison of several algorithms 132 are shown in [17]. In this article, authors evaluated the possible combinations of 133 standalone solar and wind energy systems. In [18], centralized and decentralized EMS of 134 microgrid are discussed in detail. The author focused on the following objectives such as 135 power management, economic dispatch, and unit commitment. Several linear and nonlin-136 ear methods are covered in the article. The authors in [19-20] presented different optimi-137 zation methods used for energy management and control of HRESs and ESSs. A compre-138 hensive review on software tools and algorithms used for sizing objectives are also dis-139 cussed. In [21], authors discovered several linear programming and intelligent techniques 140 for the energy management of stand-alone and grid connected HRESs. Optimal sizing, 141 modeling, control aspects and reliability issues in microgrids were discussed by authors 142 in [22]. In [23], authors presented an energy management plan for microgrids. It covered 143 different computational optimization techniques applied to scheduling, reliability, envi-144 ronmental, and sizing problems. 145

Considering the electric vehicle as a storage element, the plug-in electric vehicle (EV) 146 appears as a crucial agent in the energy management of residential applications. The authors in [24] discovered several energy management approaches, in which EV are linked 148 with microgrid as a major player. In [25], authors presented a rule-based control strategy 149 to manage the power flow between grid, batteries, and EV. The benefits of using an electric vehicle as an active agent in energy balance and a reduction of cost are shown in the study. 152

Most literature reviews have mainly focused on the EMS issues of AC or hybrid microgrid systems. Different aspects of microgrids have been addressed, such as protection and control schemes, reactive power compensation and frequency control to solve energy management problems. Nevertheless, the EMS issues in DC microgrid system have not been specifically and much addressed, especially for the residential applications. Hence, this review paper contributes to provide a comprehensive review of various EMS applied for DC microgrid in residential applications.

The paper is structured as follows. Section 2 presents the DC microgrid architecture, 160 communication technologies and microgrid control structure. In Section 3, EMS with different strategies about DC microgrid are classified and reviewed. Some existing EMS strategies for DC microgrid residential applications are also discussed in this section. Some relative discussions are made in Section 4. Finally, Section 5 draws the conclusions. 164

## 2. DC microgrid architecture

## 2.1. Physical architecture

In an architectural context, DC microgrid comprises of distributed generators (DGs), 167 storage system (SS), power converters and loads interconnected through one or more DC 168 buses as shown in Figure 3. Power converters (AC/DC, DC/AC) are still necessary because 169 several sources and loads cannot be directly connected to the DC bus. During normal operating conditions, two types of microgrid networks (AC, DC) are interconnected through 171

PCC while the loads are supplied from the local sources (RES based DG units) and if nec-172essary, from the main grid. If the load demand power is less than the power produced by173DG units, excess power can be exported to the main system which can be utilized in case174of short production.175

With the integration of these components, the whole system becomes simpler as com-176 pared to AC microgrid. A smaller number of converters are required because most of the 177 microgrid elements have DC nature, which reduces the system cost and gives higher effi-178 ciency in terms of losses. Due to the system simplicity, reactive power and harmonic dis-179 tortion is not a problem in such kind of system. Despite of all these advantages, DC mi-180 crogrid has some challenges at the same time, because the structure of the present power 181 grids, transformers, cables, and even the protection system is designed specifically for AC 182 applications. For this reason, the most possible solution given by many researchers is to 183 build a hybrid AC/DC microgrid system for a better integration of all elements with the 184 main grid in [26-28]. 185

This idea presents a new paradigm for the definition of the distributed generation189operation, in which AC and DC sources are connected to the corresponding networks.190These networks are linked together through PCC with the main grid as presented in Fig-191ure 3. Specifically, this paper attempts to show the DC microgrid system for residential192applications. Therefore, it discusses about the system design and control of microgrid in193terms of different voltage levels and its application.194

In residential DC microgrid system, generally distributed generators, energy storage 195 system and local loads are connected through a common DC bus by means of line regu-196 lating converters or directly connected depending on the operating bus voltage. Several 197 voltage levels have been found in the literature concerning residential DC microgrid var-198 ying from 5 V to 400 V. These DC bus voltages are inspired from existing DC applications, 199 such as universal serial bus (USB) which is the most common way to distribution 5 V DC 200 power. Transport applications like camping cars operate with 12-24 V, and telecommuni-201 cation applications operate with 48 V [29]. Concerning residential application operating 202 on 24 V DC bus, a design of a 250 W DC solar nano-grid with 24 V DC distribution bus 203 was presented in [30]. In some literature, a small scale of DG such as a single house or a 204 building is considered as a nano-grid but in this article, the microgrid term is used in a 205 general sense. Another voltage level of 380-400 V was investigated in the literature used 206 for the data centers. A 380 V DC test system was presented in [31], which has been con-207 structed in Obihiro, Japan. It was concluded that the system allowed not only to reduce 208

the environment load while improving energy efficiency but also to form an independent 209 community energy system. In [32], the authors have implemented an experimental plat-210 form of DC microgrid with a bus voltage level of 380 V. The system is composed of PV 211 array, WT, an energy storage system by lithium battery pack and a supercapacitor, LED 212 lights and controllable electric loads. It has been shown that the converter performances 213 were well achieved. And the ability to control the power distribution between each unit 214 connected to the bus was validated. The existing DC bus levels in residential applications 215 in the literature, with their pluses and minuses, are summarized in Table 1. 216

As can be seen, most of DC appliances generally operate on 12 V or 24 V. However, 217 with the development of standards such as IEEE 2030.10-standard for DC microgrids [32], 218 DC loads running on 48V have equally exist in the market. Therefore, for the time being, 219 most of commercialized DC home appliances operating on 5 V, 12 V, 24 V, 48 V are presented in Table 2, with their power ranges and operating voltages. 221

The specific power range of appliances may negotiate different voltage capabilities for the access of electricity. Depending on the power appliances (low power, medium 225 power, and high-power appliances), different voltage levels (5 V, 12 V, 24 V, 48 V) could 226 be defined. Based on the literature survey, this work considers 380-400 V voltage level for 227 the proposed DC system environment. With this voltage level, additional converters are 228 required for adapting available appliances and it is easily compatible with utility voltage 229 230 V AC with a minor modification. Therefore, for residential applications, 380-400 V DC 230 bus could be an appropriate voltage level. Additionally, proper control and protection is 231 necessary for the system reliability and stability. 232

### 2.2. Communication technologies

In microgrid system, an efficient data communication system is required for continuous, fast, and reliable operation. Selection of microgrid communication system depends on system configurations and its protocols. Control objectives, its implementation and cost are also important factors to consider.

In the literature, several wired and wireless communication technologies have been 239 suggested for the effective communication among different microgrid components. It de-240 pends on the data rate, distance, and quality of service, reliability, and power consump-241 tion. Commonly wired technologies such as ethernet, power line communication (PLC), 242 and fiber optics have a higher data transmission rate and reliability, but the installation 243 cost is relatively high. Meanwhile, technologies such as ZigBee, Z-wave, global system for 244 mobile communications (GSM), general packet radio service (GPRS) and worldwide in-245 teroperability for microwave access (WiMAX or Wi-Fi) can be deployed with lower instal-246 lation cost. Both wired and wireless communications are studied in this article. Wired 247 networks are preferred because of reliability and security reasons, while wireless technol-248 ogies are more advantageous in terms of low deployment cost. However, they have low 249 data transmission rate and signal interference problems [15]. An overview of different 250 communication technologies that can be used for microgrid operations is summarized and 251 compared in Table 3. 252

In the literature, several internet protocols (IP) have also been discussed, which provide internet services in microgrid applications. Mostly used protocols are network timing protocol (NTP) for time synchronization, transmission control protocol (TCP) and user 260 datagram protocol (UDP). In [39], a Modbus protocol was used for data exchange between 261 programmable logic controllers (PLCs). Two main versions of Modbus were presented in 262 this study, i.e., remote terminal unit (RTU) and TCP, known as Modbus TCP/IP. It basi-263 cally consists of the Modbus RTU protocol with a TCP interface that runs on ethernet and 264 widely used for industrial networking and communication. 265

The most used standards in wired communication for serial transmission are RS-232, 266 RS-422 and RS-485, which could be deployed over various physical links such as fiber 267 optics and ethernet for microgrid networking. RS-485 protocol is mostly used for the en-268 ergy management of DC microgrid system. Another open standard, which is widely used 269 for commercial and domestic building automation is called Konnex. In [40], authors used 270 it with international standard Modbus for the energy management of smart buildings. 271

## 2.3. Control structure

In prospect of microgrid reliability, stability and proper operation, control structure 273 has a great importance. Many researchers have addressed the operational and control is-274 sues in microgrids to allow their stable operation in both grid-connected and islanded 275 mode. Microgrid control structure is based on various objectives. For example, based on 276 their controller function, connection with grid and response time, a systematic classifica-277 tion of various control techniques is presented in Figure 4. 278

With reference to power systems control architecture, control techniques can be cat-279 egorized into centralized, decentralized, and distributed control, as shown in Figure 5. In 280 centralized control, microgrid central controller (MGCC) determines controlling actions 281 for all units. In this control, a huge communication is required between all units and the 282 central controller. Due to large geographical area and distance, it is not feasible to have a 283 fully centralized control among microgrids. In decentralized control, every single unit is 284 controlled by its own local controller, and it receives only local information such as fre-285 quency and voltage. Some local controllers can exchange information with the neighbor 286 control unit. However, with little communication, fully decentralized control is also not 287 possible because of dependency of various units within the system. It can cause the system 288 to become unstable or operate non-optimally. Therefore, a compromise between these two 289 controls can be obtained by introducing a third approach called distributed control 290 scheme. It consists of some degrees of centralizing along with some degrees of decentral-291 ization properties. In distributed control method, each unit uses local information such as 292 frequency and voltage provided by its neighbors. In this method, local units exchange 293 information through two-way communication links. This method can also preserve the 294 unit's privacy because a lot of important information is not shared globally [41].

It is important to note here that PV, WT, and storage system with the loads in Figure 304 5 are used as an illustration in a nano-grid scale. Each unit can be further replaced by one 305 or several nano-grids to constitute a larger scale microgrid. 306

2.2.1. Control objectives and scope

The main building block of microgrid, integrates several DG units, energy storage 308 systems and loads together to build a small power system. To control such systems, it is 309

important to define a set of controlling objectives. By doing this, the proper operation of<br/>the system is achievable. Hierarchical control structure has been proposed in the literature<br/>[45-46] which consists of three levels, i.e., primary, secondary, and tertiary control, as<br/>shown in Figure 6.310310312



Figure 6. Hierarchical control levels in a microgrid structure (adapted from [46]).

The primary control is based on each local DG controller, which mainly involves volt-317 age loop control, current loop control, MPPT control and SOC estimation. As there is no 318 information exchange between each DGs, they are totally decentralized. Secondary con-319 trol is a higher level than primary control. It is linked with the voltage compensation and 320 sharing performance enhancement. It deals with voltage control for the regulation of DC 321 bus voltage. The tertiary control is on the top layer of the microgrid control diagram, and 322 its dynamic response is the slowest one among the three layers. In the tertiary control, 323 economic dispatch, power flow optimization, and optimal energy scheduling issues are 324 usually considered. In [45], the tertiary control is regarded as EMS, which is designed to 325 achieve the accurate power sharing control among DG units, and the power exchange 326 between microgrid and external grid in case of grid-connected mode. Additionally, it 327 deals with the energy market, organizing the energy dispatch scheduling from an eco-328 nomic point of view. Based on the hierarchical control, energy management strategies can 329 be defined. Hence, the decisions on microgrids are made by the EMS. In this sense, multi-330 objective functions ought to be specified by using the information such as demand fore-331 casting, power generation, energy storage, weather forecasts, energy grid prices, and so 332 on [47-49]. Based on previous literature review [18,20,50-51], an analysis has been made 333 based on multi-objective functions. The research objectives and scopes are detailed as fol-334 lows. 335

- The primary control is implemented on each local DG according to decentralized 336 control scheme. The objective is essentially to regulate the local voltages and currents. 337 It also controls the breakers/switches (on/off and protection functions) and load control (curtailment functions). 339
- Primary control may cause voltage deviations, especially when the heavy loads are 340 connected to or disconnected from microgrid. The system might run abnormally or 341 drop into under or over voltage protection. The objective herein is to develop a dis-342 tributed secondary control scheme for the voltage quality enhancement such as volt-343 age unbalance compensation. For regulating the DC bus voltage, droop control is 344 recommended for the voltage control among microgrids. The proposed control 345 scheme should be flexible and make the controller have the plug-and-play property. 346
- 3. A tertiary control structure is developed in a way that microgrid central controller 347 considers the optimal power flow, economic dispatch, and optimal energy 348

scheduling problems in the microgrid to formulate an EMS. The EMS uses inputs 349 (weather forecast, load demand, SOC, energy prices, etc.) to carry out scheduling and 350 optimization procedures. It determines the optimal set points for distributed gener-351 ation (DG) and load operation in the microgrid. 352

Based on the objective functions, a typical hierarchical control for DC microgrid is summarized and presented in Figure 7. In this way, the control system can be more 354 flexible and reliable while respecting the system objectives and the operating con-355 straints.



Figure 7. Typical control objectives and functions in DC microgrid.

### 3. DC microgrid energy management system (EMS)

Microgrid EMS is a multi-objective system that deals with technical, economical, and 362 environmental issues. The main objectives of the EMS are to optimize the operation, en-363 ergy scheduling, and system reliability in both grid-connected and islanded modes. 364 Therefore, for the controlling purposes, an EMS is necessary within a microgrid to have a 365 connection with each part of the system as shown in Figure 8. The whole microgrid oper-366 ation is controlled and coordinated by microgrid central controller (MGCC) and local con-367 trollers (LCs) via communication network called information and communication tech-368 nology (ICT) [52]. It should be noted that as a single microgrid is illustrated herein (with 369 less geographical area and distance), a MGCC is applied for illustration. 370

Different energy management strategies have been proposed in the literature to achieve an optimal and efficient operation of microgrid. Common techniques and methods used for the energy management of microgrid systems can be classified into two major categories, i.e., classical methods and artificial intelligence methods, as shown in Figure 9. In addition, several existing software tools and hardware components dedicated to residential applications are also listed at the end of this section. More details of each category are given in section 3.1 and 3.2. It should be noted that different classifications may exist in the literature, such as rule-based and optimization-based EMS. In addition, a practical EMS may be a combined form of different methods. 382

## 3.1 Energy management based on classical methods

A limited number of studies have been carried out using classical methods for the 386 energy management of DC microgrid system. Most of the research are conducted in the 387

size optimization of standalone PV-WT HES [53-57]. However, they may provide useful 388 guides for EMS design of residential applications. Commonly used classical methods in-389 clude iterative, linear programming (LP), mixed integer linear programming (MILP), sto-390 chastic and robust programming methods, and model predictive control, which are re-391 viewed in the following subsections. 392

## 3.1.1. Iterative algorithms

In the literature, iterative algorithms are utilized to realize different objective func-394 tions. It has been implemented for the sizing optimization of standalone systems with 395 single objective optimization (SOO) functions. In [58], Hosseinalizadeh et al. applied an 396 iterative algorithm to optimize a standalone PV-WT-FC-BS-HT HES in terms of minimizing the system's total cost of energy for four different regions in Iran. The authors of [56] 398 have evaluated the reliability of the HES by using loss of energy expectation (LOEE) and 399 loss of load expectation (LOLE) as estimation parameters. In this study, it has been as-400 sumed that the value of LOLE parameter must be less than 2% to achieve a system relia-401 bility. The study found that the PV-WT-BS HES was more economical and reliable without 402 the FC system. Bhuiyan et al. [59] proposed an enumeration-based iterative algorithm to 403 perform the energy management in terms of component size optimization within mi-404 crogrid residential communities. This system comprised of PV, WT, BS and DGs. In this 405 research, the system reliability was evaluated by analyzing the battery SOC and the power 406 balance between generation and demand. Furthermore, the study found that PV-WT-DG 407 HES system to be techno-economic in meeting the energy demand of remote consumers. 408

## 3.1.2. Linear programming methods

A few studies have recently used linear programming (LP) to implement the energy 410 management in terms of optimizing the standalone HES with PV and WT [60-61]. No-411 gueira et al. [60] suggested a methodology that uses LP to size and simulate a standalone 412 PV-WT-BS HES for a remote rural area by minimizing the total cost of the system while 413 assuring the system reliability by using the measure of loss of power supply probability. 414 Indu Rani et al. [62] proposed a residential microgrid system in which PV panels were 415 connected to the grid to supply DC loads without any interruption. An effective power 416 flow management system was designed to achieve this goal. Its effectiveness in providing 417 uninterruptible power to DC loads and maintaining the total harmonic distortion (THD) 418 of the injected grid current has been proved. In [63], Battistelli et al. suggested a practical 419 prototype to assess the contribution of the vehicle-to-grid (V2G) systems to support the 420 electricity market. An optimization model based on linear programming algorithm was 421 integrated into the EMS to assess the interaction between the small electric energy systems 422 (e.g., microgrids) and the main grid. Meanwhile, stochastic programming and robust op-423 timization (more details in section 3.1.4) were applied to deal with uncertainties related to 424 renewable power generation and vehicles aggregation separately. Karami et al. [64] pro-425 posed a simple and efficient EMS for a hybrid system comprising of a PV panel, a FC 426 system, a battery, and a super-capacitor. Sixteen different scenarios covering both night 427 and daylight were considered for the power flow management. The optimal energy pro-428 duction was achieved by the application of MPPTs on both PV and FC and the use of 429 compensators. Pascual et al. [12] proposed an EMS for a residential microgrid system con-430 sisting of PV panels, a WT, and a battery connected to the main grid. The main objective 431 is to minimize the power peaks and fluctuations for energy exchange with the grid. The 432 renewable generation and load forecasting together with the battery SOC were considered 433 in a single control rule to achieve the goal. 434

## 3.1.3. Mixed-integer linear programming (MILP)

MILP is used for the modeling of the energy management problems because it con-436 siders integer and binary variables to decide the operation system. In the literature, sev-437 eral authors used MILP methods for microgrid EMS according to the variables and objec-438 tive functions. In [65], Sukumar et al. proposed a power sharing, continuous run, and 439

on/off-based mix-mode microgrid EMS. The on/off mode was modeled and solved by a 440 MILP solution approach that optimizes the operation of microgrid with respect to on/off 441 connection status of FC system. Meanwhile, the other two modes were modeled and 442 solved by an LP method. Comodi et al. [66] introduced a MILP energy trade profit model-443 based EMS for residential microgrid system. The PV power was forecasted by a basic neu-444 ral network (NN) method. The integration of thermal storage and batteries was realized 445 by load management. The batteries were concluded uncompetitive for the residential ap-446 plications because of their high investment and replacement cost in the residential market. 447 For optimal energy management of residential microgrid system, an operating cost-mini-448 mization model based on MILP was proposed in [9]. It encompassed energy trading cost, 449 penalty cost on adjustable load shedding. Both energy costs and battery wear costs were 450 included in the minimization. In this study, three types of loads were considered namely: 451 critical, adjustable, and shiftable loads. The loads were divided in different power levels 452 which analyzed the tradeoff between load demand and the battery state of charge (SOC). 453 454

## 3.1.4. Stochastic and robust programming methods

Stochastic and robust programming is considered as a two-stage approach which 455 deals with constrained optimization with uncertainty. In microgrid systems, the energy 456 management is facing new challenges due to the increasing number of variable generation 457 sources. To meet these challenges, stochastic and robust optimization methods are pro-458 posed to overcome the uncertainties in [67]. A probabilistic scenario-based optimal day-459 ahead economic operation was presented for a hybrid AC/DC microgrid system. It mini-460 mized the overall operating cost by using the forecasting values of electricity price, solar 461 power, wind power, AC and DC loads. A two-stage stochastic programming model was 462 presented in [68] to optimize microgrid operation while considering uncertainties of RERs 463 and load demand. The first stage is associated with optimization of investment cost of 464 microgrid. And the second stage deals with the energy management operation of mi-465 crogrid. 466

## 3.1.5. Model predictive control methods

Model predictive control (MPC) is very useful for the defining the energy manage-468 ment strategy in microgrid system. In the literature, MPC is widely used to minimize the 469 daily generation cost and emission of the microgrid system while considering the tech-470 nical constraints in real operations. In [69], Solanki et al. presented an EMS strategy based 471 on a MPC approach. Authors emphasized on use of smart loads to perform an efficient 472 operation. A supervised NN was used to estimate the residential controllable load. In an-473 other study [70], an MPC-based EMS of a grid-connected microgrid was presented to min-474 imize the energy trading cost with the main grid, and to ensure a better utilization of bat-475 tery during peak load demand. It also ensured the maximum use of wind power to meet 476 the local demand. Authors introduced a fault tolerant scheme to have a smooth operation 477 of microgrid during sudden failures of WTs and power supply shortage. Akter et al. [71] 478 suggested a hierarchical model for power sharing among residential consumers. Each 479 house was equipped with a central EMS controller to share information in a grid-con-480nected mode residential microgrid. The intention was to maximize the energy sharing 481 among houses in comparison with the main grid to minimize the investment cost. The 482 authors concluded that the payback period was reduced due to power sharing among 483 residential consumers. 484

### 3.2 Energy management based on artificial intelligence methods

Diverse studies have been focused on the utilization of artificial intelligence methods 486 for the multi-objective energy management of microgrids. In this category, artificial intel-487 ligence techniques are used to solve single-objective optimization (SOO) and multi-objec-488 tive optimization (MOO) problems. In general, artificial intelligence methods are more 489 flexible and efficient in dealing with complex optimization problems, such as fuzzy logic 490 (FL), neural network (NN) and evolutionary computation methods. In addition, multi-491 agent system (MAS) composed of multiple interacting intelligent agents has also been in-492 troduced to microgrid. This subsection gives a more detailed review on these studies. 493

## 3.2.1.Fuzzy logic methods

FL techniques are widely used for energy management in standalone or grid-con-495 nected hybrid renewable energy systems. FL can effectively manage the multi control 496 functions. Several studies have been found in the literature about FL based EMS. The de-497 sign and implementation of an EMS based on fuzzy control for DC microgrid system was 498 presented in [72]. In this work, the modeling, analysis, and control of the DERs and ES 499 devices were completed in MATLAB/Simulink environment. The FL controller managed 500 the battery SOC to ensure a longer battery life and to offer better performance for the 501 entire system at low cost. Different membership functions with variables were defined for 502 both inputs and outputs of the system. The simulation result validated the accuracy of the 503 proposed system with a fuzzy controller that can maintain the battery SOC at a certain 504 level irrespective of the amount of power generated from the microgrid system. Erdinc et 505 al. [73] studied a FL based EMS for a standalone hybrid power system. This residential 506 system was comprised of WT, PV, FC system, and batteries. The PV and wind energy 507 served as the primary power sources, the FC provided backup power during the unavail-508 ability of the primary sources, and the battery unit was used for storage. The main objec-509 tive of this study is to employ a FL based EMS to regulate the overall system power flow 510 while maintaining the battery SOC. The authors herein justified the advantages of the FL 511 based EMS over other previously developed approaches, in the aspects of fast response 512 capability and ease of adapting to new conditions during the period of operation. 513

## 3.2.2.Neural network methods

The neural network (NN) is another intelligent technique commonly used for control 515 and energy management of microgrid systems. It is an advanced approach which is com-516 putationally intelligent and has humanlike expertise. NN has achieved remarkable suc-517 cess in control system applications due to its reliability, computational capability, and 518 adoptability to handle complex nonlinear systems. Wang et al. [74] introduced a Lagrange 519 programming NN approach to optimize economic dispatch and minimize the system ob-520 jective function. Meanwhile, a radial basis function NN was applied for the day-ahead 521 prediction of renewable energy production and load demand. In [75], Venayagamoorthy 522 et al. proposed an intelligent adaptive dynamic EMS for a grid-connected microgrid. An 523 action-dependent heuristic dynamic programming (ADHDP) combining the concept of 524 dynamic programming and reinforcement learning was developed by using two NNs. 525 Meanwhile, an evolutionary strategy was proposed to dynamically optimize the EMS 526 over time. It maximized the utilization of RERs and minimizes carbon emissions to 527 achieve a reliable and self-sustainable system. It can also improve the battery life. Azmy 528 and Erlich [76] presented an artificial NN approach for optimizing the performance of FC 529 system for residential applications. Jifang et al. [77] proposed a NN based control strategy 530 for multi-energy common DC bus hybrid power system. The authors developed a hybrid 531 model for an hourly forecast of PV and wind renewable energy system. 532

## 3.2.3. Evolutionary computation

Evolutionary computation is inspired by biological evolution and forms another pop-534 ular subfield of artificial intelligence. Genetic algorithm (GA) is a random-based classical 535 evolutionary algorithm. It is one of the most powerful optimization algorithms. In several 536 studies [78-79], GA has been implemented to find the optimal sizing of hybrid system. 537 Ogunjuyigbe et al. [73] used GA for the optimal sizing of hybrid energy storage system 538 (HESs) in standalone mode. In this study, the authors inspected five different combina-539 tions for residential loads. The study found that PV-WT with HESs is the most optimal 540 combination in terms of cost, net dump energy and CO<sub>2</sub> emissions. In [79], the authors 541 used GA for the optimal sizing of renewable energy sources (RES) with battery storage 542 system (BSs) for four different residential zones in Karnataka, India. The study found that 543

PV, WT, and BSs are the most cost-effective solution for residential applications. An improved version of GA, called non-dominated sorting genetic algorithm (NSGA-II), was544proved version of GA, called non-dominated sorting genetic algorithm (NSGA-II), was545discussed in [80-81]. Kamjoo et al. [80] applied the NSGA-II algorithm to optimize a546standalone PV-WT-BSs combination for residential loads in Kent, UK and provided promising results in solving MOO problems.547

Meanwhile, several other algorithms are also used to solve the non-linear optimiza-549 tion problem including particle swarm optimization (PSO), ant colony optimization 550 (ACO), fruit fly optimization algorithm (FOA) and others. PSO is one of the most popular 551 heuristic algorithms in solving non-linear optimization problem because of its simplicity, 552 ease of implementation and fast convergence. Suhane et al. [82] used ACO to find the 553 optimal sizing of PV, WT, BS, and DG in terms of minimizing the total cost for a small 554 village in India. Fruit fly optimization algorithm (FOA) is a heuristic evolutionary com-555 putation method used in finding global optimization. In [83], authors utilized an im-556 proved FOA (IFOA) algorithm for the optimization design of standalone PV-WT-BS-DG 557 system in Dongao island in China. The study found that with a smaller number of WTs 558 and battery units, total cost can be reduced. 559

## 3.2.4. Multi-agent system (MAS)

Multi-agent system (MAS) is made up of intelligent agents embedded in different 561 sources and loads working all together to solve the problem of energy consumption con-562 trol in the network. A MAS-based approach is used for optimal operation of microgrid 563 system. All the system elements like storage units, generation units, grid and consumer 564 side are considered as an agent. Anvari-Moghaddam et al. [84] suggested MAS-based 565 EMS for efficient operation of a grid-connected residential microgrid. The agents were 566 classified into central coordinator agent, building management agent, RER agent, battery 567 agent, and service agent. The objectives of the proposed method were to minimize opera-568 tional cost while satisfying the consumers comfort level. 569

### 3.3 Existing software tools and sardware components for microgrid EMS

This section introduces both software tools and hardware components used for mi-571 crogrid applications. In the literature, many open-source software tools have been used 572 for the optimization of hybrid renewable energy systems. The most used software tool in 573 size optimization for PV-WT HES is Hybrid Optimization Model for Electric Renewables 574 (HOMER) [85]. Another software, named Improved Hybrid Optimization by Genetic Al-575 gorithm (i-HOGA) has been used in several studies for sizing optimization for standalone 576 PV-WT HES [86]. TRNSYS and graphical user interface (GUI) are graphically based soft-577 ware tools and extremely flexible [87]. Several hardware components such as Arduino, 578 Raspberry Pi (RPi), and Color Control GX (CCGX), and SCADA are explored in [39,88]. 579 All these tools are primarily used for the energy management of microgrids. 580

## 3.3.1.Software tools

Mostly researchers throughout the world have used the HOMER to optimize their 582 suggested hybrid systems. HOMER is a computer software that can evaluate various de-583 sign options for both standalone and grid-connected energy systems. Three main tasks 584 that the HOMER can perform are simulation, optimization, and sensitivity analysis [89]. 585 Bhakta et al. [90] utilized HOMER for sizing, optimizing, and performing the economic 586 analysis of a PV/wind hybrid system with a battery bank for microgrid residential appli-587 cation in Northeast India. In [91], Das et al. has done a feasibility study to find the optimal 588 size combination of hybrid energy system for household user in Kuakata, Bangladesh. 589 Giannoulis and Haralambopoulos [92], Al-Karaghouli and Kazmerski [93], Bekele and 590 Palm [94], Bangladesh. Ma et al. [95], Adaramola et al. [96], Olatomiwa et al. [97], Nandi 591 and Ghosh [98], Sen and Bhattacharya [99], Lau et al. [100], used HOMER to optimize their 592 proposed standalone hybrid systems. Different locations throughout the world (Nigeria, 593 Bangladesh, Ethiopia, Iraq, Hong Kong, Ghana, India, Malaysia, and Greece) are covered. 594

Each survey suggested a particular combination of components which is different from 595 others in terms of performance according to a certain location. 596

i-HOGA is a hybrid energy system optimization software developed by the University of Zaragoza [101]. It utilizes GA for the size optimization of single- or multi-objective 598 functions. i-HOGA performs optimal control strategies with less computational time compared to the use of GA alone. In [102], Fadaeenejad et al. used the i-HOGA software to 600 analyze the optimal size combination for a remote village in Malaysia in terms of minimizing the amount of cost of energy and CO<sub>2</sub> emission. 602

TRNSYS software can be used to simulate the behavior of transient systems. In [87], 603 Behzadi and Niasati examined a hybrid system consisting of PV, battery, and FC. In this 604 system, TRNSYS software was used to conduct the performance analysis. The system siz-605 ing could be done by using the GA via i-HOGA, manual calculation, or HOMER. Authors 606 used three different energy management strategies to dispatch energy in this hybrid sys-607 tem. Firstly, the value of excess energy is checked. If it is positive, the excess energy will 608 be directed to charge the battery to its maximum SOC. The excess energy is then directed 609 to produce more hydrogen. However, if the excess energy is negative and the SOC of the 610 battery is less than its minimum SOC, then FC system will supply the load if the pressure 611 in the hydrogen tank is higher than the critical value; otherwise, the battery will supply 612 the load. In the second step, the control system never checks for the minimum SOC. It 613 only checks for the level of pressure in the hydrogen tank. Lastly, the nominal power of 614 each component is checked, and control system decides that how much amount of power 615 can flow toward each storage device. A similar approach was presented in [103], in which 616 a hybrid energy system (hydrogen storage and a supercapacitor) is used as a storage sys-617 tem. In this paper, the aim of proposed energy management strategy is to satisfy the load 618 requirement. The PV panels prioritize supplying the load, and surplus energy is used to 619 generate hydrogen. When the hydrogen storage system is filled, excess energy is directed 620 to the supercapacitor. If the storage system is fully charged, then the solar system will be 621 automatically shut down. 622

GUI integrating different algorithms is graphically used for sizing optimization and 623 measuring system efficiency in homes and offices for residential applications. In several 624 articles, GUI is considered as a real-time monitoring and energy management tool. In ref-625 erence [104], GUI is used to optimize the size of a hybrid PV, WT, BS, and DG system 626 while considering the peaks and troughs of wind speed and solar irradiance for a com-627 plete year. The proposed method used the measured annual hourly solar irradiation and 628 wind speed to simulate the real time operation of the hybrid system. In the study, authors 629 found that the peaks of solar irradiation and wind speed affect the size optimization re-630 sults. 631

## 3.3.2. Hardware components

Arduino is an open-source hardware platform supportive for electronic prototyping.633It has been used in different projects and have several applications. In [39], authors used634Mega 2560 model to measure the temperature of PV modules by means of a network of635digital temperature sensors. Arduino microcontroller has been used to verify the smart636grid features [105]. In this study, a multi-agent approach is used to address the complexity637638639

Raspberry Pi (RPi) is an open-source and series of small single-board computers 639 (SBCs) developed by the Raspberry Pi Foundation of the University of Cambridge in 2012. 640 It provides huge computation resources and wide connectivity options. Raspberry Pi fea-641 tures a Broadcom system on a chip with an integrated ARM cortex A72 processor and on-642 chip graphics processing unit (GPU). In Addition, USB 3.0 and Gigabit Ethernet ports are 643 available. In the context of EMS, it can bring new possibilities for the integration and de-644 velopment of an operating system (OS). According to authors, it gives an easy access to a 645 high level of computation while providing the same input/output pins as a microcontrol-646 ler [106]. In [88], authors used raspberry Pi (RPi) board for sending information to local 647

data base for the supervisory control of microgrid testbed. Another innovative device has 648 been developed by Victron Energy Almere Haven (Netherlands), i.e., color control GX 649 (CCGX). With this device full system control is gained by the exchange of data with solar 650 chargers, inverters, batteries, and other connected appliances. According to the authors in 651 [39], this device is very useful for real-time operation in microgrid system. As it provides 652 full access to the very extensive controls and settings of all system components such as, 653 PV, battery, solar charger, and generator. It allows remote user and installer to login from 654 anywhere, at any time. 655

Another category of powerful, real-time simulation devices is investigated in the lit-656 erature, including real-time simulators from OPAL-RT, Typhoon and dSPACE enter-657 prises. It provides real-time simulations for electrical conversion and enables customers 658 to conduct precise and exhaustive testing more quickly. In [99], authors designed a real-659 time simulation platform to simulate and control the system. In the studied system, PV 660 panels and WT were linked with the batteries. And the objective was to control the speed 661 of WT and maintain the battery SOC. Authors in [40], presented an intelligent EMS based 662 on complete supervisory control and data acquisition (SCADA) system for smart building 663 applications. The duties were performed in an educational building with an MG Labora-664 tory testbed, which was named LAMBDA at the Sapienza University of Rome. The pro-665 posed model examined the daily production and consumption of different sources and 666 loads in real time and evaluated the economic aspect. 667

## 3.4 Energy management strategies analysis

In different control frameworks, the problems can be formulated in different man-669 ners according to the objective functions and the underlying controls. Previously, numer-670 ous energy management strategies have been discussed in the article but few of them are 671 highlighted in accordance with the DC microgrid system for residential applications. Most 672 adopted energy management strategies such as, linear programming-based EMS, artifi-673 cial-intelligence based EMS, hardware and software tool-based EMS like SCADA, 674 HOMER are chosen with the system configuration (PV/wind/fuel cell/storage) and control 675 objectives and are summarized in Table 4. 676

The EMS integrated DC microgrid structure is presented previously in Figure 8, consisting of PV panels, WT connected with storage system (e.g., batteries and supercapacitor) via power converters. All the elements are connected to the common DC bus. With the accordance of DC microgrid system, a few similar systems streamed from the literature are presented in Table 5, with their element characterizations and corresponding EMS. It should be noticed that no single method can satisfy all the requirement, and hybrid methods may be used in combination in an EMS.

The review has classified different methods for the energy management of microgrid 688 systems coupled with various RES and storage system. Table 4 and 5 have summarized 689 the research conducted in comparing several algorithms and techniques used for size op-690 timization and EMS. In Table 5, more specifications are given on the existing microgrid 691 systems in the literature with their element characterization, and different EMS strategies. 692

The cited articles related to the EMS of DC microgrid for residential applications in 693 this review paper are 74 in total, among them 73 % (54 articles) were published during the 94 period of 2015-2021, and 27 % (20 articles) were published during the years 2010-2014. A 695 growing trend has been observed regarding the EMS design and implementation in DC 696 microgrid domain in the recent years especially after the year 2015. A graphical representation of the references in years is illustrated in Figure 10. 698

## 4. Discussion

The previous reviews have mainly focused on the AC or hybrid AC/DC microgrid 709 systems (islanded/grid-connected mode) which comprises on several DERs and storage 710 elements. DC microgrid system has not been specifically addressed, especially for the residential applications. It is thus interesting to have an overview on its different aspects, 712 such as the architecture design, control design, communication technologies and EMS. 713

For residential applications, 380-400 V DC could be an appropriate voltage level for 714 the common DC bus based on a synthesis of different appliances' voltage levels and their 715 power ranges. Apart from the common DC bus voltage level, a variance of DC voltage 716 standards, such as 12 V, 24 V and 48 V can be defined according to different appliance 717 groups, as summarized in Table 1 and 2. Reasonable design of a set of DC voltage levels 718 may favor the system efficiency, reduce the power losses due to the high step-up ratio and 719 much conversion stages, and augment the users' safety as lower DC voltage levels are 720 applied. In the future study, further quantitative analysis can be made for setting variant 721 DC voltage standards dedicated to residential applications. 722

For the microgrid communication technologies, the communication links in rural and 723 residential area microgrids mainly depend on the cost and data rate. Nowadays, wired 724 technologies still dominates in microgrids due to the existing hardware components and 725 the relatively mature communication techniques and protocols. An increase of wireless 726 technologies has been observed in recent years due to their low deployment cost, high 727 flexibility, and low power consumption. Different communication standards and proto-728 cols exist for both technologies. The interoperability among the different standards will 729 be an essential part of the information and communication technology (ICT) in order to 730 modernize the microgrid and make it really smart. In recent years, the concepts such as 731 the internet of things (IoT), block chains and cyber-physical microgrid, have been much 732 focused on, which indicate the importance of the ICT aspect. 733

The energy management of DC microgrid system for residential applications has 734 been specifically emphasized in this review. For the microgrid EMS, it can be noticed that 735 a growing trend is observed towards the use of artificial intelligence methods for the op-736 timization and energy management of system, due to their inherent advantages in dealing 737 with complex multi-objective optimization problems. It should be noted that no single 738 method can meet all the requirements of an EMS. Hybrid methods can be combinedly 739 used for a practical EMS. In addition, in more recent articles, the predictive functions have 740 been integrated into the EMS design to consider the influences of the factors such as future 741 energy generation, load demand, energy market variation in hours or even days ahead. 742 Another aspect is that apart from EMS, the health management strategies (HMS) should 743 be equally considered, include the degradation cost for each component (e.g., battery deg-744radation cost), the PV shading cost (e.g., the shading effect on PV panels), the reliability 745 of the converters (e.g., the degradation effect of the switching devices). An interaction of 746 both EMS and HMS could be interesting for an both efficient and reliable operation of the 747 microgrids. 748

## 5. Conclusions

Compared with traditionally used AC microgrid and hybrid AC/DC microgrid, DC 750 type has the advantages in terms of system efficiency, reliability, and cost. Nevertheless, 751 various issues such as its protection system, architecture design, control strategies, stabilization techniques deserve tremendous research efforts. This paper has particularly reviewed several critical issues regarding DC microgrid in residential applications, including its architecture design, communication technologies, control structure and EMS classifications. 756

Concerning its architecture, the DC bus level of 380-400 V has been considered as an 757 appropriate voltage level for the common DC bus considering the different voltage levels 758 and power ranges of residential appliances. However, different DC voltage standards 759 may exist in the future microgrid to further improve the system efficiency and reduce the 760 power conversion stages. The communication technologies have also been briefly dis-761 cussed, including both wired and wireless technologies. Compared with the dominated 762 wired technologies, the wireless type has demonstrated more interests due to their low 763 deployment cost, high flexibility, and low power consumption. As illustrated in the dis-764 cussion part, the ICT part will be essential to construct modern and smart microgrids. 765 Tremendous effort is still needed in the future. 766

Particular attention has been paid to the EMS issues in the tertiary level specially for 767 residential applications. Two major categories have been summarized, including classical 768 and artificial intelligence methods. According to the literature research, classical methods 769 have been majorly applied for solving optimization problems. Iterative algorithm, linear 770 programming, mixed-integer linear programming, stochastic and robust programming, 771 and model predictive control in this category have been briefly introduced. Artificial in-772 telligence methods, including fuzzy logic, neural network, evolutionary computation 773 methods together with multi-agent system, have gained a popularity for the multi-objec-774 tive energy management of microgrids. In this category, advanced techniques are used to 775 solve single-objective optimization (SOO) and multi-objective optimization (MOO) prob-776 lems. In general, they are more flexible and efficient in dealing with complex optimization 777 problems. In addition, in recent publications, the predictive functions on future energy 778 generation, low demand and energy market variation and so on have been integrated into 779 the EMS. Health management strategies (HMS) considering the degradation cost and the 780 reliability of each component have also been integrated into the EMS objective functions. 781 The interaction of EMS and HMS could be an interesting research direction to guarantee 782 an efficient and reliable operation of DC microgrids. 783

Some existing software tools have also been listed, such as HOMER, i-HOGA and TRANSYS, which could be interesting for residential end users due to their good interpretability. Final analysis has been done based on several examples of DC microgrids for residential applications including the system elements with their types and power levels, and the controlling objective of each part and the overall EMS. They could provide some concrete examples for future designers of DC microgrid for residential applications.
