67 Abstract

68 **Objective:** To analyze the factors associated with response (control of ocular inflammation and

69 corticosteroid sparing effect) to biologics (anti-TNF- α agents and tocilizumab) in patients with

70 refractory uveitic macular edema.

71 **Design:** Multicenter retrospective observational study.

Subjects: Adult patients with uveitic macular edema refractory to systemic corticosteroids
and/or disease modifying anti-rheumatic drugs.

Methods: Patients received anti-TNF-α agents [IFX 5 mg/kg at weeks 0, 2, 6 and every 4-6
weeks (n=69) and ADA 40 mg/14 days (n=80)] and tocilizumab [8 mg/kg every 4 weeks
intravenously (n=39) and 162 mg/week subcutaneously (n=16)].

Main Outcome Measures: Analysis of complete and partial response rates, relapse rate, low
vision (visual acuity in at least one eye ≥ 1 LogMAR), corticosteroid sparing effect and adverse
events at 6 months.

Results: 204 patients (median age of 40 years [28-58] with 42.2% of men) were included. Main 80 etiologies of uveitis included Behçet's disease (17.2%), birdshot chorioretinopathy (11.3%) and 81 82 sarcoidosis (7.4%). The overall response rate at 6 months was of 46.2% (21.8% of complete 83 response) with anti-TNF-α agents and 58.5% (35.8% of complete response) with tocilizumab. 84 In multivariate analysis, treatment with tocilizumab (OR 2.10 [95% CI 1.06–4.06], p=0.03) was 85 independently associated with complete response of uveitic macular edema, compared to anti-86 TNF- α agents. Anti-TNF- α agents and tocilizumab did not differ significantly in terms of 87 relapse rate (HR=1.00 [0.31-3.18], p=0.99) or occurrence of low vision (OR=1.02 [0.51-2.07], p=0.95) or corticosteroid-sparing effect (p=0.29). Adverse events were reported in 20.6% of 88 89 patients, including 10.8% of serious adverse events.

90 Conclusions: Tocilizumab seems to improve complete response of uveitic macular edema
91 compared to anti-TNF-α agents.

92 Introduction

Non-infectious inflammatory uveitis is a heterogeneous group of diseases, characterized
by inflammation of intra-ocular structure. It can be associated with systemic autoimmune
diseases or be sporadic of unknown etiology. With a prevalence of 121/100,000 persons (1),
uveitis is one of the five common causes of visual loss in industrialized countries (2). Cataract,
glaucoma and macular alterations account for the main ocular complications of uveitis (3,4).

98 Uveitic macular edema (uveitic ME) is related to the breakdown of the outer and/or the 99 inner blood-retinal barrier secondary to chronic inflammation and secretion of pro-100 inflammatory factors such as TNF-a (tumor necrosis factor), prostaglandins and VEGF 101 (vascular endothelial growth factor) (5,6). These pro-inflammatory factors result in an increase 102 of permeability of the retinal pigment epithelium and the retinal vasculature (7,8). Uveitic ME 103 is more common in patients with intermediate uveitis (25-70%), posterior uveitis (19-34%) and panuveitis (18-66%). Uveitic ME is responsible for a severe decrease of visual acuity in one-104 third of patients with posterior uveitis (9), supporting an effective therapeutic management. 105

106 Several treatments can be used for uveitic ME management. Local corticosteroids, with 107 periocular injections or, mostly, intravitreal implants of corticosteroids, are usually proposed in cases of unilateral uveitic ME, absence of associated systemic disease or as an adjunct to 108 109 systemic therapy (7). Intravitreal implants of dexamethasone (OZURDEX®) have been shown 110 to improve visual acuity (VA) of more than 2 lines in 50% of patients. However, in a recent 111 literature review, almost one third did not have any visual improvement despite a decrease of central foveal thickness (CFT) (10). Fluocinolone acetonide implant (RETISERT®) has also 112 shown its efficacy in uveitis. Recently, Tomkins-Netzer et al. (11) reported that the cumulative 113 114 percent of eyes with resolution of CME was 94% within the 7 years of follow-up, with a median 115 time of resolution of one year. However, the cumulative percent of eyes with relapse of uveitic ME was 43%. Conventional immunosuppressive drugs such as mycophenolate mofetil, 116

117 methotrexate or azathioprine have shown their efficacy in the resolution of uveitic ME (12,13). 118 Interestingly, systemic immunosuppressive drugs have shown their efficacy on uveitic ME 119 resolution with fewer adverse events than corticosteroid implant (14). Biotherapies appear as 120 an attractive option in the treatment of uveitic ME, though few data are available. Adalimumab 121 (ADA), an anti-TNF- α antibody, has been approved by the Food and Drug Administration (FDA) and the European Medicine Agency (EMA) for the treatment of patients with non-122 123 infectious non-anterior uveitis in case of corticosteroid-dependency (15) or contraindication to 124 corticosteroids (16). However, it is a priority to evaluate macular edema as a trial endpoint because it is a major cause of functional visual loss during uveitis. A Cochrane review (17) 125 126 reported that no prospective study has focused on the resolution of uveitic ME with biologics. The efficacy of anti-TNF- α agents and tocilizumab (TCZ), an anti-IL6 receptor, in the 127 resolution of macular edema has been suggested in few retrospective studies (18-20). 128

129 Data regarding factors associated with response to anti-TNF- α agents or TCZ are 130 lacking in refractory ME in non-infectious uveitis. In the BIOVAS study (BIOtherapies in 131 macular edema and retinal VASculitis) from the French uveitis network, our aim was to analyze 132 the efficacy, as well as adverse events of anti-TNF- α agents and TCZ to control ocular 133 inflammation and corticosteroid sparing effect in a large retrospective cohort of patients with 134 refractory ME in non-infectious uveitis.

136 <u>Methods</u>

137 <u>Patients</u>

This was a multicenter retrospective observational study conducted in participating Internal Medicine and Ophthalmology departments of the French Uveitis Network between 2018 and 2020. Adult patients with refractory uveitic ME were included. Refractory ME was defined as macular edema resistant to a first line therapy with systemic corticosteroids and/or

disease modifying anti-rheumatic drugs (DMARDs, i.e., mycophenolate mofetil, methotrexate, 142 143 azathioprine etc) and which requires treatment escalation with anti-TNF- α agents (ADA and 144 infliximab, IFX) or TCZ. Uveitic ME was defined by a CFT of > 300 µm measured with spectral 145 domain optical coherence tomography (OCT) and the presence of intraretinal cystic spaces or subretinal fluid in the absence of choroidal neovascularization. Patients were excluded if they 146 147 presented non-infectious uveitis without macular edema or macular edema unrelated to uveitis. 148 Patients previously treated with intravitreal implants of dexamethasone within 6 months were 149 excluded.

150 The study complied with the ethical principles of the Declaration of Helsinki. This study was 151 approved by the local ethics committee of Pitié-Salpêtrière Hospital (Number: 1867484). 152 Informed consent was not required as per French regulations for research on Humans due to 153 the retrospective strictly observational nature of the study.

155 <u>Study treatment</u>

156 IFX was administered intravenously at 5 mg/kg at week 0, 2, 6 and every 4-6 weeks, left at the 157 discretion of the clinician. ADA was administered subcutaneously at 80 mg then 40 mg every 158 2 weeks. TCZ was administered at 8 mg/kg every 4 weeks intravenously or at a dose of 162 mg 159 every week subcutaneously. The choice of biotherapy was left at the discretion of the clinician. 160

161 <u>Data collection</u>

162 Collected data included demographic characteristics (age, sex, date of diagnosis), 163 treatment characteristics (concomitant treatment, corticosteroid dose, adverse events), uveitis 164 characteristics (etiology, anatomic localization according to the Standardization of Uveitis 165 Nomenclature [SUN] (21)), course of visual acuity (Snellen and LogMAR), evolution of 166 anterior chamber cells according to SUN classification (21), evolution of vitreous haze grade

according to Nussenblatt classification (22), and presence of vasculitis based on fluorescein
angiography). CFT was measured with OCT (Cirrus HD-OCT Carl Zeiss Meditec, Dublin, CA
and Spectralis, Heidelberg Instruments, Heidelberg, Germany). For bilateral uveitic ME, the
most affected eye was considered for analysis.

172 <u>Study endpoints</u>

173 The primary objective was the complete response of uveitic ME at 6 months. Complete 174 response was defined as a complete resolution of uveitic ME (CFT \leq 300 µm with resolution of intraretinal cystic spaces) and a corticosteroid dosage of ≤ 10 mg/ day at 6 months, without 175 intraocular inflammation (grade 0 for anterior chamber cells and vitreous haze (22)). Partial 176 response was defined as an improvement of macular edema without complete resolution, an 177 improvement of intraocular inflammation and a reduction of the initial corticosteroid dosage at 178 179 6 months. Patients with complete resolution of uveitic ME with a corticosteroid dosage of > 10180 mg/ day at 6 months were also considered as partial responders. The remaining patients were 181 considered as non-responders.

Secondary end points included factors associated with relapse of uveitic ME, factors associated with low visual acuity and adverse events. Relapse was defined as an increase of macular thickness requiring a change in therapeutic strategy (increase of corticosteroid dose, intra-ocular corticosteroid injection, or another biotherapy) in at least one eye. Low vision was defined as visual acuity in at least one eye $\geq 20/200$ (1 LogMAR).

For the evaluation of primary and secondary end points, each treatment line was considered per patient for univariate and multivariate analysis. A line of treatment was defined as the sequence from the initiation of a new therapeutic strategy to the next one or last follow-up. We assumed treatment lines as independent.

192 <u>Statistics</u>

193 Data on categorical variables were summarized as number and percent and compared 194 using Fisher's exact test. Data on continuous variables were summarized as the median and 195 interquartile range (IQR) and were compared using Wilcoxon test or Kruskal-Wallis tests. For 196 the evaluation of primary and secondary end points, each treatment line was considered per 197 patient for univariate and multivariate analysis. Factors associated with complete response or low vision were assessed using logistic regression. Factors associated with relapse were 198 199 assessed using Cox proportional hazards models. For both endpoints, an adjusted multivariate 200 model was used with backward variable selection based on Akaike's information criterion. 201 Clinically relevant variables were candidates for the stepwise selection and the treatment group 202 variable was forced into the adjusted model. Cumulative incidences of relapse were estimated 203 using Kaplan-Meier method. Statistical analyses were performed using R Studio Version 3.6.1 204 and p values < 0.05 were considered to be statistically significant.

206 **Results**

Baseline data are summarized in Table 1. Two hundred and four patients (women 207 [57.8%], with a median age [IQR] of 40 years old [28-58]) were included in the study: 149 208 patients (73%) were treated with anti-TNF- α agents (80 with ADA and 69 with IFX) and 55 209 210 patients (27%) received TCZ (39 intravenous and 16 subcutaneous). One hundred and ten 211 (53.9%) patients had panuveitis and 77 patients (37%) had retinal vasculitis. The main etiologies of uveitis were Behcet's disease (35 patients, 17.2%), birdshot chorioretinopathy (23 212 213 patients, 11.3%) and sarcoidosis (15 patients, 7.4%). One hundred and eighty-three patients 214 (89.7%) and 82 patients (40.2%) received systemic corticosteroids or DMARDs, respectively, 215 in combination with anti-TNF- α agents or TCZ. Patients treated with TCZ were significantly 216 older (p=0.03) and uveitis etiologies were significantly different between the two groups

217 (p=0.03). Forty-two patients (76%) treated with TCZ had previously received anti-TNF- α 218 agents. Most of patients had been previously treated with DMARDs: 82% in the anti-TNF- α 219 group and 87% in the TCZ group (p=0.40). Median time [IQR] to follow-up was 74.5 months 220 [37-137], with a median time [IQR] of 88 months [37-144], 72.5 months [39-131] and 76 221 months [38-135] for IFX, ADA and TCZ, respectively. Median time from diagnosis of uveitis 222 to introduction of biotherapy was 40 months [11.7-89.6] for anti-TNF- α agents and 29 months 223 [9-60] for TCZ (p=0.15).

Response of uveitic ME to treatment.

A total of 280 lines of treatment were studied including 225 lines of anti-TNF- α agents (117 ADA/108 IFX) and 55 lines of TCZ. Complete response at 6 months was achieved in 24.5% of whom 21.8% with anti-TNF- α agents and 35.8% with TCZ. ADA and IFX had similar complete response rate: 22.2% and 21.3% respectively.

In univariate analysis (Table 2), the factor associated with complete response was TCZ
treatment (odds ratio OR 2.08 [95% CI 1.09–3.99], p=0.027). In multivariate analysis,
treatment with TCZ (OR 2.10 [95% CI 1.06–4.06], p=0.03) was independently associated with
complete response of uveitic ME, compared to anti-TNF-α agents (Figure 1).

Partial response was obtained in 24.1% of whom 24.4% with anti-TNF-α and 22.6%
with TCZ.

237 **Relapse of uveitic ME.**

Relapse under treatment occurred in 44.6% of patients, with a median time [IQR] to
relapse of 41 months (Q1: 10 months, Q3 not reached) after the introduction of biological agents
(Figure 2, Supplementary data). The estimated relapse rate at 6 months after the introduction

241	of biological agents was of 16% (95% CI 0.10-0.22). The median duration of disease control
242	was 12 months [6.8-28.5] for anti-TNF- α agents and 11 months [6-15.3] for TCZ (p=0.34).
243	In univariate analysis (Table 2), the factors associated with relapse risk were posterior
244	uveitis, Behçet's uveitis, non-idiopathic uveitis and treatment. In multivariate analysis,
245	posterior uveitis was associated with an increased relapse risk (HR 2.50 [95% CI 1.03-6.05],
246	p=0.043), whereas Behçet's disease was inversely associated with relapse risk compared to the
247	reference (idiopathic uveitis) (HR 0.40 [95% CI 0.21–0.77], p=0.007) (Figure 1).
248	
249	Low visual acuity.
250	Median [IQR] visual acuity at the initiation of biological agents was 20/50 (0.4
251	LogMAR [0.2-0.7]). At 6 months, visual acuity improved to 20/40 (0.3 LogMAR [0.1-0.5]).
252	At 6 months, 80 patients (32.1%) had low vision, including 66 (83%) treated with anti-TNF- α
253	agents and 14 (17%) with TCZ.
254	At 6 months, in univariate analysis (Table 2), the factors associated with low visual
255	acuity included Behçet disease, non-idiopathic uveitis and treatment. In multivariate analysis,
256	Behçet's disease (OR 3.05 [95% CI 1.38-6.81], p=0.006) was independently associated with
257	poor visual prognosis compared to the reference (idiopathic uveitis) (Figure 1).
258	
259	Corticosteroid sparing effect.
260	Biological agents had a significant corticosteroid-sparing effect (Figure 3). The median
261	[IQR] daily dose of prednisone was 19 mg [10-30] at the initiation of ADA compared to 10 mg
262	[7.4-18.5] after 6 months of treatment (p<0.0001). For IFX, the median daily dose decreased
263	from 20 mg [10-30] to 10 mg at 6 months [0-40] (p=0.0006). For TCZ, the median daily dose
264	decreased from 15 mg [8-20] to 10 mg at 6 months [0-40] (p=0.0006). However, there was not

265	significant difference for corticosteroid sparing between anti-TNF- α agents and TCZ
266	p=0.29), nor between ADA and IFX (p=0.54) and intravenous or subcutaneous TCZ (p=0.26).

268 Adverse events.

Adverse events occurred in 20.6% of patients and serious adverse events requiring 269 270 treatment discontinuation were observed in 10.8% (Table 3). For anti-TNF- α agents, at least 271 one adverse event occurred in 23.5%, with 12.8% of serious adverse events requiring treatment 272 discontinuation. For TCZ, at least one adverse event occurred in 12.7%, with 5.5% of serious adverse events. No death occurred during follow-up. Most of adverse events were infections 273 274 (54.5%), hypersensitivity reaction (18.2%) and auto-immune reaction (13.6%). Hospitalization 275 was required for 3 infections (meningitis, Pseudomonas aeruginosa bacteremia and deep 276 abscess). There was no opportunistic infection.

278 Discussion

In this multicenter study, from the French uveitis network, we analyzed the efficacy of anti-TNF- α agents or TCZ to control ocular inflammation and corticosteroid sparing effect in a cohort of patients with refractory macular edema in sight-threatening non-infectious uveitis. The main conclusions drawn by this study are: 1) TCZ improved the odds of complete response of uveitic ME by 2 times as compared with anti-TNF- α agents, 2) Risk of low visual acuity of uveitic ME was increased by 3 times in Behçet's disease, 3) Adverse events observed with anti-TNF- α agents or TCZ were consistent with the known safety profile.

Our study showed that TCZ improved the odds of complete response of uveitic ME by
2 times compared with anti-TNF-α agents after 6 months of treatment. There was no significant
difference between ADA and IFX efficacy nor between intravenous or subcutaneous TCZ. The

290 efficacy of both anti-TNF-α agents and TCZ (20) in uveitic ME resolution has been suggested 291 in literature. In the prospective VISUAL III study, Shuler et al. showed that patients with active 292 uveitis (n=242) had an improvement of CFT after 78 weeks of treatment with ADA whereas 293 patients with inactive uveitis (n=129) had a stability of uveitic ME (23). Schaap-Fogler et al. 294 found a significant decrease of CFT from 515 µm to 262 µm (p=0.04) after 6 months of 295 treatment with anti-TNF-α agents. Similar results were observed with TCZ at 6 months (CFT 296 decreased from 516 µm to 271 µm [p<0.001]) (24) or at 12 months (CFT decreased from 433 297 μm to 259 μm [p<0.0001]) (25).

298 The efficacy of TCZ has mostly been shown for uveitic ME refractory to anti-TNF-a agents (24,25). The originality of the BIOVAS study is to compare anti-TNF-α agents and TCZ 299 300 for their efficacy to resolve uveitic ME in non-infectious uveitis. TCZ efficacy is supported by 301 several experimental data from the literature. High levels of IL-6 were found in the aqueous 302 humor of patients with uveitis (26). Recently, Matas et al. (27) showed a correlation between 303 high serum levels of IL-6 and poor uveitic ME prognosis, whereas high levels of circulating 304 lymphocytes T regulators were associated with uveitic ME resolution. Taken together, these 305 results suggest that TCZ is a promising therapy for uveitic ME. Further prospective studies are 306 warranted to define which biologics might be used as the first therapeutic option in sight-307 threatening uveitic ME. Therefore, the French Uveitis Network developed a prospective study 308 comparing ADA and TCZ in sight-threatening uveitis (ClinicalTrial.gov NCT02929251).

309 Overall improvement of uveitic ME at 6 months of treatment was obtained in 46.2% 310 with anti-TNF- α agents and 58.5% with TCZ. Complete and partial responses were observed 311 in 21.8% and 24.4% of patients with anti-TNF- α agents and 35.8% and 22.6% with TCZ, 312 respectively. In the BIOVAS study, complete response was defined as the resolution of uveitic 313 ME, related to the new challenge to consider sight-threating uveitis. Previous studies on ADA 314 efficacy focused on the resolution of intra-ocular inflammation (anterior chamber and/or

vitreous haze) and found better outcomes, ranging from 70% (18),(28) to 90% (29) of complete
response at 6 months. These results highlight the severity of uveitic ME and the difficulty of
managing these patients, despite the current development of the therapeutic arsenal. Suhler et
al. (23) in the VISUAL III study showed that 40% of patients with active uveitis did not respond
to ADA.

320 Uveitic ME has been identified as a risk factor of visual loss in uveitis. Up to 30 to 42% 321 of patients with uveitic ME had significant visual loss in a large study of uveitic ME (5). Matas 322 et al. (30) highlighted bilateral uveitic ME, systemic disease and the presence of anterior 323 chamber cells as good prognostic factors and showed that CFT was unfavorably associated with 324 preserved vision. In our study, we showed that the risk of low visual acuity of uveitic ME was increased by 3 times in Behçet's uveitis. This risk has been reported in the literature, and 325 estimated to be as high as 25% in different studies (31,32). In a retrospective study of 107 326 327 Behçet's patients, the risk of visual loss at 10 years was 39% (33) and biologic agents were 328 identified as protective factors. Our study highlights the poor visual prognosis of Behcet's 329 disease despite therapeutic advances.

330 The adverse events observed with anti-TNF- α agents and TCZ in this study were consistent with the known safety profile of these biologics, and no new safety concerns were 331 332 identified during longer-term exposure. No evidence of new or worsening of uveitis was 333 observed. Serious adverse events were observed in 12.8% and 5.5% with anti- TNF- α agents 334 and TCZ, respectively. These results are similar to those of the VISUAL studies where 11.7% (15), 9.6% (16) and 19% (23) of serious adverse events were reported. An increased risk of 335 336 serious adverse events with IFX was previously reported (34). For TCZ, Vegas-Ravenga et al. (25) reported three adverse events (nausea, viral conjunctivitis and bullous impetigo) in 25 337 338 patients with uveitis during 12.7 months of follow-up. In the prospective STOP-uveitis study,

two of the 37 patients developed low absolute neutrophil counts, requiring treatmentdiscontinuation for one of them (20).

341 The choice of biotherapy was up to the clinician. A potential bias in our work was a 342 temporal bias. Indeed, anti-TNF- α agents were the first biotherapy used in the management of 343 uveitis, before TCZ (18). In the BIOVAS study, the median year of introduction of anti-TNFα agents was 2014 [2011-2017] compared to 2018 [2017-2018] for TCZ (p<0.0001). This time 344 345 bias may have influenced the results, in support of anti-TNF- α agents. Moreover, in our study, 346 76% of the patients treated with TCZ had previously been treated with anti-TNF- α agents, but 347 without success, suggesting more severe disease. Despite this severity and the temporal bias, 348 TCZ appeared to be more effective.

349 The comparison of our two groups shows a significant difference for age (older patients in the TCZ group) and uveitis etiologies. Seventy-six percent of the patients in the TCZ group 350 were previously treated with anti-TNF- α agents. Thus, it was expected that patients in this group 351 352 would be older. Concerning the etiological diagnoses, we did not perform subgroup studies. 353 Further studies comparing the two biotherapies according to uveitis etiologies (i.e. Behcet's 354 disease) are ongoing. However, there was no significant difference between the two groups, concerning initial ophthalmologic characteristics (visual acuity, ocular inflammation, retinal 355 356 vasculitis), thus allowing comparison of ophthalmic efficacy for the current episode.

We acknowledge some limitations in this study. Our analysis was performed as a retrospective review. We were unable to collect complete longitudinal data on patients who were seen only on an intermittent basis. Prospective enrollment and data collection from the time of diagnosis would have been ideal but more difficult to achieve with rare diseases. Although the present study only compared anti-TNF- α agents and TCZ based on observational non-randomized observations, we used a logistic regression approach to minimize a potential confounding bias.

- 364 In conclusion, TCZ has shown a tendency to be more effective than anti-TNF- α agents 365 (IFX or ADA) in the improvement of uveitic ME in this large series of refractory uveitis. In an 366 era of biologics, Behçet's disease is still the main independent factor associated with low visual 367 acuity. 368




Figure 2: Cumulative incidence of relapse with biological agents.


