- 12 Ventricular–arterial coupling (VAC) is a very interesting variable in the field of heart failure
- 13 (HF), enabling a more in-depth evaluation of patients' profile. Indeed, "vascular" scenarios
- 14 have been mentioned for years as an important entity within the scope of HF, yet without any
- practical approach to efficiently identify them. The assesment of VAC can fill in this gap. 15
- 16 A consensus document was published in the European journal of Heart failure in January
- 17 2019 presenting the assessment, clinical implications and therapeutic perspectives related to
- VAC in a clinical HF setting¹. To show the clinical usefulness of VAC, this viewpoint 18
- 19 presents the assessment of VAC in various clinical scenarios such as systemic hypertension
- and heart failure with reduced and preserved ejection fraction (HFrEF and HFpEF) 20
- 21 respectively. In order to facilitate the utilization of VAC into everyday clinical practice; a
- 22 simplifying Excel sheet for the VAC calculation is provided.
- The interplay between the heart and the arterial system has recently gained much attention 23
- since interventions that improve both myocardial and vascular functions may delay the 24
- progression to HF, valvular heart disease and possibly even improve prognosis 1.2. Today, the 25
- assessment of VAC in clinical practice is being facilitated by advances in the non-invasive 26
- 27 assessment of cardiac imaging. Traditionally, VAC has been defined as the combined marker
- 28 of arterial and myocardial function, expressed as E_a/E_{es} ratio, where E_a reflects arterial
- elastance (an index of arterial load on the left ventricle) and Ees ventricular elastance (an index 29
- of the contractility of the left ventricle)³. The E_a/E_{es} ratio has shown to be a key determinant of 30
- HF and increased arterial stiffness, both independently associated with impaired 31
- 32 microcirculation causing damage to the end organs such as the kidneys.

- The arterial elastance (Ea) is defined as the ratio of end-systolic pressure (ESP) and stroke 34
- 35 volume (SV) (ESP/SV)⁴ which is influenced by the vascular resistance, pulsatile load and
- 36 heart rate. In contrast, E_{es} is a load-independent measure of the left ventricular (LV)
- 37 contractility and reflects the slope of the end-systolic pressure-volume relationship (ESPVR),
- originated from the principles of pressure-volume curve as the ratio of ESP and end-systolic 38
- 39 volume: ESP/ESV⁵. Subsequently, E_a/E_{es} (ESP/SV)/(ESP/ESVi) can be further simplified as
- ESV/SV, after removing ESP in the equation. Ees is affected by LV chamber stiffness and 40
- 41 geometry and has an inverse correlation with LV mass.

In order to calculate Ees, invasive multi-beat intraventricular catheterization has been 1

- 2 regarded as the golden standard method. However, the non-invasive method by *Chen* et al. is
- 3 commonly used where E_{es} can be calculated by the formula: $E_{es} = (DBP - [End (est) \times SBP \times Ee])$
- 4 0.9])/End (est) × SV where DBP and SBP are diastolic and systolic arm-cuff BPs, End(est) is
- 5 the estimated normalized ventricular elastance at the onset of ejection, and SV is Doppler-
- 6 derived stroke volume (Figure 1).
- 7 To elicit VAC results in routine practice, this viewpoint presents the assessment of VAC in
- 8 various archetypal clinical scenarios such as systemic hypertension and heart failure with
- 9 reduced and preserved ejection fraction (HFrEF and HFpEF). We hope these examples will
- 10 promote the use of this formula among physicians managing patients with HF. In addition, an
- excel sheet providing embedded calculations is provided as a supplementary file. Within 11
- 12 routine care, physicians will only have to enter key variables from their echocardiographic
- exams (namely SBP, DBP, LV ejection fraction, stroke volume, pre-ejection time and ejection 13
- 14 time) and the sheet will provide correct calculations of E_{es}, E_a and VAC. This simplified sheet
- is more easily usable that the previous iOS based VAC calculators (iElastance); it reaches a 15
- wider audience as it is not tied to a platform/operating system and also allows decimals for the 16
- 17 included variables⁶.

- 18 Previous studies have shown that the optimal value of VAC derived from the E_a/E_{es} ratio
- should range from 0.5 to 1 reflecting the state when the stroke work of left ventricle is ideal^{7,8}. 19
- 20 **Patient 1** (figure) consequently corresponds to a "normal" situation, as both BP, EF, stroke
- volume, and their interplay are within normal range. 21
- 22 When arterial load (E_a) increases to the point when E_a/E_{es} >1, a VAC mismatch appears with
- subsequent lower left ventricle contractile efficiency⁹. This mismatch in VAC is often seen as 23
- the effect of increasing age and development of hypertension. Yet, the increase of E_a is met by 24
- 25 a simultaneous increase of Ees (i.e. LV contractility) which preserves the VAC despite the
- 26 presence of hypertension observed in patient 2. In the example of patient 3 with HFrEF, Ees
- is decreased as expected whilst E_a is slightly increased resulting in $E_a/E_{es} > 2$. It should be 27
- 28 acknowledged that E_a/E_{es} ratio has some limitations: i.e. it does not characterize the LV
- loading sequence¹⁰. Also, in HF with preserved ejection fraction (HFpEF), it may be normal 29
- 30 because both E_a and E_{es} are increased (patient 4). We would consequently like to emphasize
- 31 that the use of Pulse wave velocity (PWV)/ Global Longitudinal strain (GLS) ratio may be
- 32 more appropriate in a number of settings to characterize VAC since it incorporates the gold
- 33 standard methods to assess arterial load (PWV) and LV contractility (GLS). Importantly,
- 34 PWV/GLS has been shown to be better correlated with subclinical target organ damage
- (TOD) compared with the traditional echocardiographic method (E_a/E_{es})¹¹. Further, 35
- PWV/GLS might also help predicting response to resynchronization therapy and the benefit 36
- 37
- from sodium glucose transporter 1 inhibitor (SGLTi), glucagon-like protein 1 inhibitor (GLP1i) and anti-inflammatory treatment in patients with rheumatoid arthritis 12-14. Yet, even
- 38
- if PWV/GLS is likely more appropriate in a research setting, we can already use VAC in 39
- 40 routine practice, only using simple echocardiographic measurements.
- We hope that the figure presented herein (along with the provide online calculator)¹⁵ will 41
- 42 promote the adequate calculate E_a/E_{es} ratio and prompt the use of VAC in patients with HF

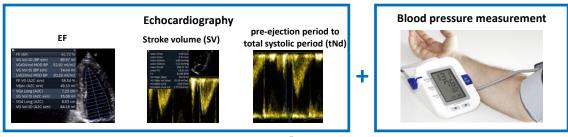
