# Impact of smoking on Cardiovascular risk and Premature Ageing: Findings from the

**Take home message:** The clinical markers of premature cardiovascular ageing seen in smokers were similar to non-smokers that were two decades older than smokers. Also, smoking was strongly associated with plasma proteins indicating inflammation, endothelial dysfunction and apoptosis.

### Abstract

**Background:** Smoking may lead to premature ageing, but the impact on the cardiovascular system and circulating proteins needs further study. In the present study, we aim to understand the impact of smoking on heart and vessels and circulating biomarkers of multiple domains including cardiovascular damage, premature ageing and cancer-related pathways.

**Methods:** The STANISLAS Cohort is a longitudinal familial cohort with detailed cardiovascular examination and biomarker assessment. This study included all the participants enrolled in the fourth visit of the STANISLAS Cohort for whom information on smoking habits was available (n= 1696). We assessed pulse wave velocity, intima-media thickness, echocardiographic parameters and a total of 460 proteins to study the association of circulating plasma proteins with smoking status (never vs. past vs. current smoking) while adjusting for potential confounders.

**Results:** Current smokers were approximately 18 years younger but had higher LVMi and similar PWV, cIMT, frequency of hypertension, diabetes and carotid plaques compared to the much older never smokers. After multivariate selection, 25 proteins were independently associated with current or past smoking. Current smoking was strongly associated with higher levels of EDIL-3, CCL11, TNFSF13B, KIT, and lower levels of IL-12B and PLTP (p < 0.0001) while past smoking was associated with FGF-21, CHIT1, and lower levels of CXCL10, IL1RL2 and RAGE (p < 0.01).

**Conclusion:** Current smoking is associated with signs of early onset of cardiovascular ageing and proteins biomarkers that regulate inflammation, endothelial function, metabolism, oncological processes and apoptosis.

# **INTRODUCTION**

Tobacco smoking is one of the most important risk factors for cardiovascular, metabolic, pulmonary, and oncological diseases, leading to more than 6 million deaths worldwide each year (1). Smoking causes life expectancy reduction, premature biological ageing, and early onset of multiple diseases (2).

Smoking can lead to an increase of vascular stiffness and carotid intima-media thickness, both of which are early markers of damage to the cardiovascular system (3, 4). On top of the damage to the cardiovascular system, smoking might induce alterations in markers related to premature ageing and oncologic diseases. Thus, assessing the impact of cigarette smoking in the cardiovascular system and in multiple circulating proteins of healthy people, might help expanding the knowledge about the early biological signature associated with smoking.

The STANISLAS (Suivi Temporaire Annuel Non-Invasif de la Santé des Lorrains Assurés Sociaux) cohort is a prospective familial cohort including mostly "healthy" participants with a detailed cardiovascular and biomarker assessment, allowing to determine the impact of smoking in multiple organ systems and circulating proteins. The main aim of the present study is to assess the association of smoking status (current, past, and never) with markers of premature cardiovascular damage, and circulating protein expression that may indicate enhanced cardiovascular risk, premature ageing, and over-expression of cancer-related pathways.

#### **PARTICIPANTS and METHODS**

## **Study population**

The details of the STANISLAS study have been published elsewhere(5, 6). Briefly, STANISLAS is a familial, longitudinal, single-centre cohort study with the objective to determine the genetic and environmental factors associated with cardiovascular disease onset, incidence and progression. The study protocols for all examinations were reviewed and approved by the Local Ethics Committee of CPP –Est 3, France. All participants provided written informed consent to participate in the study. The study data and materials can be fully available upon reasonable request to the authors.

# Study design

The STANISLAS cohort started with 4295 participants (from 1006 families) recruited from 1993 to 1995 for the first visit (V1). Visits 2 and 3 were conducted from 1998 to 2001 and from 2003 to 2004, respectively; but detailed cardiovascular examinations were not conducted, nor circulating protein biomarkers were assessed. The visit 4 (V4) was conducted from 2011 to 2015 and included 1705 participants (from 634 families). In V4, participants underwent a detailed medical history, anthropometric measures, clinical and laboratory investigations including research-quality echocardiography, vascular examinations and assessment of circulating protein profile. For this analysis, we included all the participants included in V4 and for whom information on smoking status was available.

Standardized procedures were followed for all the investigations, blood, and urine sample collection. Blood samples (EDTA, heparin) were stored at central biobank facility between -80  $^{\circ}$ C and -196 $^{\circ}$ C.

#### Smoking status and estimation of smoking duration

At V4, participants were interviewed for assessing present smoking status (never, past, and current), duration and intensity of smoking. Intermittent smokers who smoked at the time of interview were considered as current smokers. Current and past smokers were asked for how long have they been smoking and for how long have they smoked, respectively. In addition, past smokers were enquired for how long they have stopped smoking.

# **Circulating proteins**

Circulating plasma proteins were analysed using the Olink Proseek® Multiplex cardiovascular (CVD) II, III, cardiometabolic (CM), organ damage (OD) and inflammatory (INF) panels. The protein assay is based on proximity extension assay (PEA) technology, where 92 Oligoneucleotide-labelled antibody probe pairs per panel (total of  $92 \times 5$ ; n =460 proteins) are allowed to bind to their

specific target protein. Target protein bound Oligoneucleotide probe pairs hybridize giving rise to DNA amplicon with each ID- barcoding their respective antigens. The amplicons are subsequently quantified using a Fluidigm BioMark<sup>™</sup> HD real- time PCR platform. The platform provides log2-normalized protein expression (NPX) data. Full details are described in White paper from Olink (https://www.olink.com/resources-support/white-papers-from-olink/).

# **Statistical analysis**

Baseline continuous variables are expressed as mean  $\pm$  standard deviation (m  $\pm$  SD) or as median and inter quartile range depending on the normality distributions, and categorical variables as frequencies (percentage). Comparison of baseline characteristics was performed using ANOVA or Kruskal–Wallis and Chi-squared or Exact Fisher test as required.

To study the association between smoking status (current, past, never smokers) and circulating proteins, multinomial logistic regression models were used (never smokers were set as the referent category). First, the potential association of each circulating protein with current and past smoking was determined while adjusting for relevant clinical confounders at V4 (sex, age, body mass index [BMI], systolic blood pressure office [SBP], diabetes, total cholesterol, microalbuminuria, estimated glomerular filtration rate [eGFR], Pulse Wave Velocity [PWV], carotid intima media thickness [cIMT], carotid plaques, left ventricular mass index [LVMi], use of antihypertensive drugs and lipid lowering drugs). We further adjusted the above mentioned model using Ankle Brachial Index (ABI) as additional clinical confounder to verify the association of smoking status with circulating proteins (Supplemental table S4). Second, the p-value of the association of each protein biomarker was corrected for false discovery rate (FDR set at 1%) using the Benjamini-Hochberg method. Subsequently, a multivariable stepwise forward selection model set at 5% (pvalue  $\leq 0.05$  was considered to stay in the model and p-value > 0.05 was considered for removal from the model) was performed using all significant proteins at 1% of FDR and "forcing" the clinical variables in the model. Odds ratios and their 95% confidence intervals are reported for the proteins which had overall significant p-value of association with smoking status. Since the circulating proteins were measured using NPX values on a  $\log_2$  scale, the odds ratio (OR) represents the association per doubling in protein concentrations.

In addition, we assessed the association of circulating proteins with smoking status separately for the "parents" enrolled in the STANISLAS cohort to verify if the results were influenced by presence of family members (*Supplementary table S5*).

Since there was large difference in age and sex of the participants in each group, we performed a propensity score matching on age and sex on the whole population of 1696 patients. However, this method drastically reduced our sample size. We found that only 210 patients were well matched according to sex and age (70 patients in each group of never smoker, current smoker or past smoker). Thereafter, we decided to perform inverse probability weighting (IPW) analyses in order to keep the whole population in the analysis.

The propensity score (PS) representing the *a priori* likelihood of being in smoking status category (never smoker, current smoker or past smoker) was computed using multinomial logistic regression of the smoking status on characteristics for the full sample (sex, age, BMI, SBP, diabetes, total cholesterol, microalbuminuria, eGFR, PWV, cIMT, carotid plaques, LVMi, use of antihypertensive drugs and lipid lowering drugs):

An inverse probability weighting (IPW) analyses was then performed using stabilized weights (*Supplementary table S6*). The balance between the three groups (never smoker vs. current smoker, never smoker vs. past smoker and current smoker vs. past smoker) were assessed using absolute standardized mean differences. For each variable, the absolute standardized mean difference represents the absolute difference between the mean values in each two groups divided by the common SD. We performed then weighted multinomial regression models between smoking status and circulating proteins.

The two-tailed significance level was set at p<0.05. All analyses were performed using SAS version 9.4.6 (SAS Institute Inc., Cary, N.C., USA).

#### **Network Analysis**

The complex network analysis was performed using the Fight Heart-Failure Graph Knowledge Box (FHF-GKB)(7), a platform representing the most available public knowledge on the human proteins, protein-GO (Gene Ontology) terms annotation and protein-pathways relationship, provided by Edgeleap company. The FHF-GKB complex network was queried in order to explore pathways and biological process that connect the biomarkers. All the GO terms from the biological process aspect associated with the biomarkers were retrieved. Then for each GO term, the number of linked biomarkers is compared to the number of annotated proteins in the whole FHF-GK Box using Fisher's exact Test. The resulting p-values are then corrected into FDR according to the Benjamini-Hochberg procedure. Only GO terms with FDR values less than 0.05 were considered for further analysis. The resulting graph is displayed in figure 2 illustrating the main connection between proteins overrepresented biological and processes.

### RESULTS

#### **Baseline characteristics**

The mean age of participants was 55 years and 51% were women; 46% of the participants had never smoked, 32% had stopped smoking, and 22% were current smokers. (*Table 1 & Figure 1*). Current smokers were younger than past and never smokers; median age  $(pct_{25-75})$ : 36.5 (31.0 - 56.0) vs. 58.0 (52.0 - 62.0) vs. 55.0 (34.0 - 60.0), respectively (p<0.001). In current smokers, the median duration of smoking was 16  $(pct_{25-75}; 12-30)$  years.

Despite being ~18 years younger, current smokers had similar frequency of hypertension and diabetes, and had higher microalbuminuria, LVMi and lower HDL levels than never smokers. Moreover, current smokers had similar cIMT (median [pct<sub>25-75</sub>] 592.5 [510.9 - 669.0] vs 612.0

[525.0 714.0]), PWV (median [pct<sub>25-75</sub>] 7.9 [7.1 - 8.8] vs 8.0 [7.2 - 9.2]), and carotid plaques (9.8% vs 9.1%) than never smokers.

Past and never smokers had similar age, but despite the similar age a higher proportion of past smokers had diabetes, carotid plaques and used antihypertensive and lipid lowering drugs as compared to never smokers. Furthermore, cIMT was higher in past smokers compared to never smokers. A similar pattern was observed in the past smokers who stopped smoking more than 14 years ago. (*Table 1 & Supplemental Table S1*).

In "parents" subgroup of the cohort, the median  $age(pct_{25-75})$  of participants was 59 (57-63) years. Both, current smokers and past smokers had higher microalbuminuria, LVMi, PWV and increased presence of carotid plaques compared to never smokers. (*Supplemental Table S2*).

## Association of smoking status and circulating proteins

After multivariable selection, 25 proteins were independently associated with smoking: 14 with current smoking, 6 with both current and past smoking, and 5 with past smoking alone (*Table 2*).

Particularly, compared to never smokers, current smokers expressed higher levels of EDIL-3 (EGFlike repeat and discoidin I-like domain-containing protein 3), CCL11 (Eotaxin-1), TNFSF13B (Tumour necrosis factor ligand superfamily member 13B) and KIT (Mast/stem cell growth factor receptor Kit) (p < 0.0001 for all after correction for potential confounders and multiple testing). On the other hand, current smokers expressed lower levels of IL-12B (Interleukin-12 subunit beta) and PLTP (Phospholipid transfer protein) (p < 0.0001 for both after correction for potential confounders and multiple testing). A similar pattern of association of circulating protein (EDIL-3, CCL11, TNFSF13B, IL-12B, SCF/KIT, PLTP) in current smokers was seen after adjusting for ABI (*Supplemental table S4*). Similarly, after IPW analyses, CCL11, TNFSF13B, KIT, and IL-12B remained significantly associated with current smoking status (*Supplemental table S6*).

Both current and past smoker expressed higher levels of ADM (Adrenomedullin), VEGF-D (vascular endothelial growth factor -D) and IGFBP-2 (Insulin-like growth factor binding protein-2)

and lower levels of TR (transferrin receptor) and IGFBP-1(Insulin-like growth factor binding protein-1). However, VEGF-D did not remain significantly associated with the smoking status after adjustment for ABI (*Supplemental table 3*). After IPW analyses, VEGF-D and TR remained significantly associated current and past smoking (*Supplemental table S6*). However, EDIL-3 was significantly associated with both current and past smokers after IPW adjustments.

Past smoking was associated with higher levels of FGF-21 (Fibroblast growth factor 21), CHIT1 (Chitotriosidase-1), and lower levels of CXCL10 (C-X-C motif chemokine 10), IL1RL2 (Interleukin-1 receptor-like 2) and RAGE (Receptor for advanced glycosylation end products). After IPW analyses, CHIT1, FGF-21, RAGE and IL1RL2 remained significantly associated with past smoking status (*Supplemental table S6*).

In the "parents" subgroup of the STANISLAS cohort, a total of 17 proteins were significantly associated with smoking status. 11 proteins associated with smoking status in the "parents" subgroup were same as those identified in the whole cohort. Further, the pattern of association of circulating proteins with smoking status remained similar: Current smoker had significantly higher levels of CCL-25, KIT, VEGF-D and lower levels of IL-12 B and PLTP. Both current and past smokers had higher levels of KIM1 (Kidney injury molecule-11) and lower levels of TR and LOX-1 (Lectin-like oxidized LDL receptor1) and past smokers expressed higher levels PLTP, FGF-21 and lower levels of IL1RL2. (*Supplemental Table S5*).

### DISCUSSION

This study shows that current smokers have features of premature cardiovascular ageing, similar to those of people two decades older; furthermore, current smokers express higher levels of proteins associated with inflammatory processes (e.g., IL 12B, TNFSF13B, CCL11), endothelial damage/function (e.g. EDIL-3), metabolic dysregulation (e.g. PLTP), oncologic processes (e.g., KIT, EDIL-3), and apoptosis (e.g., TNFSF13B, KIT). The different protein profile of smokers, past

and never smokers could provide an insight on the underlying protein pathways of the sub-clinical changes of premature ageing and other diseases associated with smoking.

In the STANISLAS cohort, current smokers had higher LVMi and increased presence of carotid plaques compared to non-smokers. Large observational studies have reported similar findings such as ventricular hypertrophy, subclinical atherosclerosis in smokers(8, 9). Sub-clinical cardiovascular diseases like increased LVMi, PWV and carotid plaques are independent risk markers of cardiovascular morbidity and mortality. Further, PWV is linearly associated with vascular stiffness. The reference value of PWV for age group 30-39 was found to be 6.4 (5.2–8.0) m/s while that for 50-59 was 8.1 (6.3–10.0) m/s(10). The PWV of smokers (median age 36.5 years) in our study corresponds to the PWV of 50-59 years of age group, pointing towards an accelerated vascular ageing in smokers. Additionally, low HDL suggests an adverse lipid profile among current smokers (11).

Cigarette-smoke induced oxidative stress and inflammatory immune response are the two likely mechanisms that explain premature ageing and increased incidence of chronic diseases in smokers (12). Several studies have demonstrated that smoking induces a pro-inflammatory state along with accelerated ageing called "inflamm-ageing"(13, 14). Inflamm-aging is associated with overexpression of cytokines such as the TNF superfamily and its receptors, and interleukins and leads to a decline in overall health and increases the risk of multi-morbidity (14). Among current smokers, we found a strong association between smoking and overexpression of proteins mediating inflammatory response (CCL-11 and TNFSF13B). CCL-11 is a potent chemoattractant for eosinophils associated with allergic inflammatory response, while TNFSF13B, an inflammatory cytokine, regulates B-cell and T-cell activation, recruitment and survival. Our findings are concordant with previous *in vivo* studies that demonstrated cigarette smoke induces the expression of CCL-11 plays a role in vascular inflammation and the atherosclerotic process by increasing endothelial

permeability and vascular smooth muscle calcification in presence of reactive oxygen species (17, 18). On the other hand, overexpression of TNFSF13B, is associated with atherosclerotic diseases and chronic obstructive pulmonary disease (COPD)(16, 19). Moreover, TNFSF13B signalling activates NF-kB pathway and MAP/ERK kinase pathways which inhibits apoptosis and may lead to cancer progression (20). Increased expression of TNFSF13B is reported in multiple myeloma, lung and breast cancers (21). In contrast to raised TNFSF13 B and CCL-11, current smokers had reduced levels of IL-12B which is a cytokine modulator of T-cell and NK cell function. Cigarette smoke suppresses IL-12B production by activating MAP Kinase (22). Reduced levels of IL-12 predispose smokers to increased risk of bacterial infection and cancers by altering immune cell regulation (23). Moreover, in a study on the impact of lifestyle choices on ageing, it was shown that lower IL-12B predicted increase in the biological age (vs chronological age) in smokers(24).

Smokers had high expression of EDIL-3, a glycoprotein expressed by endothelial cells, which promotes neo-angiogenesis by facilitating adhesion of vascular smooth muscle cells to endothelial cells(25). EDIL-3 expression is upregulated in injured vessels walls with neo-intimal thickening (25). EDIL-3 overexpression could be a possible mechanism leading to high cIMT in smokers. Further, it is noteworthy that several studies have reported the association of EDIL-3 with pathological angiogenesis in cancer cells(26, 27). In addition, smoking upregulated KIT (receptor tyrosine kinase expression); KIT activation regulates several physiological processes. However, dysregulated KIT expression is seen in several cancers(28).

In our study, current smoking was associated with reduced levels of circulating PLTP. PLTP is a key protein in lipid metabolism and reverse cholesterol transport(29, 30). A study in normolipidemic smokers reported that smokers have 40% lower PLTP activity and had a higher concentration of pro-atherogenic lipoproteins compared to non-smokers(31). However, there are conflicting evidence regarding the PLTP activity levels and the risk of cardiovascular disease. Both, higher and lower levels of PLTP activity are associated with an increased risk of atherosclerosis(29,

30). Moreover, recent evidence suggests that PLTP may regulate inflammation and progression to COPD in lung epithelial cells in response to cigarette smoke (32).

Smoking was associated with several proteins (higher levels of EDIL-3, CCL-11, PLTP, MMP-10, TNFSF13B and lower levels of TWEAK and AXL) that are known to initiate and facilitate progression of atherosclerotic lesion. It is well-established that smoking causes atherosclerosis, a fibro fatty lesion central to cardiovascular diseases, by increasing oxidative stress, vascular inflammation and dysfunction, platelet coagulation and impaired lipid profile. CCL-11 and EDIL-3 mediate vascular inflammation - triggering vascular smooth muscle proliferation which contributes towards plaque progression. Also, CCL-11 and MMP10 cause increased calcification of vessel wall(17, 25, 33). A recent study showed that CCL-11 mediated activation of eosinophils create extracellular eosinophilic trap and enhances atherogenic platelet adhesion to vessel wall (34). Similarly, TWEAK-receptor interaction induces expression of adhesion molecule in endothelial cells and cytokine production that lead to smooth muscle cell proliferation (35). Pathological intimal thickening and calcification causes atheroma progression and plaque instability. TNFSF13B and PLTP have been associated with atherogenic potential but exact mechanisms are not yet elucidated (20, 29). In contrast, in vitro studies, have demonstrated that over expression of AXL inhibits calcium accumulation in vascular smooth muscle cells suggesting diminished protective effect at lower levels(36).

In addition, smokers had high levels of several other circulating proteins which have a role in regulating lung inflammation and alveolar matrix degradation leading to chronic obstructive pulmonary disease (SCGB3A2, MMP-10, CCL-11 and TNFS13B) (16, 37-39). Modified expression of SCGB3A2 in proximal and distal airway epithelium is associated with modulation of fibrosis in lungs and remodelling of airway epithelium seen in COPD (39, 40). However, most of the studies reported here were conducted on bronchoalveolar lavage fluid or in the *in vitro* cell lines and not in the blood or plasma of smokers. Profile of circulating proteins may be different from the protein expression at the local *milieu* in the lungs.

In past smokers, we found that there was an increased association of smoking with diabetes, raised cIMT, presence of carotid plaques and use of lipid-lowering drugs. Correspondingly, we found a significant association with markers of cardiovascular and metabolic risk (VEGFD, IGFBP-1, IL1RL2, FGF-21). Previous studies have published similar findings where past smoking was associated with increased risk of atherosclerotic diseases compared to never smokers (41). Notably, ADM, VEGF-D, IGFBP-1, IGFBP-2 and TR were significantly associated with both current and past smoking status The level of circulating proteins associated with inflammatory immune response became normalized in past smokers. These findings suggest that smoking-induced organ damage do not completely recede on smoking cessation. Despite the absence of active smoking in past smokers, the level of several circulating proteins having protective effect against vascular injury remained at comparable levels as of current smokers. In fact, ADM, VEGF and IGF/IGFBP may have large overlap with each other in their downstream signalling pathways in cardiac and endothelial cells(42). ADM and VEGF-D over-expression have a dual response on cardiovascular system; ADM reduces fluid shear-stress in vessel walls (eNOS pathway) (43), but its overexpression is also associated with increased risk of atherosclerotic plaque formation and calcification (44, 45). Similarly, VEGF-D protects against oxidative stress (46), but its overexpression increases the risk of cardiac fibrosis (47). Additionally, mechanistic studies in cell lines demonstrated that ADM upregulates VEGF expression in cell lines, thereby promoting angiogenesis (48). The IGF system plays a role in insulin sensitization, VSMC proliferation and endothelium mediated nitric oxide production(49). Over-expression of IGFBP-1 protects against oxidative stress induced senescence of human coronary arterial endothelial cells by activating akt signalling (50). In our study, smokers and past smokers had lower level of IGFBP-1 suggesting a reduced protective potential of IGFBP-1. It appears that the complex cross-talk among dysregulated protein expressions have a potential role in increased risk of cardiometabolic disease in past smokers.

Further, relatively few markers of the inflammatory response (RAGE, CXCL10) were associated with the protein profile of past smokers suggesting that smoking cessation may halt the progression towards the early onset of chronic diseases in past smokers. Similar findings have been reported previously where successful smoking cessation for over one year was associated with a significant reduction in inflammatory markers of cardiovascular diseases (51). However, lower levels of RAGE could also be due to use of statins and anti-hypertensive medication in past smokers. These drugs protect against AGE-RAGE signalling mediated harmful effects by inhibiting RAGE expression (52).

In "parents" subgroup of the cohort, a similar pattern of association was seen between circulating proteins and smoking status suggesting the results are not largely influenced by family members in the cohort. Current smoking was mostly associated with altered expressions of proteins regulating inflammatory pathway (EDIL-3, KIT, IL-12B, IL-27) whereas past smoking was associated with proteins associated with increased cardiovascular metabolic risk (FGF-21, IL1R2). Certainly, there are some changes in the protein profile in the "parents" subgroup likely due to older age of participants in this subgroup.

Few clinical trials have investigated the use of anti-inflammatory and antioxidant therapies for reducing cardiovascular risk in smokers and non-smokers and reported modest benefits (53, 54). The possible reason for the limited success of anti-inflammatory and anti-oxidant therapy could be due to the vast array of plasma proteins are altered (24, 55) and several pathways may be interlinked. However, the interaction between inflammatory markers and biomarkers of endothelial dysfunction seems to be the underlying pathological mechanisms triggered in smokers. Besides, some of the proteins may be elevated as a compensatory response to oxidative stress and organ damage. Increased expression of ADM and VEGF-D counters oxidative stress and improves vascular integrity and endothelial repair (43, 46). However, prolonged expression of these proteins may cause vascular remodelling and organ damage. These results underscore the need for a better understanding of protein pathways and assessment of novel proteins biomarkers as potential

therapeutic target in smoking-related chronic diseases. Of course, the best way to decrease the impact of smoking-related organ damage is to develop better strategies for preventing people from smoking and help those who smoke to quit as early as possible. Indeed, our study suggest that past smokers also have higher risk of organ damage, however some of that risk may be mitigated after quitting smoke.

# Limitations

Some limitations should be acknowledged in the present study. First, the analysis is cross-sectional. We cannot determine the directionality of the association between circulating proteins and smoking. Second, we could not study the influence of duration and intensity of cigarette smoking and the circulating plasma protein profiles. Third, the proteins concentrations were measured as standardized NPX value at log<sub>2</sub> scale and hence, no conversion to standard values is possible. Fourth, we could not study the association between passive smoking and circulating proteins because we did not have information about exposure to passive smoking. Lastly, we did not study the association between onset of COPD, overt cardiovascular disease or cancers and circulating proteins because of the very young age of smokers. Nevertheless, investigating the changes in the protein profile due to smoking will enhance the understanding of protein pathways that contribute towards the protective as well as the causative role of circulating proteins in smoking-related diseases.

#### Conclusion

Current smoking was associated with signs of vascular ageing such as raised PWV, cIMT and more frequent carotid plaques. Further, several protein biomarkers of premature ageing, cardiovascular disease, inflammation, and cancer-related pathways were associated with smoking. The distinct protein profile of current and past smokers provides insight into protein pathways that may be involved in the onset of smoking-related diseases and may help in the development of preventive strategies.
