Distinct Pathological Pathways in Patients with Heart Failure and Diabetes

138 Abstract

Background. Diabetes adversely affects clinical outcomes and complicates treatment in patients
with heart failure (HF). A clear understanding of the pathophysiological processes associated
with type 2 diabetes in HF is lacking.

Methods. We performed network and pathway overrepresentation analyses to identify unique pathological pathways in patients with and without diabetes using 92 biomarkers from different pathophysiological domains measured in plasma samples of 1572 patients with HF (31% diabetes) and reduced ejection fraction (HFrEF; LVEF <40%). We validated our results in an independent cohort of 729 patients (30% diabetes).

Results. We first compared biomarker profiles between HF patients with and without diabetes. Patients with diabetes showed higher levels of galectin-4, GDF-15 and FABP-4 and lower levels of PON-3. We then performed network analyses that revealed that epidermal growth factor receptor (EGFR) and galectin-3 were the most prominent connecting proteins. Translation of these networks to biological pathways revealed that diabetes was associated with inflammatory response and neutrophil degranulation. Diabetes conferred worse outcomes after correction for an established risk model (hazard ratio [HR] 1.20; 95% CI 1.01-1.42).

Conclusion. Concomitant diabetes in patients with HFrEF is associated with distinct pathophysiological pathways related to inflammation, protein phosphorylation and neutrophil degranulation. These data support the evaluation of anti-inflammatory therapeutic approaches, and EGFR in particular, for patients with HF and diabetes.

Condensed abstract

189 Introduction.

Diabetes is present in 30 - 40% of patients with heart failure (HF) with reduced ejection fraction (HFrEF)(1–3) and increases the risks of mortality and hospitalization for HF(4–6). Patients with DM have an increased risk of developing HF and patients with HF are at increased risk for developing DM(7, 8) and increases the risks of mortality and hospitalization for HF(4–6). Therefore, we need to better understand potential pathophysiological differences between HF patients with and without diabetes.

Network analyses can identify relevant pathophysiologic mechanisms by enriching empirically found biomarkers within the context of disease pathways(9–12). Therefore, we aimed to (1) compare the characteristics of the patients with and without DM, (2) use network analyses to compare biomarker profiles and associated pathways in patients with DM compared to those without DM, which might offer new avenues for potential therapeutic targets.

202 Methods.

203 *Patient population.*

We studied patients from the BIOSTAT-CHF project, which is described elsewhere (13, 14). In 204 brief, BIOSTAT-CHF includes two cohorts of patients with HF. The main aim of BIOSTAT-205 CHF was to characterize biological pathways related to response/no-response to guideline-206 recommended pharmacological therapy for heart failure. Our index cohort consisted of 2516 207 208 patients with HF from 69 centers in 11 European countries. Inclusion criteria for the index cohort 209 include: patients with >18 years of age, having symptoms of new-onset or worsening HF, confirmed either by a LVEF of ≤40% or BNP and/or NT-proBNP plasma levels >400 pg/ml or 210 211 >2,000 pg/ml, respectively. All patients were sub-optimally treated with ACEi/ARBs and/or beta-blockers, and anticipated initiation or uptitration of ACEi/ARBs and beta-blockers to ESC
recommended target doses. Patients in both the index and validation cohort could be enrolled as
in-patients or from out-patient clinics(13). Biomarkers were available in 1572 patients with
LVEF <40% of the index cohort (supplementary figure 1)(15). We validated our results in an
independent cohort of 1738 patients from 6 centers in Scotland, UK. In total, 729 patients had an
LVEF <40% and biomarker data available. Diabetes was defined as having a medical history of
diabetes and/or being on anti-diabetic medication.

220 *Clinical and biomarker measurements.*

Medical history, current use of medication and a physical examination were all recorded at 221 222 baseline. A large biomarker panel with 92 biomarkers was measured in the index and validation 223 cohort. An overview of biomarkers and their pathophysiological function are presented in 224 supplementary table 1. Assay characteristics are presented in supplementary table 2. Biomarkers were measured using a high-throughput technique using the Olink Proseek® Multiplex CVD III 225 226 96x96 kit, which measures 92 manually-selected cardiovascular-related proteins simultaneously 227 in 1µl plasma samples. The kit uses a proximity extension assay (PEA) technology, where 92 oligonucleotide-labeled antibody probe pairs are allowed to bind to their respective target present 228 in the sample. PEA is a homogeneous assay that uses pairs of antibodies equipped with DNA 229 230 reporter molecules. When binding to their correct targets, they give rise to new DNA amplicons each ID-barcoding their respective antigens. The amplicons are subsequently quantified using a 231 Fluidigm BioMark[™] HD real-time PCR platform. The platform provides normalized protein 232 expression (NPX) data wherein a high protein value corresponds to a high protein concentration, 233 but not an absolute quantification. 234

236 *Role of funding source*

The source of funding did not influence the study design or collection of the data nor theanalyses or interpretation of the data or writing of the manuscript.

240 *Statistical analysis.*

Differences between clinical characteristics of patients with and without diabetes were tested 241 using Student's t-test, the Mann-Whitney-U test or the chi-square-test where appropriate. 242 243 Differences in expression of biomarkers between patients with and without diabetes was 244 performed using the Linear Models for Microarray data analysis (Limma; software (version 3.34.9)(16) with a false discovery rate of 0.05 according to the Benjamini-Hochberg method and 245 246 a log2 fold change cutoff of 0.2. In addition, to test independence of associations, we performed 247 multivariable logistic regression analyses to test the independent association of biomarker with 248 diabetes status, correcting for relevant clinical confounders including age, sex, body mass index 249 (BMI), ischemic etiology of HF, history of hypertension and eGFR. Similarly, for both the index 250 and validation cohort, biomarkers that passed the cut-off values for the FDR corrected p-value 251 and log2 fold change cutoff were then used in subsequent network analyses. To provide 252 biological context to the proteins found, we created a general network of human physical PPI, 'HsapiensPPI', consisting of 17,625 unique nodes with 330,157 interactions between them based 253 254 on data from BIND(17), BIOGRID(18), DIP(19), HPRD(20), INTACT(21) and pdzBase(22) 255 (see supplementary methods). Context-specific networks were constructed by selecting nodes and interactions that occur only between members from the protein list being investigated (N0-256 257 networks, colored as orange) and/or by selecting nodes that indirectly interact, one-neighboraway, with members of the list (N1- networks, colored as blue). Physical cohesiveness of 258 context-specific networks were assigned using the Physical Interaction Enrichment(PIE) 259

260 procedure that corrects for biased enrichment, in general PPI networks, of proteins that are, e.g., often studied (23). Analysis of PPIs was performed and plotted using Cytoscape version 261 3.7.0(24), where the node size corresponds to the betweenness centrality(11, 24). A larger node 262 size, the more connected the node is in the network. Pathway overrepresentation analyses was 263 performed using EnrichR, using gene ontology (GO) terms (25, 26). Survival analyses was 264 performed using R version 3.5.1 using the Survival and Survminer packages(27). Cox regression 265 analyses was used for multivariable survival analyses. Multivariable correction was performed 266 using the BIOSTAT-CHF risk model, which includes age, blood urea nitrogen (BUN), N-267 terminal pro-B-type natriuretic peptide (NT-proBNP), hemoglobin (Hb), the use of a beta-268 blocker at time of inclusion, HF-hospitalization in year before inclusion, peripheral edema, 269 systolic blood pressure, high-density lipoprotein cholesterol and sodium. All tests were 270 performed two-sided and a p-value of smaller than 0.05 was considered statistically significant. 271

273 **Results.**

274 Baseline characteristics and clinical outcome

Among 1572 patients with HFrEF, 493 (31%) had diabetes. Patients with diabetes were slightly 275 older (69 vs, 67 years, P=0.002), had a higher BMI (29 vs. 27 kg/m², P <0.001) and had worse 276 signs and symptoms of HF in comparison to patients without diabetes (Table 1). Furthermore, 277 patients with diabetes more often had a history of hypertension (72% vs. 53%, P < 0.001) 278 279 compared to patients without diabetes. Among patients with diabetes, 322 (65%), 183 (37%) and 345 (70%) were on oral anti-diabetic medication, insulin or diet controlled respectively. 280 Furthermore, patients with diabetes had worse eGFR (lower), but similar NT-proBNP levels 281 compared to patients without diabetes (Table 1). Patients in the index cohort, were slightly 282

younger and more often in NYHA class III/IV compared to the validation cohort, but had asimilar prevalence of comorbidities as well as signs and symptoms (supplementary table 3).

286 Differential protein expression, network and pathway enrichment analyses

287 In the index cohort, 10 proteins were significantly upregulated and 1 protein was significantly downregulated in patients with diabetes compared to patients without diabetes (Figure 1A & B). 288 In the validation cohort, 13 proteins were significantly upregulated and 3 proteins were 289 significantly downregulated in patients with diabetes compared to patients without diabetes 290 (Figure 1B). In both cohorts, 8 proteins were significantly upregulated. These include Chitinase-291 3-like protein 1 (CHI3L1), fatty-acid binding protein 4 (FABP4), galectin-4 (GAL4), trefoil 292 factor 3 (TFF3), tumor necrosis factor receptor 1 and 2 (TNFR1 and TNFR2), TNFR super 293 family 14 (TNFRSF14) and growth differentiation factor 15 (GDF15). Paraoxonase 3 (PON3) 294 295 was downregulated in both cohorts. After additional correction for age, sex, BMI, an ischemic etiology of HF, history of hypertension and eGFR, biomarkers remained differentially expressed 296 in patients with diabetes compared to those without (P for all <0.05). When investigating the 297 298 association of these biomarkers with diabetic medication (oral vs insulin), levels of TNFR2 (OR: 0.76; 95%CI 0.59-0.99) and TNFRSF14 (OR 0.75; 95%CI 0.56-0.98) were slightly lower in 299 patients on oral medication compared to those not on oral medication after correcting for age, 300 sex, BMI, ischemic etiology of HF, history of hypertension, and being on insulins or diet 301 controlled. 302

Results of network analyses are shown in figure 2A. The size of the nodes reflects the number of shortest paths running through the node (edge-betweenness), the larger the node, the higher the number of shortest paths run through the node within the network. In other words, a larger node reflects a greater connectedness within the network. The color of the node relates to
either empirically found proteins (orange) or propagated nodes in the N1 network (blue). In the
index cohort, epidermal growth factor receptor (EGFR), galectin 3 (GAL3) and granulin (GRN)
were important nodes (hubs) in the network of diabetics (Figure 2A). A summary of the proteins
measured and their respective functions can be found in supplementary table 1.

We then performed functional classification of our N1 networks (Figure 2A) by contrasting the networks against gene ontology terms. The top 10 enriched pathways implicated several key pathways involved in the pathophysiology of HF. Pathways relating to positive regulation of intracellular transduction as well as inflammatory response, neutrophil degranulation and neutrophil mediated immunity were overrepresented (figure 2B).

317 *Clinical outcomes*

Compared to patients without diabetes, patients with diabetes were more likely to die or get 318 319 hospitalized for HF within 2 years (hazard ratio [HR] 1.32; 95%CI 1.06-1.66, survival curve as 320 shown in Supplementary figure 2). A similar increase in risk for death and/or heart failure 321 hospitalization was found in the validation cohort (HR:1.63; 95%CI 1.28-2.08, p<0.0001). 322 Among patients who died, patients with DM died equally of CV causes compared to those 323 without DM in both the index (68% vs 68%, P = 0.987) and validation cohort (68% vs 65%, P =324 0.77). After correction for the BIOSTAT risk model, patients with diabetes were at higher risk for the primary composite outcome in the index cohort (HR 1.20; 95%CI 1.01-1.42). However, 325 326 this association was attenuated in the validation cohort (HR 0.92; 95%CI 0.42-1.97). Additional correction for ischemic etiology of HF attenuated the association in the index cohort (HR 1.15; 327 95%CI 0.96-1.36). Of the 10 differentially expression biomarkers, only GDF15 was 328

independently associated with the primary combined outcome after correction for the BIOSTAT-CHF risk model (supplementary table 4). Correcting for GDF15 on top of the clinical risk model, attenuated the association of DM with higher rates of the composite primary outcome (P = 0.07).

332 Discussion.

This is the first study using comprehensive network analyses to distinguish pathophysiological pathways in HF patients with and without diabetes. In two independent cohorts we found that patients with diabetes had higher levels of galectin-4, GDF15 and FABP4 and lower levels of PON3. Furthermore, network analyses showed that EGFR, galectin-3 and granulin are important hubs in HF patients with diabetes. Lastly, we found that specific pathophysiologic processes in diabetes are associated with inflammation and neutrophil degranulation.

In a previous study, network analyses was used to compare biomarker profiles between 339 patients with HFrEF and HFpEF (28), where patients with HFpEF had increased inflammation to 340 those with HFrEF. In the present study, patients with diabetes and HFrEF have an upregulation 341 of inflammatory pathways, suggesting that inflammation might also play an important role in 342 patients with HFrEF and diabetes. In the BIOSTAT-CHF study, patients with diabetes and 343 HFrEF were more likely to die or get hospitalized for HF within the first 2 years compared to 344 patients with HFrEF without diabetes. These findings are in line with earlier results from the 345 CHARM-study, which reported similar results (6). 346

A better understanding of the pathophysiology of diabetes in HFrEF is a prerequisite for identifying novel treatment targets and effectively treating diabetes in patients with HFrEF. In the first step of our analyses, we compared biomarker levels between patients with and without diabetes. Our study found that GDF15, galectin-4 and FABP4 were considerably higher in patients with diabetes, while levels of PON3 were lower. Of note, none of the biomarkers 352 identified as hubs within the present study identified patient endotype membership in our previous publication(15), which is also in line with the observation that the prevalence of 353 diabetes did not strongly differ between endotypes. Furthermore, levels of GDF15 are increased 354 in HFrEF and might predict new onset HF in patients with diabetes(10, 31–33). Galectin-4 is 355 involved in inflammation, but no data is available on the role of galectin-4 in patients with 356 concomitant diabetes and HF (34). FABP4 independently predicts left ventricular hypertrophy 357 and dysfunction as well as incident HF in non-diabetic populations (35, 36). PON3 is potentially 358 cardioprotective and attenuates atherogenesis in mice (37). There is evidence that paraoxonases 359 360 prevent the development of HF and has anti-inflammatory properties, but is often reduced in the presence of atherosclerosis. 361

To provide biological context, we performed network analyses using biomarkers that 362 were differentially expressed between patients with and without diabetes to identify protein-363 protein interactions in patients with diabetes compared to those without. An earlier study in 364 patients with acute HF from the PROTECT trial, found that among patients with DM, levels of 365 366 inflammatory markers (TNFR-1a, periostin) and angiogenesis (VEGFR, angiogenin) were significantly increased(9). In addition, network analysis in this study suggested that 367 368 inflammation and cardiac fibrosis are potentially increased in patients with DM (9). The present studies extends on these previous findings by (1) providing more comprehensive analysis using 369 more biomarkers in a larger number of patients and (2) providing independent validation of our 370 371 findings. Network analyses revealed that EGFR and galectin-3 were important hubs. Galectin-3 is associated with both new onset diabetes as well as severity of HF(38, 39). In HF, galectin-3 is 372 increased and associated with cardiac fibrosis, LV dysfunction and higher mortality(39). EGFR 373 374 is a transmembrane protein serving as a receptor for epidermal growth factor. Aberrant EGFR

signaling is strongly implicated in diabetic nephropathy and HF in experimental studies(41, 42).
EGFR inhibition with gefitinib had a protective effect on cardiac remodeling, decreased cardiac,
decreased collagen deposition and improved levels of BNP and Troponin-I in a diabetic mouse
model(43). In humans, EGFR-inhibitors such as Cetuximab, Panitumumab and Erlotinib are
currently used to treat several forms of cancer including breast, colon, lung and pancreatic
cancer(44). Taken together, our results suggest that EGFR inhibition in patients with DM and HF
might warrant further study.

In the following step of our analyses we used pathway enrichment analyses to identify 382 383 biological pathways upregulated in patients with diabetes. We found that enriched biological pathways in patients with diabetes were associated with inflammatory response and neutrophil 384 degranulation. This is in line with earlier suggestions by Paulus et al, where the authors 385 suggested that this excess inflammation might be mediated by advanced glycation end products 386 (AGEs) deposition(47-51). Our results highlight the importance of pathways related to 387 inflammation and EGFR in patients with HFrEF and diabetes, which might warrant future 388 389 studies into patient specific drug programs involving these pathways.

391 Limitations.

BIOSTAT-CHF is primarily a Caucasian cohort and extrapolation of results to other ethnicities is unclear. Despite rigorous attempts to identify all patients with diabetes, the diagnosis might have been missed in some patients. However, the fact that no non-diabetic patients were on antidiabetic medications (and even not on diet), makes this unlikely. HbA1c was only available in a limited number of patients. Lastly, no information is available on duration of diabetes, which might have influenced results. Our biomarker panel of 92 proteins is limited. Future studies with a more comprehensive set of proteins or genes would likely provide more pathophysiological
differences between diabetic versus non-diabetic HFrEF patients.

401 **Conclusion.**

In the present study we show that concomitant diabetes in patients with HFrEF is associated with distinct pathophysiological pathways, related to inflammation, protein phosphorylation and neutrophil degranulation. These data support the evaluation of anti-inflammatory therapeutic approaches, and epidermal growth factor receptor in particular, for patients with HFrEF and diabetes.
