1 Effect of Empagliflozin on Circulating Proteomics in Heart Failure: Mechanistic 2 Insights from the EMPEROR Program

1 Abstract

- 2 Background: Sodium glucose co-transporter 2 (SGLT2) inhibitors improve
- 3 cardiovascular outcomes in diverse patient populations, but their mechanism of
- 4 action requires further study.

Aims: To explore the effect of empagliflozin on circulating levels of intracellular
 proteins in patients with heart failure, using large-scale proteomics.

- 7 *Methods*: Over 1250 circulating proteins were measured at baseline, week 12 and
- 8 week 52 in 1134 patients from EMPEROR-Reduced and EMPEROR-Preserved,

9 using the Olink® Explore 1536 platform. Statistical and bioinformatical analyses

- 10 identified differentially expressed proteins (empagliflozin vs placebo), which were
- 11 then linked to demonstrated biological actions in the heart and kidneys.
- 12 *Results*: At week 12, 32 of 1283 proteins fulfilled our threshold for being differentially
- expressed, i.e., their levels were changed by $\geq 10\%$ with a false discovery rate < 1%
- 14 (empagliflozin vs placebo). Among these, nine proteins demonstrated the largest
- 15 treatment effect of empagliflozin: insulin-like growth factor-binding protein 1,
- 16 transferrin receptor protein 1, carbonic anhydrase 2, erythropoietin, protein-
- 17 glutamine gamma-glutamyltransferase 2, thymosin beta-10, U-type mitochondrial
- creatine kinase, insulin-like growth factor-binding protein 4, and adipocyte fatty acid-
- 19 binding protein 4. The changes of the proteins from baseline to week 52 were
- 20 generally concordant with the changes from baseline to week 12, except
- empagliflozin reduced levels of kidney injury molecule-1 by ≥10% at week 52, but not
- 22 at week 12. The most common biological action of differentially-expressed proteins
- appeared to be the promotion of autophagic flux in the heart, kidney or endothelium,
- 24 a feature of 6 proteins. Other effects of differentially-expressed proteins on the heart
- included the reduction of oxidative stress, inhibition of inflammation and fibrosis, and
- the enhancement of mitochondrial health and energy, repair and regenerative
- 27 capacity. The actions of differentially expressed proteins in the kidney involved

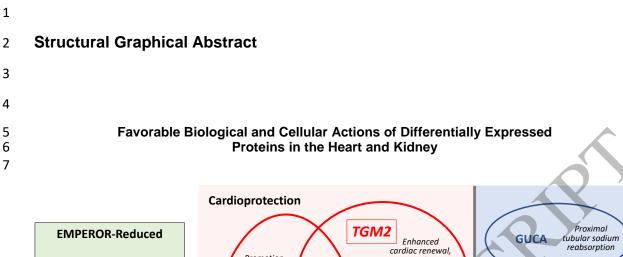
promotion of autophagy, integrity and regeneration, suppression of renal

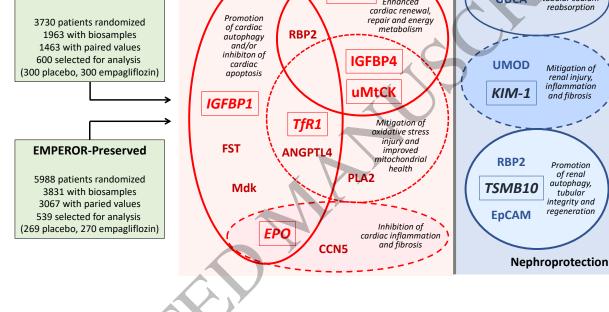
29 inflammation and fibrosis, and modulation of renal tubular sodium reabsorption.

30 Conclusions: Changes in circulating protein levels in patients with heart failure are
 31 consistent with the findings of experimental studies that have shown that the effects
 32 of SGLT2 inhibitors are likely related to actions on the heart and kidney to promote
 33 autophagic flux, nutrient deprivation signaling and transmembrane sodium transport.

1 Introduction

2

Sodium-glucose co-transporter 2 (SGLT2) inhibitors improve cardiovascular
outcomes across a wide range of high-risk patients, including those with type 2
diabetes, chronic kidney disease, and heart failure with a reduced or preserved
ejection fraction.¹ These benefits have been characterized by a decrease in the risk
of cardiovascular mortality and heart failure hospitalizations and a reduction in major
adverse renal events.²

9

The underlying mechanisms by which SGLT2 inhibitors improve heart failure and 10 11 renal outcomes are incompletely understood. Recent evidence suggests that SGLT2 inhibitors may induce a state of starvation mimicry, characterized by enhanced 12 nutrient deprivation signalling and autophagic flux, which leads to an improvement in 13 mitochondrial function, a decrease in oxidative stress, and suppression of 14 proinflammatory and profibrotic pathways.³ It has also been hypothesized that 15 SGLT2 inhibitors may decrease the activity of sodium-hydrogen exchangers in the 16 heart and kidneys, which may reduce intracellular sodium in cardiomyocytes and 17 promote urinary sodium excretion.⁴ Mediation analyses have identified increases in 18 haemoglobin and decreases in uric acid as statistical intermediaries of the benefits of 19 SGLT2 inhibitors on heart failure and renal outcomes.^{5,6} Changes in haemoglobin 20 and uric acid may reflect the effects of enhanced nutrient deprivation signalling on 21 erythropoietin production and the effects of augmented autophagic flux on oxidative 22 stress.3,7 23

We performed large-scale proteomic analyses of biosamples collected in the
 EMPEROR-Reduced and EMPEROR-Preserved trials before and following short and long-term treatment with empagliflozin to gain insights into the potential
 mechanisms of action of SGLT2 inhibitors in patients with chronic heart failure.

3 Study Populations and Biosampling

A total of 9718 patients were randomized into the EMPEROR-Reduced (n=3730) 5 and EMPEROR-Preserved (n=5988) trials. Participation in sampling for biobanking 6 7 of plasma, serum, DNA, and urine was voluntary and not a prerequisite for participation in the trials. Biosamples were collected only if a separate informed 8 consent had been signed, in accordance with local ethical and regulatory 9 requirements. The countries that participated in the biobanking substudy and the 10 methodology of sample collection are described in Supplementary Methods 1. 11 12 In EMPEROR-Reduced, 3831 patients gave consent for the collection of biosamples, 13 and of these, 1963 patients had samples available at baseline (i.e., before 14 randomization) and at one or both on-treatment sampling visits (at week 12 or week 15 52). In EMPEROR-Preserved, of the 3067 patients who gave consent for the 16 collection of biosamples, 1463 patients had samples available at baseline and at one 17 or both on-treatment sampling visits (at week 12 or week 52). The plasma samples 18 of 600 patients (out of 1963) in EMPEROR-Reduced and of 539 (out of 1463) in 19 EMPEROR-Preserved were randomly selected, and patients were stratified by 20 treatment assignment and data availability. This sample size was determined by 21 budgetary constraints. A total of 599 patients (out of the 600) in EMPEROR-22 Reduced and 535 (out of 539) in EMPEROR-Preserved had good quality samples 23 with available data both at baseline and at one or both post-randomization visits; 24 thus, a total of 1134 patients were included in the pooled analysis (EMPEROR-25 Pooled), see Supplementary Methods 2. 26

In these 1134 patients, measurements of circulating proteins were performed using
the Olink® Explore 1536 platform, which utilizes proximity extension assay (PEA)
technology with a dual-recognition DNA-coupled readout, in which oligonucleotide-

labelled antibody probe pairs bind to their respective targets.⁸ The Olink[®] Explore 1 1536 platform consists of 1472 protein assays and 64 internal controls, and divided 2 into four 384-plex panels, and in each panel, overlapping assays of interleukin-6, 3 interleukin-8, and tumor necrosis factor- α are included as an additional quality 4 5 control. The platform provides log₂ normalized protein expression values with relative quantification. Performance of the assays was blinded to the treatment allocation. 6 Samples were allocated in a random order to avoid any systematic influence of study 7 or timepoint. Protein expression values were missing when samples failed quality 8 control (as specified by the manufacturer), and missing values were not imputed. 9 Proteins that were below the limit of detection in >33% of baseline samples were 10 excluded from the analysis. A total of 1283 proteins were evaluated. 11

13 Statistical and Bioinformatical Analysis

14

Differences in the level of proteins were assessed using mixed models for repeated 15 16 measurements, in which we calculated the between-group difference (empagliflozin vs placebo) in the change in plasma concentrations for each protein from baseline to 17 week 12 and week 52, while adjusting for the baseline covariates that had been 18 19 prespecified in the statistical plan for each trial (i.e., age, sex, geographical region, diabetes, left ventricular ejection fraction, estimated glomerular filtration rate 20 [eGFR]). We also prespecified an adjustment for the baseline protein expression 21 and trial assignment (EMPEROR-Reduced and EMPEROR-Preserved). The change 22 23 from baseline in eGFR was included as a covariate in a post hoc sensitivity analysis. 24

We identified differentially-expressed proteins as those fulfilling two independent criteria: (1) proteins with $|\log_2 \text{ fold change}| > \log_2(1.1)$, corresponding to a $\geq 10\%$ increase from baseline ($\log_2 \text{ fold change} > 0.1375$) or a symmetric >9.09% decrease from baseline; and (2) a false discovery rate q-value (FDRq) <1%, which applies a Benjamini-Hochberg correction to the raw P-value, in order to minimize inflation of a false positive error rate due to multiplicity of comparisons.⁹ Significance of
differences between treatment effects at week 12 and 52 were investigated by a

3 treatment-by-visit interaction term in the model.

4

5 All proteins measured in the Olink[®] platform are known to exert diverse function

- 6 across many biological domains. We initially grouped differentially-expressed
- 7 proteins according to their reported actions in oncology, but these groupings had
- 8 little meaning in cardiology and nephrology. Therefore, we performed an extensive
- 9 biomedical literature search to identify the biological effects of differentially-
- 10 expressed proteins in the heart and kidneys.

12 **Results**

- 14 Patient Characteristics
- 15

The 1134 patients had a mean age of 70 years, 32% were women, 85% were White, 16 and 57% were recruited in Europe. In addition, 48% had type 2 diabetes, the mean 17 left ventricular ejection fraction was 40%, and the mean eGFR was 61 ml/min/1.73 18 m². When the 1134 patients whose biosamples were analysed were compared with 19 the 8584 patients who were randomized in the EMPEROR trial but were not 20 represented in the current analyses, patients not in the current analysis were more 21 likely to be women (37% vs 32%), less likely to be White (72% vs 85%), or from 22 Europe (40% vs 57%), and had a higher ejection fraction (45% vs 40%), 23 Supplementary Table 1. 24

1 Differentially Expressed Proteins at Week 12

Based on our prespecified criteria and covariate adjustment, 32 of 1283 proteins
fulfilled our threshold for being differentially expressed at week 12; all were
increased by ≥10% (log₂ fold change > 0.1375) and had a false discovery rate < 1%
(corresponding generally to a raw P-value < 0.0007 for the difference between
empagliflozin and placebo), Table 1.

9 Among these, nine proteins demonstrated the largest treatment effect of empagliflozin (log₂ fold change > 0.201 (corresponding to a >15% increase with a 10 11 false discovery rate < 1%. These were insulin-like growth factor-binding protein 1 (IGFBP1), transferrin receptor protein 1 (TfR1), carbonic anhydrase 2 (CA2), 12 erythropoietin (EPO), protein-glutamine gamma-glutamyltransferase 2 (TGM2), 13 thymosin beta-10 (TMSB10), mitochondrial creatine kinase U-type (uMtCK), insulin-14 like growth factor-binding protein 4 (IGFBP4), and adipocyte fatty acid-binding 15 16 protein 4 (AFABP4). Among these, the effect of empagliflozin on TfR1 was particularly noteworthy with a nearly 20% increase and an exceptionally low false 17 discovery rate (2.5×10^{-10}) with a raw P-value of 1.9×10^{-13} . 18 19

The effects of empagliflozin (corrected for placebo) on all measured circulating 20 21 proteins (corrected for placebo) from baseline to week 12 are shown in Supplementary Table 2 and displayed in Supplementary Figure 1. No differentially 22 expressed protein showed a statistically significant interaction between EMPEROR-23 Reduced and EMPEROR-Preserved at week 12, Supplementary Table 3. No 24 differentially expressed protein met the criteria for a meaningful decrease in level at 25 26 week 12. Of note, N-terminal prohormone B-type natriuretic peptide declined at 12 weeks, but the change was not statistically significant. 27

In a post hoc sensitivity analysis, we examined the effects of empagliflozin vs 1 placebo on the changes in protein levels from baseline for all 1283 proteins after the 2 inclusion of the change in eGFR from baseline to week 12 as an additional covariate. 3 No new proteins were found to be differentially expressed. Of the 32 differentially 4 5 expressed proteins in our original model, adjustment for the change in eGFR did not meaningfully influence the effect size for proteins with the largest treatment effect, 6 but 5 of the 6 proteins with the smallest changes in our original model now fell 7 meaningfully below the threshold of log₂ fold change of 0.1375 following adjustment 8 (Table 1). For the remaining 27 proteins, the false discovery rate generally 9 increased modestly, but remained < 5% for all proteins, and was < 2% for all but 4 10 proteins. 11 12 Differentially Expressed Proteins at Week 52 13 14 The changes of the proteins from baseline to week 52 were generally concordant 15

16 with the changes from baseline to week 12 (Supplementary Figure 1), as demonstrated by a lack of significant treatment-by-time interactions for all proteins, 17 with one exception. When compared with placebo, empagliflozin did not have a 18 19 meaningful effect on kidney injury molecule-1 (KIM-1) at week 12, but it decreased KIM-1 at week 52 (Figure 1), log₂ fold change -0.18 (95% CI -0.10 to -0.27), a 12% 20 21 decrease with a false discovery rate of 0.006%. The effect of empagliflozin on KIM-1 at 52 weeks was significantly different from that at 12 weeks, visit-by-treatment 22 interaction false discovery rate of 0.008%. 23

25 <u>Biological Actions of Differential Expressed Proteins on the Heart and Kidney</u> 26 27

24

As noted above, after adjustment for changes in eGFR, the circulating levels of 27 proteins were increased by $\approx 10\%$ or more by empagliflozin at 12 weeks, and one 1 protein was decreased by at least 10% by the drug at 52 weeks. The known

2 biological effects of these 28 proteins are shown in Table 2.¹⁰⁻⁶²

Fourteen proteins have established effects in the heart, and of these, the most
common effect was the promotion of autophagic flux (5 proteins), which was
particularly characteristic of the three cardiac-acting proteins that had the largest
effect size (IGFBP1, TfR1 and EPO), Table 1.^{10,13,15} Most of the other 11 proteins
have been shown to reduce oxidative stress or its consequences, inhibit apoptosis,
inflammation and fibrosis, and enhance the energy, repair and regenerative capacity
of the heart (Table 2 and Figure 2).

Nine proteins have established effects in the kidney (Table 2), and of these, three
proteins (carbonic anhydrase 2, guanylin and uromodulin) have actions on sodium
transport in the renal tubules.^{46,47,50} Two proteins have been shown to inhibit renal
injury, inflammation, and fibrosis (uromodulin and KIM-1),^{51,54} and three proteins play
a role in promoting renal autophagy, tubular integrity and regeneration (RBP2,
TSMB10 and EpCAM), Figure 2 and Table 2.^{24,56,57}

19 Discussion

Our proteomics analysis of blood samples taken from participants pooled from the 20 EMPEROR-Reduced and EMPEROR-Preserved trials indicate that circulating levels 21 of approximately 30 proteins changed meaningfully during SGLT2 inhibition with 22 empagliflozin (Structured Graphical Abstract). Concentrations of these proteins 23 changed by at least 10%, and they did so with substantial consistency, yielding 24 results that were highly statistically significant, even after major adjustment for 25 multiplicity of testing. Our thresholds for identifying differentially expressed proteins 26 were similar to or more stringent than those used in other cardiovascular proteomics 27 analyses; we used a false discovery rate of < 1%, rather than the < 5% that has 28

been commonly used in other studies.⁶³ Importantly, the changes in the circulating 1 levels of most differentially-expressed proteins were not related to changes in renal 2 clearance than may have been produced by empagliflozin as a result of its action to 3 reduce intraglomerular filtration pressures, since our results did not meaningfully 4 5 change following adjustment for changes in glomerular filtration rate. It should be understood that most of the proteins that we assessed act intracellularly, and it is 6 plausible that changes in circulating levels parallel changes in the intracellular 7 concentration of these proteins with subsequent release from cytosol. However, the 8 magnitude of this release does not necessarily reflect the intracellular expression or 9 activation of these proteins, whose stochiometric relationships may not be linear. 10 Furthermore, our proteomics analyses cannot identify the organ sources of this 11 protein release. 12

In experimental studies, SGLT2 inhibitors have been shown to exert cardioprotective 14 and nephroprotective effects by promoting autophagic flux and mitigating apoptosis, 15 muting oxidative and other cellular stresses, inhibiting proinflammatory and 16 profibrotic pathways, and enhancing cellular energy stores and metabolism.^{3,64-68} It 17 is therefore noteworthy that most of the 33 differentially expressed proteins identified 18 in our proteomics analyses have been shown to exert favourable effects on the heart 19 and kidney in hypothesis-driven experimental studies performed in animal models of 20 cardiac and renal injury (Table 2). Of particular note, six proteins have been shown 21 to promote autophagic flux in the heart, kidney or endothelium, i.e., IGFBP1, TfR1, 22 EPO, follistatin, ANGPTL4 and RBP2.^{10,11,13,15,19, 24,30} 23

Five proteins have been shown to reduce the levels or consequences of oxidative
stress and improve mitochondrial health in the myocardium (TfR1, PLA2,

27 ANGLPTL4, IGFBP4 and uMtCK).^{13,28,29,31,36} Four proteins have been reported to

28 enhance energy metabolism, cardiac repair or the renewal of cardiomyocytes

29 (RBP2, IGFBP4, TGM2 and uMtCK).^{23,32-35} As a result of these and other actions,

(uromodulin and KIM-1);^{49,52} three proteins have been shown to promote renal autophagy or enhance the integrity or regeneration of renal tubular cells (RBP2, TSMB10 and EpCAM),^{55,57} and three proteins (carbonic anhydrase 2, guanylin and uromodulin) play a role in renal tubular sodium transport.^{47,49} Therefore, our proteomics analyses suggest that the pathways that are influenced by SGLT2 inhibitors in patients with heart failure are similar to those influenced by these drugs

in animal models of cardiac or renal stress.⁶⁴⁻⁶⁹ 10

Importantly, our conclusions remained unaltered even when we focused on proteins 12 with the most marked changes, Figure 1. The protein that showed the most striking 13 increase was IGFBP1, which binds to insulin-like growth factor 1 (IGF1) to limit its 14 activity. IGF1 has demonstrable deleterious effects on the heart to suppress 15 autophagy, and its upregulation promotes the development of cardiomyopathy.¹⁰ 16 The protein that showed the second largest treatment effect in the current study was 17 TfR1, which is required for iron transport into cardiomyocytes to prevent contractile 18 dvsfunction,⁷⁰ but it also enhances nutrient deprivation signaling.¹⁴ Knockout of TfR1 19 leads to mitochondrial derangements, suppression of autophagy and the 20 development of cardiomyopathy.¹³ The third most differentially expressed protein 21 related to heart function was EPO, which is classically known as the principal 22 stimulus to red blood cell production. However, EPO also exerts direct effects on the 23 heart (independent of its actions on erythrocytosis) to promote autophagy, prevent 24 adverse ventricular remodelling, and mute proinflammatory and profibrotic signaling 25 in the myocardium.¹⁵⁻¹⁷ Interestingly, all three proteins are functionally related to the 26 increases in haemoglobin seen in clinical trials with SGLT2 inhibitors, a physiological 27 change that is the most important statistical mediator of the benefit of SGLT2 28 inhibitors to reduce heart failure and major adverse renal events.^{5,6} Specifically, 29

many of the differentially-expressed proteins have favourable effects to retard

maladaptive ventricular hypertrophy or remodelling, Table 2. In addition, two

proteins have demonstrated effects to mitigate renal injury and inflammation

IGFBP1 promotes the stability of hypoxic inducible factor $1-\alpha$,¹¹ an important endogenous stimulus to the production or erythropoietin, while TfR1 ensures the adequacy of intracellular levels of iron in erythrocytes.⁷¹ Interestingly, increased levels of ANGPTL2 may also serve as an indicator of increased hypoxic inducible factor $1-\alpha$ signaling.⁶²

Three prior studies have reported the results of proteomics analyses before and after 7 SGLT2 inhibition, but the three studies each evaluated fewer than 80 patients, less 8 than 10% of the patients in the current EMPEROR proteomics substudy.^{63,72,73} Of the 9 three, the study most comparable to our analyses was carried out by Ferrannini et 10 al,⁶³ although that study differed from ours in several important respects. First, 11 Ferrannini et al studied the effects of empagliflozin in patients with type 2 diabetes, 12 whereas we studied the effects of empagliflozin in patients with chronic heart failure. 13 Ferrannini et al measured proteins using an aptamer-based assay, whereas we 14 performed measurements using a proximity extension assay method. Ferrannini et 15 al performed measurements after only 4 weeks of treatment, whereas we carried out 16 our assessments after 12 and 52 weeks of therapy. Despite these differences, it is 17 noteworthy that Ferrannini et al. also observed that the proteins most prominently 18 affected by SGLT2 inhibition were IGFBP1, TfR1, EPO and adipocyte fatty acid 19 binding protein 4 (AFABP4), findings that are strikingly concordant with the major 20 observations of the current proteomics analyses from the EMPEROR trials. 21 Interestingly, IGFBP1, TfR1, EPO and AFABP4 are all linked to increased activity of 22 sirtuin-1, a nutrient deprivation sensor that promotes autophagy and is known to be 23 increased by SGLT2 inhibitors in experimental studies and that appears to be 24 essential to mediating their benefits.⁷⁴ Experimentally, the effects of SGLT2 25 inhibitors to reduce cellular stress and attenuate apoptosis in cardiomyocytes are 26 abolished when the actions of sirtuin-1 are inhibited.⁷⁵ It is therefore noteworthy that 27 sirtuin-1 directly stimulates the expression of both IGFBP1 and AFABP4;^{12,42} TfR1 is 28

required for sirtuin-1 synthesis;¹⁴ and sirtuin-1 can stimulate the production of EPO
 by an action on hypoxia-inducible factor 2-α.¹⁸

Our proteomics findings are also consistent with the upregulation of proteins that 4 have favourable effects on renal structure and function. Upregulation of RBP2 may 5 enhance the ability of retinoic acid to prevent renal injury by promoting 6 autophagic flux in renal parenchymal cells.²⁴ Increases in circulating levels of 7 TSAMB10 and EpCAM may be critical to establishment of the adhesion and polarity 8 of renal tubular cells, a critical step in their regeneration following injury.⁵⁵⁻⁵⁸ During 9 long-term treatment, SGLT2 inhibition produced meaningful decreases in KIM-1, 10 which mediates renal tubular cell injury and apoptosis and promotes tubulointerstitial 11 inflammation and fibrosis.⁵²⁻⁵⁴ The concerted actions of these differentially-increased 12 proteins closely mimic the known effects of SGLT2 inhibitors to prevent renal injury, 13 inflammation, and fibrosis in experimental studies of renal stress in animal models.⁶⁴ 14 15

Interestingly, several of our differentially-expressed proteins may represent a 16 mechanism by which the kidney may compensate for the renal tubular actions of 17 SGLT2 inhibitors. SGLT2 inhibitors interfere with sodium reabsorption in the 18 proximal renal tubule through an action to inhibit both SGLT2 and sodium-hydrogen 19 exchanger isoform 3 (NHE3).^{69,76} Guanylin also acts in the proximal tubule to inhibit 20 NHE3,⁴⁷ but it is secreted following a dietary salt load;⁷⁷ its action reinforces the 21 effect of SGLT2 inhibitors to promote the urinary excretion of sodium and 22 bicarbonate.^{76,78} Yet, the observed increase in levels of CA2 may represent a 23 compensatory mechanism to these effects. CA2 binds to NHE3 to increase its 24 activity,⁴⁶ and CA2 enhances the renal tubular adaptation to the increase in urinary 25 bicarbonate that follows the action of SGLT2 inhibitors and guanylin to inhibit 26 NHE3.⁷⁹ In addition, CA2 acts to counter the increase in free water clearance that is 27 seen when glycosuria is induced by SGLT2 inhibitors.⁸⁰ Uromodulin can further 28 counteract the natriuretic effect of SGLT2 inhibitors by enhancing sodium 29

reabsorption more distally in the nephron.⁵⁰ The activation of these
counterregulatory mechanisms may explain why the initial natriuretic and osmotic
diuretic response to SGLT2 inhibitors is not sustained.⁸¹⁻⁸³ Accordingly, we observed
no meaningful decrease in NT-proBNP in the current study, a finding consistent with
our earlier observations based on a conventional ELISA assay.⁸⁴

Our findings should be considered in light of certain strengths and limitations. Our 7 proteomic analyses examined >1200 proteins in blood collected from >1100 patients 8 who participated in two placebo-controlled randomized trials. Therefore, our study 9 represents the largest proteomic database to date on the effects of SGLT2 inhibitors. 10 Despite this advantage, we had insufficient number of patients in each trial to 11 adequately examine potential differences in the effects of SGLT2 inhibitors between 12 patients with a reduced and preserved ejection fraction, and we needed to pool our 13 data across both trials to maximize statistical power. Another strength of the study is 14 that we assessed changes at both 12 and 52 weeks, enabling us to show that the 15 effects seen early in treatment were generally not meaningfully different during long-16 term therapy. Although we adjusted for changes in renal function that occurred 17 during the first 12 weeks, we did not adjust for changes in concomitant medications, 18 which have the potential to influence protein expression independent of the study 19 medication; however, changes in background therapy during the first 12 weeks were 20 modest. 21

Most importantly, although our proximal extension assay has certain advantages over aptamer-based methods (which measure protein fragments), our Olink platform measured only a small fraction of the intracellular proteins that have been implicated in the action of SGLT2 inhibitors in experimental studies. Furthermore, we did not measure many of the proteins that Ferrannini et al⁶³ noted to be meaningfully changed by empagliflozin using aptamer-based methods (including growth differentiation factor 15 and ferritin). Most importantly, we did not directly measure any of the proteins that are involved in enhanced nutrient deprivation signalling and

2 have been implicated in mediating the actions of SGLT2 inhibitors on

3 cardiomyocytes and renal tubular cells (e.g., sirtuin-1, proliferator-activated receptor

4 gamma coactivator 1-α, phosphorylated mammalian target of rapamycin, and

5 phosphorylated AMP-activated protein kinase). These should be the focus of further

- 6 investigation.
- 7

8 Conclusion

Proteomics is rapidly emerging as an innovative approach to gaining potential 9 insights into the mechanisms of disease and drug action. Our proteomics analysis of 10 blood samples taken from participants pooled from two trials of empagliflozin in heart 11 failure identified differential expression of a small select group of circulating proteins 12 following SGLT2 inhibition. The biological effects of differentially-expressed proteins 13 on the heart were primarily focused on the promotion of autophagic flux, but they 14 also included favorable effects to reduce oxidative stress, inhibit inflammation and 15 fibrosis, and enhance the energy stores and the repair and regenerative capacity of 16 the heart. The effects of differentially-expressed proteins in the kidney involved the 17 enhancement of renal autophagy, suppression of renal inflammation and fibrosis, 18 and promotion of renal tubular integrity and regeneration as well as compensatory 19 mechanisms that can limit the ability of SGLT2 inhibitors to produce sustained 20 increases in sodium and water excretion. The actions of differentially-expressed 21 22 proteins identified in patients with heart failure are consistent with the findings of 23 experimental studies that have linked the benefits of SGLT2 inhibitors on the heart and kidney to their actions on autophagy, inflammation and fibrosis, and cellular 24 stress and viability. Our findings suggest that the results of these experimental 25 studies are likely to be highly relevant to the clinical setting. 26 27

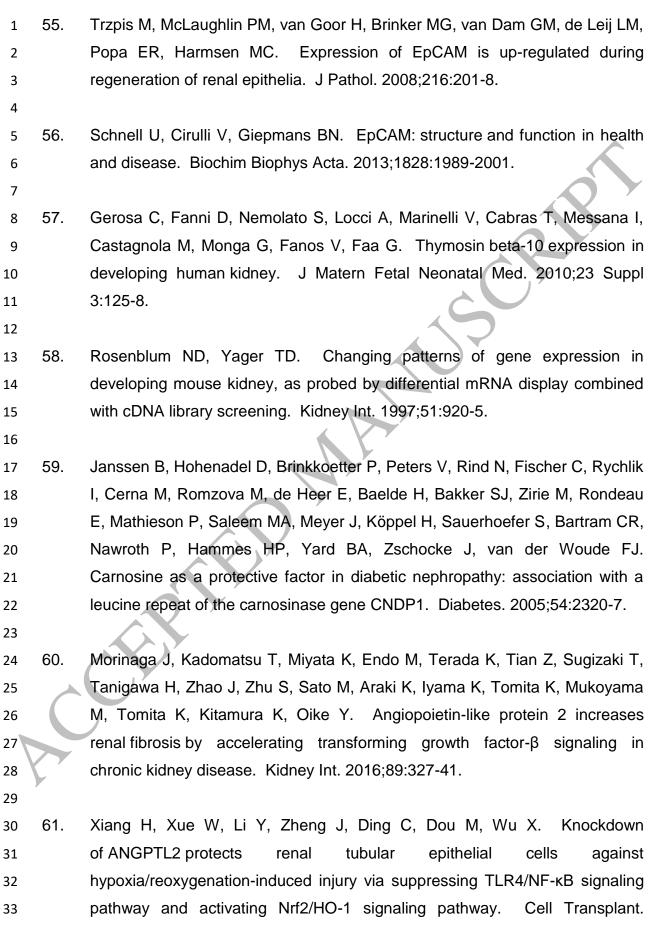

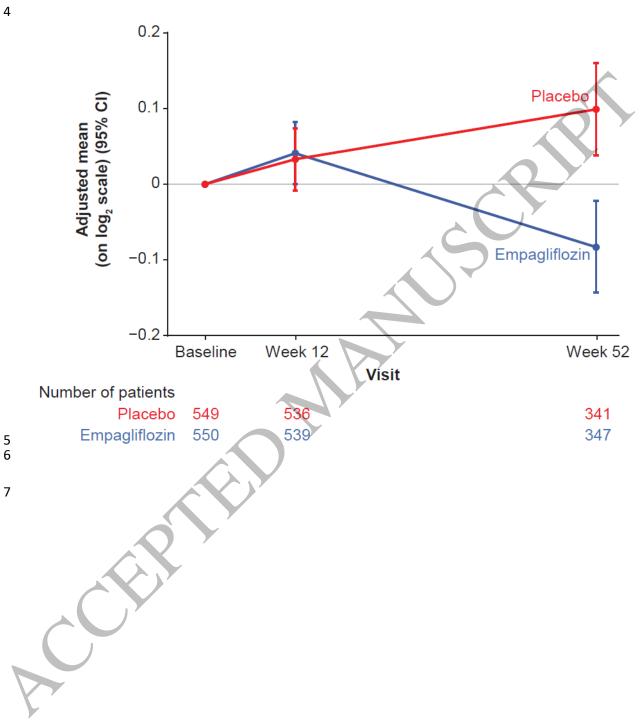

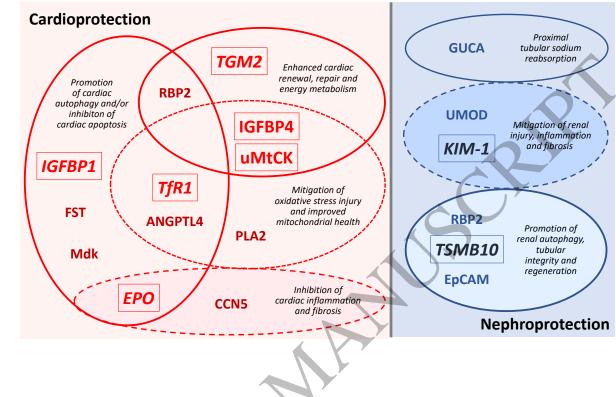
1 Figure 1. Kidney Injury Molecule-1 (KIM-1): Changes from Baseline in the
