54 Abstract

Objective: Although cardiovascular benefits of β1-adrenoreceptor blockade have been
described in sepsis, little is known about its impact on the adaptive immune response,
specifically CD4 T cells. Herein we study the effects of β1-adrenoreceptor modulation
on CD4 T cell function in a murine model of sepsis.

59 Design: Experimental study.

60 Setting: University laboratory

61 Subjects: C57BL/6 mice

Interventions: High-grade sepsis was induced by cecal ligation and puncture (CLP) in wild-type mice ($\beta_1^{+/+}$) with or without esmolol (a selective β_1 -adrenoreceptor blocker), or in β_1 -adrenoreceptor knockout mice ($\beta_1^{-/-}$). At 18 hours after surgery echocardiography was performed with blood and spleen collected to analyze lymphocyte function.

Measurements and Main Results: At 18 hours, B1+/+ CLP mice exhibited characteristics of high-grade sepsis and three surrogate markers of immunosuppression, namely decreased splenic CD4 T cells, reduced CD4 T cell proliferation and increased Treg cell proportions. Pharmacologic and genetic β_1 -adrenoreceptor blockade reversed the impact of sepsis on CD4 T and Treg proportions and maintained CD4 T cell proliferative capacity. β₁-adrenoreceptor blocked CLP mice also exhibited a global decrease in both pro- and anti-inflammatory mediators and improved in vivo cardiovascular efficiency with maintained cardiac power index despite the expected decrease in heart rate.

Conclusion: β_1 -adrenoreceptor activation enhances Treg inhibitory function and thus 77 contributes to sepsis-induced immunosuppression. This can be attenuated by β_1 -

adrenoreceptor blockade, suggesting a potential immunoregulatory role for thistherapy in the management of sepsis.

Introduction 102

Sepsis is a leading cause of intensive care unit admission and recognized by the World Health Organization as a major healthcare issue (1). Unfortunately, despite significant efforts, all research conducted over the last four decades has systematically failed to. yield new therapies (2).

Sepsis is the consequence of a highly complex and dysregulated inflammatory host 17 109 ¹⁹ 110 response to infection leading to life-threatening organ dysfunction (3). After initial 22 111 activation, the immune system is downregulated, leading to immunosuppression. This 24 112 is characterized in part by an increase in regulatory T cells (Treg cells) and a decreased $\frac{1}{27}$ 113 ability to respond to subsequent infections (4). A disproportionate and prolonged 29 114 activation of the sympathetic nervous system (dysautonomia) also occurs, ³¹ 115 characterized by loss of cardiovascular variability, and excessive release of 34 116 endogenous catecholamines (5). Guidelines however continue to recommend ³⁶ 117 norepinephrine and epinephrine as first-line vasopressor or inotropic support therapies 39 118 to achieve circulatory stabilization in septic shock (6). This advice is proffered ⁴¹ 119 notwithstanding an extensive literature highlighting the potent immunomodulatory 44 120 properties of these catecholaminergic agents (7). Faced with this paradox, the concept of "decatecholaminization" has emerged over the last decade to minimize, where 122 possible, the use of catecholamines during sepsis (3, 7).

Beta-1 adrenoreceptor (β_1 -AR) blockade is a therapeutic approach aimed at downregulating the excessive adrenergic stimulation induced by sepsis. Initial singlecenter studies in human septic shock have mainly reported hemodynamic benefits with

improvements in cardiac efficiency and, in one study, a survival benefit (8-10). Premorbid β_1 -blocker exposure is also associated with a decrease in ICU mortality (11-129 13) which may relate to their immunomodulatory actions (14-16).

Relatively few experimental and, in particular, clinical studies have investigated the inflammatory effects of β_1 -AR blockade in sepsis. These studies report a global decrease in both pro- and anti-inflammatory circulating cytokines though have not delved into underlying mechanisms (14-17). Little is also known about the effects of β_1 -AR blockade on the early adaptive immune response (18, 19). We hypothesized that β_1 -AR blockade plays a fundamental role, during sepsis in the early adaptive immune response, enabling a reduction of sepsis-induced immunosuppression. The present study was thus designed to assess the effects of β_1 -AR blockade on CD4 T cells in a murine model of sepsis.

141 Materials and Methods

143 Sepsis model

A full description is provided in **Supplemental Digital Content – Methods**. β_1 -AR (C57BL/6J, DBA/2, 129Sv) knockout mice (β_1 -/-) and wild type littermates (β_1 +/+), obtained free of charge from the Institute of Pharmacology and Toxicology of Munich, Germany, were used for this study. The French Animal Care Committee, in accordance with European regulations, approved all protocols (n°APAFIS#4636). Sepsis was induced by cecal ligation and puncture (CLP) in both male and female mice aged 12-16 weeks, weighing 22-32 grams. For fluid resuscitation, all mice received an isovolemic subcutaneous fluid bolus of 5 ml physiological saline solution (0.9% NaCl; Baxter, Guyancourt, France) per 100g body weight.

An incision was performed between the scapulae in all mice and a mini-osmotic pump (2001D, Alzet, Cupertino, CA) implanted subcutaneously in animals to be treated with the selective β_1 -AR blocker, esmolol (Esmocard®, Amomed, Pantin, France). In nontreated groups, animals only underwent a skin incision without implantation of the minipump. The esmolol dosage was chosen according to both the literature and preliminary experiments aiming to reduce heart rate (HR) by 20% (**Supplemental Digital Content – Figure 1**).

162 Experimental design

 β_{3} $\beta_{1^{+/+}}$ mice were randomly assigned to four groups: sham, sham + esmolol, CLP or CLP + esmolol. Esmolol was infused at 18 mg/kg/h (8 µl/h, 120 µl over the 15 hours of intervention) via a subcutaneous mini-osmotic pump which was activated 3 hours post-

insertion. $\beta_1^{-/-}$ mice were randomly assigned to two groups: sham or CLP. The number 166 of mice used and reasons for failed measurements and for exclusion are provided in 167 168 Supplemental Digital Content – Methods and Table 1.

Immunophenotyping

Splenocytes were isolated according to standard methods. Splenocyte Fc receptors were blocked (CD16/CD32-purified antibodies, eBioscience[™], ThermoFisher Scientific, San Diego, CA) and cell surface markers used to identify total T cells (CD3+), CD4 T cells (CD3+ CD4+), CD8 T cells (CD3+ CD4-) and Treg cells (CD3+ CD4+ CD25^{hi} CD127^{low}, Foxp3) in viable cells. Th1 (INF-y+), Th2 (IL-4+) and Th17 (IL-17+) status was also characterized by intracellular staining of CD4 T cells. A full description is provided in Supplemental Digital Content – Methods, and the Treg cell gating strategy in Supplemental Digital Content – Figure 2.

Proliferation assay

Splenocytes were stained with Tag-it Violet[™] Proliferation and Cell Tracking Dye (5 µM/10⁶ cells; Biolegend, San Diego, CA) according to the manufacturer's instructions and stimulated with phytohemagglutinin (PHA; 4 µg/10⁶ cells; Remel, ThermoFisher Scientific, San Diego, CA) for 72 hours at 37°C. Tag-it Violet signal was assessed in live CD4 T cells by flow cytometry. A full description is provided in Supplemental **Digital Content – Methods.**

Purification of CD4+ CD25- T cells and CD4+ CD25+ Treg cells

CD4 T and Treg cells were isolated in a two-step procedure following the manufacturer's instructions (CD4+ CD25+ Regulatory T Cell Isolation Kit,

MiltenviBiotec, Bergisch Gladbach, Germany). A full description is provided in 191 Supplemental Digital Content – Methods and Supplemental Digital Content – Figure 3 panels A and B. 193

Co-culture of CD4 T cells with catecholamine-stimulated Treg cells

Treg cells were stimulated with 1 μ M dobutamine (β_1 -AR agonist), norepinephrine (α_1 and β_1 -AR agonist), phenylephrine (α_1 -AR agonist); (all from Sigma-Aldrich) or PBS for 30 minutes, then washed twice to remove the catecholamines. Pre-treated Treg cells were co-cultured with CD4 T cells at a 1:4 ratio. Cells were activated with anti-CD3/CD28 beads and proliferation assessed by taking pictures every 2 hours for 5 days (37 °C, 5% CO2) using the 20x objective of the IncuCyte® S3 Live-Cell Analysis System (Sartorius, Goettingen, Germany). Analysis was performed using IncuCyte™ Basic Software. A full description is provided in Supplemental Digital Content -

- Methods and Supplemental Digital Content Figure 3 panel C.

Echocardiography

Transthoracic echocardiography was performed 18 hours after CLP with a VEVO770 (FUJIFILM VisualSonics, Toronto, Canada) and a 30 MHz mechanical probe. A full 208 description is provided in **Supplemental Digital Content – Methods.** Mean arterial pressure (MAP) was measured by a blood pressure transducer (Emka, Paris, France) inserted into the left carotid artery.

Blood counts

In 5–6 mice from each group, complete blood counts were measured (Micros 60 ABX, Radeberg, Germany).

215 Quantification of inflammatory mediators

In 5–6 mice from each group, the plasma levels of 46 inflammatory mediators were
measured in duplicate using the Magnetic Luminex® Performance Assay – Mouse XL
Discovery Premixed kit (Bio-Techne, Minneapolis, MN) according to the
manufacturer's instructions.

220 Immunohistochemistry

A full description is provided in Supplemental Digital Content - Methods. Hearts were sectioned into transverse slices from apex to base and embedded in optimal cutting temperature compound (CellPath, Newtown, Powys, UK) for immunohistochemistry. Leukocytes were stained on 7-µm thick sections with rabbit polyclonal antibody to CD45. Sections were counterstained with hematoxylin. For each heart section CD45 positive cells were counted using a 40x objective lens in 10 fields in a blinded manner by three different researchers independently.

Survival study

Survival was studied in $\beta_1^{+/+}$ CLP mice, $\beta_1^{+/+}$ CLP + esmolol (18 mg/kg/h) mice, and β_1^{-} /- CLP mice. Census of animals was undertaken twice a day for 5 days. Administration of esmolol (Esmocard®, Amomed, Pantin, France) was started 3 hours post-CLP and continued for a total infusion period of 24 hours.

Statistical analysis

235 Results are expressed as mean and standard deviation (mean \pm SD). Results in $\beta_1^{-/-}$ 236 mice were compared using a Mann-Whitney test while the Kruskal-Wallis test was

used to compare $\beta_1^{+/+}$ groups. When the Kruskal-Wallis test was significant, *post hoc* comparisons were performed between sham, CLP, and CLP + esmolol groups using Dunn's multiple comparisons and a Bonferroni correction. Variations were calculated as follows: 100-((mean group 1/mean group 2)x100).

To analyze the effect of catecholamines on Treg cells co-cultured with CD4 T cells, we firstly assessed the interaction between groups at each timepoint. Considering the mouse as a random effect, the p-value of the test for the treatment effect was calculated. Only the last p-value (obtained at 132 hours) is shown. For measurement of plasma inflammatory mediators, groups were compared using the Mann-Whitney test. Benjamini-Hochberg adjustment was performed for multiple comparisons.

Kaplan–Meier curves were drawn. Significance was assessed using the log-rank test.
P values <0.05 were considered statistically significant. Statistical analysis was
performed using R, version 3.6.2 (R Foundation for Statistical Computing, Vienna,
Austria), using Graph-Pad Software 6.0, (San Diego, CA) and NCSS Statistical
Software 9 (East Kaysville, UT).

Results

β_1 -AR stimulation contributes to a post-septic immunosuppressive phenotype.

Male and female mice were used in equal numbers for all experiments (sex ratio 1.02). Eighteen hours after surgery, septic mice displayed falls in white blood cells and in circulating lymphocytes (-72% vs. sham, p=0.05 and -79% vs. sham, **Figure 1, panel A and B**). In spleens taken from $\beta_1^{+/+}$ mice, sepsis induced a significant decrease in CD4 T cell proportions (-34% vs. sham, p<0.001) which was counteracted by β_1 -AR blockade (+37% vs. CLP, p=0.03) (**Figure 1, panel C**). In $\beta_1^{-/-}$ mice, sepsis significantly decreased the proportion of CD4 T cells (-17% vs. sham, p=0.02), however no change in CD8 T cells proportion was observed between groups (**Figure 1, panel C and D**).

With respect to Treg cells (CD25^{high} CD127^{low} Foxp3+), in $\beta_1^{+/+}$ mice, CLP induced an increase in the Treg cell proportion (+65% *vs.* sham, p <0.001 **Figure 1, panel E**) and a trend to an increase in Treg cell count in the spleen which was inhibited by β_1 -AR blockade (-19% *vs.* CLP, p=0.04) (**Supplemental Digital Content – Figure 4**).

In $\beta_1^{-/-}$ septic mice, the proportion of Treg cells was unchanged (+7% *vs.* sham, p=0.68). Of note, β_1 -AR blockade in $\beta_1^{+/+}$ sham mice had no impact on CD4 T cell and Treg cell proportions (**Supplemental Digital Content – Figure 5**). No modification was observed in other CD4 T cells subsets (Th1 (INF- γ +), Th2 (IL-4+) and Th17 (IL-17+)) in these experimental groups (**Supplemental Digital Content – Figure 6**). These findings were not caused by differences in cell viability between groups (**Supplemental Digital Content – Figure 7**).

$279 \quad \beta_1$ -AR activation induces a decrease in CD4 T cell proliferation during sepsis.

After culturing splenocytes for 72 hours with PHA stimulation, the proliferative response of CD4 T cells was measured to assess sepsis-induced immune suppression. In $\beta_1^{+/+}$ mice, sepsis reduced the proliferative capacity of CD4 T cells (-15% vs. sham, p=0.04). However, administration of a β_1 -AR blocker limited this effect (-8% vs. sham, p=0.38). In $\beta_1^{-/-}$ mice, sepsis did not decrease the proliferative capacities of CD4 T cells (-4% vs. sham, p=0.71) (**Figure 1, panel F**). These results were not caused by variations in cell viability between groups (**Supplemental Digital Content – Figure 8).** Of note, β_1 -AR blockade in $\beta_1^{+/+}$ sham mice had no impact on CD4 T cell proliferation (**Supplemental Digital Content – Figure 5**).

 β_1 -AR stimulation of Treg cells increases their immunosuppressive capacities.

The direct effect of β₁-AR stimulation on the immunosuppressive function of Treg cells was assessed in vitro. CD4 T cell counts tended to decrease after five days of coculture with Treg cells pre-treated with the β₁-AR agonist dobutamine, in comparison to untreated Treg cells (p=0.08, **Figure 2, panel A**). This lower cell count, noted when co-culture was performed with dobutamine pre-treated Treg cells, was not caused by an increase in cell death (**Figure 2, panel B**). Similar results were found when coculture assays of CD4 T cells were performed in the presence of norepinephrine and phenylephrine pre-treated Treg cells (**Supplemental Digital Content – Figure 9**).

β1-AR blockade, despite a reduced heart rate, did not alter hemodynamic
 characteristics in sepsis.

Hemodynamic parameters were measured by echocardiography (**Supplemental** Digital Content – Table 2). In $\beta_1^{+/+}$ septic mice, administration of a β_1 -AR blocker

induced a decrease in heart rate (-24% *vs.* sham, p<0.001; -14% *vs.* CLP, p=0.07). In $\beta_1^{-/-}$ mice, sepsis did not affect heart rate (+9% *vs.* sham, p=0.24).

Compared to $\beta_1^{+/+}$ sham, high-grade sepsis induced a decrease in mean arterial pressure (MAP) (-27% vs. sham, p<0.001), stroke volume (SV) (-40% vs. sham, 0.004), CI (-49% vs. sham, p<0.001), and cardiac power index (CPI) (-64% vs. sham, p<0.001). These parameters remained unaltered by the administration of a β_1 -AR blocker (MAP: +8% vs. CLP, p=0.51; SV: +6% vs. CLP, p=0.99; CI: +2% vs. CLP, p=0.99; CPI: +25% vs. CLP, p=0.99). In $\beta_1^{-/-}$ mice, sepsis induced a decrease in MAP (-19% vs. sham, p=0.04), SV (-47% vs. sham, p<0.001), CI (-37% vs. sham, p=0.002) and CPI (-50% vs. sham, p<0.001).

16 Sepsis does not influence leukocyte infiltration in the heart

Leukocyte infiltration into cardiac tissue was analyzed by immunohistochemistry. No
 change was observed in septic compared to sham mice. Pharmacological and genetic
 blockade of β1-AR had no influence on myocardial leukocyte infiltration (Supplemental
 Digital Content – Figure 10).

β₁-AR modulates the concentration of both pro- and anti-inflammatory

circulatory mediators.

The plasma levels of 46 inflammatory mediators were measured. Briefly, all inflammatory mediators were increased in $\beta_1^{+/+}$ CLP mice compared to sham controls (**Supplemental Digital Content – Table 3**). Compared to $\beta_1^{+/+}$ CLP mice, esmololtreated CLP mice showed an overall decrease in plasma concentrations of 58% (18/31) and 60% (9/15) for pro- and anti-inflammatory mediators, respectively (**Figure**

329 3). For instance, compared to $\beta_1^{+/+}$ CLP mice, administration of a β_1 -AR blocker **330** reduced plasma TNF- α by 66% *vs.* CLP (p=0.02), and IL-10 by 82% *vs.* CLP (p=0.01). **331** In $\beta_1^{-/-}$ mice, sepsis induced an overall increase in both pro- and anti-inflammatory **332** mediators compared to sham animals (**Supplemental Digital Content – Table 3**).

β_1 -AR modulates survival during sepsis.

The survival rate was documented in $\beta_1^{+/+}$ CLP, $\beta_1^{+/+}$ CLP + esmolol and $\beta_1^{-/-}$ CLP mice (**Figure 4**). Survival at 110 hours decreased from 60% in $\beta_1^{-/-}$ CLP mice, to 37% in $\beta_1^{+/+}$ CLP + esmolol mice and 35% in $\beta_1^{+/+}$ CLP mice (log rank p=0.13).

39 Sex does not affect the β_1 -AR effect.

Sensitivity analyses were performed on results obtained for major hemodynamic
 parameters (Supplemental Digital Content – Figure 11) and immune
 (Supplemental Digital Content – Figure 12) effects according to sex. No differences
 were found between male and female mice.

344 Discussion

In the present study, we confirm that experimental mid-grade sepsis induces three hallmark features of immunosuppression as seen in human sepsis: a significant decrease in splenic CD4 T cells, an increase in splenic Treg cells, and a decrease in CD4 T cell proliferation capacity (4). A notable finding was the marked increase in Treg cells in the spleen of septic mice, which could be counteracted by pharmacologically or genetically blocking β_1 -AR signaling. This observed decrease in Treg cells in treated animals was associated with a simultaneous increase in CD4 T cells and a global decrease in circulating pro- and anti-inflammatory mediators, indicating the involvement of β_1 -AR in the septic-immune phenotype. These results also translated into an *in vivo* global improvement in cardiac efficiency.

To investigate the immune and cardiovascular roles of β₁-AR in sepsis, we deliberately chose only a fluid-resuscitated murine model of CLP to avoid any interference between exogenous catecholamine administration and the immune system (20-23). This model depicts all hemodynamic and survival characteristics of a typical mid-grade sepsis, with an increase in both plasma pro- and anti-inflammatory mediators and a decrease in CD4 T cell proportion (24-28). Analysis of CD4 T subtypes revealed that early after onset of sepsis, the percentages of Th1, Th2 and Th17 cells were unchanged. Many studies usually report a switch from Th1 to Th2 phenotypes, and a decrease in Th17 cell percentages (29-32). However, other studies found that sepsis could also disrupt in a time-dependent manner both the representation and the function of CD4 T cell subsets, including Th1, Th2, Th17 (20-23). Unlike other lymphocyte populations, Treg cells are increased during trauma in both animals and humans, as well as during sepsis

and septic shock (as seen in our study) (21, 22). This increase in Treg cells contributes 369 lymphocyte paralysis and. more broadly, enhances the post-septic to immunosuppressive process (33).

ß-adrenergic stimulation contributes to CD4 T cell dysfunction

In both innate and adaptive immune cells, adrenergic receptors are widely expressed though not well characterized, particularly for the β subtype (34). Numerous studies 375 have demonstrated the presence of β -AR on almost all lymphocyte subtypes (35-37). However, until recently, only β_2 -AR but not β_1 -AR subtypes were found on T cells (38, 377 39). As a consequence, β_1 -AR stimulation was not considered to have a major role in inflammation (40). β₁-AR were found to be widely expressed on splenic CD4 T cells only recently. In cirrhotic mice, the β_1 -AR agonist dobutamine could re-activate 380 inhibited Treg cells, suggesting the presence of β_1 -AR on their surface (41). 382 Accordingly, we too found that in vitro CD4 T cell proliferation tended to be reduced by Treg cells pre-treated with dobutamine. Apart from its β_1 -AR activity, dobutamine also has activity on the β_2 -AR. This is known to exert some anti-inflammatory effects when stimulating Treg cells and which may have mitigated the β_1 effects (36). In addition to CD4 T cell dysfunction, stimulation of β -ARs in innate and adaptive cells has recently been confirmed as a crucial factor involved in immunoparalysis. We have summarized the effects of β-AR agonists on innate and adaptive immunity in **Supplemental Digital** Content – Figure 13 (7).

ß-adrenoreceptor blockade reversed sepsis-induced dysautonomia

In numerous conditions, such as acute heart failure, burn injuries, and septic shock, β₁-AR blockade has been consistently associated with protective effects on inflammation and hemodynamics (15, 42, 43). As others, we too found a global decrease in pro- and anti-inflammatory mediators in animals with mid-grade sepsis treated by β_1 -AR blockade (15, 44, 45). Underlying mechanisms are still not elucidated. In *Listeria monocytogenes* infected mice, acute cold or restraint stress (surrogates of sympathetic adrenergic stimulation) inhibited the host T cell response and increased cytokine production (46). In this model, pharmacological blockade of the β_1 -AR but not the β_2 -AR could downregulate this pro-inflammatory state and shorten time to bacterial clearance (47).

In β_1 -AR blocked animals with mid-grade sepsis, we found the decrease in Treg cells in the spleen was associated with a concomitant increase in CD4 T cells, as reported previously (48). In addition, we found that the proliferative capacity of splenic CD4 T 405 cells in septic animals was maintained when the B1-AR was blocked either 407 pharmacologically or genetically. This suggests that β_1 -AR activation contributes to sepsis-induced immunosuppression, which could be reversed by β_1 -blockade. By comparison, volunteers challenged with lipopolysaccharide, and then being infused with norepinephrine for 5 hours showed a shift to an anti-inflammatory state (decreased TNF- α /IL-10 ratio) which could be counterbalanced by β -AR blockade (increased TNF- α /IL-10 ratio) (49). β_1 -AR blockade in our septic animals reduced the inflammatory burden and, taken as a whole, helped to shift from an immunosuppressive state to a state of immune homeostasis. 414

⁵¹ 415 Beside this immune rebalancing in experimental mid-grade sepsis, it is important to ⁵² 416 reiterate that β_1 -AR blockade also has major cardiovascular effects. In agreement with ⁵⁵ 417 most other experimental or clinical studies, septic mice receiving β -AR blockade ⁵⁸ 418 showed no alteration in cardiac power, despite a decrease in HR, suggesting improved

cardiac efficiency (10, 15, 44, 50). However, it should be borne in mind that animals only received an initial subcutaneous bolus of fluid resuscitation, and no fluids nor catecholamines thereafter. While the association between an increased Treg cell percentage during sepsis and an immunosuppressive state is well proven, effects on survival remain inconclusive (51, 52). The benefits of β_1 -AR blockade on immune and cardiovascular function should improve survival. However, in the present study, and without any treatment (antibiotics, fluid or vasopressors), no improvement was seen in survival. In a similar CLP surgery model, Ackland et al. also found that metoprolol infusion commenced 6 hours after the onset of fecal peritonitis did not confer any benefit in improving survival whereas pretreatment was effective (45). A dose effect may be relevant as the β_1 -AR blocker was infused only during the first 24 hours after CLP surgery. In a single-center study prolonged administration of esmolol in septic shock patients, titrated to maintain heart rate between 80-94 bpm, was associated with increased survival (10).

434 Limitations

 β_1 -AR and β_2 -AR are widely expressed on both innate and adaptive immune cells. Specifically, it has been reported that naïve CD4 T cell subtypes Th1, Th17 and Treg cells, but not Th2, express β_2 -AR (35, 53). β_2 - AR stimulation promotes a shift from Th1 to a Th2 anti-inflammatory pattern and could activate Treg suppressive functions (36, 54). β_2 -AR stimulation may enhance the macrophage M2 anti-inflammatory phenotype, favoring IL-10 production by CD4 T cells (37). Beneficial effects of β_2 -AR modulation remain unclear during sepsis. In a murine endotoxemia model, β_2 -AR blockade reduced survival while, in septic pigs, it amplified sepsis-induced hepatic injury (37, 55, 56). In this study, we only investigated the impact of β_1 -AR blockade on

alteration of CD4 T cell patterns. The impact of selective β_2 -AR modulation as well as non-specific β-AR blockade on CD4 T cells during sepsis merits investigation.

Our initial intention was to create a CLP model with an expected 48 hour-mortality rate of 70% (26). However, despite using a larger 18G needle to puncture the cecum (instead of the usually recommended 22G needle for mice) and without administering antibiotics (avoided so as not to interfere with the infectious/inflammatory processes), the 48 hour-mortality was 30% in the non-treated CLP mice control group. Nonetheless, this remains a severe model. It would be worthwhile repeating the study with full-code resuscitative measures including ongoing fluid administration, catecholamines (if required), and antibiotics (24). Limitations of murine CLP models should also be acknowledged, for example youth, underlying good health, a homogenous infectious insult and severity, and a similar time-interval from CLP induction to evaluation. The immune system in mice is also not identical to humans and human sepsis is far more heterogeneous in nature. Nonetheless, such models remain useful for mechanistic understanding and an initial assessment of the impact of interventions. Measurements were only performed at 18 hours post-CLP. Serial assessments in a less severe model could clarify the evolving inflammatory profile of this disease.

Perspectives and potential clinical implications

The deleterious effects of a disproportionate and prolonged activation of the adrenergic system are now well established (5, 7). In both clinical trials and cohort studies, shortand long-term administration of β -AR blockers are associated with a mortality benefit. However, there is yet no conclusive explanation for this benefit (10, 13). In this study,

we confirmed that our CLP sepsis model is associated with an immunosuppressive
phenotype characterized by an increase in Treg cells and a decrease in CD4 T cell
proliferation capacity. These features could be reversed by a β1-AR blockade.

If confirmed, our results could lead to a redesign of clinical trials with lower doses of β1-AR blocker, improving hemodynamic tolerance in the early stage of sepsis and septic shock. These findings have yet to be confirmed in other animal models and in human sepsis but supports the potential benefits of decatecholaminization during sepsis and, especially, septic shock.

In summary, in the murine model tested, the β_1 -AR contributes to sepsis-induced immunosuppression through modulation of regulatory T cell inhibitory functions. β_1 -AR blockade, while restoring CD4 T cell homeostasis, also decreased global systemic inflammation and improved cardiac efficiency **(summary Figure 5)**. Thus, instead of considering β_1 -AR blockade only for its hemodynamic effects, we suggest an immunoregulatory mechanism by which β_1 -AR blockers may also be beneficial.
