- 1 Abstract:

Background: In the EMPEROR-Preserved trial, empagliflozin improved clinical outcomes of
patients with heart failure with preserved ejection fraction. In this pre-specified analysis, we aim
to study the effect of empagliflozin on cardiovascular and kidney outcomes across the spectrum
of kidney function.

8 Methods: Patients were categorized by the presence or absence of chronic kidney disease (CKD) 9 at baseline (CKD defined by an estimated glomerular filtration rate [eGFR] <60ml/min/1.73m² or 10 urine albumin to creatinine ratio [UACR]>300mg/g). The primary and key secondary outcomes 11 were (1) a composite of cardiovascular death or first HF hospitalization (primary outcome); (2) 12 total number of HF hospitalization, (3) eGFR slope; and a prespecified exploratory composite 13 kidney outcome including a sustained > 40% decline in eGFR, chronic dialysis or renal 14 transplant. The median follow-up was 26.2 months. 15 16 Results: 5,988 patients were randomized to empagliflozin or placebo, of whom 3,198 (53.5%) 17 had CKD. Irrespective of CKD status, empagliflozin reduced the primary outcome (with CKD 18 HR 0.80 [95% CI 0.69, 0.94], and without CKD HR 0.75 [95% CI 0.60 0.95], interaction 19 P=0.67) and total (first and recurrent) hospitalizations for HF (with CKD 0.68, [95% CI 0.54, 20 0.86], and without CKD 0.89 [95% CI 0.66, 1.21], interaction P=0.17). Empagliflozin slowed the slope of eGFR decline by 1.43 (1.01, 1.85) ml/min/1.73m²/year in patients with CKD and 1.31 21 (0.88, 1.74) ml/min/1.73m²/year without CKD (interaction P=0.70). Empagliflozin did not 22 23 reduce the pre-specified kidney outcome in patients with or without CKD (with CKD HR 0.97

1 Introduction

Randomized trials have shown that sodium glucose cotransporter -2 inhibitors (SGLT2i) prevent
hospitalizations for heart failure (HF) and slow the decline of renal function in patients with type
II diabetes (T2D)¹⁻⁸, chronic kidney disease (CKD)^{9,10}, and HF with reduced ejection
fraction.^{11,12}

7 While pharmacologic therapies to improve cardiovascular outcomes have been demonstrated 8 across multiple therapeutic classes in patients with HF and reduced ejection fraction, there has been few therapeutic options for those with a preserved ejection fraction.¹³ Recently, in the 9 10 EMPEROR-Preserved (Empagliflozin Outcome Trial in Patients with Chronic Heart Failure with 11 Preserved Ejection Fraction) trial, empagliflozin versus placebo reduced the composite of 12 cardiovascular death or HF hospitalization and total (first and recurrent) hospitalizations for HF, and slowed the progressive decline in kidney function.¹⁴ For the first time, a therapeutic option is 13 14 now available for patients with HF and preserved ejection fraction.

16 Among those with HF and preserved ejection fraction, CKD is one of the most common comorbidities being present in up to 50% of patients.^{15–17} Reduced renal function, as measured 17 by estimated glomerular filtration rate (eGFR), portends worse prognosis in patients with HF and 18 preserved ejection fraction.^{16,17} Furthermore, the high prevalence of CKD potentially limits the 19 therapeutic options for patients with HF and preserved ejection fraction.^{18,19} Within EMPEROR-20 21 Reduced (Empagliflozin Outcome Trial in Patients with Chronic Heart Failure with Reduced 22 Ejection Fraction), empagliflozin reduced the risk of the primary outcome of time to cardiovascular death or first hospitalization for HF and the decline in eGFR slope in patients 23 with and without CKD.²⁰ 24

2	Within EMPEROR-Preserved, patients with an eGFR as low as 20 ml/min/1.73m ² were eligible
3	for enrollment; as more than half of the patients had prevalent CKD at baseline, a robust
4	assessment could be conducted regarding the efficacy and safety of empagliflozin on cardiac and
5	kidney outcomes according to the presence of CKD and across a wide range of baseline kidney
6	function. The present analysis reports the prespecified analysis of EMPEROR-Preserved on
7	cardiovascular and kidney outcomes among patients with and without CKD.
8 9 10	Methods
11	The design and rationale of the ENIPEROR-Preserved that have been previously published.
12	To summarize, EMPEROR-Preserved was a double-blind placebo-controlled trial that
13	randomized 5,988 patients with symptomatic HF (New York Heart Association [NYHA] of 2 or
14	greater) and a left ventricular ejection fraction (LVEF) of more than 40% to receive
15	empagliflozin (10 mg orally once per day) or matching placebo.
16	
17	Randomization was performed with a permuted block design and was stratified by geographic
18	region, diabetes status, estimated glomerular filtration rate (eGFR) of less than 60 ml or 60 ml or
19	more per minute per 1.73 m ² , and a LVEF of less than 50% or \ge 50% (all measured at
20	screening). The primary outcome and the first two secondary outcomes were included in a
21	hierarchical testing procedure. The primary outcome was analyzed as the time to the first event
22	of the composite of adjudicated cardiovascular death or hospitalization for HF. The first
23	secondary outcome was the occurrence of all adjudicated hospitalizations for HF, including first
24	and recurrent events. The second secondary outcome was the rate of decline in the eGFR during
25	double blind treatment. In the main trial, empagliflozin, versus placebo, reduced the risk of the

1	primary composite outcome: 13.8% in empagliflozin group versus 17.1% in placebo group;
2	hazard ratio, 0.79; 95% confidence interval [CI], 0.69-0.90. Ethics approval was obtained at each
3	study site, and all patients provided informed consent to participate in the study; the registration
4	identifier at ClinicalTrials.gov is NCT03057951.
5 6 7 8	Baseline categorization of kidney impairment For the prespecified subgroup analyses, patients were categorized by the presence or absence of
9	CKD at baseline. Prevalent CKD at baseline was defined by the presence of an eGFR <60
10	ml/min/ $1.73m^2$ (as measured by the CKD-EPI equation) or urine albumin-to-creatine ratio
11	(UACR) > 300 mg/g. Conversely, no CKD was defined by an eGFR \geq 60 ml/min/1.73m ² and
12	UACR =300 mg/g. We evaluated the treatment effect on all three of the hierarchically-ranked</td
13	outcomes and on several cardio-kidney outcomes within the following patients: (1) presence or
14	absence of baseline CKD; and (2) five baseline eGFR categories (<30, 30-<45, 45-<60, 60-<90,
15	and $\geq 90 \text{ ml/min}/1.73 \text{m}^2$).
16 17 18	Kidney endpoint definition

19 The pre-specified composite kidney outcome was defined as time to first occurrence of chronic

20 dialysis, kidney transplant, sustained reduction of \geq 40% eGFR or sustained eGFR <15

21 mL/min/1.73 m² if baseline eGFR was > 30 mL/min/1.73 m² or <10 mL/min/1.73 m² for patients 22 with baseline eGFR < 30 mL/min/1.73 m².

23 Further, to better align with definitions used in other trials, we explored alternative definitions.

24 These include i) sustained reduction of \geq 40% eGFR, end stage kidney disease (ESKD) or renal

25 death, ii) sustained reduction of \geq 50% eGFR or ESKD, iii) sustained reduction of \geq 50% eGFR,

26 ESKD or renal death, and iv) sustained reduction of 57% eGFR or ESKD and v) sustained

5	suicide, pancreatic causes). The category 'Renal cause' was used for 'renal death'.
4	pulmonary, neurological, haemorrhage, non-CV procedure or surgery, hepatobiliary causes,
3	categories (i.e. infections, malignancies, other non-CV causes, trauma, gastrointestinal,
2	Committee (CEC) adjudicated all fatal events. Non-CV death were categorised into several

9 Patient characteristics and adverse events were analyzed descriptively. Time-to-first event 10 analyses were performed with a Cox proportional-hazards model, adjusted for age, sex, region, 11 diabetes status, and ejection fraction at baseline. These analyses were performed according to the 12 intention-to-treat principle for all randomized patients, and included data up to the end of the 13 planned treatment period. Total (first and recurrent) hospitalizations for HF were 14 evaluated accordingly with a joint frailty model that accounted for cardiovascular death, adjusted 15 for the same covariates as the Cox model. As prespecified, the slope of eGFR decline was 16 analyzed based on on-treatment data (baseline and other off-treatment data were not included in 17 the model) by a random coefficient model allowing for random intercept and random slope per 18 patient. Continuous endpoints were analyzed in a mixed model with repeated measures 19 (MMRM). An ANCOVA analysis was used to compare eGFR change from baseline to follow-up 20 (planned 30 days after treatment discontinuation) between the two treatment groups. 21 22 The slope model, the MMRM, and the ANCOVA model included baseline eGFR and the

23 covariates of the Cox model. To assess the consistency of effects across CKD subgroups,

subgroup-by-treatment interaction terms were added to the models. Adverse event analyses were

based on patients with events occurring during the on-treatment period (including 7 days after
 last drug consumption by the patient). SAS® Version 9.4 was used for all analyses.

Patient characteristics

7 8

9 Among the 5,976 patients in the trial, who could be classified according to CKD categories

10 (99.8% of trial population), 3,198 (53.5%) had prevalent CKD at baseline (Table 1). Compared

11 with patients without CKD, those with CKD were older (74.2 vs. 69.2 years), had a longer

12 duration of HF (mean time since diagnosis: 4.6 vs 4.1 years), were more likely to have a

13 hospitalization for HF in the past 12 months (24.9 vs. 20.5%), and were more likely to have

14 diabetes (52.3 vs. 45.3%). Furthermore, compared to those without CKD, those with CKD were

15 less likely to be treated with an ACEi or ARBs (76.9 vs. 80.5%). Compared to those without

16 CKD, as expected and reflective of the subgroup definition for prevalent CKD, baseline eGFR

17 was lower for patients with CKD (mean: 46.3 vs. 77.1 ml/min/1.73m²), and UACR was higher

18 (median: 32 vs. 15 mg/g). The baseline characteristics in the placebo and empagliflozin groups

19 were well balanced in patients with and without CKD as described in Supplemental Table 1. The

20 patient characteristics across the 5 eGFR categories are presented in Supplemental Table 2.

21

22 Primary and key secondary endpoints

Compared to patients without CKD those with CKD had a higher rate of the primary composite
outcome, first and recurrent hospitalizations for HF, composite kidney outcome, all-cause
hospitalizations, cardiovascular and all-cause death (Table 2).

1	Compared to placebo, empagliflozin reduced the primary outcome of time-to-first cardiovascular
2	death or hospitalization for HF irrespective of CKD status (Figure 1 and Supplementary
3	Figure 1): HR 0.80 (95% CI 0.69-0.94) in patients with CKD and HR 0.75 (95% CI 0.60-0.95)
4	in patients without CKD; interaction P =0.67. Empagliflozin reduced the key secondary endpoint
5	of total (first and recurrent) HF hospitalizations irrespective of CKD status: HR 0.68 (95% CI
6	0.54, 0.86) in patients with CKD and HR 0.89 (95% CI 0.66, 1.21) in patients without CKD;
7	interaction P =0.17 (Figure 1). Empagliflozin reduced the absolute difference in the slope of
8	decline in eGFR irrespective of CKD: 1.43 (95% CI 1.01, 1.85) ml/min/1.73m ² /year in patients
9	with CKD and 1.31 (95% CI 0.88, 1.74) ml/min/1.73m ² /year in patients without CKD;
10	interaction P =0.70 (Table 3). Results were consistent across eGFR and UACR categories
11	(Table 3). The change of eGFR over time for patients with and without CKD is shown in Figure
12	2. An early eGFR decrease ("dip") was only observed in the empagliflozin-treated arms.
13	Following this "dip", stabilization of the eGFR trajectories was observed in the empagliflozin-
14	treated groups; in patients with CKD, eGFR was similar after week 76 in empagliflozin versus
15	placebo; in patients without CKD, the placebo arm had a greater decline in eGFR until the end of
16	the study (Figure 2).

19 categorization and measurements of eGFR at baseline and 30 days after discontinuation of

20 treatment, empagliflozin reduced the decline in eGFR from baseline to 30 days after drug

21 discontinuation by 2.4 (95% CI 1.3, 3.5) ml/min/1.73m² in patients with CKD and by 2.4 (95%

22 CI 1.2, 3.5) ml/min/1.73m² in patients without CKD; interaction P =0.97 (**Table 4**).

1	Event rates by eGFR categories across outcomes are presented in Figure 3. The effect of
2	empagliflozin on the primary composite outcome and the key secondary
3	outcomes across the 5 eGFR categories, is shown in Figure 3. Overall, baseline kidney
4	function did not influence the impact of empagliflozin on the primary endpoint, total
5	hospitalizations for heart failure, or other outcomes (all trend p-values > 0.05 ; Figure 3).
6 7 8	Additional kidney outcomes
9	The pre-specified composite kidney outcome (of a greater than 40% sustained decline in eGFR,
10	chronic dialysis or kidney transplant or sustained eGFR <15 ml/min/1.73 m ² [for patients with
11	baseline eGFR \geq 30] or sustained eGFR <10 (for patients with baseline eGFR <30]) was not
12	reduced in patients with and without CKD: HR 0.97 (95% CI 0.71,1.34) in patients with CKD
13	and HR 0.92 (95% CI 0.58, 1.48) in patients without
14	CKD; interaction P =0.86 (Figure 4). The results were consistent across eGFR categories
15	(Figure 5) and across alternative definitions of kidney outcomes (Supplementary Figure 2).
16	
17	Investigator reported acute kidney injury was less frequent in the empagliflozin group (HR 0.73
18	[95% CI 0.56, 0.95], p-value 0.0193), both in patients with CKD and without CKD: HR 0.76
19	(95% CI 0.56, 1.02) with CKD and HR 0.66 (95% CI 0.38, 1.15) without CKD; interaction
20	P=0.67. Furthermore, empagliflozin reduced progression to macroalbuminuria (HR 0.82 [95% CI
21	0.68, 0.98], p-value 0.0264) in patients who at baseline were normo/microalbuminuric: HR 0.80
22	(95% CI 0.63, 1.01) with CKD and HR 0.84 (95% CI 0.64, 1.10) without CKD; interaction p =
23	0.77 (Figure 4 and Supplemental Figure 3).

Adverse Events by CKD status at baseline

4	Compared to those without CKD, patients in the empagliflozin group with CKD were more
5	likely to have adverse events including symptomatic hypotension (8.1 vs. 4.8%), hyperkalemia
6	(8.1 vs. 4.1%), volume depletion (14.4 vs. 9.0%), and urinary tract infection (11.0 vs. 8.6%)
7	(Table 5). However, empagliflozin appeared to be well tolerated and frequencies of adverse
8	events were similar between those randomized to empagliflozin versus placebo regardless of
9	CKD status (Table 5).
10 11 12	Discussion
13	This prespecified study of the EMPEROR-Preserved trial evaluated the effect of empagliflozin
14	versus placebo in HF patients with prevalent CKD at baseline on the primary outcome, key
15	secondary outcomes, and kidney outcomes. Our study has the following key findings: 1)
16	empagliflozin reduced the risk of the primary outcome of the composite of cardiovascular death
17	or hospitalization for HF, the key secondary outcome of total hospitalizations for HF, and of
18	eGFR slope, in patients with and without CKD; 2) the benefit across the primary and key
19	secondary outcomes was consistent across the spectrum of eGFR; 3) empagliflozin reduced the
20	reporting of acute kidney injury and slowed progression to macroalbuminuria overall and across
21	CKD and eGFR categories; and 4) empagliflozin was well-tolerated in patients with and without
22	CKD.
23	

24 Overall, among patients with T2D, HF with reduced ejection fraction, CKD, and Acute HF,

25 SGLT2i have demonstrated broad clinical benefit.^{1,22–241,22–24} These findings also extended to

subgroups of those with CKD among patients with $T2D^{25}$ or in HF with reduced ejection 1 2 fraction.^{20,26} A pooled meta-analysis of the DAPA-HF (Dapagliflozin and Adverse Events in 3 Chronic Heart Failure and a Reduced Ejection Fraction) and EMPEROR-Reduced trial have 4 demonstrated efficacy of the SGLT2i dapagliflozin and empagliflozin to reduce the risk of the 5 composite of cardiovascular death or first hospitalization for HF in patients with eGFR < 60 $ml/min/1.73m^2$ (HR 0.77, 95% CI 0.86, 0.88) and those with eGFR >/= 60 ml/min/1.73m² (HR 6 0.72, 95% CI 0.62, 0.82).²³ However, a detailed analysis of the benefit of SGLT2i across CKD 7 8 populations in patients with HFpEF, including evaluation of eGFR slopes, has not been 9 conducted. The present findings further expand on the existing literature by demonstrating that 10 among patients with HF with LVEF greater than 40%, in those with and without CKD, 11 empagliflozin reduces the risk of cardiovascular death or hospitalization for HF and reduces the 12 decline in eGFR slopes.

14 Real-world registries clearly indicate an increase in the risk of cardiovascular outcomes in patients with HF and preserved ejection fraction associated with worse baseline eGFR.^{16,1716,17} 15 16 Until recently, there were limited therapeutic options for patients with HF and preserved ejection fraction with reduced eGFR. The EMPEROR-Preserved trial recruited patients with eGFR as 17 low as 20 ml/min/1.73m² aligning with the EMPEROR-Reduced trial eGFR exclusion criteria.¹¹ 18 The DAPA-HF trial excluded patients with $eGFR < 30 \text{ ml/min}/1.73 \text{m}^2$ while the DELIVER trial 19 20 (Dapagliflozin Evaluation to Improve the Lives of Patients With Preserved Ejection Fraction Heart Failure) excluded patients with $eGFR < 25 \text{ ml/min}/1.73 \text{m}^2$. The EMPEROR-Preserved 21 trial had a similar proportion of patients with $eGFR < 60 \text{ ml/min}/1.73\text{m}^2$ (50%) when compared 22 to EMPEROR-Reduced $(48\%)^{20}$, DAPA-HF $(41\%)^{26}$, and DELIVER (49.9%).²⁷ The present 23

results highlight the efficacy of empagliflozin in reducing the risk of the primary and key
secondary outcomes across the spectrum of eGFR categories, even in those with baseline eGFR
ranging from 20-30 ml/min/1.73m². Given the large proportion of patients with reduced eGFR in
those with HF and preserved ejection fraction, our results support a treatment strategy with
empagliflozin in patients who would have limited therapeutic options.

7 The kidney-protective effects of SGLT2i have previously been shown in patients with type 2 diabetes and chronic kidney disease in the CREDENCE trial^{9,109,10} and in patients irrespective of 8 diabetic status in the DAPA-CKD trial.¹⁰ The EMPEROR-Preserved trial demonstrated that 9 10 empagliflozin significantly reduced the rate of decline in eGFR - a prespecified outcome that 11 was explored within the hierarchical testing model for the trial – and slowed the progression to 12 macroalbuminuria. Such results align with the data from previously published randomized trials of SGLT2i in patients with T2D² and HF.^{20,26} However, empagliflozin did not reduce the risk of 13 14 major renal outcomes in those with or without CKD, consistent with the findings from the 15 overall trial. This is in contrast to the effect in EMPEROR-Reduced, whereby empagliflozin reduced the risk of major renal outcomes (which was defined in the same way in EMPEROR-16 Preserved) in patients with and without CKD: HR 0.53, 95% CI 0.31-0.91 with CKD and HR 17 0.46, 95% CI 0.22-0.99 without CKD.²⁰ There was a greater eGFR decline in participants 18 19 without baseline CKD (Figure 2, Table 3), a finding noted also within the EMPEROR-Reduced 20 trial. With lower baseline values for eGFR in patients with prevalent CKD, the magnitude of 21 benefit on eGFR slope with empagliflozin was proportionally similar in patients with and 22 without CKD. In EMPEROR-Preserved, there was no statistically significant difference in the 23 effect of empagliflozin versus placebo on the eGFR slope by prevalent baseline CKD. Whilst in

1 both treatment arms, participants with higher baseline eGFR have larger absolute decline, loss in 2 eGFR are likely to be more clinically meaningful in patients with CKD in whom even smaller 3 decline in eGFR indicates more earlier progression towards end-stage kidney disease. Overall, 4 the incidence of renal events was relatively small and lower in EMPEROR-Preserved than 5 EMPEROR-Reduced in patients with CKD (2.87 vs 3.77 per 100-patient years respectively) and 6 without CKD (1.52 vs. 2.27 per 100-patient years respectively). The manuscript evaluating data 7 from EMPROR-Reduced identified a (nominally) significant treatment effect when evaluating 8 baseline eGFR interaction for the effect of empagliflozin on eGFR slope. This was identified 9 whether the analysis categorized patients by CKD or by 5 eGFR subgroups. However, these 10 analyses are model-dependent and are based on absolute differences. Our analysis did not 11 indicate a significant interaction of the treatment effect with baseline eGFR. The differences 12 between the two trials may have arisen due to differences in trial inclusion criteria, duration of 13 follow-up, comorbidity burden which may influence risk of progression of CKD, or chance (due 14 to multiple hypothesis testing). Longer follow-up may have uncovered whether slowing both, the 15 eGFR decline and progression to macroalbuminuria, would have translated into a difference in 16 renal outcomes over time.

The proposed mechanisms of action of SGLT2i on glomerular function remains unclear.
Potentially, the initial drop in the eGFR with initiation of SGLT2i is related to the hemodynamic
effect of diminishment of proximal nephron sodium reabsorption resulting in a restoration of
tubuloglomerular feedback and a decrease in intraglomerular hydrostatic pressures.^{28,29} However,
animal models evaluating gene knock out of SGLT2 suggests that the hemodynamic effect may
not be related to longer term renal protection.^{30,31} Emerging evidence suggests that a critical

1 determinant of injury in the diabetic kidney is through oxidative and endoplasmic reticulum 2 stress; such stress impacts glomerular podocytes and renal tubules by dysregulating autophagy processes which increases susceptibility to injury.^{32,33} SGLT2i may be able to reduce oxidative 3 4 stress by inducing a state of nutrient and oxygen deprivation by increasing sirtuin-1 (SIRT1), 5 AMP-activated protein kinase (AMPK), and hypoxia-inducible factors (HIF-1 α and HIF-2 α) 6 which can exert renoprotective effects through the promotion of autophagic flux in addition to direct effects on sodium transport and inflammasome activation.^{33–35} The impact of SGLT2i on 7 albuminuria has been extensively described and may be related to a variety of mechanisms.^{36,37} 8 9 Animal models suggest that SGLT2i may reduce albuminuria through direct effects on the 10 kidney; for instance, in diabetic mice, SGLT2i reduced albuminuria by ameliorating 11 intraglomerular hypertension in addition to tubulointerstitial fibrosis, which are the major contributors to chronic kidney damage.^{38–40} Whether such mechanisms are dominant among 12 13 patients with HF and preserved ejection fractions warrants further exploration. The results of the 14 DELIVER trial will provide further insights into the intersection of kidney outcomes with 15 SGLT2i in HFpEF populations.

Overall, the likelihood of serious adverse events was numerically lower in the EMPERORPreserved trial compared to the EMPEROR-Reduced trial as reflected by the placebo event rate
of serious adverse events in patients with and without CKD: 49.5 vs. 61.2 per 100 patient-years
with CKD and 29.9 vs. 48.6 per 100 patient-years without CKD. Consistent with the result of the
EMPEROR-Reduced trial, patients with CKD in EMPEROR-Preserved had a greater likelihood
of adverse events compared to those without CKD. This likely represents a frail physiologic
phenotype that increases the risk of adverse outcomes even among placebo-treated patients with

CKD compared to those without CKD. Of note, in totality serious adverse events were lower in the empagliflozin-treated groups in both patients with and without CKD; furthermore, adverse events leading to drug discontinuation were balanced between treatment groups in those with and without CKD. And acute kidney injury was reported less frequently in the empagliflozin group, regardless of baseline CKD status. These results highlight the overall safety and tolerability of empagliflozin across the spectrum of HF.

8 Limitations

9

10 Several limitations of this analysis warrant noting. While this was a prespecified analysis, the 11 EMPEROR-Preserved trial was not powered to assess the effect of empagliflozin in subgroups 12 such as CKD. In addition, the trial was not sufficiently powered to evaluate adverse renal 13 outcomes across subgroups of patients with and without CKD, nor primary and key secondary 14 outcomes in further CKD subgroups such as the 5 categories of eGFR. The definition of acute 15 kidney injury was based on MedRA coded reporting of investigator-reported adverse events and 16 therefore may have some heterogeneity in reporting across trial sites. Our results must be kept 17 within context that our statistical analysis plan had prespecified that the slope of eGFR decline 18 was analyzed based on on-treatment data whereby baseline and other off-treatment data were not 19 included in the model.

21 Conclusion

1 In the EMPEROR-Preserved trial, empagliflozin reduced the key efficacy outcomes of time-to-2 first cardiovascular death or hospitalization HF, total (first and recurrent) HF hospitalizations, 3 and slowed the rate of eGFR decline and the progression to macroalbuminuria, in patients with 4 and without CKD. These results were consistent across a broad kidney function spectrum. These 5 benefits on clinical outcomes in addition to the well tolerated and consistent safety profile 6 provide further evidence for the benefit of empagliflozin in patients with HF and preserved 7 ejection fraction independent of CKD. These results are consistent across the broad spectrum of 8 eGFR including those with severe kidney function impairment down to an eGFR of 20 $ml/min/1.73m^2$.
