RÉSUMÉ

Les affections cardiovasculaires sont des pathologies complexes résultant des relations et interconnexions d'un grand nombre de facteurs de risque génétiques, constitutionnels et environnementaux. Si l'étiologie génétique de ces affections a largement été étudiée ces dernières années, de nombreuses zones d'ombre persistent. En effet, les variants fonctionnels à l'origine de la large hérédité génétique des facteurs de risque cardiovasculaire et les mécanismes d'interactions gène-gène-environnement masquant ou modulant l'effet de la génétique restent encore à élucider. Le développement d'outils plus performants que l'approche classique gène candidat et la mise en place d'études épidémiologiques axées sur des populations pédiatriques dans lesquelles les interactions gène-environnement sont minimisées pourraient apporter une information déterminante. C'est le postulat principal que nous avons poursuivi au cours de cette thèse.

Ce mémoire présente l'étude de la génétique de certains facteurs de risque des pathologies cardiovasculaires : les lipides, la pression artérielle, l'haptoglobine et le facteur de croissance de l'endothélium vasculaire (VEGF), avec comme outil de base, une population de familles Françaises supposées saines suivies pendant dix ans à l'occasion de trois examens de santé : la cohorte STANISLAS.

Nous avons dans un premier temps quantifié la hérédité de ces facteurs de risque cardiovasculaire de façon à souligner l'intérêt de les étudier dans des populations pédiatriques. Ainsi, nous avons mis en évidence la forte hérédité génétique des traits lipidiques (44% pour le cholestérol total et 32,8% pour le HDL-cholestérol ; $p<0,001$) ; et de l'haptoglobine (35,3%, $p<0,001$) dans la cohorte STANISLAS. Nous avons également constaté une absence d'hérédité génétique de la pression artérielle, résultat contradictoire avec une étude antérieure que notre équipe a mené sur la même population.

Après avoir décrit l'influence des facteurs de risque cardiovasculaire des parents STANISLAS sur les phénotypes de leurs enfants, nous avons réalisé un Genome-Wide Scan (GWS) sur un échantillon de 631 enfants non apparentés issus de la cohorte STANISLAS de façon à mener des études d'association pangénomique ou Genome-Wide Association Studies (GWAS) selon deux approches distinctes :

- Une approche exploratoire destinée à rechercher des variants génétiques associés à un facteur de risque émergent des pathologies cardiovasculaires : l'haptoglobine ;
- Et une approche réplicative chez l'enfant axée sur des facteurs de risque largement étudiés par la communauté scientifique : les lipides et la pression artérielle.

Les études pangénomiques nécessitant des réplications dans de larges populations indépendantes, nous avons intégré à cette occasion des Consortia Internationaux nous donnant accès à près de 9 000 enfants appartenant à quatre cohortes pédiatriques (OBE, NFBC86, GENDAI et Verona) ainsi qu'à plus de 13 300 adultes provenant de trois cohortes distinctes (DESIR, Framingham et PIVUS).

Nous avons ainsi pu démontrer que certaines associations génétiques mises en évidence chez l'adulte avaient un effet observable dès l'enfance et avons découvert 11 variants génétiques inédits, dont 6 non répliqués chez les adultes : rs12591800, rs4918082, rs2607919, rs933193, rs724815 et rs314672.

Dans le cas de l'haptoglobine, marqueur récemment proposé en prévention cardiovasculaire, nous avons découvert et répliqué un variant expliquant 42% de la hérédité génétique globale : le rs2000999 ($p_{\text{méta-analyse}}=8,1\times 10^{-59}$). Ce variant a été très récemment associé au cholestérol total et au LDL-cholestérol ; association que nous avons répliquée dans nos populations pédiatriques ($p_{\text{cholestérol total}}=0,002$, $p_{\text{LDL}}=0,0008$). Ainsi, nous avons proposé un biomarqueur liant l'inflammation au risque cardiovasculaire et agissant dès l'enfance.

Les discordances que nous avions précédemment constaté en ce qui concerne la hérédité de la pression artérielle nous ont mené à expérimenter l'influence d'un facteur tiers : l'obésité, sur l'effet des variants associés à ce trait et ceci nous a permis de mieux souligner l'importance de la prise en compte des facteurs d'environnement.

Ce cheminement faisant, nous avons pu discuter des outils bioinformatiques, biostatistiques et méthodologiques manquants encore aujourd'hui à l'approche pangénomique. Nous avons également traité de l'opportunité de l'utilisation de clusters génétiques en prévention et des interactions gène-gène, problématique classique de l'épidémiologie génétique, en nous appuyant sur l'approche gène-candidat étant donné le manque de méthodologie adéquate dans les études pangénomiques.

Une autre lacune de ces études est le fait qu'elles se limitent généralement à l'identification de variants inédits sans investiguer leurs éventuelles fonctionnalités. Ainsi, nous avons démontré l'intérêt de l'intégration d'une approche transcriptomique aux résultats pangénomiques du VEGF, molécule dont la variabilité interindividuelle est pour plus de la moitié sous contrôle génétique (60,6%). Nous avons pu mettre en évidence quatre variants génétiques originaux indépendamment associés au VEGF : rs6921438 ($p=6,11\times 10^{-506}$), rs4416670 ($p=1,47\times 10^{-12}$), rs6993770 ($p=2,50\times 10^{-16}$) et rs10738760 ($p=1,96\times 10^{-34}$) et permettant d'expliquer 48% de la hérédité génétique de ce trait. Parmi eux, la fonctionnalité du SNP rs6993770 a pu être démontrée par une approche transcriptomique.

En conclusion, lors de notre thèse, nous avons eu à la fois une démarche épidémiologique et une démarche de proposition de designs intégrés permettant de mener plus avant les investigations sur l'étiologie génétique des pathologies cardiovasculaires.

ABSTRACT

Complex synergies of genetic, constitutional and environmental risk factors are at the origin of cardiovascular pathologies. Their genetic etiology has been extensively investigated these last decades but many questions remain. Indeed, functional variants explaining the large genetic heritability of cardiovascular risk factors and gene-gene-environment interactions hiding or modulating genetics underpinning cardiovascular physiopathology still have to be elucidated. Above the classic candidate gene approach, developing more efficient tools and designing epidemiologic studies focused on pediatric populations in which gene-environment interactions are minimized could be determinant. This is the major postulate followed during our thesis.

Herein we describe our study of the genetics of several cardiovascular risk factors: lipids, blood pressure, haptoglobin and vascular endothelial growth factor (VEGF), on a French family cohort of supposedly healthy subjects followed during ten years: the STANISLAS Family Study.

In a first step, we assessed the heritability of these cardiovascular risk factors and stressed the interest of studying them in pediatric populations. We highlighted the large genetic heritability of lipid traits (44% for total cholesterol and 32.8% for HDL-cholesterol; $p < 0.001$); and haptoglobin (35.3%, $p < 0.001$) in the STANISLAS cohort. In contradiction with previous studies of our team performed on the same population, we did not observe any significant genetic heritability for blood pressure.

After describing the parental influence of cardiovascular risk factors in the children of the STANISLAS cohort, we performed a Genome-Wide Scan (GWS) on a subsample of 631 unrelated children selected in the STANISLAS cohort and followed two approaches of Genome-Wide Association Studies (GWAS) focused on pediatric populations:

- An exploratory approach seeking for genetic variants associated to an emerging cardiovascular risk factor: haptoglobin;
- And a replication approach focused on widely studied risk factors: lipids and blood pressure.

Since replications in large independent populations are needed in GWAS, we integrated International Consortia giving us access to almost 9,000 children from four pediatric cohorts (OBE, NFBC86, GENDAI and Verona) and 13,300 adults from three different cohorts (DESIR, Framingham and PIVUS).

We demonstrated that genetic associations highlighted in adults were observable in childhood and found 11 novel genetic variants associated to lipid traits and among which 6 were not replicated in adults: rs12591800, rs4918082, rs2607919, rs933193, rs724815 and rs314672.

Concerning haptoglobin, a recently proposed cardiovascular risk marker, we discovered and replicated a variant explaining 42% of its genetic heritability: rs2000999 ($p_{meta-analysis} = 8.1 \times 10^{-59}$). This variant was recently associated to total and LDL-cholesterol; an association we replicated in our pediatric populations ($p_{total\ cholesterol} = 0.002$, $p_{LDL} = 0.0008$). SNP rs2000999 thus present a putative link between inflammation and cardiovascular risk beginning in childhood.

The discrepancies previously observed in the heritability assessment of blood pressure led us to evaluate the effect of obesity on variants associated with this trait. We thus stressed the importance of taking into account environmental factors.

This journey gave us the opportunity to address the tools missing in bioinformatics, biostatistics and methodologies used in GWAS approaches. We also discussed the opportunity of using genetic clusters in prevention strategies and gene-gene interactions, a classic problematic of genetic epidemiology, using a candidate gene approach since there is no such methodology available in GWAS yet.

Another major gap was the fact that GWAS generally identify novel variants without seeking for their eventual functionality. We thus demonstrated the interest to integrate transcriptomic approaches to GWAS using VEGF, a molecule having more than the half of its interindividual variability under genetic control (60.6%). We highlighted four novel genetic variants having an effect on VEGF: rs6921438 ($p = 6.11 \times 10^{-506}$), rs4416670 ($p = 1.47 \times 10^{-12}$), rs6993770 ($p = 2.50 \times 10^{-16}$) and rs10738760 ($p = 1.96 \times 10^{-34}$) and explaining 48% of its genetic heritability. Among them, we demonstrated the functionality of rs6993770 using a transcriptomic approach.

In summary, during our thesis, we followed an epidemiologic approach and proposed integrated designs in order to upgrade the investigations on genetic epidemiology of cardiovascular diseases.

AVANT-PROPOS

En 2030, les maladies cardiovasculaires (MCV) seront à l'origine de 23,56 millions de décès et représenteront toujours la principale cause de mortalité au niveau mondial selon les prévisions de l'Organisation Mondiale de la Santé (OMS).

De nombreuses études épidémiologiques ont été à l'origine d'une meilleure compréhension de l'étiologie de ces pathologies complexes et à la mise en place de mesures préventives basées sur la minimisation des facteurs de risque identifiés. Ainsi, sur le plan évolutif, 'l'épidémie cardiovaseulaire' a régressé dans les pays industrialisés depuis le début des années 1980 ... mais pour atteindre un plateau.

Cette inflexion de l'effet des mesures préventives est bien évidemment due aux limites de l'efficacité des interventions mises en place, notamment à l'adhésion des populations cibles (réponses aux campagnes de prévention visant le tabagisme, la consommation d'alcool, ... etc.), mais surtout au fait que la communauté scientifique n'a pas encore élucidé la totalité des phénomènes menant au développement des pathologies cardiovasculaires. Notamment la génétique sous-jacente.

Le challenge de ces prochaines années est donc de 'réinventer' les techniques et méthodologies d'épidémiologie génétique dont nous disposons.

Historiquement, ces études épidémiologiques étaient basées sur une approche 'gène candidat' définie selon une connaissance *a priori* de la physiopathologie de la maladie d'intérêt et la communauté scientifique s'est donc logiquement heurté aux limites de ses propres connaissances. D'où le plateau observé.

Avec l'avènement des typages pangénomiques ou Genome-Wide Scan (GWS), une approche s'affranchissant de l'hypothèse préalable a vu le jour et a permis de mettre en évidence des cheminements physiopathologiques non soupçonnés et par la même occasion, des biomarqueurs inédits. Les études d'associations pangénomiques ou Genome-Wide Association Studies (GWAS) en sont encore à leurs préludes et n'intègrent pas encore les techniques statistiques complexes qui permettraient, comme pour l'approche gène-candidat, d'incorporer les interactions gène-gène (épistasie) et les interactions gène-environnement. Elles ont néanmoins permis de révolutionner la connaissance étiologique des MCV et des facteurs de risque associés.

L'équipe EA4373 'Génétique Cardiovasculaire' dispose d'un outil permettant de mener à bien ces investigations : la Cohorte STANISLAS regroupant à l'inclusion 1 006 familles nucléaires d'origine Lorraine depuis plus de deux générations. Ces familles, composées de deux parents ayant au moins deux enfants, ont fait l'objet de trois bilans de santé à cinq ans d'intervalle au Centre de Médecine Préventive (CMP) de Vandœuvre-lès-Nancy. Au cours de ces bilans de santé, des données à la fois socio-économiques, biologiques et cliniques ont été recueillies. Au total, 600 variables différentes ont été obtenues pour chaque participant et des banques ADN / ARN / et lymphocytaires ont été constituées et conservées dans un Centre de Ressources Biologiques (CRB) mis en place à cette occasion : le CRB Interactions Gènes-Environnement en Physiopathologies CardioVasculaires (IGE-PCV).

Cet outil nous a permis de mettre en place une stratégie d'étude de divers facteurs de risque des MCV avec une approche pangénomique et de proposer des outils méthodologiques et logistiques acquis tout au long de nos travaux de recherche.

La nécessité, dans le design de telles études, d'analyses confirmatoires dans des populations indépendantes, a mené notre équipe à intégrer des Consortia Internationaux de façon à avoir accès à de larges populations de réPLICATION de nos résultats. Nous avons fait appel en priorité à des populations pédiatriques afin de mieux explorer les interactions gène-environnement du fait de la complexité de telles interactions et du manque de standardisation de l'information concernant ces facteurs dans les populations adultes existantes : les facteurs d'environnement ont un poids moindre chez l'enfant.

Parallèlement, nous avons traité de questions importantes en épidémiologie génétique comme l'utilité des clusters dans la classification des sujets à risque cardiovasculaire ainsi que la nécessité d'intégrer la transcriptomique aux études pangénomiques de façon à déterminer la fonctionnalité éventuelle des variants génétiques mis en évidence.

Notez que lors de la rédaction de ce mémoire, nous avons choisi d'utiliser le 'nous' singulier. Notre contribution effective dans chaque étude est signalée dans le chapitre 'PUBLICATIONS' à la fin de la page de résumé de chaque article.

En règle générale, nous avons participé à la conception des designs des études, à la veille bibliographique et méthodologique, aux débriefings hebdomadaires fédérant l'ensemble des équipes collaboratrices, aux analyses statistiques (en ayant préalablement suivi des formations spécifiques pour les analyses pangénomiques), à la rédaction des articles, ainsi qu'à leur suivi après soumission.

Nous avons également participé à la gestion des échantillons biologiques au sein du CRB IGE-PCV : aliquotages et gestion de la traçabilité des échantillons biologiques.

CHAPITRE 1 – HYPOTHÈSES ET OBJECTIFS

Le développement des MCV est conditionné par des interrelations complexes existant entre facteurs de risque génétiques, constitutionnels et environnementaux que les nombreuses études d'épidémiologie étiologique ont permis d'élucider en partie. En partie seulement, notamment en ce qui concerne l'épidémiologie génétique, car l'approche classique était basée sur la présélection de variants génétiques impliqués dans des voies métaboliques connues.

Or la physiopathologie des MCV empreinte également des voies méconnues que seul l'avènement des études pangénomiques 'hypothesis free' a permis d'entrevoir.

Ainsi, grâce à cette révolution technologique, depuis 2007, de nombreux variants inédits associés aux pathologies cardiovasculaires ou à leurs facteurs de risque ont été mis en évidence et de nouvelles voies métaboliques identifiées. Néanmoins, des zones d'ombres persistent, notamment l'effet cumulatif des variants identifiés qui reste pour le moment très en deçà de l'héritabilité génétique estimée des facteurs de risque cardiovasculaire. Nous pensons que ce fossé provient de carences dans l'information et la modélisation génétiques. Côté modélisation, l'héritabilité manquante pourrait s'expliquer par des phénomènes épistasiques, c'est-à-dire d'interaction entre gènes. En effet, leur influence n'est pas simplement additive, ou dominante/récessive, mais aussi interactive et seule une approche systémique par réseaux de gènes permettra de l'évaluer. De plus, les interactions gène-environnement ne sont pas encore intégrées aux approches pangénomiques alors qu'il est établi que dans certains cas, la présence de gènes parfaitement fonctionnels ne suffit pas à l'émergence d'un trait chez l'individu en l'absence de certaines stimulations environnementales. Enfin, la fonctionnalité de l'immense majorité des variants issus des GWAS reste méconnue.

Ainsi, dans cette thèse, nous avons émis l'hypothèse que la compréhension des pathologies multifactorielles par l'approche pangénomique est conditionnée par la nécessité de mettre en œuvre des designs intégrés permettant d'appréhender les 'carences' méthodologiques qu'elle comporte. Notamment, l'étude de la fonctionnalité des variants inédits, des phénomènes épistasiques et des interactions gène-environnement qu'il est difficile d'appréhender dans le cadre d'études de réPLICATION intégrant des populations d'horizons divers et avec un recueil de l'information non standardisé. Pour ce dernier point, notre postulat était de nous focaliser sur des populations pédiatriques où les facteurs d'environnement (tabagisme, consommation d'alcool, prise de la pilule, ... etc.) sont moins importants pour la recherche de nouveaux variants de quatre voies métaboliques associées au risque cardiovasculaire : les lipides, la pression artérielle, l'inflammation via l'haptoglobine et l'adhésion via le facteur de croissance de l'endothélium vasculaire (VEGF).

Nous avons donc poursuivi quatre objectifs majeurs :

- (1) Acquérir les compétences méthodologiques et logistiques que nécessite une approche pangénomique.
- (2) Mettre en évidence des variants inédits associés aux facteurs de risque des pathologies cardiovasculaires précédemment cités.
- (3) Appréhender les possibilités et limitations méthodologiques des études d'associations pangénomiques dans le domaine du risque cardiovasculaire.
- (4) Expérimenter une stratégie globale exploratoire intégrant l'étude des interactions gène-gène et gène-environnement en nous basant sur des gènes-candidats ainsi que sur la recherche de fonctionnalité par la transcriptomique.

CHAPITRE 2 – SITUATION DU SUJET

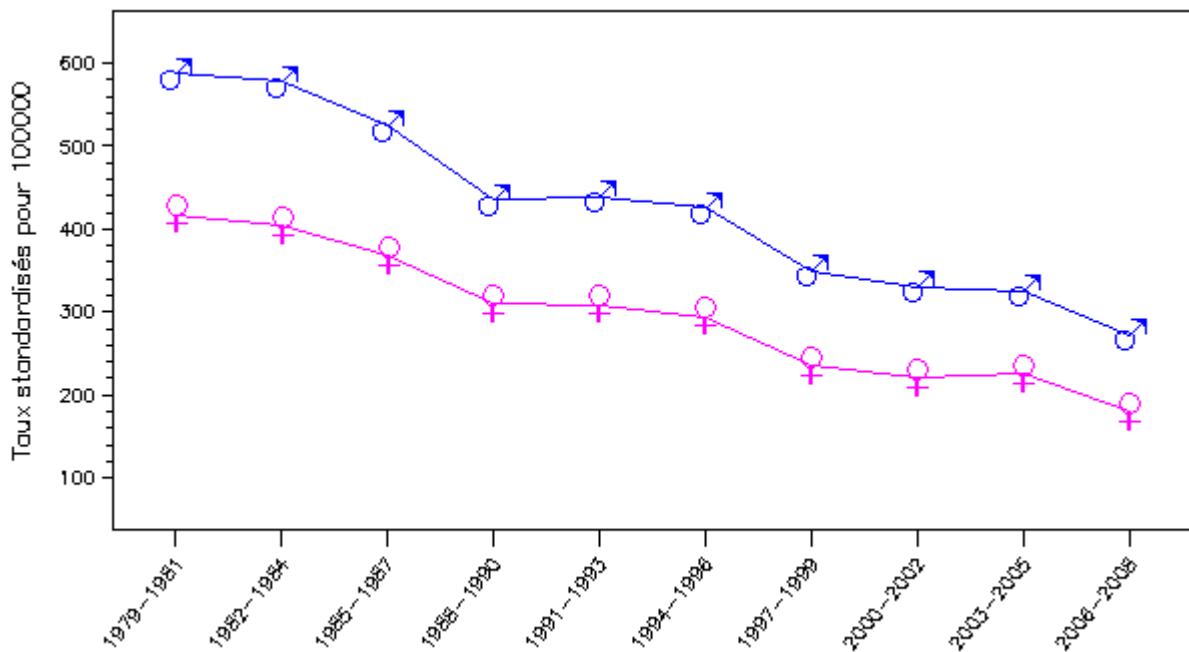
1. Épidémiologie des maladies cardiovasculaires

Les MCV sont à l'origine de 17,1 millions décès chaque année dans le monde, ce qui représente 29% de la mortalité globale selon les données de l'OMS et elles atteindront 23,56 millions de décès au niveau mondial en 2030.

En France, malgré un ralentissement de la mortalité cardiovasculaire depuis ces trente dernières années (**Figure 1**), ces affections ont été à l'origine de plus de 146 000 décès en 2008 (53,5% de femmes) soit 27,5% de la totalité des décès toutes causes confondues (**Tableau 1**) selon les données du 'Centre d'Épidémiologie sur les causes médicales de Décès' (CépiDC – INSERM, <http://www.cepidc.vesinet.inserm.fr/>).

Les MCV sont donc toujours une préoccupation majeure de santé publique, dont les principales manifestations sont les cardiopathies ischémiques et les maladies cérébrovasculaires. Elles représentaient respectivement 25,7 et 22% de décès en 2008.

2. Physiopathologie des maladies cardiovasculaires

Sous la terminologie de MCV, la littérature médicale fait référence à différentes pathologies chroniques ou évènements ayant en commun une physiopathologie liée à l'athérosclérose infraclinique et responsable de mort prématuée : les maladies coronariennes, les accidents vasculaires cérébraux (AVC), les pathologies vasculaires périphériques et l'insuffisance cardiaque. Ces affections sont dites multifactorielles car elles sont la résultante de l'association synergique de plusieurs facteurs de risque 'se rapportant à des attributs, caractéristiques ou expositions d'un individu, associés à une incidence accrue de l'affection' (lien de causalité entre le facteur et la maladie). Ces facteurs de risque sont retenus en fonction de différents critères :

- La force de leur association avec la maladie exprimée par le risque relatif observé chez les sujets exposés par rapport aux non exposés ;
- Le caractère graduel de cette association quand le risque de développer la maladie augmente parallèlement au niveau du facteur de risque ;
- La temporalité c'est-à-dire le fait que le facteur de risque précède bien la maladie et non l'inverse ;
- Le caractère universel de l'association vérifié par la cohérence entre différentes études portant sur des populations différentes et des groupes vivant dans des conditions différentes ;
- L'indépendance, c'est-à-dire la persistance de l'association entre le facteur et la maladie même lorsque sont pris en considération les effets d'autres facteurs de risque dans le cadre d'une analyse multivariée ;
- Le caractère plausible de l'association vis-à-vis des résultats d'autres approches (sciences fondamentales, expérimentations animales ou in vitro, études cliniques, ... etc.) ;
- Et enfin la réversibilité quand la correction du facteur de risque permet de réduire l'incidence de la maladie. Il s'agit là de l'argument le plus fort en termes de causalité nécessitant la réalisation d'essais cliniques d'intervention pour être affirmé.

Classiquement, les recommandations identifient trois groupes de facteurs de risque cardiovasculaire en fonction de leur degré d'imputabilité et de l'état actuel des connaissances scientifiques [Agence nationale d'accréditation et d'évaluation en santé (ANAES) Juin 2004. Méthodes d'évaluation du risque cardiovasculaire global. Service Évaluation en Santé Publique ; Grundy et al^a. 1999 ; Grundy et al^b. 1999] :

- Les facteurs de risque majeurs qui ont un effet multiplicateur sur le risque cardiovasculaire indépendamment des autres facteurs de risque ;
- Les facteurs de risque prédisposants qui ont un effet potentialiseur lorsqu'ils sont associés aux facteurs de risque majeurs ;
- Et les facteurs de risque émergents (ou discutés) des MCV associés à un risque augmenté mais dont le degré d'imputabilité et/ou le mécanisme d'action sont méconnus à ce jour.

Ces facteurs de risque sont soit constitutionnels ou génétiques donc non modifiables, soit environnementaux et donc modifiables.

Notez que le terme 'marqueur de risque' est préférable dans les cas où le facteur est fortement associé au risque de survenue de la MCV tout en n'ayant pas l'un des critères précédemment cités. Notamment la séquence temporelle ou le caractère indépendant. Par exemple, l'impact de l'obésité sur le risque coronarien est en bonne partie dépendant de son impact propre sur l'hypertension artérielle (HTA), les dyslipidémies et le diabète.

Dans la pratique toutefois de tels marqueurs sont très utiles pour identifier certains individus particulièrement à risque, car ils peuvent intégrer l'impact de plusieurs facteurs de risque. Il peut s'agir de paramètres cliniques comme la pression pulsée (PP) ; ou de mesures para-cliniques comme l'épaisseur intima-média (EIM) mesurée au niveau carotidien et qui prédit le risque ultérieur d'évènement cardiovasculaire.

2.1. Les facteurs de risque classiques des maladies cardiovasculaires

Les facteurs de risque classiques et donc validés des MCV sont l'âge et le sexe, les antécédents familiaux, le tabagisme, l'HTA, les dyslipidémies, le diabète, l'obésité, les facteurs nutritionnels et la sédentarité.

2.1.1. L'âge et le sexe

Il est bien établi que le risque cardiovasculaire augmente avec l'âge et que l'homme est nettement plus exposé aux accidents cardiovasculaires que la femme en période d'activité génitale. Cette disparité est d'ailleurs visible sur les courbes d'évolution des taux de décès (**Figure 1**). Néanmoins, la surmortalité masculine est plus marquée avant 65 ans (**Tableau 2**), avec des proportions quasiment inchangées depuis 30 ans ; puis le niveau de risque de la femme rejoint très progressivement celui de l'homme après la ménopause.

Lors de ses recommandations en 2000, L'ANAES, devenue la Haute Autorité de Santé (HAS) en 2004, proposait de considérer l'âge comme un facteur de risque des MCV à partir de 45 ans chez l'homme et de 55 ans chez la femme.

2.1.2. Les antécédents familiaux

Il s'agit des accidents cardiovasculaires précoces survenus chez les parents du premier degré (avant 55 ans chez l'homme et 65 ans chez la femme).

Il a été démontré, notamment par une étude prospective au sein de la cohorte Framingham [Schildkraut et al. 1989], que la survenue d'un décès d'origine coronarienne chez un parent augmentait de 30% le risque de maladie coronarienne chez ses enfants, hommes ou femmes, avec une probabilité plus forte qu'elle s'installe avant 60 ans. Ce facteur de risque est d'ailleurs l'un des composants des équations de calcul du risque cardiovasculaire absolu (RCVA) [Anderson et al^a. 1991 ; Anderson et al^b. 1991].

Néanmoins, sa prise en compte comporte une certaine imprécision car l'âge réel de survenue de l'évènement cardiovasculaire est souvent difficile à déterminer par le sujet investigué. De plus, cette prédisposition familiale englobe également les anomalies métaboliques familiales (dyslipidémies, diabète, ... etc.) déjà incluses dans les équations de risque.

2.1.3. Le tabagisme

Avec de nombreux composants délétères favorisant les complications de l'athérosclérose [Pipe et al. 2010] et un effet d'autant plus élevé que le sujet est jeune [Gooding & Ferranti. 2010], le tabagisme est un facteur de risque cardiovasculaire modifiable exposant tout particulièrement au risque d'infarctus du myocarde et de mort subite : les gros fumeurs inhalant la fumée voyaient leur risque de mort subite multiplié par 5 dans l'Étude prospective parisienne [Jouven et al. 1999]. Il est également un facteur de risque majeur de l'artériopathie oblitérante des membres inférieurs.

Son caractère réversible est bien établi : en prévention primaire, le risque coronarien des sujets en sevrage tabagique depuis 2 à 3 ans ne diffère pas significativement de celui de sujets n'ayant jamais fumé. En prévention secondaire le risque de récidive d'infarctus ou de décès diminue de près de 50% dès la première année pour rejoindre en quelques années le risque de sujets n'ayant jamais fumé.

2.1.4. L'hypertension artérielle

Il n'existe pas de seuil de pression artérielle individualisé en deçà duquel le risque cardiovasculaire que constitue ce trait peut être considéré comme nul.

Le rôle délétère de la pression artérielle diastolique (PAD) a été le premier à avoir été mis en évidence mais c'est la pression artérielle systolique (PAS) qui a la signification pronostique la plus impactante. Quant à la PP (PAS-PAD) elle traduit une altération de la compliance (ou fonction d'amortissement) des gros vaisseaux.

L'HTA est également un composant permettant la détermination du RCVA [Anderson et al^a. 1991 ; Anderson et al^b. 1991] mais la pression artérielle est mesurée en clinique, au cabinet du médecin, ce qui altère souvent sa signification pronostique.

Au niveau circulatoire, le processus d'artériosclérose, se traduisant par une atteinte pathologique de la média au niveau des gros et des petits vaisseaux, est un phénomène spécifiquement lié à l'HTA et au vieillissement à l'inverse du processus d'athérosclérose, dans lequel l'HTA n'intervient qu'en tant que facteur de risque.

Au niveau cardiaque, l'HTA favorise la formation de plaques athéromateuses au niveau des gros troncs coronariens, générant ainsi une authentique insuffisance coronarienne organique. Elle contribue également, en collaboration avec divers facteurs neurohormonaux, à l'apparition d'une hypertrophie ventriculaire gauche associant hypertrophie myocytaire et expansion du tissu de soutien.

Les traitements antihypertenseurs ont un effet direct sur la morbidité et la mortalité cardiovasculaire en réduisant nettement le taux de survenue des AVC (de 30 à 40% suivant les populations considérées) et des accidents coronariens (10 à 15 %). Ainsi, l'HAS [Prise en charge des patients adultes atteints d'hypertension artérielle essentielle – Actualisation 2005] préconisait les objectifs tensionnels suivants :

- PAS/PAD < 140/90 mmHg chez l'adulte d'âge moyen ;
- PAS < 150 mmHg chez le sujet âgé avec hypertension systolique ;
- PAS/PAD < 140/80 mm Hg chez le diabétique de type 2 ;
- PAS/PAD < 130/85 mm Hg chez l'insuffisant rénal sans protéinurie ;
- PAS/PAD < 125/75 mm Hg chez l'insuffisant rénal avec protéinurie > 1g/j.

2.1.5. Les dyslipidémies

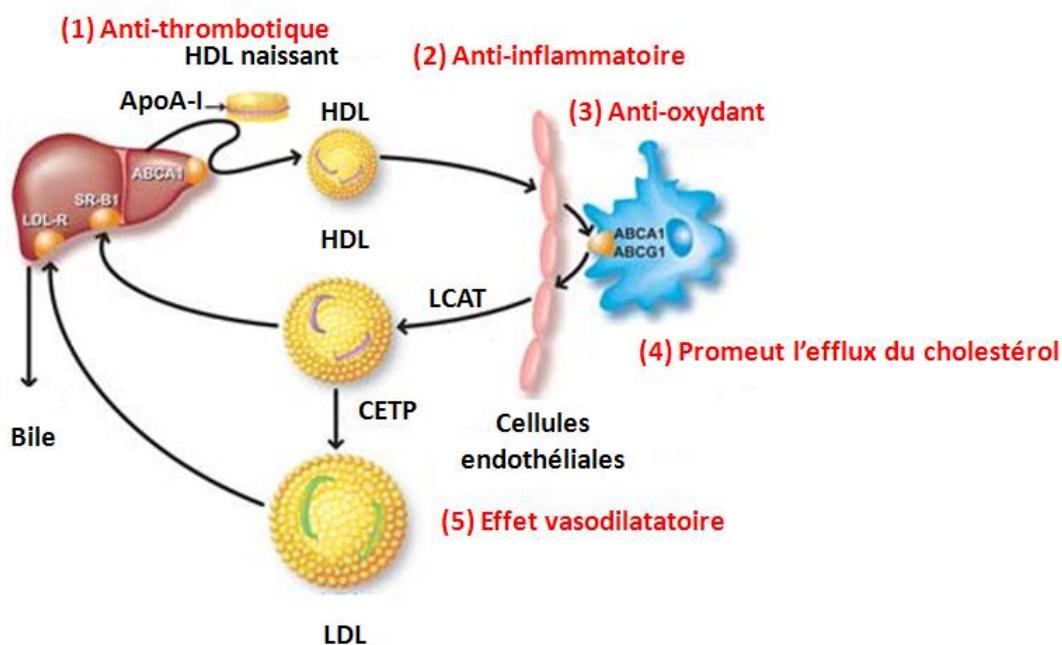
Le cholestérol total et le LDL-cholestérol

Le lien entre hypercholestérolémie et athérosclérose est particulièrement bien établi, essentiellement pour les pathologies coronaires. L'élévation du cholestérol total et de la low-density lipoprotein cholesterol (LDL-C, forme principale de transport du cholestérol dans l'organisme) est associée à une augmentation curvilinéaire du risque coronarien [Stamler et al. 2008]. Néanmoins, cette relation est très atténuée chez les femmes en raison du poids important que joue la high-density lipoprotein cholesterol (HDL-C) ainsi que chez les sujets âgés de plus de 65 ans comme cela sera exposé par la suite.

Le HDL-cholestérol

Le HDL-C est impliqué dans le transport reverse du cholestérol vers les voies d'élimination (**Figure 2**). C'est donc sa diminution qui constitue un facteur de risque cardiovasculaire comme cela a été démontré dans de nombreuses études épidémiologiques : une augmentation du HDL-C de 0,026 mmol/L s'accompagne d'une diminution du risque coronarien de 2% chez l'homme et de 3% chez la femme [Gordon et al. 1989].

Il s'agit également d'un facteur dont les interconnexions avec les facteurs de risque classiques des MCV sont connues ; notamment le fait que sa concentration est abaissée par le tabagisme, l'hypertriglycéridémie, et à l'inverse augmentée par la consommation d'alcool et les œstrogènes. Cette dernière caractéristique explique en partie la protection féminine vis à vis du risque coronarien évoquée précédemment et le fait que cette protection féminine disparaisse progressivement avec la ménopause.

Selon les recommandations françaises, une concentration en HDL-C inférieure à 0,9 mmol/L (inférieure à 1,03 mmol/L selon les recommandations américaines) peut être considérée comme un facteur de risque supplémentaire. Il a d'ailleurs été proposé, notamment par l'étude Framingham [Anderson et al^a. 1991 ; Anderson et al^b. 1991], d'utiliser les ratios [cholestérol total / HDL-C] ou [LDL-C / HDL-C] pour la prédition du risque coronarien.

Les Triglycérides

L'élévation des triglycérides (TG), et notamment l'hypertriglycéridémie ($> 1,32\text{-}1,75 \text{ mmol/L}$) est associée à une augmentation du risque coronarien. Cependant, la relation entre TG et risque coronarien est largement dépendante de l'effet d'autres facteurs de risque qui s'accompagnent souvent d'une élévation de la triglycéridémie : l'obésité, le diabète, l'hypercholestérolémie, la baisse du HDL-C, l'HTA, ... etc.

Récemment, le phénotype ‘hypertriglycéridémie-fort tour de taille’ (hypertriglyceridemic-waist phenotype) a été associé à une détérioration du profil de risque cardiométabolique et à une accentuation du lien entre hypertriglycéridémie et pathologies coronariennes [Arsenault et al. 2010] chez 21 787 participants âgés de 45 à 79 ans issus de la ‘European Prospective Investigation of Cancer (EPIC)-Norfolk Prospective Population Study’ et suivis sur une dizaine d’années.

2.1.6. Le diabète

Le diabète est fortement lié au risque de maladie coronarienne qu'il multiplie par un facteur 3 chez la femme, et 2 chez l'homme. Ainsi, le risque cardiovasculaire des femmes diabétiques rejoint celui des hommes non diabétiques.

L'étude MONItoring trends and determinants in CArdiovascular disease' (MONICA) menée par l'OMS a pu observer que la mortalité coronarienne était aussi élevée chez un diabétique n'ayant pas fait d'infarctus, que chez un non diabétique ayant déjà fait un infarctus dans une population Finnoise [Miettinen et al. 1998] : la quantification du RVCA donne donc un poids équivalent au diabète et aux antécédents d'infarctus.

Une attention toute particulière devrait être portée à la prévention primo-secondaire du diabète comme cela a récemment été discuté, toujours au sein de populations Finnoises [Barengo en al. 2008] : quatre études de population menées dans les années 70 (1972 et 1977) puis 80 (1982 et 1987) et réunissant un total de 16 779 hommes et 18 235 femmes suivies pendant dix ans ont permis d'observer une augmentation, en une décennie, du

risque relatif de mortalité coronarienne chez les hommes diabétiques comparés aux hommes non diabétiques :

- De 1,67 à 1,75 chez les hommes de 25 à 49 ans ayant un diabète antérieur à leur inclusion dans une cohorte ;
- Et de 1 à 1,92 chez les hommes développant un diabète au cours de leur période de suivi.

2.1.7. L'obésité

Un excès ou une insuffisance de poids est chiffrable par le calcul de l'indice de masse corporelles (IMC) ou rapport [poids / taille²] selon la formule de Quetelet (**Tableau 3**).

L'obésité et la surcharge pondérale sont associées à un risque coronarien nettement accru mais ce facteur est en partie dépendant de son impact sur les autres facteurs de risque cardiovasculaire : l'HTA (75% en partie dues à la surcharge pondérale), les dyslipidémies ou le diabète.

Néanmoins, la surcharge pondérale a un effet propre car après ajustement sur les facteurs associés, le risque ne s'annule pas. En effet, Rimm et ses collaborateurs ont démontré que le risque relatif de maladie coronarienne chez les hommes âgés de 40 à 65 ans après cet

ajustement était de 1,72 pour un IMC compris entre 25 et 29 ; de 2,61 entre 29 et 33 ; et de 3,44 pour les obèses ayant un IMC > 33 kg/m², en comparaison avec les hommes ayant un IMC < 23 kg/m² [Rimm et al. 1995]. Au delà de 65 ans l'association entre surcharge pondérale et risque coronarien était cependant très atténuée.

La répartition de l'adiposité est également un facteur de risque en soi. En effet, une répartition de type centrale ou androïde de l'adiposité (au niveau de l'abdomen) majore significativement le risque. Ainsi, le tour de taille (**Tableau 4**), ou le ratio [tour de taille / tour de hanche] constituent des facteurs de risque importants et l'excès d'adiposité abdominale est fortement associé à plusieurs perturbations des facteurs de risque cardiométaboliques [Liu et al. 2010].

2.1.8. Les facteurs nutritionnels

L'influence majeure des facteurs nutritionnels sur le risque cardiovasculaire, et en particulier coronarien, est démontrée par de nombreux travaux épidémiologiques.

En 1952, une étude comparative portant sur les habitudes alimentaires et les risques de MCV visant à suivre de façon précise l'état de santé de 13 000 individus répartis dans sept pays (les États-Unis, la Finlande, la Hollande, le Japon, l'Italie, la Yougoslavie, et la Grèce) sur plus de vingt ans : la ‘Seven Countries Study’ [Keys et al. 1984 ; Kromhout et al. 1989], a montré d'importantes différences d'incidence des maladies coronariennes entre

populations, le minimum étant observé au Japon et dans les populations méditerranéennes avec des incidences plus de 10 fois inférieures à celle observée en Finlande. Ces disparités étaient expliquées en partie par une cholestérolémie plus basse. Cependant à cholestérolémie égale, le risque coronarien était beaucoup plus faible dans les pays à faible incidence, soulignant l'influence d'autres facteurs environnementaux dont les facteurs nutritionnels. En particulier, l'étroite corrélation entre consommation en graisses saturées et risque coronarien [Kromhout et al. 1999].

Mais l'importance des facteurs nutritionnels est également observable dans le cas des études de migration comme cela a été le cas pour la 'Ni Hon San Study' dans laquelle il a été démontré qu'une consommation plus importante en protéines animales et en graisses saturées des Japonais ayant immigré à Hawaï était à l'origine de l'incidence moindre des AVC observée dans cette communauté par rapport à celle demeurée au Japon [Takeya et al. 1984]. De telles disparités chez des sujets de différentes ethnicités vivant dans des zones géographiques (ou culturelles) différentes a également été observée par le 'Honolulu Heart Program' (HHP) [Benfante et al. 1992].

2.1.9. La sédentarité

Une méta-analyse de plusieurs études de cohorte a démontré que la sédentarité multipliait par 1,9 le risque de décès d'origine coronarienne après ajustement sur les autres facteurs de risque [Berlin & Goldtiz. 1990]. De même, dans les suites d'un infarctus du myocarde, l'absence d'activité physique est associée à une plus forte mortalité totale et coronaire, par rapport aux patients qui bénéficient d'une réadaptation cardiovasculaire.

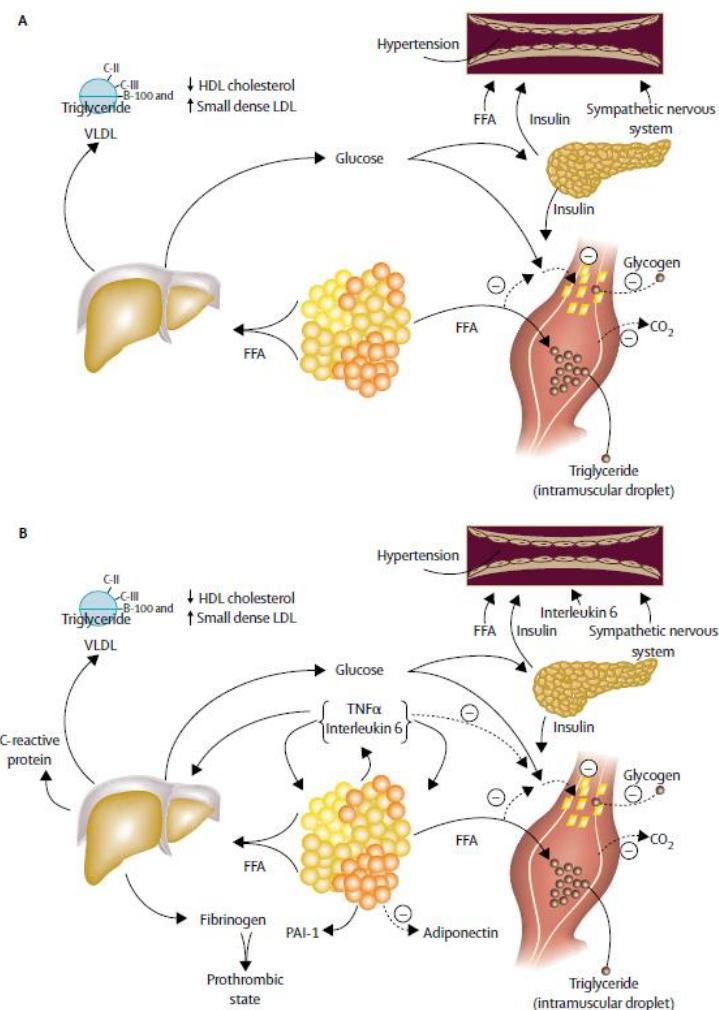
En prévention primaire, une activité physique régulière diminue le risque cardiovasculaire tout en modifiant de nombreux facteurs de risque associés [Aijaz et al. 2010] et en post infarctus, un programme de réadaptation cardiovasculaire est préconisé par la Société Française de Cardiologie.

2.1.10. Le syndrome métabolique

Le syndrome métabolique (SM) ou syndrome X est un cluster regroupant diverses anomalies cliniques et biologiques souvent modérées mais dont l'association présente un risque cardiovasculaire majeur [Alberti et al. 2005 ; Eckel et al. 2010] (**Figure 3**). Ce syndrome, qui a été répertorié dans la 10^{ème} révision de la classification internationale des maladies (CIM10) en 1990, n'est cependant pas une pathologie proprement dite mais un état pré-pathologique ou ‘bombe à retardement cardiovasculaire’ augmentant le risque de diabète de type 2 et de maladie coronarienne [Eckel et al. 2005].

Il en existe plusieurs définitions, proposées notamment par l'OMS et l'European Group for the Study of Insulin Resistance (EGIR) en 1999, le National Cholesterol Education Program's Adult Treatment Panel III (NCEP-ATPIII) en 2001 et l'International Diabetes Federation (IDF) en 2005. Les différenciations de ces définitions portaient sur les seuils de classification des composantes du SM mais un consensus relatif existait sur les facteurs à prendre en compte : une insulinorésistance, une dyslipidémie, une hypertension, et une obésité abdominale (**Tableau 5**).

A : Les acides gras libres (FFA) sont émis en abondance par une masse étendue de tissu adipeux. Dans le foie, les FFA conduisent à une augmentation de la production du glucose et, des triglycérides et de la sécrétion des VLDLs. Les anomalies des lipides et lipoprotéines associés incluent la diminution de la concentration en HDL-C et une augmentation de la densité des LDLS. Les FFA réduisent également l'insulinosensibilité au niveau musculaire en inhibant l'entrée du glucose médiée par l'insuline. Les défauts associés incluent une diminution de la transformation du glucose en glycogène et une augmentation de l'accumulation des lipides sous forme de triglycérides. B: L'effet endocrine et paracrine de l'état proinflammatoire se superpose et contribue à l'IR produite par des FFA en excès. Produites par différentes cellules dans le tissu adipeux qui incluent les adipocytes et les macrophages, l'augmentation de la sécrétion d'IL-6 et de TNF- α , parmi d'autres cytokines, conduit à une aggravation de l'IR et à la lipolyse des stocks de triglycérides qui sont transformés en FFA circulants. L'IL 6 et d'autres cytokines sont également augmentées et peuvent conduire à des productions hépatiques élevées de glucose et des VLDL ainsi qu'à une augmentation de l'IR au niveau musculaire. Les cytokines et les FFA augmentent aussi la production hépatique de fibrinogène et de PAI-1 qui complète la surproduction de PAI-1 par le tissu adipeux. Ceci conduit à un état pro-thrombotique. Des diminutions dans la production de l'adiponectine, une cytokine anti-inflammatoire et insulinosensibilisante, sont également associées au SM et pourraient contribuer à la physiopathologie du SM.

2.2. Les facteurs de risque émergents des maladies cardiovasculaires

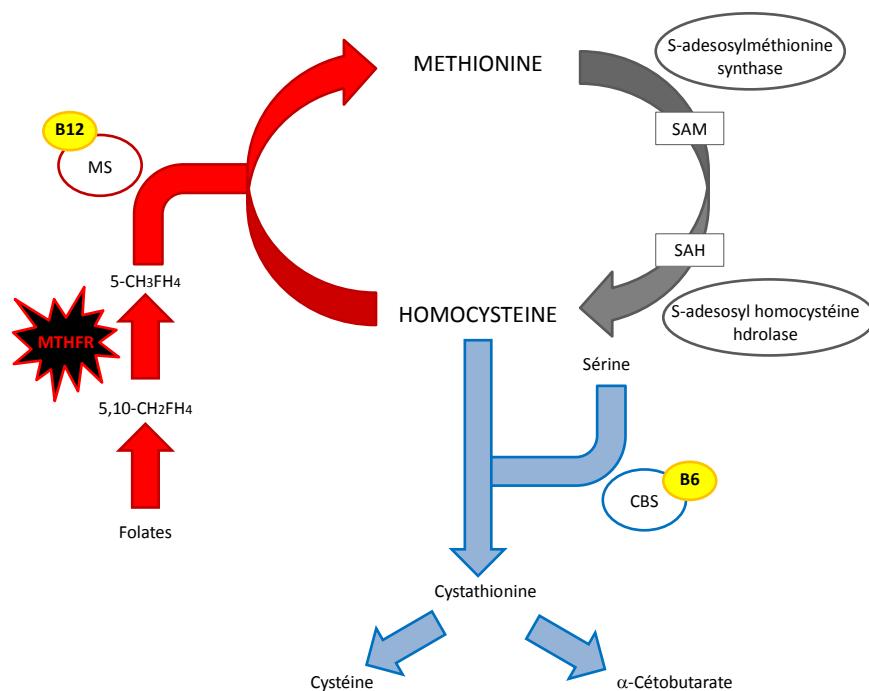
Il s'agit de facteurs de risque en cours de validation : l'hyperhomocystéinémie, les facteurs psychosociaux, les facteurs thrombogéniques, les marqueurs de l'inflammation, les molécules d'adhésion, les traitements hormonaux, la fréquence cardiaque, ... etc.

Cette liste est donc par définition non exhaustive.

2.2.1. L'hyperhomocystéinémie

L'homocystéine est un acide aminé intervenant dans le métabolisme de la méthionine et des folates. Elle se situe au carrefour de 2 voies métaboliques : la transsulfuration qui dégrade l'homocystéine en cystéine avec l'intervention de la vitamine B6 comme cofacteur ; et la reméthylation qui la retransforme en méthionine avec pour cofacteur la vitamine B12 et les folates (**Figure 4**).

Physiologiquement, l'homocystéinémie est comprise entre 5 et 15 mmol/L. L'homocystinurie, maladie autosomique récessive rare, associe une hyperhomocystéinémie majeure (concentration 20 fois supérieure à la normale), un retard mental, des anomalies osseuses, une luxation du cristallin et des thromboses artérielles et veineuses précoces. Une hyperhomocystéinémie modérée a également été associée à une élévation du risque athérothrombotique mais sa quantification n'a pas pour autant été préconisée en prévention primaire [Ducros et al. 2009].

Des études d'intervention visant à supplémenter l'alimentation en folates seuls ou en association aux vitamines B6 ou B12 ont pourtant montré leur efficacité à abaisser la concentration sérique en homocystéine et en cholestérol total chez les enfants [Papandreou et al. 2010] et à réduire le risque coronarien des sujets âgés ayant un déficit en vitamines B12 [Kurt et al. 2010].

2.2.2. Les facteurs psychosociaux et environnementaux

Le risque cardiovasculaire des catégories sociales défavorisées est plus élevé pour des raisons d'ordre à la fois culturel, économique et nutritionnel ; ce qui explique la complexité de mener de telles études car elles sont soumises à de nombreux facteurs de confusion. Les bénéfices éventuels d'une prise en charge de facteurs psychosociaux sont donc difficiles à évaluer.

Du point de vue environnemental, il a été observé, notamment par l'étude MONICA, que la température journalière moyenne était inversement proportionnelle au taux d'infarctus et que la pollution atmosphérique avait également un impact cardiovasculaire [Bener et al. 2009].

2.2.3. Les facteurs thrombogéniques

Un grand nombre de facteurs prothrombotiques ont été individualisés au cours de ces dernières années : en particulier le fibrinogène et le facteur VII (FVII) ont été désignés comme des facteurs de risque d'infarctus du myocarde indépendants du cholestérol et du tabac, la viscosité sanguine, le taux de globules blancs et la concentration en facteur de von Willebrand, et l'inhibiteur de l'activateur du plasminogène 1 (PAI-1).

2.2.4. Les marqueurs de l'inflammation

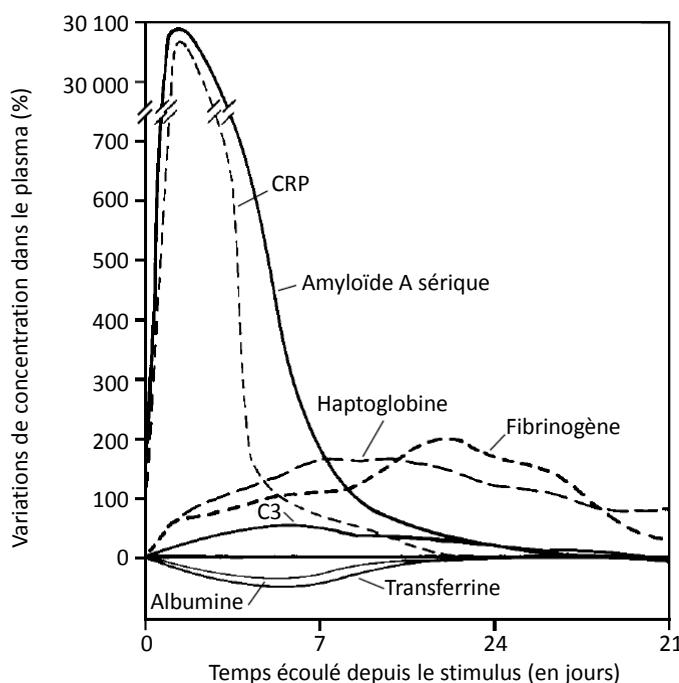

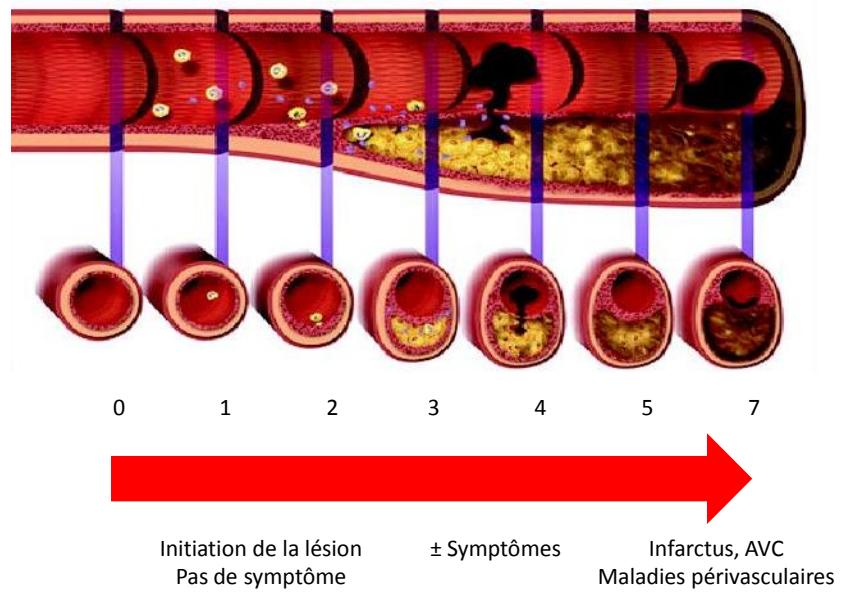
Figure 5 : Profils de variation de concentration plasmatique des protéines de la phase aiguë de l'inflammation à la suite d'un stimulus modéré

Il a clairement été établi que le processus inflammatoire se situait au cœur de nombreuses pathologies et l'opportunité d'utiliser la quantification des marqueurs de l'inflammation, notamment les protéines de la phase aiguë ou Protéines de la Réaction Inflammatoire (PRI) (**Figure 5**), pour identifier les sujets à risque cardiovasculaire en prévention primaire a été discutée. Les recommandations de la ‘National Cholesterol Education Program Adult Treatment Panel III’ [Expert Panel on Detection, Evaluation, and Treatment of High Blood Cholesterol in Adults. 2001] exposaient notamment (1) le manque de standardisation de leur quantification ; (2) de résultats cohérents issus des études épidémiologique prospectives et (3) le fait que la prise en compte de tels marqueurs ne modifiait pas les scores prédictifs préexistants. La Vème conférence de ‘l’American Heart Association’ (AHA) [Pearson et al. 2004] déplorait quant à elle en 2004 le manque de consensus professionnel ou gouvernemental sur la manière d’intégrer la quantification de tels marqueurs dans la pratique clinique.

Néanmoins, l’implication des marqueurs de l’inflammation (protéine C-réactive ou CRP, quantification des leucocytes, ... etc.) dans la médiation de tous les stades du processus d’athérosclérose (**Figure 6**) [Libby et al. 2002] en commençant par le stade infraclinique et surtout leur forte implication dans les effets pléiotropiques des thérapies hypolipémiantes [Albert et al. 2001 ; Liao. 2002 ; Topol. 2004] suggèrent un effet bénéfique de leur incorporation dans les stratégies de prise en compte du risque cardiovasculaire.

Traditionnellement, le fait qu’une augmentation de la CRP majore le risque cardiovasculaire est connu : il s’agit d’un marqueur et d’un activateur de l’inflammation qui interagit avec les

autres cytokines au niveau de l'endothélium et favorise le développement des plaques athéromateuses. Elle est également un marqueur de la présence de nombreux éléments inflammatoires au sein de la plaque, caractéristique connue pour favoriser sa rupture. C'est donc un facteur de risque entré depuis déjà quelques temps dans la pratique courante.

Les protéines de la phase aiguë de l'inflammation sont définies empiriquement comme des protéines dont la concentration plasmatique évolue au cours d'une réaction inflammatoire. Les Protéines dont la concentration plasmatique augmente sont appelées Protéines de la Réaction Inflammatoire positives (PRI+) et celles dont la concentration plasmatique diminue Protéines de la Réaction Inflammatoire négative (PRI-). Chez l'Homme, les PRI+ sont l' α_1 glycoprotéine acide, l' α_1 protéase inhibiteur, l' α_1 antichymotrypsine, l'haptoglobine, la céroloplasmine, la CRP et l'Amyloïde A protéine. Les principales fonctions des PRI résultent d'une interaction des protéines avec des ligands d'origine diverse, et de la formation de complexes dont l'épuration est assurée soit par le système réticulo-endothélial, soit par l'hépatocyte. Il s'ensuivra l'inactivation des protéases, la neutralisation de molécules toxiques tels l'hémoglobine et les ions superoxydes, l'évacuation de débris membranaires, leucocytaires ou cellulaires et de débris nucléaires telle la chromatine. La chute de la concentration plasmatique des PRI au cours d'une réaction inflammatoire, entraîne une augmentation de la fraction libre de certains ligands (acides gras, hormones, vitamines, oligoéléments).

Mais d'autres marqueurs de l'inflammation ont récemment été proposés en prévention cardiovasculaire. L'haptoglobine notamment est une molécule de la phase aiguë de l'inflammation (Figure 4) synthétisée par le foie et dont une diminution drastique est un indice d'hémolyse pathologique, d'insuffisance hépatique, ou de maladie rénale. Cette protéine, comme l'ensemble des protéines de la phase aiguë, est régulée par des cytokines [Gabay & Kushner. 1999] et a pour propriété principale de former un complexe avec l'hémoglobine lors de son relargage par les érythrocytes en vue de son élimination dans le foie. Le taux d'haptoglobine a été lié au développement de maladies infectieuses telles que la malaria, la tuberculose et l'infection au virus de l'immunodéficience humaine (VIH) [Carter et al. 2007]. L'haptoglobine est composée de deux paires de chaînes α et β et est présente sous trois formes phénotypiques associées à diverses pathologies : Hp1-1, Hp2-2 et Hp2-1 [Koda et al. 1998]. Il a notamment été démontré que des sujets diabétiques porteurs du

phénotype Hp2-2 avaient un risque cardiovasculaire quatre à cinq fois plus élevé [Asleh et al. 2008].

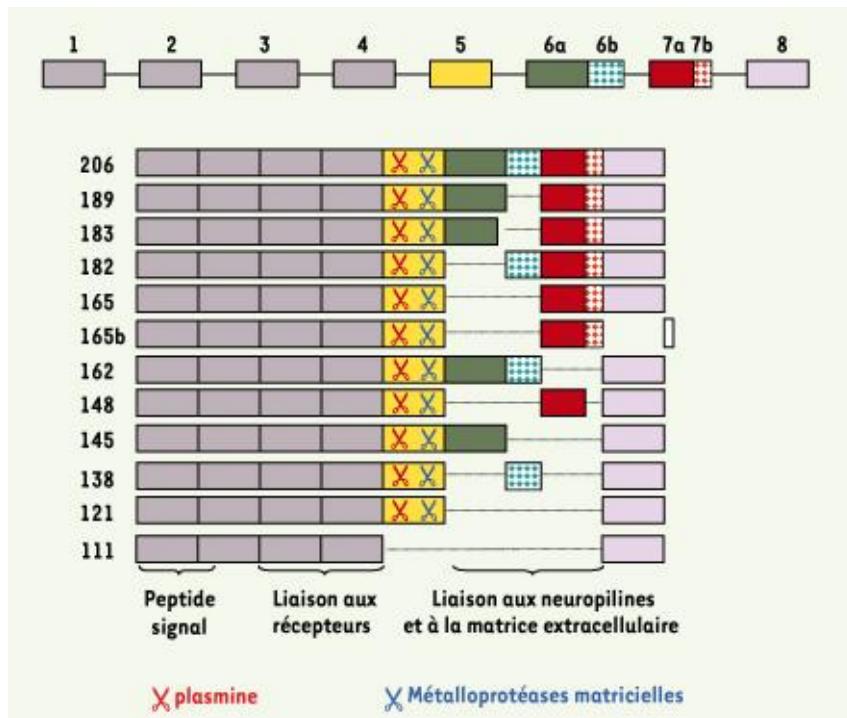
Récemment, l'haptoglobine a été liée, à la suite d'une étude prospective sur près de 12 ans, à l'infarctus du myocarde, aux AVC et à l'insuffisance cardiaque chez 342 125 sujets issus de l'Apolipoprotein Mortality RISK study (AMORIS) [Holme et al. 2010]. Dans cette même population, l'importance de l'incorporation des marqueurs communs d'inflammation, dont l'haptoglobine, dans les stratégies de prédition d'événements cardiovasculaires [Holme et al. 2010] a permis de rouvrir le débat sur l'opportunité d'utiliser de tels marqueurs en prévention.

2.2.5. Les molécules d'adhésion

Le VEGF est l'un des principaux facteurs contrôlant le développement et le maintien de l'arbre vasculaire chez l'homme (angiogenèse) avec le Fibroblast Growth Factor (FGF). Ce facteur est principalement associé au développement tumoral et métastatique [Carmeliet & Jain. 2000] mais il est également au centre de nombreuses pathologies [Ferrara et al. 2003] dont les MCV. En effet, des taux élevés de VEGF circulants ont été observés dans les cas de pathologies ischémiques [Hojo et al. 2000 ; Blann et al. 2002] et des thérapies pro-angiogènes ciblées entre autre sur ce type de pathologie et utilisant le VEGF sont en phase d'essais cliniques [Buysschaert et al. 2007]. Des taux élevés de VEGF ont également été associés à l'insuffisance cardiaque [Chin et al. 2002], aux AVC [Slevin et al. 2000] ainsi qu'au diabète [Wirostko et al. 2008].

Le gène codant pour le VEGF contient 8 exons dont un épissage alternatif aboutit à l'existence de plusieurs isoformes (**Figure 7**). Les variants $VEGF_{206}$ et $VEGF_{189}$ sont peu biodisponibles en raison de leur liaison élevée à la matrice extracellulaire, alors que le variant $VEGF_{121}$ est actif et librement diffusible. Le variant $VEGF_{165}$, également diffusible, a des propriétés de liaison intermédiaires.

Les exons 1 et 2 codent pour le peptide signal, impliqué dans la sécrétion de la protéine dans le milieu extracellulaire, les exons 3 et 4 pour les sites de liaison aux récepteurs et pour un site de glycosylation, et les exons 6 et 7 pour les séquences de liaison à la matrice extracellulaire et aux neuropilines.

2.3. La composante génétique des maladies cardiovasculaires

La physiopathologie des MCV est donc extrêmement complexe et implique des interconnexions entre facteurs de risque très divers, dont certains sont encore méconnus. Mais à cette complexité phénotypique s'ajoute une composante génétique très importante et c'est ces interactions gène-gène-environnement qui sont à l'origine de la survenue de pathologies cardiovasculaires (**Figure 8**).

La physiopathologie cardiovasculaire comporte une part d'héritabilité génétique très importante (**Tableau 6**) et la recherche des variants impliqués dans cette héritabilité est dans un premier temps passée par une approche gène candidat [Casas et al. 2006].

Figure 8 : Modèle d'interactions gène-gène-environnement impliquées dans la physiopathologie des maladies cardiovasculaires

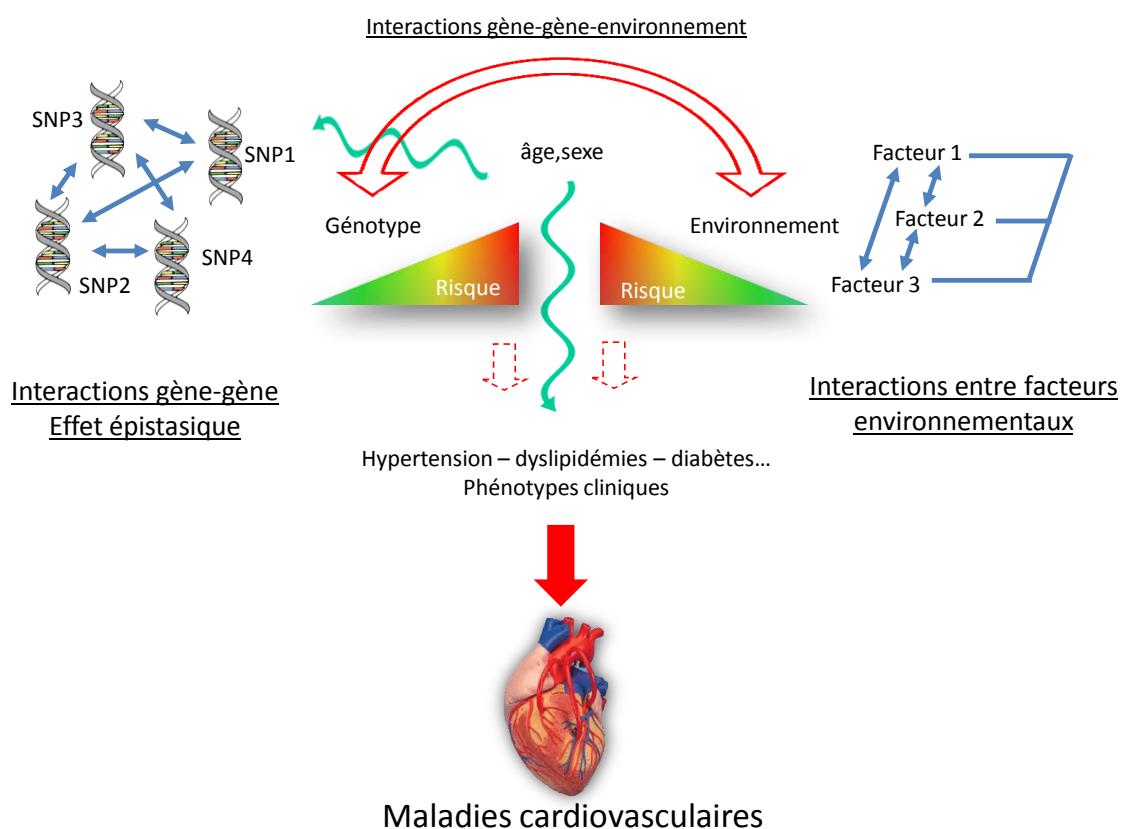

Au sein de l'EA4373, l'héritabilité génétique de nombreux traits liés à ces affections a pu être quantifiée :

- La molécule d'adhésion intracellulaire 1 (ICAM-I), la E-Sélectine et la P-Sélectine [Pontheiux et al. 2003 ; Ponthieux et al. 2004 ; Marteau et al. 2008] ;
- L'interleukine 6 (IL-6) et le facteur de nécrose tumorale alpha (TNF α) [Haddy et al. 2003 ; Haddy et al. 2005] ;
- L'IL-8, la protéine chimiotactique 1 de Monocyte (MCP-1), le facteur de croissance épidermique (EGF) et le VEGF [Berrahmoune et al. 2006 ; Berrahmoune et al. 2007^b] ;
- L'insuline [Maumus et al. 2007] ;
- Et la CRP [Berrahmoune et al. 2007^c].

De nombreux variants génétiques associés, au stade infraclinique, à la variabilité interindividuelle de divers facteurs de risque cardiovasculaire ont également pu être identifiés. Notamment les gènes *APOE* [Schiele et al. 2000 ; Siest et al. 2000], *ESELE* et *PSELE* [Pontheiux et al. 2004, Marteau et al. 2008], *LPL* [Sass et al. 2000 ; Herbeth et al 2007], *PON* [Vincent Viry et al. 2003], *CETP* [Pallaud et al. 2001], *ACE* [Tiret et al. 1992], *MPO* [Leninger-Muller et al. 2003], *ICAM1*, *IL6* et *TNFA* [Haddy et al. 2003], *IL1* [Berrahmoune et al. 2007^a], *FGB* [Maumus et al. 2007], *VEGF* et *EGF* [Berrahmoune et al. 2007^b], *CYP2C19* [Bertrand-Thiebault et al. 2008] et *F7* [Sass et al. 2004].

Cette approche conventionnelle a aussi permis de mettre en évidence les interactions gène-environnement, notamment l'effet des allèles $\varepsilon 2$ et $\varepsilon 4$ sur la concentration de l'Apo-Lp-non-B chez les femmes sous contraceptifs oraux [Starck et al. 2001] ; de l'allèle *APOC3-1100C* sur la concentration en apolipoprotéines exclusivement chez les femmes non-fumeuses et sur l'augmentation des taux d'Apolipoprotéine A-I (ApoA-I) et d'HDL-C uniquement chez les hommes [Pallaud et al. 2001] ; l'influence du polymorphisme *L/F554* de la *SELE* sur la PAS dépendante de l'IMC [Marteau et al. 2004] ; et l'interaction entre le polymorphisme *T3801C* du cytochrome 1A1 et le *G1661A* du AHR avec le tabac sur la pression artérielle [Gambier et al. 2006].

Néanmoins, à l'heure actuelle, il est admis que cette approche basée sur une hypothèse préalable ne permettra pas à elle seule d'élucider la génétique du risque cardiovasculaire.

L'approche pangénomique, qui a vu le jour en 2007, a permis d'étendre la détermination des variants associés au risque cardiovasculaire à des voies métaboliques inédites [Manolio et al. 2008 ; Hardy et al. 2009 ; Manolio et al. 2010]

Ainsi, plus de 650 GWAS ont été menées sur diverses pathologies dont 16 sur la survenue d'évènements cardiovasculaires (<http://www.genome.gov/gwastudies>). Ces dernières ont permis de mettre en évidence 29 variants génétiques sur 20 gènes. Néanmoins, différentes voies métaboliques peuvent mener à des pathologies cardiovasculaires communes d'où l'opportunité d'effectuer des recherche sur des traits quantitatifs associés à ces voies métaboliques (lipides, pression artérielle, ... etc.) [Ouwelhand et al. 2009].

C'est ainsi que le gène *FTO* a été fortement associé à l'obésité et au diabète dans les populations à la fois adultes et pédiatriques [Meyre et al. 2009 ; Meyre et al. 2010]. Ce dernier phénotype a également été associé à 22 variants localisés à proximité des gènes *CDKN2A*, *CDKN2B*, *HHEX*, *IGF2BP2*, *KCNJ11*, *CDKAL1*, *TCF7L2*, *THADA*, *TSPAN8*, *LGR5*, *VEGF*, *NOTCH2*, *ADAM30*, *PPARG*, *SLC30A8*, *JAZF1*, *SYN2*, *CDC*, *ADAMTS9*, *CDC123*, et *CAMK1D* [Zeggini et al. 2007 ; Zeggini et al. 2008].

Les études pangénomiques effectuées sur les lipides et la pression artérielle représentent respectivement 26 et 10% de la totalité des études. Elles ont permis d'associer 97 variants dans 54 loci au métabolisme lipidique à ce jour et le gène *CETP*, précédemment connu par l'approche gène candidat, est robustement répliqué en association à la fois avec le cholestérol total, le LDL-C et les TG.

À l'inverse, les études sur l'HTA ce sont avérées peu conclusives avant la mise en place de très larges études. Les Consortia 'Cohorts for Heart and Aging Research in Genomic Epidemiology' (CHARGE) [Newton-Cheh et al. 2009] et GlobalBPgen [Levy et al. 2009] ont récemment permis de mettre en évidence 14 variants associés aux traits quantitatifs pression artérielle ou à l'HTA.

Ainsi, les GWAS ont permis d'étudier les prédispositions aux MCV sous un jour nouveau, mais l'énigme de l'héritabilité manquante perdure [Maher et al. 2008 ; Manolio et al. 2009] et de nombreuses limitations méthodologiques restent à solutionner, voire à contourner.

CHAPITRE 3 – POPULATIONS ET MÉTHODES

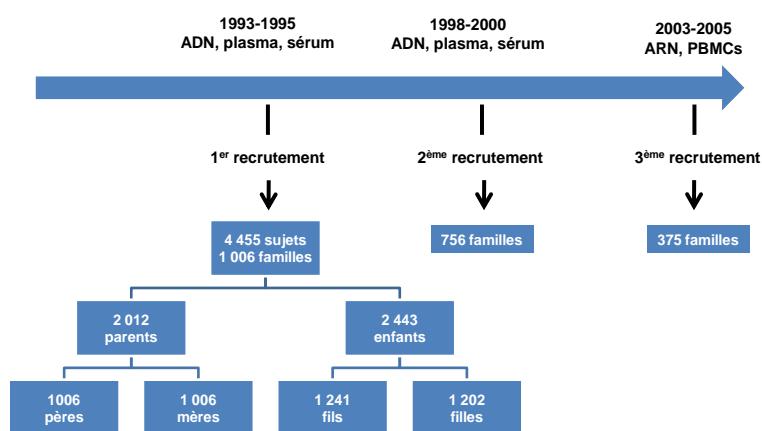
1. Populations

1.1. La cohorte STANISLAS

Initiée au CMP de Vandœuvre-lès-Nancy en 1993, la cohorte STANISLAS (Suivi Temporaire Annuel Non Invasif de la Santé des Lorrains Assurés Sociaux) [Siest et al. 1998 ; Visvikis-Siest et al. 2008] est une cohorte familiale visant à l'origine à étudier les composantes génétiques et environnementales des facteurs de risque des MCV. Les familles STANISLAS, originaires de la Meurthe-et-Moselle, ont été suivies de 1993 à 2005 à l'occasion de 3 visites médicales tous les cinq ans au CMP sur invitation de la Caisse primaire d'assurance maladie (CPAM).

Le recrutement initial a eu lieu de 1993 à 1995 (t_0) et a permis d'inclure 1 006 familles biparentales (4 455 sujets) d'origine française avec au moins deux enfants de plus de six ans. Tous les individus inclus étaient supposées sains, c'est-à-dire exempts de maladies aiguës et/ou chroniques. 75% des familles initialement recrutées ont participé à la seconde visite (1998-2000, t_5) et 375 familles à la troisième (2003-2005, t_{10}) (Figure 9).

Selon les lois bioéthiques en vigueur, chaque participant a donné par écrit son consentement éclairé, approuvé par le Comité local d'éthique de Nancy.

L'ensemble des données recueillies permettaient donc d'effectuer des études transversales ou longitudinales sur une période de 10 ans.

Lors des examens de santé, un personnel qualifié a effectué le recueil des données :

- Des médecins cardiologues pour les échographies cardiaques ;
- Des médecins du CMP pour la détermination du développement pubertaire ;
- Des infirmières du CMP pour les mesures de la pression artérielle, de la fréquence cardiaque, du tour de taille, du tour de hanches, de l'épaisseur des plis cutanés, et le l'ostéodensitométrie ;
- Des opératrices du CMP pour la mesure du poids, de la taille et de l'impédance.

1.1.1. Questionnaires alimentaires et de mode de vie

Des questionnaires standardisés en fonction de l'âge des participants (adultes/enfants/adolescents) ont été administrés lors des examens de santé. Ils ont notamment concernés les antécédents familiaux de MCV, la consommation médicamenteuse (répartie par classes de médicaments), les loisirs et l'activité physique, la consommation d'alcool et de tabac, ... etc.

Selon le type de questionnaire, ils ont été auto-administrés ou renseignés avec l'aide de personnel qualifié.

1.1.2. Données cliniques et anthropométriques

Les données anthropométriques : poids (balance électrique d'une précision de 200g), taille (toises d'une précision de 0,1 cm), tour de taille, tour de hanche ont été mesurées sur les sujets légèrement habillés et déchaussés. Elles ont permis de calculer l'IMC selon la formule de Quetelet et le ratio [taille / hanche].

Ces mesures ont été réalisées par des infirmières habilitées et la fiabilité des appareils utilisés a été périodiquement contrôlée tout au long de l'étude.

Les différents stades pubertaires ont été évalués chez les adolescents par des médecins selon la classification de Tanner datant de 1962.

La pression artérielle a été mesurée à trois reprises avec 5 minutes d'intervalle sur le bras gauche en position couchée avec un spymomanomètre ou tensiomètre à mercure. La valeur retenue était la moyenne des trois mesures consécutives.

1.1.3. Impédance bioélectrique

L'impédance bioélectrique a été mesurée dans un sous-échantillon à jeun sans activité physique préalable (à la suite d'une position couchée pendant 10 minutes). La résistance totale du corps a été mesurée à l'aide de l'analyseur d'impédance BIA-101 (RJL Systems, Detroit, MI, USA) par une personne qualifiée.

Les équations établies par Segal et collaborateurs [Segal et al. 1988] ont été utilisées pour calculer la masse maigre et la masse grasse a été estimée selon la formule suivante :

$$\text{Masse grasse (kg)} = \text{Poids (kg)} - \text{Masse maigre (kg)}$$

1.1.4. Dosages biologiques

Les prélèvements sanguins ont été effectués sur les participants à jeun depuis 12 heures au niveau d'une veine antécubitale, en position allongée. Deux types de tubes de sang modèle Vacutainer® (Becton Dickinson, Grenoble, France) ont été prélevés :

- Des tubes secs (sans anticoagulant) contenant un gel séparateur de sérum pour l'extraction de molécules contenues dans le sérum. Ces tubes ont été centrifugés à 1000×g pendant 15 minutes à température ambiante. Une partie du sérum ainsi récupéré était immédiatement analysée pour les dosages biochimiques et une autre partie stockée sous forme de paillettes dans l'azote liquide à – 196°C. Ce tube surnuméraire a servi au dosage ultérieur de l'insuline, de l'Apolipoprotéine C-III (ApoC-III) et des molécules d'adhésion.
- Des tubes d'acide Ethylenediaminetetraacetic (EDTA) pour ADN et plasma (où l'IL-6 et le TNF α sont dosés). Après avoir centrifugé le sang frais total recueilli dans des tubes EDTA à 1000×g à température ambiante pendant 10 minutes, le buffy coat formé entre le plasma et les globules rouges a été prélevé puis fractionné en paillettes stockées à – 196°C. Le plasma a également été conservé dans des paillettes à – 196°C.

Les concentrations sériques en cholestérol total, TG et glucose ont été enzymatiquement déterminées grâce à un automate AU 640 (Olympus, Rungis, France).

La concentration sérique en HDL-C a été mesurée dans le surnageant par la même technique enzymatique que pour le cholestérol total sur un automate COBAS-Mira analyser (Roche Diagnostics, Bâle, Suisse) après précipitation des lipoprotéines contenant l'ApoB (chylomicrons, VLDL et LDL) par phosphotungstate et chlorure de magnésium (méthode PTA).

Les concentrations en LDL-C ont été calculées selon la formule de Friedewald [Friedewald & Fredrickson. 1972] lorsque la concentration en TG était inférieure à 4,56 mmol/L et en l'absence de chylomicrons :

Les concentrations sériques en ApoA-I et en apolipoprotéine B (ApoB) ont été dosées par immunonéphélométrie sur un automate Behring Nephelometer Analyser II ou BNII (Dade Behring, Marburg, Allemagne).

Les concentrations sériques en ApoC-III et en apolipoprotéine E (ApoE) ont été mesurées par immunoturbidimétrie sur un automate COBAS-Mira (Roche Diagnostics, Bâle, Suisse).

Les activités enzymatiques de la gamma-glutamyltransférase (GGT), de la phosphatase alcaline (PAL), de l'aspartate aminotransférase (AST) et de lalanine aminotransférase (ALT) ont été enzymatiquement déterminées avec l'automate AU 640 (Olympus Merck, Darmstadt, Allemagne).

Les concentrations sériques en CRP, haptoglobine, orosomucoïde ont été mesurées par immunonéphélométrie sur un automate BNII (Dade Behring, Marburg, Allemagne).

Les concentrations sériques en E, L et P-sélectines et en ICAM-I ont été dosées grâce à des kits commercialisés (R&D System, Abington, Royaume-Uni) par la technique ELISA (Enzyme-Linked Immunosorbent Assay) qui utilise une méthode immuno-enzymatique de type 'sandwich'.

Les concentrations plasmatiques en IL-6 et en TNF α ont été déterminées grâce à des kits ELISA (R&D System, Abington, Royaume-Uni).

Les concentrations sériques en insuline ont été dosées grâce à un kit de dosage d'immuno-enzymologie microparticulaire (Microparticle Enzymatic ImmunoAssay ou MEIA) sur un automate IMx (Abbott laboratories, Abbott Park, IL, USA). Il s'agit d'une méthode de type 'double sandwich' permettant d'éviter d'éventuelles réactions croisées avec la proinsuline, le peptide C et le glucagon. La réaction est basée sur la formation d'un complexe entre l'insuline humaine contenue dans le sérum et des microparticules recouvertes d'anticorps anti-insuline. Par la suite, un conjugué d'anticorps anti-insuline couplé à la PAL est ajouté et se lie sur le complexe antigène-anticorps. Enfin, l'addition d'un substrat, le phosphate de méthyl-4-ombelliférone, permet d'observer l'apparition d'un produit fluorescent mesuré 448 nm. Des lavages de la matrice sont effectués entre chaque étape afin d'éliminer tout ce qui n'est pas fixé.

Les caractéristiques du test étaient les suivantes :

- Concentration moyenne en insuline : $7,19 \pm 4,98 \mu\text{U/ml}$ ($51,6 \pm 35,7 \text{ pmol/l}$) ;
- Imprécision déterminée sur un pool de sérum de 20 sujets : 2,72% ;
- Coefficients de variation (CV) = écart-type/moyenne×100 :
 - Concentrations basses d'insuline ($7,58 \pm 0,37 \mu\text{U/ml}$) : CV=4,88% ;
 - Concentrations moyennes d'insuline ($38,38 \pm 1,97 \mu\text{U/ml}$) : CV=5,13% ;
 - Concentrations élevées d'insuline ($120,23 \pm 5,38 \mu\text{U/ml}$) : CV=4,47%.

1.1.5. Les données génétiques

L'ADN a été extrait à partir du buffy coat congelé à – 196°C par la méthode de 'salting out' [Miller et al. 1988] : seul le lysat cellulaire obtenu par une RNase (la protéine K) a été traité. L'ADN extrait a ensuite été solubilisé dans un tampon TE (Tris-EDTA).

Plusieurs techniques ont permis la détermination des polymorphismes au sein de la cohorte STANISLAS : des techniques Multiplex et un GWS.

La technique Multiplex en collaboration avec Roche Molecular Systems :

Cette technique Multiplex a été développée en collaboration avec Roche Molecular Systems (Alameda, CA, USA) et a permis la mise au point de trois kits ciblant les gènes candidats impliqués dans différentes voies métaboliques liées à la physiopathologie des MCV [Cheng et al. 1998] : le métabolisme lipidique, la pression artérielle, la coagulation, l'adhésion cellulaire, le métabolisme de l'homocystéine, et pour le Multiplex III, l'inflammation uniquement.

Il s'agit d'une technique où plusieurs séquences cibles de gènes d'intérêt sont amplifiées simultanément, au cours d'une même réaction de PCR au moyen d'amorces biotinylées en 5' spécifiques aux séquences des gènes. L'étape de détection fait appel à un dot-blot inverse. Les produits de PCR sont hybridés à des sondes oligonucléotidiques complémentaires, conjuguées en 5' à la sérum albumine bovine (BSA), ce qui permet leur immobilisation en rangées sur une bandelette (ou strip) recouverte de nylon. La détection colorimétrique des

polymorphismes fait intervenir le système biotine/streptavidine-peroxydase de raifort. La concentration des sondes est définie de telle sorte que les génotypes homozygotes et hétérozygotes apparaissent avec des intensités différentes lors de la réaction colorimétrique.

Les kits Multiplex développés avec Roche contiennent le matériel suivant :

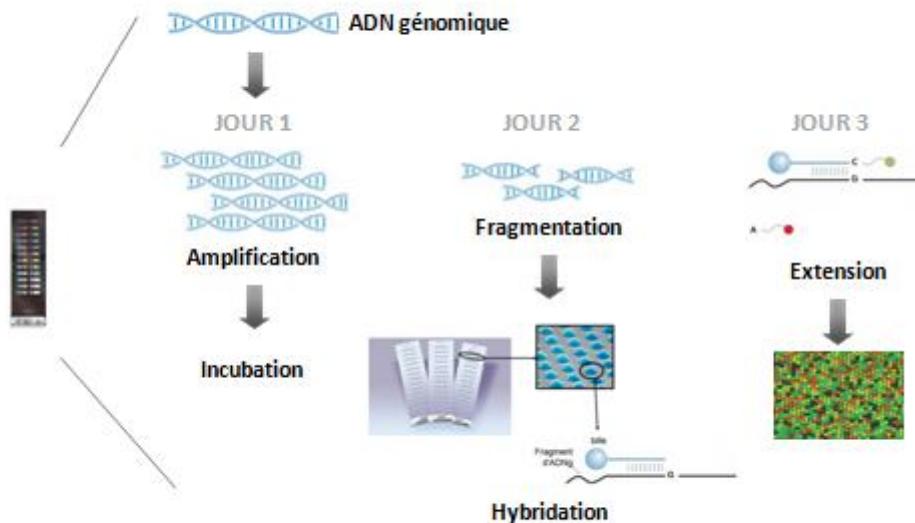
Le typage pangénomique ou genome-wide scan :

Le GWS a été effectué sur un échantillon de 631 enfants non apparentés de la cohorte STANISLAS par une puce Illumina Human CNV370-Duo selon les protocoles prévus par Illumina (**Figure 10**) [Bouatia-Naji et al. 2009].

2 552 SNPs ayant un fort déséquilibre de liaison (LD, $p < 0,001$), un faible taux de génotypage (call rate < 95%) ou une fréquence de l'allèle mineur (MAF) insuffisante (< 1%) ont été exclus lors du contrôle qualité. Nous avions au final 318 237 variants génétiques (SNPs).

Ces typages ont été effectués dans le cadre d'une collaboration avec l'UMR CNRS 9199, Institut Pasteur de Lille dirigé par le Professeur Philippe Froguel.

Figure 10 : Modalités du typage pangénomique utilisant la puce Illumina Human CNV370-Duo

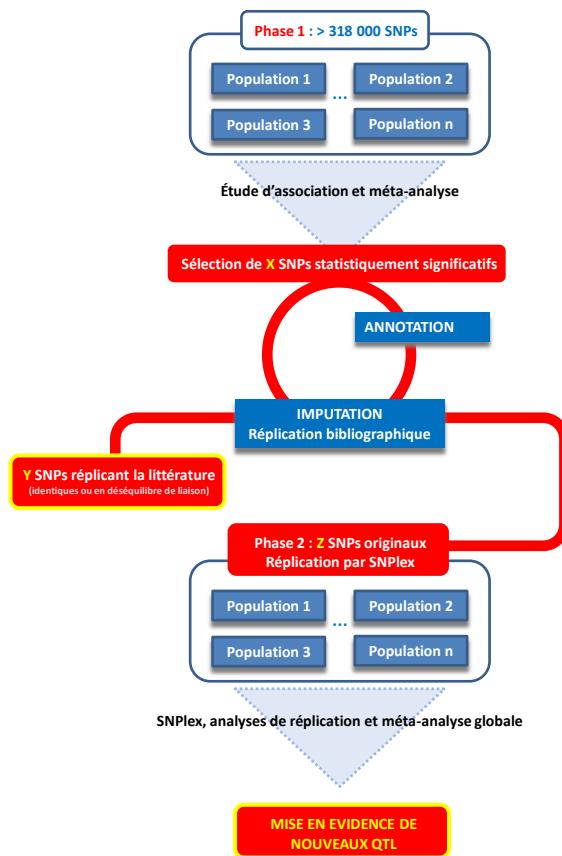

Le typage spécifique des variants génétiques issus de la phase initiale de genome-wide association study en vue des analyses de réPLICATION :

La spécificité des GWAS réside dans le fait que de telles études nécessitent plusieurs phases d'expérimentation (**Figure 11**) : une phase d'analyse pangénomique proprement dite où la ou les cohortes disposant d'un GWS, que nous appellerons la ou les 'discovery cohorts', sont analysées. Il s'agit d'une phase où un grand nombre de tests multiples sont effectués et où les significations statistiques des résultats générés sont très faibles (le seuil 'genome-wide significant' est fixé à 5×10^{-8}). Il convient donc de confirmer ou d'infirmer les associations les plus significatives obtenues lors d'une ou de plusieurs phases de réPLICATION dans des populations indépendantes [Chanock et al. 2007 ; Hoover. 2007] de façon à éliminer les faux positifs [Wang et al. 2005]. Seuls les SNPs d'intérêt (du fait de leur signification statistique ou de leur plausibilité) sont donc secondairement génotypés dans ces populations indépendantes de façon à minimiser les coûts.

Pour effectuer ces génotypages de réplication, nous avons utilisé la technologie Applied Biosystems SNPlex™ basée sur une Oligonucleotide Ligation Assay (OLA) combinée avec une technique d'amplification Multiplex.

Les variants génétiques passant le stade de contrôle qualité avaient un ‘call rate’ de plus de 95% et leur équilibre de Hardy-Weinberg (HWE) était testé ($p > 0,001$).

1.1.6. Les données transcriptomiques

Ce chapitre concerne le VEGF.

L'ARN a été extrait de Cellules mononucléaire de sang périphérique (PBMCs) précédemment isolées par centrifugation sur gradient de densité (Ficoll-PaqueTM PLUS; Amersham BioSciences), puis stockées à - 80°C [Marteau et al. 2005] avec un automate MagNaPure utilisant le kit d'isolation MagNA Pure LC RNA HP et le protocole de lyse externe RNA HP Blood (Roche Diagnostics, France).

Sa transcription reverse a été effectuée en utilisant 200 unités de M-MuLV Reverse Transcriptase et 0,25 µg d'oligos(dt) (Promega, France) [Marteau et al. 2005] et la quantification des transcrits codants pour les isoformes $VEGF_{121}$ et $VEGF_{165}$ et le gène de contrôle β -2- *microglobulin* ($B2M$) a été effectuée en utilisant une technologie TaqMan® (LC TaqMan Master kitRoche Diagnostics, France) et un LightCycler. Toutes les procédures ont été effectuées en double et le niveau de détection de chaque transcrit était compris entre 1 et 10 copies.

Les spécificités et optimisation de cette RT-PCR ont été contrôlées à l'aide de la technologie SYBR® Green (LC FastStart DNA Master^{PLUS} SYBR Green I kit, Roche Diagnostic, France).

Les primers et amorces ont été 'designées' pour amplifier spécifiquement les isoformes de VEGF en se basant sur leurs sites d'épissage. Pour toutes les expérimentations, la variabilité intra et inter-test étaient respectivement de 11% et 5%. Les produits de PCR de chaque isoforme ont été purifiés avec un kit QiaQuick (Qiagen, France) et les concentrations déterminées avec un spectrophotomètre.

La quantification protéique du VEGF (121 et 165) dans les PBMCs a été effectuée avec un appareillage Randox Ltd (Crumlin, UK) [Fitzgerald et al. 2005].

La principale population de nos investigations et la ‘discovery cohort’ de nos études pangénomiques dans les cohortes pédiatriques était la cohorte STANISLAS. Ainsi, de façon à valider les résultats que nous avons obtenus selon le design des GGWAS précédemment schématisé, il a fallu que nous intégrions des Consortia Internationaux nous donnant accès à diverses populations. Un bref descriptif de ces dernières est exposé ci-dessous.

1.2. La population OBE

Il s’agit d’une population d’enfants obèses (définis comme ayant un IMC supérieur au 97^{ème} percentile d’une cohorte Française type en fonction de l’âge et du sexe) [Rolland-Cachera et al. 1991] et appartenant à 449 familles nucléaires ayant au moins un enfant obèse. Ces enfants ont été recrutés dans l’unité endocrinienne pédiatrique de l’Hôpital Jeanne de Flandres, Lille, France ou par l’intermédiaire d’une campagne médiatique.

1.3. La Northern Finland 1986 Birth Cohort (NFBC86)

La NFBC86 est une cohorte prospective ayant inclus des mères Finnoises d’origine Européenne attendant un enfant à naître entre le 1^{er} Juillet 1985 et le 30 Juin 1986 dans deux provinces de Finlande [Jarvelin et al. 1997].

Entre Août 2001 et Juin 2002, 9 215 membres de la cohorte vivant en Finlande et d’adresse connue ont été invités à subir des examens cliniques. 6 798 sujets ont accepté de participer à cette étude au final (74% de taux de participation).

1.4. La GeNe and Diet Attica Investigation (GENDAI)

La cohorte pédiatrique GENDAI est composée d’enfants vivant dans la région d’Attica en Grèce [Papoutsakis et al. 2007]. De Novembre 2005 à Juin 2006, 1 138 péri-adolescents (53% de filles; moyenne d’âge de $11,2 \pm 0,7$ ans) ont été aléatoirement recrutés dans les écoles élémentaires d’Attica avec l’accord de l’Institutional Review Board de l’université

d'Harokopio, du Ministère Grec de l'Éducation et du comité d'éthique de l'Université d'Harokopio.

1.5. La cohorte VERONA

La cohorte Verona est composée d'enfants italiens (43% de filles ; âge moyen de 10,75 ± 1,22 ans) recrutés dans la population générale de Vérone. Les familles ciblée ont été aléatoirement sélectionnées à partir des registres municipaux de la ville et contactés par voie postale.

1.6. La cohorte Data from an Epidemiological Study on the Insulin Resistance syndrome (DESIR)

Il s'agit de 2 566 hommes et de 2 633 femmes Français âgés de 30 à 64 ans et recrutés de 1994 à 1996 parmi les assurés sociaux. Des examens de santé périodiques gratuits leurs ont été proposés. Cette étude a été approuvée par le Comité Consultatif de Protection des Personnes dans la Recherche Biomédicale (CCPPRB) de l'Hôpital Bicêtre, Paris, France et la Commission Nationale de l'Informatique et des Libertés (CNIL). Tous les participants ont signé un formulaire de consentement éclairé [Balkau et al. 1997].

1.7. La cohorte FRAMINGHAM

La Framingham Heart Study (FHS) est une étude prospective qui s'est poursuivie sur 3 générations dans la ville de Framingham, USA. Elle a été initiée en 1948 en vue d'étudier les facteurs de risque des MCV et est composée aujourd'hui de la génération originale suivie depuis 1948 [Dawber et al. 1966], de leurs enfants et conjoints de leurs enfants depuis 1971 (cohorte Offspring) [Feinleib et al. 1975] et de leurs petits-enfants depuis 2002 [Splansky et al. 2007] soit 4 095 participants avec au moins un parent issus de la cohorte Offspring. Seuls les participants de la 3^{ème} génération ont été dosés pour le VEGF dès leur premier examen de

santé en 2002-2005. L’Institutional Review Board de la faculté de Médecine de Boston a approuvé cette étude.

1.8. La Prospective Investigation of the Vasculature in Upssala Seniors (PIVUS) study

Tous les individus âgés de 70 ans et vivant dans la communauté d’Uppsala en Suède entre Avril 2001 et Juin 2004 étaient éligibles et ont été aléatoirement sélectionnés [Lind et al. 2005]. Tous les individus incorporés à l’étude ont été examinés dans le mois de leur 70ème anniversaire de façon à standardiser leurs âges. Sur les 2 025 individus conviés, 1 016 ont été intégrés à l’étude soit un taux de participation de 50% et 999 ont fourni de l’ADN. L’étude PIVUS a reçu l’accord du comité d’éthique de l’université d’Uppsala.

La concentration en haptoglobine a été quantifiée pour les populations pédiatriques OBE et GENDAI par l’unité INSERM U954 ‘Exposition aux risques génétiques et environnementaux’ de la Faculté de Médecine Henri Poincaré Nancy 1 dans le cadre de ce projet collaboratif.

2. Analyses statistiques

Les analyses statistiques ont été effectuées avec SPSS versions 14.0 à 17.0 (SPSS Inc., Chicago, IL, USA), SAS (SAS Institute, Cary, NC, USA), R, et Plink.

2.1. Test de l’équilibre de Hardy-Weinberg

L’HWE ou équilibre panmictique, est le modèle théorique central de la génétique des populations. La notion d'équilibre dans le modèle de Hardy-Weinberg est soumise à des hypothèses définissant une population idéale :

1/ Une population panmictique c'est-à-dire où les couples se forment au hasard (panmixie), et leurs gamètes se rencontrent au hasard (pangamie) ;

2/ Une population ‘infinie’ minimisant les variations d'échantillonnage ;

3/ Pas de perte ou de gain d'allèle : ni sélection, ni mutation, ni migration ;

4/ Et pas de croisement entre générations différentes : générations successives discrètes.

Ceci permet de maintenir la diversité génétique de la population et tend vers un équilibre stable de la distribution génotypique. Les fréquences alléliques restent également stables de génération en génération dans une population diploïde idéale et ne dépendent que des fréquences de la génération initiale. De plus, les fréquences génotypiques ne dépendent que des fréquences alléliques.

Ainsi, dans une population idéale de taille n et avec comme allèles du même locus A et a, p la fréquence de l'allèle A et $q=1-p$ la fréquence de l'allèle a :

Les fréquences des génotypes en HWE sont :

$$f(AA) = p^2$$

et elles sont constantes au fil des générations.

Ainsi, la formule de calcul de la fréquence allélique p dans une population donnée est :

$$p = (2 n_{AA} + n_{Aa}) / 2n$$

Au cours de notre étude, nous nous sommes assurés de l'HWE par le test du Chi-deux (χ^2) avec le logiciel SPSS pour l'approche gène candidat, ou avec le logiciel plink pour l'approche pangénomique.

2.2. Déséquilibre de liaison

L'hypothèse de déséquilibre de liaison entre les paires de loci a été vérifiée par plink.

2.3. Test d'ajustement : loi de distribution des variables

Nous avons vérifié la normalité et la symétrie de la distribution des variables étudiées par le test de Kolmogorov-Smirnov qui étudie l'écart entre la fonction des probabilités cumulées de l'échantillon et la fonction des probabilités cumulées de la loi théorique et en calculant les coefficients de dissymétrie et d'aplatissement (skewness-kurtosis).

2.4. Statistiques descriptives

Les moyennes et écart-types ont été calculées pour les variables quantitatives et les effectifs et fréquences pour les variables qualitatives. Des comparaisons d'effectifs de différents types ont été menées en utilisant le test du χ^2 .

2.5. Études d'association

Des comparaisons de moyennes de variables biologiques et cliniques ont été effectuées ainsi que des analyses de régression. Différents tests ont été effectués selon la nature et la distribution des valeurs de chaque variable.

- Des tests t de Student et analyse de variance (ANOVA) avec correction de Bonferroni le cas échéant ;
- Des régressions multiples utilisant la méthode des moindres carrés ;
- Des régressions logistiques dans le cas de variables qualitatives ;
- Des tests non paramétriques de Mann-Whitney, Kruskal-Wallis et Friedman qui ne font aucune hypothèse sur la forme des distributions sous-jacentes

2.6. Corrélations familiales

La ressemblance familiale est la ressemblance entre individus apparentés dont l'origine est le partage de gènes communs, de facteurs environnementaux, induit des corrélations familiales de deux types :

- intra-génération (entre enfants ou entre parents) ;
- et inter-génération (parents-enfants) [Tregouet et al. 1999].

CHAPITRE 4 – RÉSULTATS ET DISCUSSION

1. Étude de l'effet précoce de l'héritabilité génétique des facteurs de risque des pathologies cardiovasculaires dans la cohorte STANISLAS.

PUBLICATIONS N° 2 & 3

Comme cela a été précédemment évoqué, les divers facteurs de risque impliqués dans le développement des pathologies cardiovasculaires présentent une composante génétique dont l'amplitude et les mécanismes d'action restent à élucider. Nous avons choisi, au sein de la cohorte STANISLAS, d'en étudier certains classiques : les traits lipidiques et la pression artérielle ; et d'autres émergents : l'haptoglobine, molécule d'inflammation, et le VEGF, molécule d'adhésion cellulaire. Une telle approche visait à mettre en exergue l'intérêt de mener des études d'épidémiologie étiologique sur les variants génétiques impliqués dans l'héritabilité de ces traits au sein de populations pédiatriques. Les résultats obtenus nous ont confortés dans cette voie en nous permettant de visualiser les modulations que pouvaient exercer les facteurs environnementaux sur l'héritabilité génétique ; ou du moins sur sa quantification.

De plus, nous avons pu démontrer que sur un point de vue strictement phénotypique, les effets de cette héritabilité étaient mesurables en pratique clinique chez les enfants.

Ceci souligne donc l'intérêt, pour mesurer les effets propres de la génétique, de se focaliser sur ces populations pour lesquelles les effets de l'environnement sont encore minimes.

1.1. L'héritabilité des traits lipidiques, de la pression artérielle, de l'haptoglobine et du facteur de croissance de l'endothélium vasculaire dans la Cohorte STANISLAS.

PUBLICATION N°2

Les dyslipidémies, l'HTA, et les marqueurs de l'inflammation sont des facteurs de risque des MCV impliqués dans la détermination du SM au même titre que l'obésité centrale, l'acide urique et les enzymes hépatiques.

Dans un échantillon regroupant 667 familles nucléaires de la cohorte STANISLAS composées de deux parents et d'au moins un enfant biologique : 1 334 parents âgés de 30 à 64 ans et leurs 1 137 enfants âgés de 12 à 25 ans (**Tableau 7**), nous avons étudié de manière transversale dans un premier temps l'héritabilité génétique des divers composants du SM.

La cohorte STANISLAS ayant été suivie de manière prospective sur 10 ans, nous avons également souhaité effectuer une étude longitudinale à court terme (5 ans) et avons sélectionné, dans l'échantillon précédent, les familles ayant subi les deux examens de santé consécutifs de 1994-95 et de 1999-2000. Ceci représentait 353 familles : 706 parents et leurs 502 enfants (**Tableau 8**).

Le modèle d'estimation de l'héritabilité que nous avons utilisé prenait en compte trois composantes indépendantes : la composante polygénique, l'environnement partagé au sein de la cellule familiale, et l'environnement non partagé. Le **Tableau 9** réuni les deux premières composantes étudiées.

Avec la première étude transversale, nous avons pu mettre en évidence une grande héritabilité génétique des certains variants d'intérêt :

- Les traits lipidiques : 44% pour le cholestérol total, 32,8% pour le HDL-C, 30% pour l'ApoA-I, 38,5% pour l'ApoB, et 34,7% pour l'ApoE avec une importante signification statistique ($p<0,001$) ;
- Et un marqueur d'inflammation : l'haptoglobine avec une héritabilité génétique représentant plus du tiers de la variance globale dans cet échantillon (35,3% ; $p<0,001$).

À l'opposé, nous n'avons obtenu aucune héritabilité génétique significative pour la pression artérielle. Ce dernier résultat était en contradiction avec les études antérieurement menées sur un échantillon différent de la cohorte STANISLAS : de Andrade et ses collaborateurs [de Andrade et al. 2002] observaient en 2002 une héritabilité génétique de la PAS de 32%. Une telle disparité au sein d'une même cohorte prouve que la quantification de l'héritabilité d'un trait peut varier en fonction de la spécificité des échantillons sélectionnés et notamment en fonction de facteurs d'environnement ayant un effet modulateur ou masquant plus ou moins appuyé. C'est un aspect que nous avons choisi d'investiguer plus avant et que nous exposerons dans les chapitres à venir.

Il est à noter que lors de l'étude longitudinale des variations à 5 ans des composants du SM, aucune héritabilité génétique ne s'est avérée significative. À l'inverse, l'effet de l'environnement partagé était très élevé dans tous les cas de figure. Ceci nous permet d'insister sur le fait que la notion d'héritabilité génétique, ou du moins sa quantification, est une 'photo' à l'instant t de l'effet génétique réel, et qu'à court terme, cet effet pourrait être totalement masqué par l'environnement.

Enfin, notez que le VEGF n'étant pas un composant du SM, nous ne l'avons pas intégré à cette étude. Néanmoins, son héritabilité génétique a été précédemment évaluée dans la cohorte STANISLAS [Berrahmoune et al. 2007]. Dans le sous-ensemble de la cohorte dans lequel ce trait avait été quantifié, sa variabilité interindividuelle était pour plus de la moitié (60.6%) sous contrôle génétique. Néanmoins, les variants responsables de cette héritabilité étaient restés indéterminés à l'époque.

Nous avons donc, dans la suite de nos travaux, cherché à identifier les variants concernés.

1.2. Étude exploratoire de l'effet phénotypique de l'héritabilité des facteurs de risque des maladies cardiovasculaire chez les enfants de la Cohorte STANISLAS.

PUBLICATION N°3

Avant de poursuivre nos investigations génétiques, nous avons choisi de faire un descriptif simple de l'effet familial visualisable des facteurs de risque classiques des MCV chez les enfants de la cohorte STANISLAS : la pression artérielle (systolique et diastolique), les lipides (cholestérol total, HDL-C, LDL-C, TG), la glycémie et les données anthropométriques (IMC et tour de taille). Le but était de démontrer que dans les populations pédiatriques ayant des données infracliniques, il était quand même possible de repérer les individus à risque en fonction des variables de leurs parents.

Nous avons donc utilisé la totalité des familles STANISLAS pour lesquelles nous avions les données investiguées à disposition pour les deux premiers bilans de santé : 693 familles biparentales et leurs enfants soit 1 386 parents et 1 194 enfants au total (**Tableau 10**).

Dans un premier temps, nous avons classé les parents considérés ‘à risque’ selon le niveau individuel de leurs facteurs de risque en fonction des recommandations Nationales et Internationales :

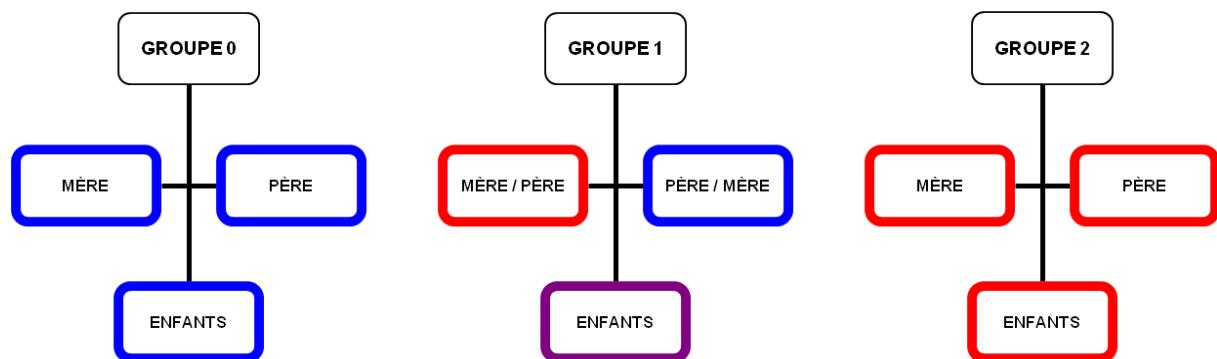
- PAS > 130mmHg pour la pré-HTA et > 140 mmHg pour l'HTA systolique ;
- PAD > 85mmHg pour la pré-HTA et > 90 mmHg pour l'HTA diastolique ;
- Cholestérol total \geq 6 mmol/L ;
- LDL-C \geq 5,16 mmol/L ;
- HDL-C \leq 1 mmol/L ;
- TG \geq 2 mmol/L ;
- Glucose > 6,2 mmol/L ;
- IMC \geq 25 kg/m² ;
- Et tour de taille > 80 cm pour les pères et 94 cm pour les mères.

Cette première classification nous a permis d'identifier les familles considérées à risque pour chaque trait étudié :

- Les familles non à risque constituaient les groupes 0 lorsqu'aucun parent n'était à risque ;
- Les familles à risque modéré ou groupes 1 lorsqu'un parent (père ou mère) était à risque pour le trait considéré ;
- Et enfin, les familles à risque élevé lorsque les deux parents avaient leurs facteurs de risque au-delà des valeurs seuil listées plus haut.

Ces groupes ainsi constitués, nous avons pu constater qu'à l'exception de la glycémie, tous les facteurs de risque cardiovasculaire des enfants appartenant aux familles à risque élevé avaient des niveaux supérieurs à ceux des enfants appartenant aux familles à risque modéré ; qui étaient eux même supérieurs à ceux des familles non à risque (**Figures 13 et 14**). Il y avait là ce que l'on pourrait qualifier 'd'effet dose' ou caractère graduel : une caractéristique requise des facteurs de risque cardiovasculaire comme cela a été précédemment expliqué.

Dans le cas de la glycémie, le faible effectif des groupes à risque était à notre sens à l'origine de la non signification des résultats. En effet, la cohorte STANISLAS est composée d'individus

a priori sains et leur glycémie est donc en moyenne en deçà des seuils préconisés en prévention.

Ainsi, même sur un plan strictement phénotypique, les effets de l'héritabilité d'un facteur de risque cardiovasculaire sont mesurables en pratique clinique chez les enfants. Il suffit pour cela d'évaluer le ‘niveau de risque’ de leurs parents.

Ce fait, associé à la difficulté que représente la quantification de l'effet propre de la génétique sur la variabilité interindividuelle d'un trait donné, souligne à notre sens l'intérêt que représente les études d'épidémiologie génétique se focalisant sur des populations pédiatriques pour lesquelles les effets de l'environnement sont encore minimes.

Figure 13 : Niveaux des facteurs de risque cardiovasculaire des enfants Stanislas en fonction des groupes familiaux au premier examen de santé

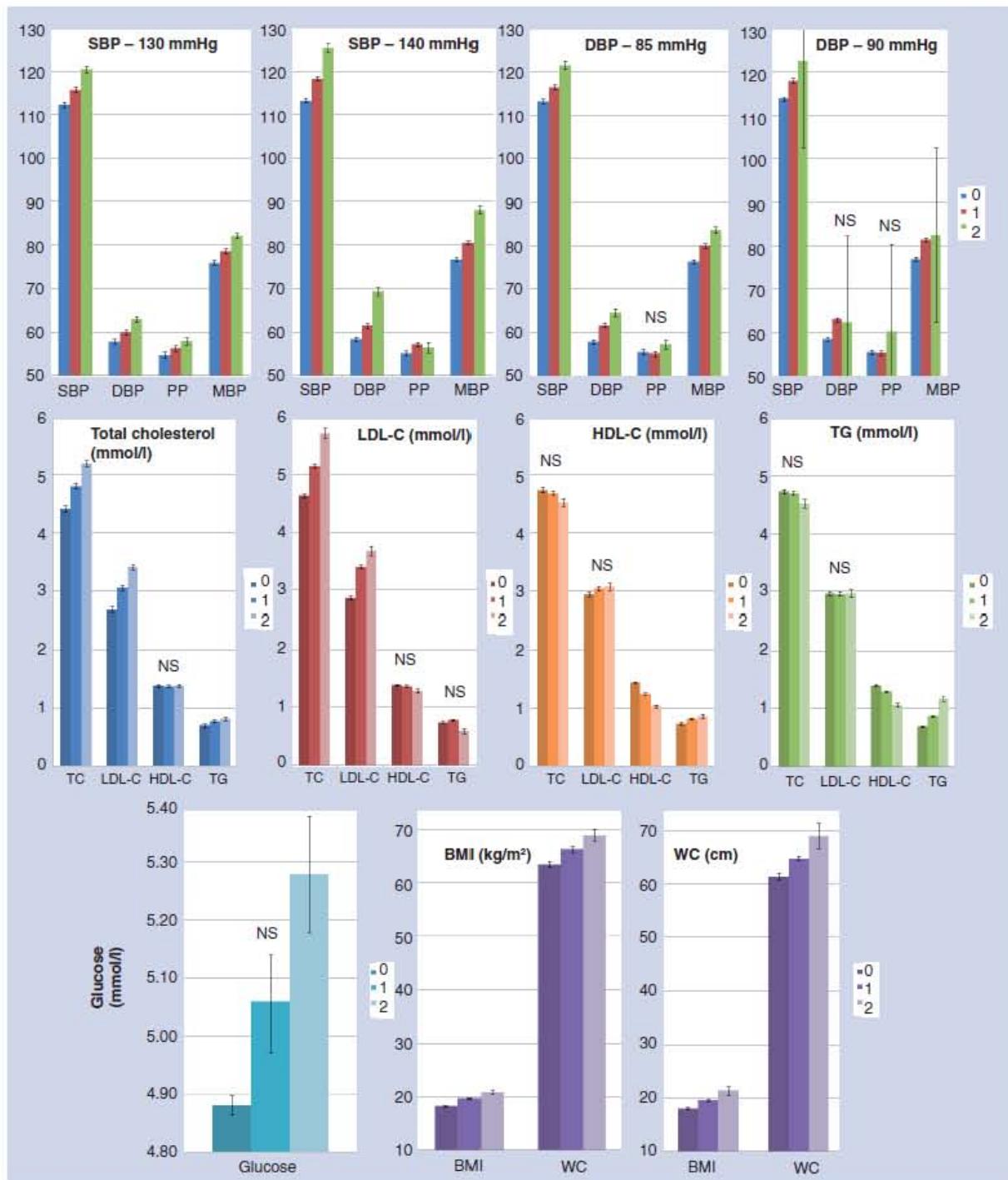
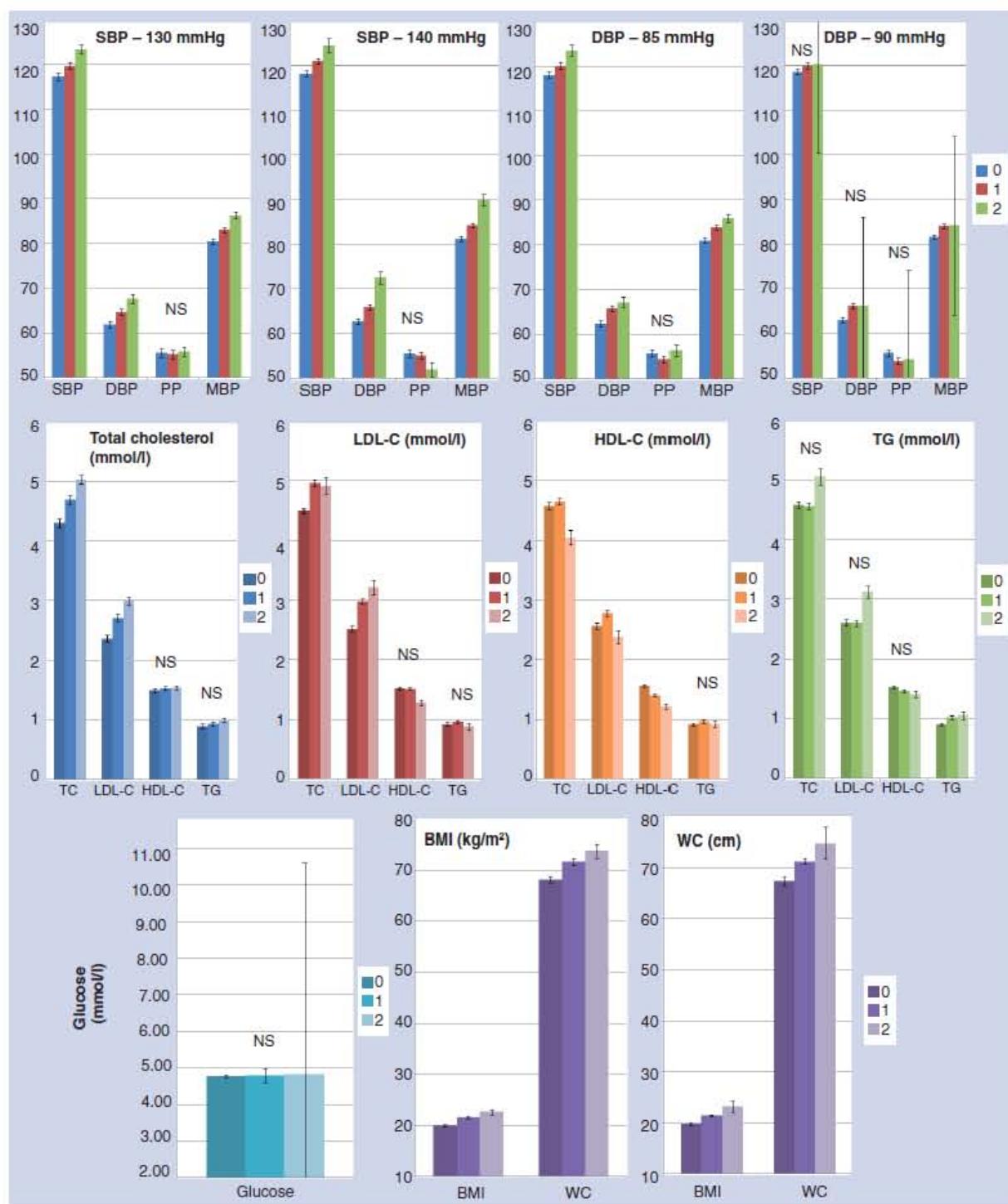


Figure 14 : Niveaux des facteurs de risque cardiovasculaire des enfants Stanislas en fonction des groupes familiaux au second examen de santé



2. Étude d'associations pangénomiques de facteurs de risque des maladies cardiovasculaire dans des populations pédiatriques : l'haptoglobine, la pression artérielle et les lipides.

Avec l'avènement des études d'associations pangénomiques ou GWAS, l'identification des variants génétiques impliqués dans la variabilité interindividuelle des facteurs de risque des pathologies cardiovasculaires a pris un tournant décisif. En effet, l'approche gène-candidat classique, utilisée antérieurement, était basée sur une connaissance *a priori* des mécanismes et des interconnexions menant au développement de la pathologie. La communauté scientifique étudiait des variants génétiques ciblés selon une hypothèse physiopathologique préalable (identification d'une voie enzymatique ... etc.). Par conséquent, les découvertes fulgurantes des premières années de l'épidémiologie génétique des pathologies cardiovasculaire ont fini par s'essouffler.

De plus, nous avons évoqué précédemment le cas de traits ayant une forte héritabilité génétique non expliquée par les gènes candidats. Ceci souligne bien la nécessité, pour dépasser le pallier atteint, de développer une approche s'affranchissant d'une hypothèse préalable et permettant par conséquent de mettre en évidence des variants et cheminements physiopathologiques inédits : l'approche pangénomique.

Nous avons effectué le GWS d'un échantillon de 631 enfants minces non apparentés issus de la cohorte STANISLAS avec pour objectif de mener des études d'association pangénomique selon deux approches distinctes :

- Une approche exploratoire et innovante visant à rechercher des variants génétiques associés à un facteur de risque émergent des MCV pour lequel nous avons observé dans la cohorte STANISLAS une forte héritabilité génétique : l'haptoglobine [Herbeth et al. 2010] ;
- Et une approche 'réplicative' des résultats antérieurement obtenus lors de l'étude de facteurs de risque classiques des pathologies cardiovasculaires dans des populations pédiatrique : la pression artérielle et les lipides.

Les GWAS ayant un design en plusieurs stades hiérarchiques consécutifs et nécessitant donc une réplication des résultats des stades antérieurs dans de larges populations indépendantes, nous avons intégré des Consortia Internationaux et initié des projets collaboratifs permettant d'avoir accès à de telles populations.

Au terme de ce volet de notre thèse, nous avons pu démontrer que les variants génétiques connus chez l'adulte pouvaient être détectés chez l'enfant et que surtout, certains variants inédits, dont l'effet pouvait être masqué par des facteurs environnementaux, étaient observables dans des populations pour lesquelles ces facteurs environnementaux étaient minimisés : les populations pédiatriques.

Nous avons également mis en évidence des variants génétiques associés à des traits jusque là non investigués et donnant un éclairage nouveau aux interconnexions existant entre divers facteurs de risque des pathologies cardiovasculaires.

2.1. Genome-Wide Association Study de l'Haptoglobine dans des populations pédiatriques.

L'haptoglobine est une molécule inflammatoire qui a la propriété de former un complexe avec l'hémoglobine lors de son relargage par les érythrocytes en vue de son élimination dans le foie. Elle a donc pour propriété avérée de prévenir la génération d'espèces d'oxygène réactives ou reactive oxygen species (ROS) [Okazaki et al. 1997].

Comme cela a été précédemment évoqué, Holme et ses collaborateurs [Holme et al. 2010] ont récemment établi un lien entre cette molécule et le risque d'infarctus du myocarde, d'AVC et d'insuffisance cardiaque dans l'étude AMORIS. L'haptoglobine est ainsi un facteur de prédiction majeur des événements cardiovasculaires [Holme et al. 2009]. Mais quel est le mécanisme sous-jacent ?

Les 631 enfants STANISLAS ont constitué l'échantillon de phase 1 ou 'discovery set'. Nous y avons effectué une GWAS et identifié une forte association de variants présents dans un block en déséquilibre de liaison de 218 kilo bases incluant le gène *Haptoglobin* (*HP*) et le gène *Haptoglobin Related Protein* (*HPR*) sur le chromosome 16 avec les taux d'haptoglobine. Seuls les variants rs2000999 ($\beta=-0,123$; $p=6,32\times10^{-13}$) et rs10492825 ($\beta=-0,093$; $p=5,50\times10^{-08}$) atteignaient le seuil 'genome-wide significant'. Leur proximité physique (en déséquilibre de liaison, $r^2=0,48$ – HapMap CEU release 27) pouvait laisser présumer que nous ne visualisions qu'un unique signal, et c'est ce que nous avons vérifié par une régression conditionnée de chaque variant sur l'autre. Lors de cette régression conditionnée, nous avons également testé tous les variants présents dans la zone de recombinaison de ce locus. Au terme de cette procédure, seul le rs2000999 dans le gène *HPR* conservait une signification élevée : $p_{ajusté \ sur \ rs10492825}=1,9\times10^{-7}$. Il était donc le seul ayant un effet indépendant sur la variabilité interindividuelle de l'haptoglobine (**Tableau 11**).

Pour cette étude spécifique, nous avons réévalué l'héritabilité génétique de l'haptoglobine dans un échantillon indépendant de celui dans lequel cette procédure avait précédemment été faite. Nous avons donc sélectionné 656 familles nucléaires (2 680 sujets) dans la cohorte STANISLAS pour lesquels les variants rs2000999 et rs10492825 avaient été génotypés. La

variance polygénique de ce trait était également élevée dans cet échantillon (24,9%) et un ajustement avec le rs2000999 diminuait ce résultat de 10,5% alors qu'un ajustement sur le rs10492825 ne changeait rien. Le variant rs2000999 participait donc à hauteur de 42% à l'héritabilité génétique globale de l'haptoglobine (**Tableau 12**).

L'association du rs2000999 a été répliquée et confirmée lors d'une phase 2 dans un échantillon familial de la cohorte STANISLAS, et les cohortes GENDAI et OBE (N=4 579, $p_{\text{réplication}}=3,5 \times 10^{-41}$, $p_{\text{méta-analyse}}=8,09 \times 10^{-59}$, **Tableau 11**).

Le rs2000999 a été très récemment associé au cholestérol total et au LDL-C dans des populations adultes : 4 200 sujets issus du consortium 'European Special Populations Research Network' (EUROSPAN, <http://eurospan.gen-info.hr/publications.html>) [Igl et al. 2010] et plus de 100 000 sujets Européens et non Européens réunis dans une large méta-analyse ayant permis de confirmer 95 variants génétiques fortement associés aux lipides [Teslovich et al. 2010]. Nous avons réaffirmé cette association dans 5 cohortes pédiatriques réunissant 8 946 enfants ($p_{\text{cholestérol total}}=0,002$, $p_{\text{LDL}}=0,0008$).

Au terme de cette étude, nous avons donc identifié un unique variant génétique, le rs2000999, expliquant quasiment la moitié de l'héritabilité génétique de l'haptoglobine (42%) et permettant de faire le lien entre inflammation et des facteurs de risque cardiovasculaire connus : les lipides. En pratique clinique, le fait que cette association soit si forte à un jeune âge souligne l'intérêt potentiel du génotypage du rs2000999 pour permettre l'identification précoce des sujets à risque concernant toutes les pathologies dans lesquelles l'haptoglobine est impliquée, et dans notre cas les MCV.

2.2. Genome-Wide Association Study de la pression artérielle dans des populations pédiatriques. Effet de l'obésité.

Nous avons vu dans le chapitre précédent que l'identification de l'effet d'un variant pouvait être conditionnée par le type de population et surtout par l'effet de l'environnement sur cette population. Dans une étude non encore publiée, nous avons donc voulu mettre en évidence ce fait en illustrant la relation bien connue entre pression artérielle et obésité [Muntner et al. 2004].

Nous avons donc mené deux GWAS simultanées chez les 631 enfants minces de la cohorte STANISLAS et chez 1 015 enfants obèses issus de la population OBE. Dans les deux populations, aucun variant n'a atteint le seuil 'genome-wide significant' mais ceci n'avait rien de surprenant car la pression artérielle est un trait qui a toujours été difficile à investiguer en GWAS [Levy et al. 2007]. Ce n'est que très récemment que des variants génétiques ont été identifiés dans de très larges populations Européennes [Levy et al. 2009 ; Newton-Cheh et al. 2010] et Japonaises [Takeuchi et al. 2009].

Nous avons par la suite entrepris de répliquer *in silico*, dans nos populations pédiatriques, les résultats obtenus par les GWAS précédemment citées. Cette procédure visait à minimiser le nombre de tests multiples et donc à augmenter le seuil de signification.

À l'exception des gènes *CYP17A1* et *ITGA9*, tous les loci mis en évidence dans des populations adultes ont pu être répliqués dans nos deux populations pédiatriques, notamment *CCL20*, *STK39*, *CNTN4*, *CAMK4*, *C6orf166-SPACA1*, *TRPA1-KCNB2*, *C14orf118*, *CDH13*, *MECOM*, *C10orf107*, *PLEKHA7*, *TBX3-BX5*, *SH2B3*, *CSK-ULK3*, *ZNF652*, *CASZ1*, *MDS1*, *ATP2B1*, *PLCD3*, *MTHFR* et *ATP2B1* (**Tableau 13**). Néanmoins, nous avons observé que les SNPs spécifiques à une population ne l'étaient pas dans l'autre et ceci expliquait le fait que la méta-analyse regroupant l'échantillon STANISLAS et l'échantillon OBE ne permettaient d'observer aucune signification nominale. Ainsi, au sein d'un même loci, le variant impliqué dans la variabilité interindividuelle de la pression artérielle (systolique ou diastolique) était dépendant de la corpulence de la population considérée.

Le cas particulier du rs7556897 localisé sur le gène *CCL20* a également soulevé notre attention. En effet, ce variant était le seul à être associé à la PAD dans les deux populations

simultanément mais avec un effet opposé : une diminution de la pression chez les enfants minces ($\beta=-1,27 \pm 0,56$; $p=0,024$) et une augmentation de la pression chez les enfants obèses ($\beta=+2,18 \pm 0,71$; $p=0,002$) (**Tableau 13**). Cette constatation venait renforcer de précédentes études *in vitro* impliquant ce gène dans la physiopathologie de l'obésité : *CCL20* code pour une chémokine de 96 acides amines exprimée dans le foie, les lymphocytes et les adipocytes [Duffaut et al. 2009] et dont l'expression a été positivement corrélée à l'IMC. Une augmentation des niveaux d'ARN messager et de la protéine chez les enfants obèses peut donc expliquer en partie une augmentation parallèle de leur pression artérielle.

Du point de vue de la fonctionnalité, le locus *SUFU* a également démontré un intérêt car il a récemment été associé à l'adipogenèse [Pospisilik et al. 2010].

Ainsi, cette étude nous a permis de prouver que les variants génétiques liés à la pression artérielle avaient un effet continu tout au long de la vie ; mais surtout que cet effet pouvait être modulé par les répercussions que pouvait avoir l'environnement sur les individus concernés : en l'occurrence ici, sur l'obésité.

Il serait opportun de répliquer ces résultats dans de plus larges échantillons, de préférence pédiatriques, et d'effectuer des études de transcriptomique de façon à nous assurer que les associations et surtout que les disparités observées sont robustes.

2.3. Genome-Wide Association Study de traits lipidiques dans des populations pédiatriques. Identification de variants inédits.

Les traits lipidiques ont largement été investigués dans le cadre des GWAS sur des populations adultes. Néanmoins, il n'existe à notre connaissance aucune étude ciblée sur des populations pédiatriques alors que ces traits subissent une influence très importante des facteurs environnementaux. Notre postulat était donc le suivant : il serait intéressant de s'assurer que les associations observées chez les adultes sont visualisables dès l'enfance mais aussi qu'il existe une sorte d'effet cumulatif des facteurs environnementaux qui masqueraient avec le temps l'effet de certains variants génétiques.

Nous avons donc mis en place une étude d'association pangénomique réunissant 9 800 enfants d'origine Européenne dans deux phases consécutives et 8 886 adultes dans une troisième phase de réPLICATION.

La 'discovery cohort' s'est composée des enfants STANISLAS et OBE pour lesquels nous avons mené deux GWAS sur le cholestérol total, les HDL et LDL-C et les TG. À la suite d'une méta-analyse, nous avons effectué un SNplex dans quatre populations pédiatriques : STANISLAS (échantillon non concerné par le GWS), NFBC86, GENDAI et Verona pour une phase 2. Nous avons ainsi pu démontrer que certaines associations génétiques mises en évidence chez l'adulte avaient un effet observable dès l'enfance comme dans le cas de la pression artérielle. Le rs780094 dans le locus *GCKR* ($p=3,70\times 10^{-14}$) a été associé aux TG [Willer et al. 2008, Aulchenko et al. 2009, Kathiresan et al. 2009]; et le gène *PCSK9* lié dans la littérature au LDL-C [Willer et al. 2008, Kathiresan et al. 2009] associé chez les enfants au cholestérol total ($p=3,96\times 10^{-05}$), aux TG ($p=1,04\times 10^{-03}$) et au HDL-C ($p=1,15\times 10^{-02}$) par l'intermédiaire du rs207136. Enfin, nous avons confirmé l'association du locus *TOMM40* proche du gène *APOE* avec le LDL-C ($p=3,25\times 10^{-13}$) et le cholestérol total ($p=7,39\times 10^{-10}$) [Aulchenko et al. 2009] via le rs2075650.

Mais nous avons surtout mis en évidence 11 variants inédits : rs10518422, rs2082163, rs11075365, rs4818278, rs2823986, rs4918082, rs2607919, rs933193, rs724815, rs12591800 et rs314672.

C'est ces 11 variants que nous avons recherché à répliquer dans une phase 3 réunissant deux populations adultes issues des cohortes STANISLAS et DESIR. Nous avons ainsi pu confirmer que 6 variants étaient spécifiques à l'enfance : le rs12591800 (*ATPBD4*, $p_{HDL}=7,41\times 10^{-05}$ et $p_{cholestérol\ total}=1,26\times 10^{-02}$); le rs4918082 (*PLCE1*, $p_{HDL}=2,62\times 10^{-03}$ et $p_{TG}=1,01\times 10^{-02}$); le rs2607919 (*NINJ2*, $p_{cholestérol\ total}=1,25\times 10^{-03}$ et $p_{HDL}=3,80\times 10^{-02}$); le rs933193 (*DAD1*, $p_{HDL}=3,77\times 10^{-03}$); le rs724815 (*NOVA1*, $p_{HDL}=1,10\times 10^{-02}$); et le rs314672 (*PRKD2*, $p_{TG}=3,18\times 10^{-02}$).

Ce derniers cas de figure peut s'expliquer par le fait que la croissance de l'effet de l'environnement sur un sujet donnée (avec l'âge) masque peu à peu l'effet de certains variants génétiques.

Cette étude en toujours en cours.

3. Identification de profils génétiques chez les sujets supposés sains de la cohorte STANISLAS : répercussions phénotypiques.

Mais pour quelle raison est-il si important de mettre en évidence les variants génétiques des facteurs de risque des MCV chez des sujets encore sains ... et jeunes ?

À terme, il serait profitable de mettre en évidence des profils génétiques permettant de sélectionner des sujets à risque sur lesquels cibler plus particulièrement des stratégies préventives adaptées.

Ainsi, nous avons recherché chez 1 551 sujets de la cohorte STANISLAS des profils génétiques ou clusters explicatifs des niveaux de facteurs de risque divers : anthropométrie, pression artérielle, lipides, consommation de tabac et d'alcool. Pour se faire, nous avons utilisé une approche gène candidat au sein de la cohorte STANISLAS.

À l'aide d'une combinaison factorielle sur 27 variants génétiques connus, nous avons isolé six clusters génétiques (**Figure 15**) ayant un potentiel discriminant indépendant de l'âge sur les facteurs de risque étudiés en relation (**Tableaux 14 et 15**). Ces clusters ou profils génétiques ont été nommés C_{1453} , C_{44} , C_{16} , C_{14} , C_{12} et C_{10} en fonction de leurs effectifs.

- C_{10} était très corrélé à une PAD et des concentrations en cholestérol total, TG, ApoB, ApoE (et LDL-C uniquement à t_0) élevées et à des concentrations en ApoA-I et HDL-C faibles ;
- Au contraire les sujets appartenant à C_{16} avaient des concentrations en cholestérol total, LDL-C (à t_0), TG (à t_5), ApoB, ApoE faibles et des concentrations en ApoA-I et HDL-C élevées ;
- C_{44} était associé à de faibles consommations d'alcool et de tabac ;
- Et les individus du profil C_{12} étaient plus minces (tour de taille, tour de hanche, IMC, poids faibles) et avaient de faibles concentrations en glucose, cholestérol total et ApoB à t_5 .

Ainsi, la détermination de clusters génétiques ‘à risque’ cardiovasculaire permet en pratique d'identifier un groupe d'individus pour lesquels les phénotypes concernés seront plus élevés.

Il serait intéressant de poursuivre cette approche en combinant les résultats GWAS avec ceux des études gène-candidat antérieures.

Figure 15 : Signature des clusters génétiques identifiés

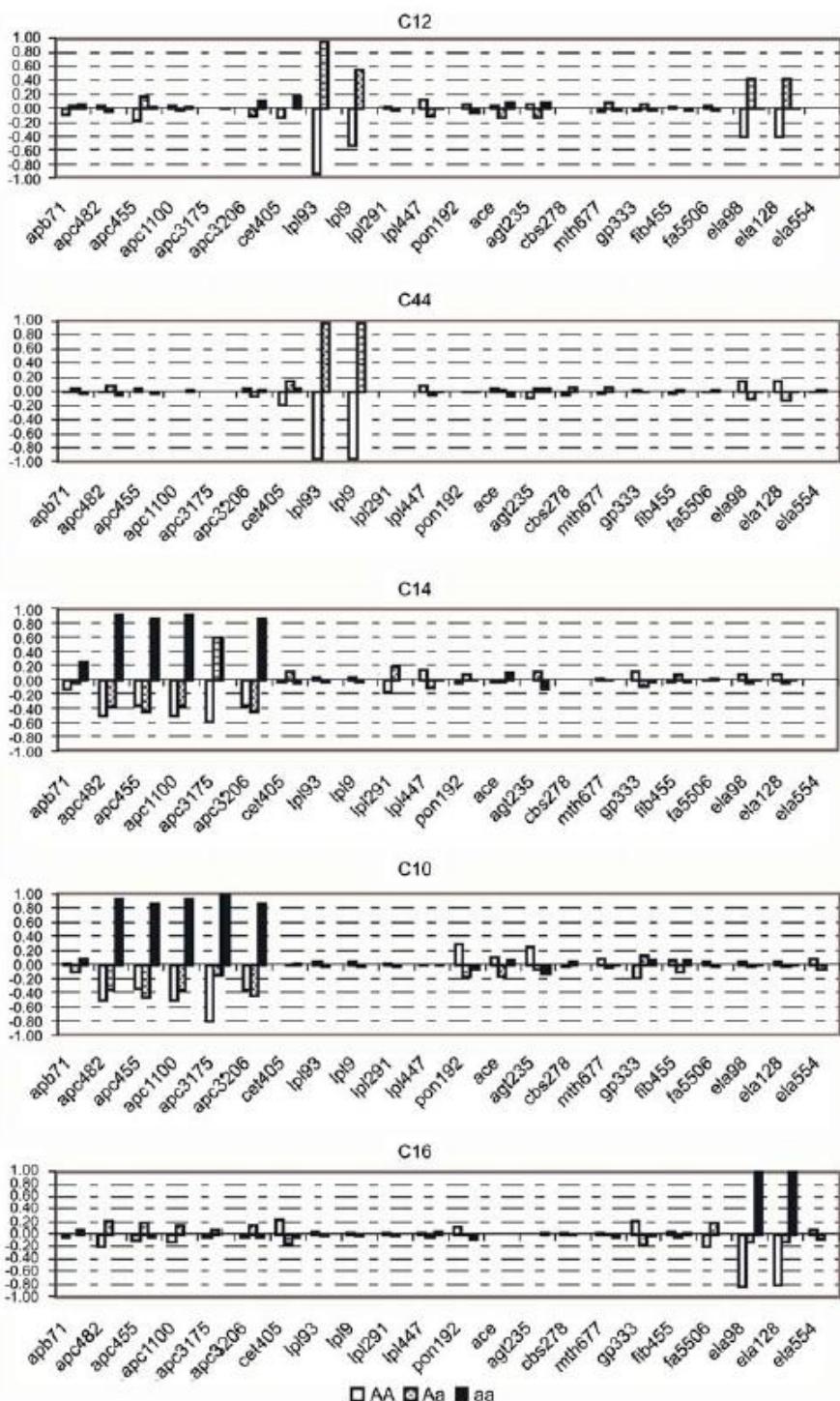

4. Quels sont les challenges méthodologiques qu'attendent les GWAS ?

PUBLICATIONS 1, 6 & 7

Les GWAS ont incontestablement révolutionné la manière d'appréhender l'épidémiologie génétique. Néanmoins, cette approche en est encore à ses balbutiements et de nombreux challenges méthodologiques restent à relever.

Comme évoqué précédemment, les facteurs environnementaux ont un effet plus ou moins important sur l'hérédité génétique des facteurs de risque des pathologies cardiovasculaires. Ces interactions gène-environnement ne sont cependant que très rarement investiguées. Pourtant, elles sont en grande partie responsables des discordances observées. La non réPLICATION dans une population lambda d'une association trouvée ailleurs peut être le reflet de l'effet de facteurs environnementaux différents.

Une autre zone d'ombre méthodologique de telles études est la prise en compte des interactions épistasiques (interactions gène-gène). Nous avons conscience sur ce dernier point de la grande difficulté méthodologique que pourrait représenter la prise en compte de tels effets dans une perspective de GWAS. Lors de la 5^{ème} conférence de Santorini 'Functional Genomics Towards Personalized Health Care' qui a eu lieu en Grèce en Septembre dernier, le Professeur Ioannidis exposait que la prise en compte de toutes les combinaisons possibles dans 12 000 000 variants génétiques correspondait à mener 10^{2085} analyses et porterait donc le seuil de genome-wide significance à $p=10^{-2087}$. Dans ces conditions, force est de constater que les approches gène-candidat ne font pas encore partie du passé.

Enfin, les GWAS permettent d'identifier des variants génétiques associés à des traits ou à des pathologies mais à ce jour, seulement 12% des SNPs identifiés sont localisés à proximité de régions codant pour des protéines [Hindorff et al. 2009]. Quarante pourcent se trouvent dans des régions intergéniques et 40 autres pourcent dans des introns. Ce phénomène peut bien sûr signifier que ces zones introniques et intergéniques pourraient avoir un rôle régulateur de l'expression de certains gènes impliqués [Hardy et al. 2009].

Ceci souligne la nécessité de placer les GWAS dans une démarche intégrée permettant de passer à une approche gène-candidat lorsqu'un design plus complexe est nécessaire à une meilleure compréhension des associations observées (et ce en attendant les avancées technologiques à venir), et allant jusqu'à une approche transcriptomique comme cela a été le cas pour notre étude pangénomique du VEGF.

4.1. Approche épistasique de la variabilité génétique de la pression artérielle.

Comme nous l'avons expliqué dans le paragraphe introductif de ce chapitre, une GWAS prenant en compte les effets épistasiques serait irréalisable à l'état actuel des connaissances et des outils à notre disposition. Néanmoins, pour illustrer le fait que la prise en compte de ces interactions gène-gène peuvent permettre de mettre en évidence des associations non significatives en individuel, nous avons entrepris d'étudier les interactions épistasiques de 100 gènes candidats de diverses voies métaboliques liées aux facteurs de risque cardiovasculaires : la régulation de la pression artérielle, l'inflammation, le métabolisme lipidique, le métabolisme de l'homocystéine, l'adhésion cellulaire et la thrombose en rapport avec la pression artérielle chez 1 912 individus d'âge moyen et d'origine française issus de notre CRB IGE-PCV (**Tableau 16**). Ces sujets étaient soit non hypertendus ne prenant donc aucune médication antihypertensive, soit hypertendus et dans ce dernier cas de figure, leur données cliniques étaient déterminées avant l'administration de médication. Ce sont ces données sans effet de la thérapie qui ont été utilisées dans notre étude.

Dans un premier temps, nous avons mené des études d'association individuelle de chaque variant ayant une MAF supérieure ou égale à 2% et ayant un HWE conforme. La puissance statistique de chaque analyse ($1-\beta$) a été calculée *a posteriori* et seules les associations observées pour des puissances supérieures ou égales à 80% ont été considérées significatives. Nous avons ainsi pu mettre en évidence neuf SNPs significativement associés à la pression artérielle dont 5 fonctionnels: les rs5742910 et rs6046 dans le gène *FVII* ($p \leq 0,024$), le rs1800469 dans *TGFB1* ($p < 0,001$), le rs1800590 dans le *LPL* ($p \leq 0,003$) et le rs2228570 dans *VDR* ($P < 0,001$).

Par la suite, nous avons analysé les interactions épistasiques de la totalité des variants quelques soient leur MAF. Toutes les combinaisons deux à deux possibles ont été testées et ceci nous a permis de mettre en évidence les interactions épistasiques fonctionnelles suivantes : *LPL* (rs1801177)**PON1* (rs662) ($p \leq 0,032$), *VCAM1* (rs1041163)**APOB* (rs1367117) ($p \leq 0,04$), *SCGB1A1* (rs3741240)**LPL* (rs1800590 et rs1801177) ($p \leq 0,031$). Il était à noter que les variants rs3741240 et rs1801177 n'étaient pas significativement associés à la pression

artérielle lors des analyses d'association individuelles et que c'est leurs combinaisons épistasique qui ont permis de mettre en évidence leur rôle sur la pression systolique et diastolique.

Cette étude a ainsi pu démontrer les interconnexions existant entre différentes voies métaboliques et de ce fait mettre en évidence de nouvelles cibles thérapeutiques impliquées dans la physiopathologie de l'HTA.

4.2. Étude d'association pangénomique du VEGF et identification des variants responsable de sa forte héritabilité génétique. Vers une approche intégrée en transcriptomique.

PUBLICATION N°7

Nous avons vu précédemment que le VEGF, qui a été dosé dans un échantillon restreint de la cohorte STANISLAS, avait une très forte héritabilité génétique (60,6%). Cette héritabilité ne s'expliquait pas par les gènes candidats dont nous disposions à l'époque et nous avons donc choisi de les identifier par une approche ‘hypothesis free’.

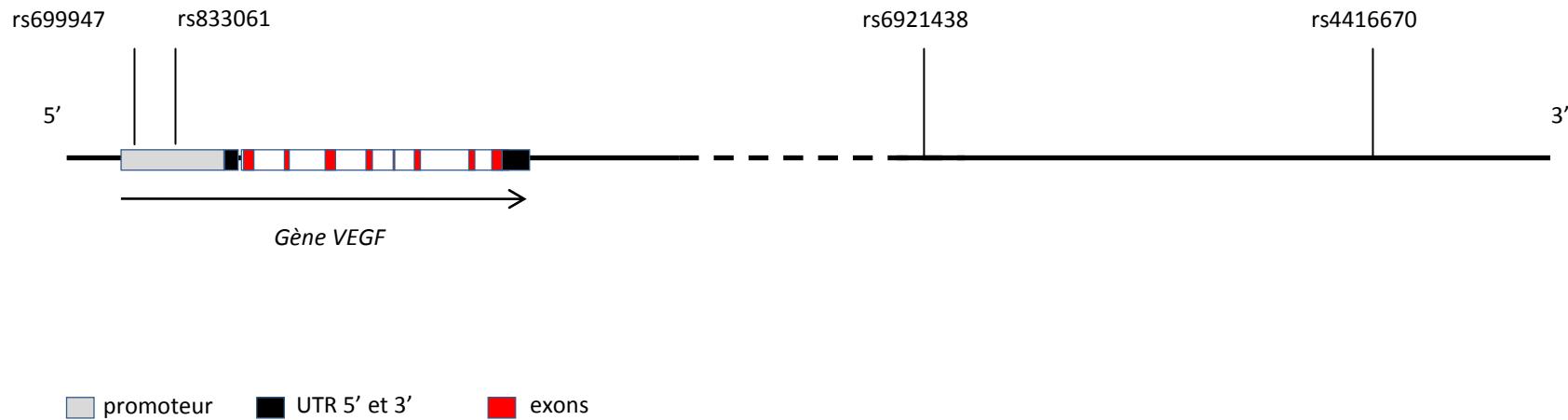
Nous avons ainsi entrepris une GWAS chez 3 546 sujets issus de la Framingham Heart Study (discovery set). Cent quarante SNPs localisés dans les régions 6p21, 8q23.1 et 9p24.2 ont atteint la ‘genome-wide significance’, dont le plus significatif : le rs6921438 sur le chromosome 6p21.1 ($p=6,11\times 10^{-506}$) localisé à 171 kilo bases du gène *VEGF* et proche du gène de la *Mitochondrial Ribosomal Protein L14 (MRPL14)* et de *MCG45491 (C6orf223)* (**Figure 16**).

Les régressions conditionnées ont permis d'identifier trois SNPs supplémentaires ayant un effet propre sur la variabilité interindividuelle du VEGF : rs4416670 ($p=1,47\times 10^{-12}$), rs6993770 ($p=2,50\times 10^{-16}$) et rs10738760 ($p=1,96\times 10^{-34}$).

Ces quatre variants (rs6921438, rs4416670, rs6993770 et rs10738760) ont permis d'expliquer 47,6% de l'héritabilité génétique globale du VEGF.

Lors d'une seconde phase, nous avons mené une étude de réPLICATION dans deux échantillons indépendants : 859 adultes issus de la cohorte STANISLAS et 868 adultes Suédois issus de la cohorte PIVUS (**Tableau 17**). À la suite des méta-analyses, 19 SNPs restaient associés à la concentration en VEGF ($p<0,05$). Ces associations étaient inchangées après ajustement sur l'HTA, le tabagisme, l'obésité centrale et le SM dans les 3 populations.

Nous avons précédemment déploré le manque d'information sur la fonctionnalité des variants identifiés dans le cadre des GWAS. Nous avons donc intégré à notre approche une étude transcriptomique et quantifié l'expression de deux variants d'épissage de l'ARNm correspondants à deux isoformes du VEGF : *VEGF₁₂₁* et *VEGF₁₆₅*. Cette expression a été quantifiée dans les PBMCs de 220 sujets issus de la cohorte STANISLAS et la corrélation des variants *VEGF₁₂₁* et *VEGF₁₆₅* a donc été testée avec les 24 variants génotypés avec succès dans la cohorte STANISLAS (**Tableau 18**). Ainsi, le rs910611 localisé sur le chromosome 6p21.1, les rs16873365, rs16873402, rs6993770 (indépendamment associé au VEGF, $p=2,50\times 10^{-16}$) et rs16873291 sur le chromosome 8q23.1 et le rs2375980 sur le chromosome 9p24.2 ont été significativement associés au variant *VEGF₁₂₁*.

Ces résultats soulignent donc la nécessité d'investiguer plus avant les facteurs de risque cardiovasculaires dont l'héritabilité, connue, ne s'explique pas par l'approche gène-candidat mais aussi la nécessité d'intégrer les approches pangénomiques dans des démarches globales permettant de déterminer la fonctionnalité de chaque variant génétique identifié.

CHAPITRE 5 – CONCLUSIONS ET PERSPECTIVES

Tout au long des trois années de nos travaux de recherche, nous nous sommes attachées à acquérir les compétences méthodologiques et logistiques nous permettant d'intégrer l'ère des études pangénomiques.

Notre équipe d'accueil, l'EA4373 'Génétique Cardiovasculaire', a une longue expérience de l'épidémiologie étiologique des MCV et a pu mettre en évidence de nombreux variants génétiques associés aux facteurs de risque de ces pathologies avec comme principal outil d'investigation la cohorte STANISLAS.

Jusqu'en 2008, l'approche gène-candidat était la principale méthodologie utilisée et notre intégration dans cette équipe visait donc à initier une approche pangénomique. Cette approche serait à intégrer dans une stratégie globale de l'équipe réunissant l'ensemble des compétences de nos chercheurs au sein du projet BiolIntelligence soutenu par l'Agence d'Innovation Industrielle (A2I) et signé en Avril 2010 avec l'INSERM transfert. Nous sommes tenus à la confidentialité en ce qui concerne les modalités de ce projet, néanmoins il est important de noter qu'il s'agit d'un projet collaboratif, financé par OSEO, et visant à proposer aux industriels des sciences de la vie, et en particulier aux industriels pharmaceutiques, des biomarqueurs pertinents en pharmacogénétique et pharmacogénomique à intégrer dans un environnement logiciel.

Dans un premier temps, nous nous sommes attachées à identifier les manquements méthodologiques que comportaient de telles approches : l'absence de prise en compte des interactions gène-gène, pour des raisons de logistique principalement, mais surtout l'absence de prise en compte des interactions gène-environnement. Ce dernier point étant complexifié par le fait que les GWAS nécessitent, pour valider les variants mis en évidence, des phases de réplication dans de très larges populations indépendantes les unes des autres et que cette diversité implique une 'non standardisation' des méthodologies de quantification de ces facteurs d'environnement. Notre premier postulat était donc qu'il serait nécessaire de mener des GWAS dans des populations minimisant l'influence de ces facteurs environnementaux : les populations pédiatriques. En effet, de telles GWAS menées sur les facteurs de risque des MCV sont minoritaires et principalement axées sur l'étude des marqueurs de l'obésité et du diabète de type 2 [Meyre et al. 2009 ; Bouatia-Naji et al. 2009 ; Qu et al. 2010 ; Scherag et al. 2010 ; Speliotis et al. 2010 ; Dupuis et al. 2010 ; Meyre et al. 2010].

Ainsi, sur le plan pratique, nous avons entrepris d'expérimenter les possibilités d'une telle stratégie en ciblant à la fois des facteurs de risque classiques et largement étudiés des MCV : les lipides et la pression artérielle, mais aussi des facteurs de risque émergents ou discutés : l'haptoglobine et le VEGF.

Ceci nous a permis de ‘designer’ et proposer une stratégie d’étude globale en trois phases intégrant diverses méthodologies et approches expérimentales schématisée dans la **Figure 17**.

1) Une phase de détermination de la part d’héritabilité génétique du trait concerné.

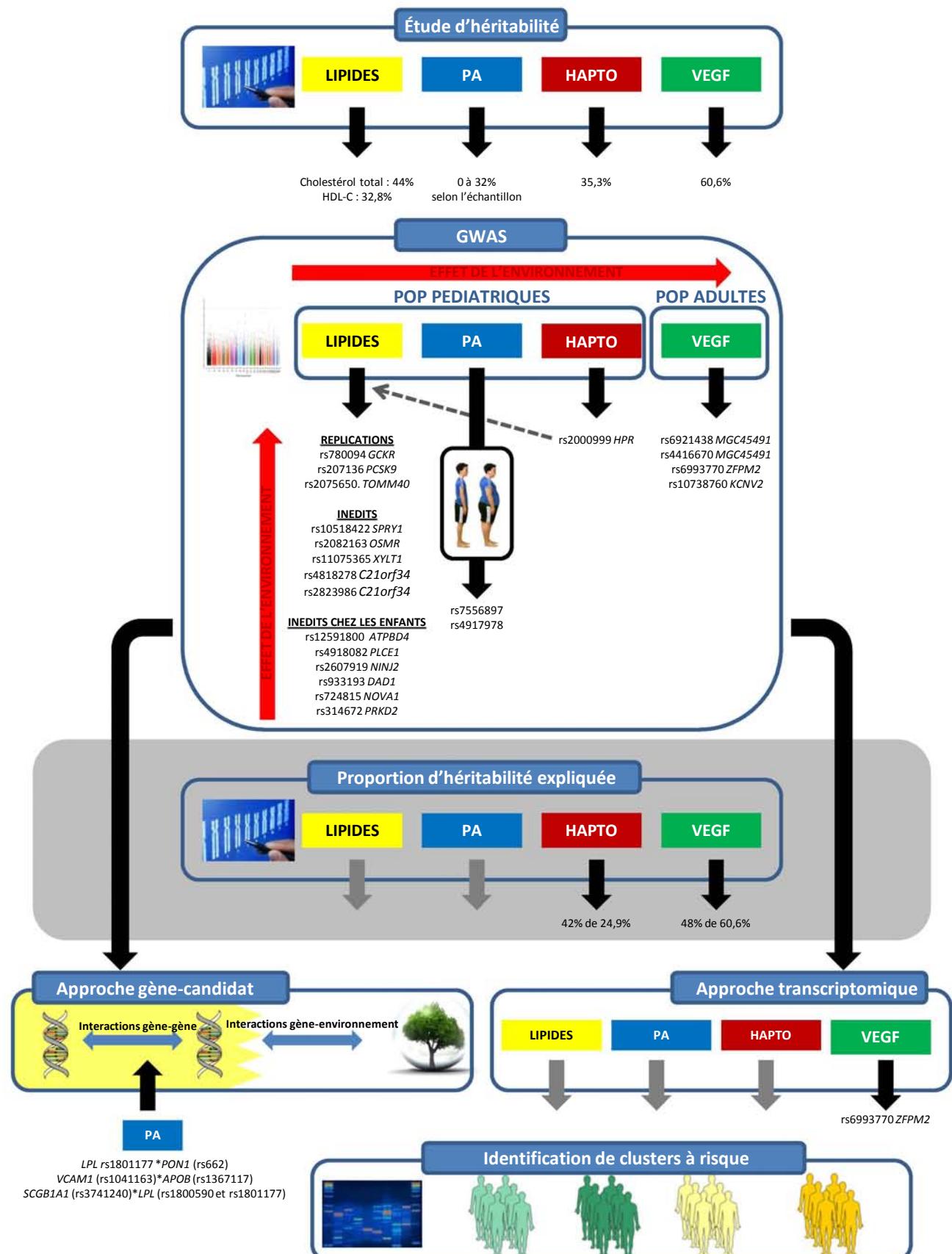
Nous avons ainsi quantifié l’héritabilité génétique (ou variance polygénique) du cholestérol total : 44%, du HDL-C : 32,8%, de l’haptoglobine : 35,3% et du VEGF dans une étude antérieure : 60,6%. Nous avons également mis en évidence la nécessité de déterminer cette héritabilité dans diverses populations de façon à identifier les traits sous forte influence environnementale. En effet, nous n’avons observé aucune héritabilité génétique pour la pression artérielle dans l’échantillon de la cohorte STANISLAS que nous avons étudié pour cette étape, résultat contradictoire avec une étude antérieure menée sur un échantillon différent de la même population.

2) Une phase de GWAS dans des populations pédiatriques.

Lors de ces travaux, nous avons pu prouver que les variants génétiques antérieurement mis en évidence dans des populations adultes, en particulier pour les lipides, avaient un effet observable dès l’enfance et surtout que de nouveaux variants pouvaient être découverts. Certains semblaient d’ailleurs spécifiques à l’enfance et des études confirmatoires sont en cours.

Dans le cas de la pression artérielle, pour laquelle nous avions constaté une forte variation de l’héritabilité, nous avons testé l’effet de l’obésité et observé une modulation de l’effet de loci connus sur la pression en fonction de la corpulence des sujets.

Cette phase pangénomique nous a également permis de mettre en évidence un variant génétique semblant être à la jonction de deux voies métaboliques car ayant une action à la fois sur l'haptoglobine et sur les lipides (cholestérol total et HDL-C).

Notez que nous avons effectué une GWAS du VEGF sur des populations adultes étant donné que son héritabilité génétique de 60,6% impliquerait une faible action des facteurs environnementaux et qu'il était donc moins primordial de les minimiser. Nous avons d'ailleurs confirmé cette forte héritabilité dans la cohorte Framingham.

Une étape pivot de nos travaux a été la détermination d'une portion importante de l'héritabilité génétique expliquée par nos GWAS : elle était de 42% pour l'haptoglobine, et de 48% pour le VEGF.

3) Enfin, nous proposons une phase explicative en deux temps par :

- a. La détermination de l'influence des phénomènes épistasiques et des interactions gène-environnement qui doivent être intégrés lors des analyses futures des variants mis en évidence par les GWAS.

En effet, en utilisant une approche gène-candidat préalable, nous avons pu démontrer l'existence de phénomènes épistasiques régulant la pression artérielle et qui n'étaient pas observables lors des analyses d'association individuelles.

- b. La recherche d'une fonctionnalité par une approche transcriptomique.

Nous avons pu démontrer l'intérêt de cette approche en identifiant un variant, parmi les 4 indépendamment associés au VEGF, lié à l'ARNm *VEGF₁₂₁* et présentant ainsi une éventuelle cible thérapeutique.

Un tel design en strates serait à notre sens un bon outil d'élucidation de l'étiologie génétique des MCV même si certaines problématiques ne sont pas encore résolues (*PUBLICATION N°1*) et permettrait la détermination de clusters à risque en prévention primo-secondaire.

Une quatrième étape serait l'expérimentation pharmacogénomique et pharmacogénétique de notre cheminement et de nos résultats dans le cadre du projet BioIntelligence. Même si nous convenons qu'il est prématûr d'imaginer avoir des retombées thérapeutiques dans un futur proche, nous sommes convaincus que de telles expérimentations doivent avoir lieu largement en amont.

C'est pour cette raison que nous allons poursuivre la mise en œuvre de ce design intégré par la détermination de la proportion d'héritabilité expliquée par les SNPs identifiés dans le cas des lipides et de la pression artérielle. Nous poursuivrons également notre approche transcriptomique sur ces deux traits mais aussi sur l'haptoglobine de façon à compléter le cheminement analytique que nous avons conçu et mis en place au cours de notre thèse.

Bien évidemment, des adaptations sont à prévoir en fonction des avancées méthodologiques et logistiques constantes, qui sont la caractéristique de l'ère des GWAS, et que nous continuerons à acquérir.

Abstract

Genome-Wide Association Studies on cardiovascular diseases and related quantitative traits revealed numerous genetic variants only partly replicated, probably due to the heterogeneity of the clinical phenotypes and populations studied. Even if new mechanisms have been identified there is still a long way to go to identifying the causal variants. Genome-Wide Association Studies methodologies should, in the coming years, integrate gene-gene and gene-environment analyses in a global scientific strategy involving subsequent transcriptomic and proteomic investigations. The Genome-Wide Association Studies era holds many promises but we are just at the beginning.

Review

Cardiovascular diseases: common disorders with important genetic component

Cardiovascular diseases (CVD) are the world's largest killers claiming 17.1 million lives each year i.e. 29% of global deaths according to the World Health Organisation (WHO). In 2004, 7.2 million deaths were due to coronary heart disease (CHD) and 5.7 million to stroke, and their prominence is expected to increase: CVD are projected to remain the leading cause of death reaching 23.56 million by 2030. Risk algorithms such as the Framingham Risk Score for absolute risk¹, incorporating classical risk factors (age, gender, blood lipid concentrations, blood pressure, body mass index, family history and smoking habit), have been constructed for primary prevention strategies the efficacy of which has reached a plateau. It is thus necessary to integrate new risk factors and DNA-based tests assessing the genetic predisposition to CVD² in public health policies. This is much more important given the high genetic component of these diseases and of their related quantitative traits².

The aetiology of CVD results from a complex combination of interrelated environmental and constitutive risk factors that have been intensively studied in the last decades³. This complex architecture and its genetic background^{4, 5} is still poorly understood and substantial discrepancies remain in estimating the heritability of numerous CVD related traits⁶.

However, for many years now, developments in genetic analyses have been instrumental in highlighting important novel biological pathways in CVD susceptibilities and have provided a far better understanding of the fundamental inherent biological pathway leading to the development of the pathologies being considered.

Before the Genome-Wide Association Study (GWAS) era, genetics of phenotypes of interest (diseases or traits) were assessed by candidate gene approaches. Twins, families and population-based studies were used to estimate heritability, and even to explore interactions between genetic and environmental factors. Candidate genes were defined when the physiopathology of a disease was known (e.g. an enzyme deficiency) and all the results which followed relied on theoretical premises. Innovative discoveries needed a hypothesis-free approach. As far as this is concerned, since 2005, GWAS designs have revolutionized the genetic understanding of CVD and their associated quantitative traits⁷⁻⁹. In fact, recent technological advances enabling rapid and accurate genotyping of millions of single-nucleotide polymorphisms (SNPs) in large populations have led to conducting GWAS for different CVD phenotypes and related traits (Figure 1) and to the identification of hundreds of genetic factors, some robustly replicated (NHGRI Catalog of published genome-wide association studies, accessed September, 2010, <http://www.genome.gov/gwastudies>: common disease-common variant hypothesis)^{10, 11} with small individual effects. Moreover, GWAS have revealed previously unsuspected pathological pathways^{4, 12}. However, finding causal variants explaining the high heritability of the different CVD phenotypes has not yet achieved satisfactory results¹³.

In this work we review GWAS findings concerning CVD and their related quantitative traits, missing heritability and future challenges.

Brief overview of Genome-Wide Association Studies on cardiovascular diseases and their related quantitative traits

To date, at least 650 GWAS focusing on about 150 distinct diseases and traits have reported more than 800 significant SNP-trait associations (genome-wide significance for $P < 5 \times 10^{-8}$, <http://www.genome.gov/gwastudies>). At least, 16 have been conducted on cardiovascular events and have reported the association of 29 genetic variants found in 20 genes (supplementary Table 1). However, the scientific community pointed out that some caution is needed when interpreting data found in GWAS for CVD, given the weak sample size of the majority of these studies. The genetic variants are very rarely robustly linked to the cardiovascular events. Similarly, the lack of suggestive associations stressed the value of having accurate clinical subtype classification and standardised methodology for multicentre studies.

GWAS of the quantitative traits related to CVD could provide an alternative approach for better comprehending the phenotypic diversity of a given CVD as stated by the Wellcome Trust Case Control Consortium (WTCCC)¹⁴.

Sixty percent of CVD and related trait GWAS are focused on obesity and have reported the association of about 60 variants in the vicinity of 35 genes (Figure 1). Less than two thirds of them, including some appreciable paediatric studies, have been replicated. Interestingly, the *FTO* gene was identified as the first locus harbouring common variants with an unequivocal impact on obesity predisposition and fat mass in population studies and being significantly associated with diabetes. The most important reports are summarised in Supplementary Table 1.

More than a quarter, at least, of all GWAS for CVD and related traits have studied fasting plasma glucose and diabetes mellitus (Supplementary Table 1). Up to ninety percent of them have been replicated in European, American and Asian populations. In two distinct studies, Zeggini et al.^{15, 16} reported the association of type 2 diabetes mellitus with 22 SNPs next to the following genes: *CDKN2A*, *CDKN2B*, *FTO*, *HHEX*, *IGF2BP2*, *KCNJ11*, *CDKAL1*, *TCF7L2*, *THADA*, *TSPAN8*, *LGR5*, *VEGF*, *NOTCH2*, *ADAM30*, *PPARG*, *SLC30A8*, *JAZF1*, *SYN2*, *CDC*, *ADAMTS9*, *CDC123*, *CAMK1D*. Of these, two SNPs in the vicinity of *TCF7L2* had the greatest association with type 2 diabetes (Supplementary Table 1).

Lipid profile and blood pressure (BP) studies represent a considerable part of the GWAS undertaken (26% and 10% respectively, Figure 1). Concerning lipid profiles, 9 GWAS revealed 97 SNPs in 54 loci ($p < 10^{-6}$). About two-thirds of SNPs have been successfully replicated, notably 2 in the vicinity of *CETP* (Supplementary Table 1).

It is important to mention that although rs3764261 in *CETP* was strongly associated with total cholesterol, low-density lipoprotein cholesterol (LDL-C) and triglycerides (TG) ($p = 7 \times 10^{-380}$)¹⁷, this SNP was not related to coronary artery diseases.

It should be noted that caution needs to be exercised with the meta-analyses on hyperlipidaemic and diabetic individuals¹⁷⁻¹⁹, since they have included some common subsamples: similar association results will not be surprising²⁰.

In addition to lipid profiles, replication studies have been relatively successful in confirming BP and hypertension (HTN) key loci²¹⁻²³. In the largest joint meta-analysis published in May 2009, by CHARGE²⁴ and GlobakBPgen⁴ consortia, researchers discovered 14 loci associated with systolic BP, diastolic BP and/or HTN. Recently, Takeuchi et al.²¹ succeeded in replicating 7 loci in Japanese subjects, whereas Liu et al.²² and Hong et al.²³ have confirmed some of them in Chinese Hans and Koreans respectively. These main findings constitute a milestone in bringing genome knowledge into BP regulation in diverse populations, as will be discussed below²⁵.

GWAS strengths and limitations

Current Genome-Wide Association Studies designs

GWAS involve various tiered designs including case-control and cohort studies for the identification of trait/disease-SNP associations. These tiered strategies allow affordable procedures to be carried out by conducting a genome-wide scan in a discovery set in order to select a core of significantly associated SNPs that will be subsequently genotyped in larger replication sets for confirmation²⁶. These intricate designs involve more and more tiers according to the complexity and originality of the trait of interest²⁷ and allow the elimination of previous spurious associations (false positives)¹¹. Traditionally, genetic associations having causal functionality and appearing in multiple populations and studies are considered reliable^{11, 26}.

Testing the association for millions of SNPs with a specific trait or disease implies a large number of statistical tests (at least one per SNP) making nominal significance (0.05) inappropriate for originally selecting associated variants. Such designs thus require large populations²⁸ and have led to large international consortia being set up in which substantial pooled GWAS have been conducted. Indeed, significant progress in the management of the methodological weaknesses of GWAS has been made under the auspices of large consortia providing numerous independent populations for pooling analyses and replications in specific fields, such as the Glucose and Insulin Related Traits Consortium (MAGIC)²⁹. These pooling strategies required controls for differences in allele frequencies³⁰ to minimise false positive findings and reinforce the validity of genetic variants found to be associated with specific traits or pathologies.

Only 12% of SNPs discovered by all the GWAS performed to date and associated with traits are located in the vicinity of protein-coding regions of genes, although SNPs in protein-coding regions are heavily over-represented on genotyping arrays³¹. Forty percent fall in intergenic regions, and another 40% are located in introns. Initially raising concern in the scientific community, the repeated replication of signals falling consecutively in so-called gene deserts sharpened the focus on the potential roles of intronic, and particularly intergenic regions in regulating gene expression⁷.

Future challenges

Over the past few years, GWAS have reported a large number of novel genetic variants associated with CVD^{32, 33}. We now need to perform GWAS on populations with diverse geographic ancestries that have undergone more mutations and greater recombination events. This type of study can give greater degrees of genetic variation and shorter stretches of linkage disequilibrium allowing better localisation of genome-wide association signals^{13, 15}. Several different ethnicities such as Japanese²¹, African Americans³⁴ and mainly Europeans^{4, 24} were examined. European populations are closely related²⁵, their genomes have undergone less recombination events than those of Africans for example³⁵, an advantage that has increased the choice of this specific descendent. Will we be able to replicate initial findings in non-European populations?

It might be asked why numerous worldwide replication studies confirmed loci but not SNPs. In fact, genetic variants having high occurrence in Europeans can differ in their frequencies across populations; many SNPs are rare in non-Europeans³⁶. Moreover, allelic frequencies differ even if the same SNP is found in diverse populations³⁷.

GWAS expansion will ultimately allow us to identify “worldwide genetic variants” that are capable of influencing CVD and will further define the most suitable ethnicity to reveal a genotype-phenotype effect.

In this context, GWAS involving African populations are potentially of interest. Low linkage disequilibrium between genetic variants is one of their main characteristics, due in part to a long history of recombination and mutations²⁵. When SNPs extend over short genomic regions, further sequencing may be very effective in defining the true risk variant²⁵.

What will be the application of these findings in clinical practice and for predicting CVD risk? Kathiresan and colleagues integrated genetics into cardiovascular risk scores on the basis of nine SNPs associated with cholesterol levels³⁸. But does it add anything more than algorithms previously constructed on the basis of phenotypes³⁹? Even strongly associated with the risk of CVD, after adjustment for standard risk factors, the new score developed by Kathiresan et al. did not change the receiver-operating-characteristic curve (AUC)³⁸. Similar

attempts in prostate cancer gave the same result⁴⁰. Finding the causal variants implicated in these pathologies could overcome this problem.

Missing heritability in cardiovascular diseases, an Achilles' heel

Recent GWAS had an enormous sample size ($\approx 100,000$ individuals) but explained only about 10% of heritability¹⁷, the “dark matter” of GWAS.

GWAS have focused on common variants (allelic frequency $>5\%$ in the general population)³⁵ and ignored low minor allele frequency (MAF) ($0.5\% < MAF < 5\%$ in the general population) and rare ones ($MAF < 0.5\%$) that are predicted to have a greater risk effect³⁵. In contrast to common variants thought to be old in the history of humanity, rare variants are more recent and therefore not geographically extended²⁵. Detecting associations with rare variants will be the first step to better understanding of their role in CVD. When focusing on rare genetic variants, GWAS require very large populations and different statistical methods that jointly analyse variants in a locus instead of testing each variant individually. The next generation of dense arrays with more genome-wide covering are making this goal feasible.

Structural large variants ($>500\text{Kb}$) such as deletions and duplications (Copy number variants) represent rare variants that may affect gene expression and pathways in humans⁵. These genomic imbalances occur at an allele frequency of $<0.05\%$ and are present in about 8% of the total population⁵, making them rare but collectively common. Results available suggest that copy number variants strongly affect gene expression, thereby affecting mRNA splicing and transcriptional activity⁴¹.

Gene-environment interactions (GxE) are also issues that blind many GWAS. Integrating gene-environment interactions could help in highlighting different loci effects according to modifiable risk factors, particularly in CVD. This strategy needs large consortia, methodological efforts and stratified designs in order to improve the existing tools for GWAS that do not yet incorporate complex statistics. Although, environmental pathways acting through epigenetic mechanisms to modify gene expression⁴² and DNA methylation⁴¹ have given some fruitful results in other chronic diseases⁴³ and exposures⁴⁴, they are yet to be studied in CVD. In addition to the usual challenges reported for genetic association studies, a successful GxE study should take into account sample size, exposure assessment and heterogeneity, described in full elsewhere⁴². GxE in GWAS requires enormous populations⁴². Smith and Day⁴⁵ explained that detecting an interaction needed a sample size at least four times greater than that required for detecting a main effect of comparable magnitude. Although difficult, studying GxE interactions could help in understanding discrepancies due to heterogeneous exposure.

Gene-gene (epistatic) interactions may also play an important role in discovering genes that have not yet been found by the consensual single-locus approach. This statement has been

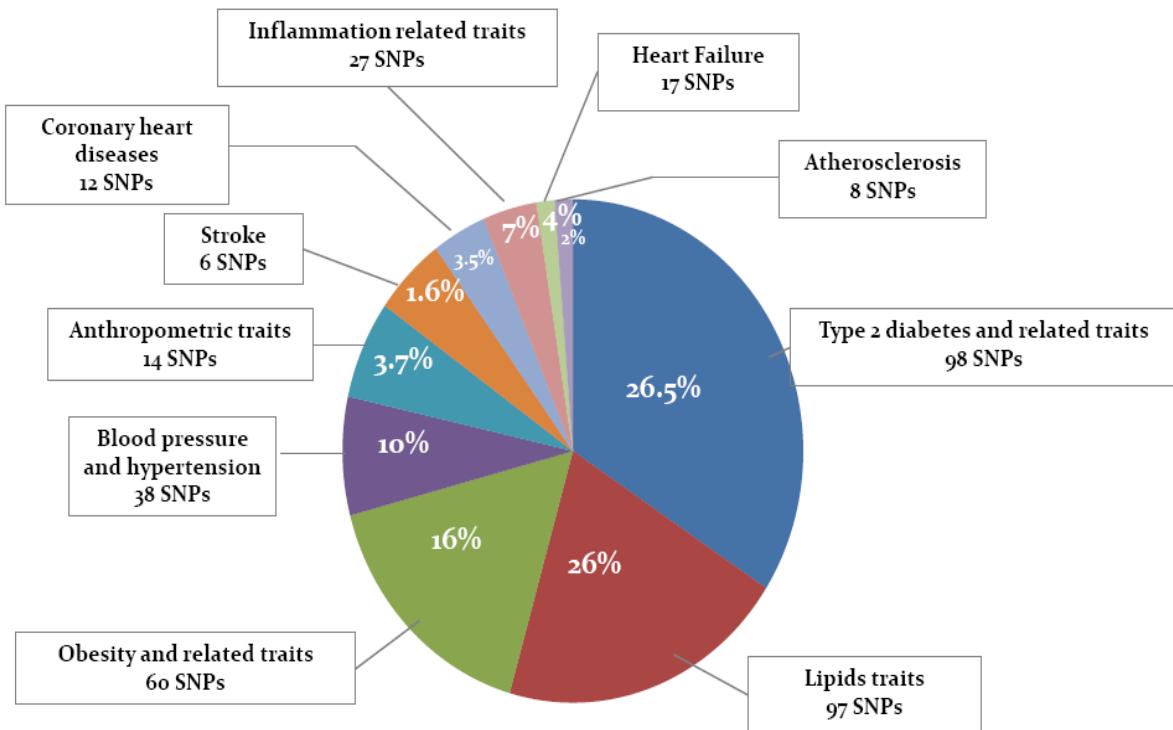
extensively reviewed^{8, 46, 47} and both parametric and nonparametric multi-locus methods have been developed to detect such interactions⁴⁸ in the last years. Epistatic interactions have been documented for susceptibility to cancer⁴⁹, morphology⁵⁰ and autoimmune conditions⁵¹. However, current epistatic designs do not have genome-wide coverage, so that their application to high-dimensional genome-wide data including all imaginable SNPs remains a crucial challenge⁵².

Furthermore, we advise that all loci associated with CVD and related traits should be replicated in paediatric populations, as a common variant could have a continuous impact throughout life. Epidemiological and pathophysiological evidence suggests that the precursors of CVD originate in childhood^{53, 54}: the atherosclerotic process starts in childhood⁵⁵ and numerous studies have shown that risk factors such as increased BP levels during childhood strongly predict HTN in adults⁵⁶. Isolating genetic variations that may influence a given risk factor for CVD at childhood, where many environmental factors such as alcohol intake, stress and smoking are absent, might therefore have major implications for public health and could be a challenge in designing primary preventive strategies.

Concluding remarks and perspectives

GWAS have revealed many novel genetic risk variants in CVD, making it an auspicious era for understanding genetics better. For the time being we need to grasp the unexpected involvement of certain functional and mechanistic pathways identified in CVD processes involving many quantitative traits. These have to be extensively investigated in parallel with the pathology itself. Future GWAS must also detect low MAF and rare variants, and include GxG, GxE and well-designed candidate gene studies (in term of statistical power, homogeneity, and exposure assessment) and involve subsequent transcriptomic and proteomic investigations. It is time to pause and think, instead of digging down and down for more genetic loci that will have even smaller phenotypic effects as the number of individuals studied rises exponentially.

Dans cette étude nous avons estimé l'héritabilité génétique et l'environnement partagé de différents traits liés au syndrome métabolique dans de jeunes familles Françaises issues de la cohorte STANISLAS par une approche transversale puis longitudinale.

Dix neuf traits assemblés en cinq clusters ont été investigués par une analyse factorielle et nous avons observé de fortes héritabilités génétiques (20 à 44%) pour les lipides, les lipoprotéines, l'acide urique, le glucose et les clusters associés ; et des héritabilités génétiques modérées (inférieures à 20%) pour les triglycérides, l'adiposité, la pression artérielle, les enzymes hépatiques et les marqueurs de l'inflammation en transversal (analyse lors du premier examen de santé). L'environnement partagé avait un effet sur toutes les variables investiguées.

En longitudinal à court terme (5 ans), les variances polygéniques étaient au contraire toutes faibles et non significatives et l'environnement partagé très élevé.

Ainsi, nous avons observé des héritabilités génétiques plus faibles que celles généralement constatées pour les traits associés au syndrome métabolique tandis que l'effet de l'environnement partagé était plus élevé.

ABSTRACT

Background: We estimated genetic heritability and common environmental influences for various traits related to metabolic syndrome in young families from France.

Methods: At entrance and after 5 years, nineteen traits related to metabolic syndrome were measured in a sample of families drawn from the STANISLAS study. In addition, 5 aggregates of these traits were identified using factor analysis.

Results: At entrance, genetic heritability was high (20 to 44%) for plasma lipids and lipoproteins, uric acid, fasting glucose, and the related clusters "risk lipids" and "protective lipids". Intermediate or low genetic heritability (less than 20%) was shown for triglycerides, adiposity indices, blood pressure, hepatic enzyme activity, inflammatory makers and the related clusters: "liver enzymes", "adiposity/blood pressure" and "inflammation". Moreover, common environmental influences were significant for all the parameters. With regard to 5-year changes, polygenic variance was low and not statistically significant for any of the individual variables or clusters whereas shared environment influence was significant.

Conclusions: In these young families, genetic heritability of metabolic syndrome-related traits was generally lower than previously reported while the common environmental influences were greater. In addition, only shared environment contributed to short-term changes of these traits.

1. Introduction

The metabolic syndrome is a complex combination of traditional cardiovascular risk factors (central obesity, hyperglycemia, insulin resistance, dyslipidemia and hypertension) [1], and of some novel additional factors that include inflammation markers (CRP, haptoglobin, orosomucoid), white blood cells count [2–4], serum uric acid [5,6] and liver enzymes [gamma-glutamyl transferase (GGT), alanine aminotransferase (ALAT), and aspartate aminotransferase (ASAT)] that are important markers of non-alcoholic fatty liver disease [7]. Several approaches exist for studying simultaneously numerous factors of the metabolic syndrome. One is the use of a bivariate genetic/environmental analysis for pairs of metabolic syndrome-related traits in different family members [8]. Another one is the use of a dimension reduction technique, such as factor analysis, that allows the study of aggregates of phenotypes (clusters) instead of the original phenotypes in variance component

analysis. This method has been used in family studies for common metabolic syndrome-related factors [9–12]. However, although some studies have included novel factors of the metabolic syndrome for studying their heritability (CRP, WBC, uric acid) [8,9,12–14], no data exists about clusters of these factors. Likewise, no study has examined whether genetic or environmental susceptibility may underlie clusters of short-term changes in these metabolic syndrome-related factors.

Therefore, we aimed to estimate additive genetic heritability and common environmental effects for clusters and individual quantitative traits of both common and novel metabolic syndrome risk factors at baseline and over 5 years. Two subsets of data of the STANISLAS Family Cohort were used: a sample of 667 families ($n=2471$ individuals) for the cross-sectional study and a sample of 353 families ($n=1208$ individuals) for the longitudinal study.

2. Methods

2.1. Study subjects

This work is based on the STANISLAS Family Study, a 10-year longitudinal study conducted since 1994 on 1006 families selected at the Center for Preventive Medicine of Vandoeuvre-lès-Nancy (east of France) [15,16]. In this work, we present 2 subsets of data, firstly on metabolic syndrome-related variables measured during the initial

examination in 1994–95 and secondly on 5-year changes of metabolic syndrome-related variables. Due to the design of the STANISLAS Family Study, subjects were of French origin and were free from acute or chronic diseases such as stroke, myocardial infarction or cancer. Children at entrance who were younger than 11 years were not included in this study.

A total of 667 families with two biological parents and at least one child (nuclear families) were eligible for the study based on the baseline check-up in 1994–95 (1334 parents aged 30–64 years at entrance and 1137 children aged 12–25 years). The response rate of individuals for the second check-up was 73%. Consequently, 353 families attending a check-up both in 1994–95 and in 1999–2000, composed of two parents and at least one child, were eligible for the longitudinal study (706 parents and 502 children).

Each subject gave written informed consent for participating in this study, which was approved by the local ethics committee (Comité de Protection des Personnes dans la Recherche Biomédicale de Lorraine, France).

2.2. Blood samples and data collection

Blood samples were collected after an overnight fast between 8.00 and 9.00 a.m. or between 11.00 and 12.00 a.m. Data were collected by using relevant questionnaires including, information about lifestyle such as tobacco, alcohol and drug consumption and personal medical history. Physical examinations and functional tests were performed and basic blood constituents were measured as described previously [15]. Serum concentrations of fasting glucose, total cholesterol, triglycerides, uric acid and activities of ASAT, ALAT, and GGT were measured with commercially available kits on an AU5021 apparatus (all from Merck, Darmstadt, Germany) on fresh aliquots, and within 2 h. Serum apolipoproteins AI and B, hs-CRP, haptoglobin and orosomucoid were measured by immunonephelometry on a Behring Nephelometer Analyser (BN II, Siemens Healthcare Diagnostics, Deerfield IL) within 2 h after sampling. Apolipoprotein E was measured by turbidimetry and HDL-cholesterol by the precipitation by phosphotungstate, both on a Cobas-Mira analyzer (Roche).

Metabolic syndrome in adults was defined according to the International Diabetes Federation (IDF) criteria [17]: waist circumference (WC) ≥ 94 cm in men or ≥ 80 cm in women plus any two of the four following criteria (1) triglycerides ≥ 1.7 mmol/l or drug treatment for elevated triglycerides, (2) HDL-C <1.03 mmol/l in men or <1.3 mmol/l in women or drug treatment for reduced HDL-C, (3) SBP ≥ 130 mm Hg or DBP ≥ 85 mm Hg or anti-hypertensive drug treatment, (4) fasting glucose ≥ 5.6 mmol/l or drug treatment for elevated glucose. For adolescents, specific IDF criteria were used: the age- and gender-specific cut-points for each metabolic syndrome component proposed in the literature [18].

For the whole sample, body weight index (BWI) that is as an appropriate measure of adiposity in children, independently of growth phenomenon and sexual maturation, was used in analysis (BWI – [weight/weight reference values for sex and age]/100). Weight reference values are derived from Rolland-Cachera et al. [19].

2.3. Statistical analysis

Statistical analyses were performed by using the SAS software package version 9.1 (SAS Institute, Inc., Cary, NC). Before statistical analyses, serum concentrations of the above mentioned variables were adjusted for the effect of time of blood sampling (between 8.00 and 9.00 a.m. or between 11.00 and 12.00 a.m.) and for between-month variability to remove the effect of daily, monthly (seasonal) and analytical variations. Briefly, for each variable, levels were regressed on both time of blood sampling (at the beginning of morning or at the end) and on monthly truncated means obtained on selected healthy males aged 20–40 years attending the health check-

up concurrently with the sample population of this study; the variable used being the sum: residual + crude mean of the overall sample.

Since the distributions of triglycerides and hs-CRP concentrations, and ASAT, ALAT and GGT activities exhibited a long-tailed positive skewness and kurtosis, \log_{10} transformation was used. The Gaussian distribution of transformed variables was verified by using normal probability plots.

Factor analysis was undertaken to avoid the problem of multiple comparisons and redundancy of information. Prior analysis, the nineteen initial metabolic syndrome-related factors measured at entrance (data from cross-sectional study): BWI, WC, systolic and diastolic blood pressures; serum concentrations of triglycerides, total cholesterol, HDL-cholesterol, apo A1, apo B, apo E, fasting glucose, uric acid, hs-CRP, orosomucoid, and haptoglobin; activities of ALAT, ASAT and GGT; and white blood cells count were adjusted for age and specific drug use separately for fathers, mothers, sons and daughters. Likewise, the 5-year changes in variables (data from longitudinal study) were adjusted for age, specific drug use and values at entrance, separately for fathers, mothers, sons and daughters. Factor analysis was followed by orthogonal (varimax) rotation to assist in interpretation of the factors and to ensure that the factors were uncorrelated. We determined the number of factors to retain by using both the proportion of common variance to be accounted for by the retained factors ($\approx 100\%$) and the Scree test. The Scree plot is a plot of the eigenvalues of derived factors. To simplify interpretations, only variables with factor loadings having absolute values greater than 0.29 were shown. The factor score for each pattern was calculated by summing levels of metabolic syndrome-related variables weighted by their factor loadings. Factor scores were standardized to have a mean of 0 and a standard deviation of 1. The scores reflect how closely participant's metabolic syndrome-related variables resemble each identified pattern, with higher scores representing closer resemblance. At baseline and for 5-year changes, each individual received a factor score for each identified cluster.

Variance component analysis was applied to assess the relative contributions of genetic and environment to metabolic syndrome-related factors and to clusters (at entrance and for 5-year changes). Under a pure polygenic model, a phenotype (P) is a function of genetic (G) and environment (E) effects (i.e., $P = G + E$), usually expressed in terms of variance components ($\sigma_P^2 = \sigma_G^2 + \sigma_E^2$). The genetic heritability (usually named broad-sense genetic) is defined as the proportion of the total phenotype variance that is due to genetic effects ($h_G^2 = \sigma_G^2 / \sigma_P^2$), mainly due to a large number of genes, each with a small, linear, and additive effect.

The environmental component can be decomposed into common familial (due to the effect of sharing the same household at the time of measurement, C) and random nonfamilial (due to individual-specific factors, R) environmental effects (i.e., $\sigma_P^2 = \sigma_G^2 + \sigma_C^2 + \sigma_R^2$). Thus, analogous to genetic heritability, the cultural heritability or common environmental variance component may be defined as ($c^2 = \sigma_C^2 / \sigma_P^2$), which is assumed to be due to a large number of linear and additive familial environmental effects [20].

The analysis was conducted by using a multivariate normal model for pedigree analysis as described by Lange et al. [21,22] with the software FISHER, which also performed goodness-of-fit test of the underlying multi-normal distribution. These three components were assumed to be normally distributed with mean equal to 0 and variance equal to σ_G^2 , σ_C^2 and σ_R^2 , respectively. For all tests, statistical significance was taken at $p \leq 0.05$.

3. Results

Baseline characteristics of the 667 families (2471 individuals) included in the cross-sectional study are presented in Table 1. Five-year changes in characteristics of the 353 families (1208 individuals) included in the longitudinal study are shown in Table 2.

Parents who did not attend the follow-up examination after five years were significantly younger than responders. In couples who did not respond, fathers had significantly higher mean values for waist-to-hip ratio (WHR), cigarette consumption, fasting glucose, triglycerides, uric acid, haptoglobin, orosomucoid, and activities of ALAT and GGT; mothers had significantly higher weight and BMI. Children of both sexes not attending the second examination were older than those who responded, and consequently had significantly higher weight, BMI, waist circumference (WC), alcohol intake and cigarette consumption. In addition, sons had higher SBP and levels of uric acid and haptoglobin and lower level of apolipoprotein A1 and high-density lipids (HDL)-cholesterol and daughter had higher DBP and GGT activity.

3.1. Factor analysis

At baseline, factor analysis identified five major factors ("risk lipids", "adiposity/blood pressure", "protective lipids", "liver enzymes"

and "inflammation") explaining 39.9%, 22.6%, 15.6%, 12.5%, and 9.4% of variance, respectively (Table 3). The first five largest positive eigenvalues accounted for 100.0% of the common variance. The Scree plot displayed a sharp bend at the sixth eigenvalue, reinforcing the preceding conclusion. The "risk lipids" factor included total cholesterol, apo B, triglycerides and apo E; the "adiposity/blood pressure" factor included WC, BWI, uric acid, and diastolic and systolic blood pressures; the "protective lipids" factor included HDL-cholesterol, and apo A1; the "liver enzymes" factor included ALAT, ASAT and GGT activities and "inflammation" factor hs-CRP, haptoglobin, orosomucoid, and WBC. Fasting glucose did not attain threshold for factor loading (>0.29).

With regard to the 5-year changes in metabolic syndrome-related variables, the factor analysis (Table 3) identified the same precedent five major clusters: "risk lipids", "body mass/blood pressure", "liver enzymes", "inflammation", and "protective lipids" accounting for 36.6%, 21.8%, 17.5%, 13.0% and 10.5% of the total variance in the data set, respectively (99.4% of the common variance). The clusters at entrance and for 5-year changes included the same variables, except

uric acid that was no longer included in the ‘adiposity/blood pressure’ factor in the longitudinal study.

3.2. Genetic heritability and common environmental variance

We used the model that assumed three independent components (polygenic, common (familial) environmental and random non familial) with no differences in parts of component variances according to generation for all clusters and individual traits. Only the estimates of genetic heritability and common environmental variance are shown in Table 4 for baseline and 5-year changes, respectively. At entrance, polygenic variance was statistically significant for total cholesterol, apolipoprotein B, apolipoprotein E, uric acid, fasting glucose, HDL-cholesterol, apolipoprotein A1, ALAT, haptoglobin and three clusters (“risk lipids”, “protective lipids” and “liver enzymes”); values varied from 18.4% to 44.0%. Conversely, for triglycerides, waist circumference, body weight index, systolic and diastolic blood pressure, activities of ALAT and GGT, hs-CRP, orosomucoid, WBC and two clusters (“adiposity/blood pressure” and “inflammation”), polygenic variance was not statistically significant. At entrance, common environmental variances were statistically significant from zero for all individual variables and clusters with a range of 7.8–25.8%. With regard to 5-year changes, polygenic variance was no longer statistically significant for any of the individual variables or factors (Table 4). Common environmental variance was statistically significant for all variables except for triglycerides, hs-CRP, ASAT activity and “liver enzyme” cluster.

4. Discussion

The “STANISLAS Family Study” was planned in order to estimate genetic heritability and common environmental influence for risk factors of complex diseases such as the metabolic syndrome, taking advantage of specific features of this unique sample of French nuclear

families, including parents of middle age and young children in good health. In this paper, with regard to metabolic syndrome-related factors: 1) we added to the literature with our specific data about components of familial aggregation of traditional traits and clusters; 2) we estimated heritability of novel associated traits and clusters (to our knowledge, no data exists for these traits); 3) we estimated components of familial aggregation for short-term changes of these associated traits and clusters. In addition, due to the design of the STANISLAS Family Cohort, subjects of this study were not excluded on the basis of elevated risk factors or drug use. Including such subjects make the results about familial aggregation potentially applicable to general population of the east of France.

4.1. Factor analysis

The factor analysis approach has been used in previous studies of the metabolic syndrome [23–28], including family aggregation [9–12] and has yielded a variety of possible models. We identified five summary factors named as “risk lipids”, “adiposity/blood pressure”, “protective lipids”, “inflammation” including inflammatory markers and “liver enzymes” including three important markers of liver metabolism. Noteworthy, these two last clusters were reported only in the STANISLAS Study. Likewise, when using patterns of changes of these metabolic variables, the same five summary clusters were revealed and confirmed, suggesting a relationship between these variables and their changes over time.

In our population, blood pressure was loaded with BWI and WC, contrary to most previous studies. Our results suggest a strong relationship of adiposity with blood pressure regulation, or the existence of a common causal factor that underlies the different components of the metabolic syndrome. These findings are in agreement with a familial study on metabolic syndrome on supposed healthy individuals [10]. Interrelationships between adiposity and

blood pressure could be different in healthy individuals as compared to patients with insulin resistance or diabetes. In contrast, we did not find the common cluster named "glucose/insulin resistance" [9,10,25–28]; this is probably due to lack of biological parameters related to glucose metabolism such as fasting insulin, as well as to the healthy state of our sample of population.

4.2. Heritability

In order to compare our data, we collected the main worldwide results from twin and family studies (nuclear or of complex pedigree) where genetic and common environmental variances were estimated (see online [Supplementary material](#)). Values of genetic heritability in this table are not absolute measurements, but rather reflect the amount of genotypic variation as compared to environmental variation. The estimates are specific to a given population and are generally larger when the genetic background is more diverse (increasing of the genetic variance) or when environmental effects are minimized (decreasing of the environmental variance). Consequently, heritability for the same trait may vary quite widely across populations where the relative importance of these components is very different [20]. Comparison of data of the literature should take into account important criteria such as: design (twins, nuclear families or more complex pedigrees), origin and characteristics of the population (age, sex, lifestyle, genetic background, genetic isolate, with or without risk factors, acute or chronic diseases), number and type of traits studied, adjustment for covariates, method used to estimate heritability (path analysis or analysis of variance). As an example, the online table (see [Supplementary material](#)) shows that genetic heritabilities from twin studies are higher than those estimated from nuclear family studies or complex pedigrees.

With regard to genetic heritability our results are high (20 to 44%) and close to the estimates or within the ranges described by other family studies for plasma lipids and lipoproteins (total cholesterol, apo B, apo E, apo A1, HDL-cholesterol), uric acid and fasting glucose. Conversely, genetic heritability for triglycerides, adiposity indices (waist circumference and body weight index), blood pressure (both diastolic and systolic), hepatic enzyme activity (ALAT, ASAT, GGT) and inflammatory markers (hs-CRP, orosomucoid and white blood cells) is low (less than 19%), smaller than published data and often not statistically significant. Genetic heritability of haptoglobin level represents about a third of global variance and seems to be an exception. However, in spite of no data exists about familial resemblance of this protein, haptoglobin has been described as polymorphic with three major phenotypes that are associated with differences in serum concentrations [29].

Estimates of genetic heritability at entrance for the five clusters are consistent with those of the related individual trait: high for "risk lipids" and "protective lipids" (40% and 35%, respectively), intermediate for "liver enzymes" (18%) and low for "adiposity/blood pressure" and "inflammation" (about 7%). However, triglycerides and uric acid appear as exceptions, probably due to low factor loadings with their respective clusters. Discordance between heritability estimates of "inflammation" cluster and haptoglobin remains unexplained. Higher genetic heritability for "risk lipids", "protective lipids" and related individual traits is consistent with the success to date in identifying genetic polymorphism associated with raised cholesterol, apo- and lipoproteins in general population [30]. On the contrary, small genetic components for "adiposity/blood pressure" and "inflammation factors" could reflect the difficulties to identify genomic regions involved in the regulation of these related factors in the general population (for instance, for body weight and obesity, [31]). Generally, the genetic component is lower and environmental influence is higher in nuclear families including young parents and children than those including older subjects [32,33].

When comparing common environmental influence with previous studies (see online [Supplementary material](#)), our estimates are often

higher or close to the upper range and more than 14% for triglycerides, waist circumference, body mass index, adiposity/blood pressure cluster, glucose, HDL-cholesterol, protective lipid cluster and apo A1; risk factors that are generally influenced by long-term lifestyle interventions [34]. Common environmental influence observed in our study for orosomucoid, white blood cells count and the related cluster could be due to familial aggregation of various benign infections. Unfortunately, for numerous factors, no data exists about common environmental influence for comparison with our results.

With regard to 5-year changes, polygenic variance was low and not statistically significant for any of the individual variables or factors whereas shared environment influence was significant for most factors and clusters except for triglycerides, hs-CRP, ASAT and related cluster. Our findings highlight the impact of the common familial environment and lifestyle in the short-term change of metabolic syndrome components. While genetic factors have only an effect at baseline, only environmental factors seem to influence substantially changes of metabolic syndrome-related variables over short time. Data about change of these factors are very scarce and hard to compare with ours. For instance, a recent family study showed that changes in BMI over 8–10 year period appear to be genetically influenced (heritability of 36%), while heritability estimates for changes in waist was lower (21%) [35]. Similarly, a 12-year follow-up in the Quebec Family Study suggested that 36% of the phenotypic variability of BMI was transmissible [36]. Discrepancies with our data could be due to difference in methodology: the first study used complex pedigree (80 families and 379 subjects) with about 73% of subject aged 45 years and more [35]; in the second study, only global heritability due to both genetic factors and the shared common familial environment was estimated [36].

4.3. Strengths and limitations

The major strengths of our present study were that the participants were young (including children and adolescents), stemmed from nuclear families (without complex pedigrees), at low-risk of cardiovascular diseases, drawn from the general population of the east of France without genetic isolation phenomenon. No study about familial aggregation of MS factors was ever done in this area. Moreover, both cross-sectional and short-term longitudinal approaches were studied and both individual traits and clusters were analyzed. For these reasons, our data specific of young, healthy and unselected French families are unique.

Several limitations of our study have also to be addressed. First, estimates of genetic heritability didn't take into account major gene effects that are largely or entirely nonadditive, gene–gene interactions (epistasis) and gene–environment interactions. Second, as in our study in samples of nuclear families, consisting of parents and offspring, the genetic and familial environmental effects could be resolvable with difficulties because these relatives share both genes and environments. Third, various factors could affect the estimation and interpretability of heritabilities, for example, assumptions regarding linearity and additivity, assortative mating, and the underlying distribution of the data (non Gaussian distribution of the data can lead to errors in hypothesis testing) [20]. Nevertheless, the software FISHER performed goodness-of-fit test of the underlying multinormal distribution. Lastly, genetic heritability estimates from clusters could be under or overestimate due to individual traits included in there computation (for instance triglycerides).

In conclusion, in these young families from the east of France, estimates of genetic heritability at entrance were generally lower than previously reported while the common environmental influences were greater. Only common environmental factors are related to short-term changes. Our data highlight the importance of lifestyle, at least for short-time periods, on the evolution of the metabolic syndrome-related traits.

Les antécédents familiaux des pathologies cardiovasculaires sont des facteurs de risque connus des maladies cardiovasculaires. Le but de notre étude était donc d'évaluer l'influence des niveaux de risque parentaux sur le niveau de ces mêmes facteurs de risque chez leurs enfants dans une cohorte familiale d'origine Française : la cohorte STANISLAS dans laquelle des familles biparentales avec au moins deux enfants biologique avaient été suivies pendant cinq ans à l'occasion de deux examens de santé. Les facteurs de risque des enfants (pression artérielle, traits lipidiques, glycémie, indice de masse corporelle et tour de taille), étaient comparés en fonction du niveau de risque des parents dans 693 familles. À l'exception de la glycémie, tous ces traits, bien qu'infracliniques, étaient plus élevés dans les familles ayant les deux parents à risque pour le trait considéré à t_0 et à t_5 .

Ainsi, il serait opportun d'envisager des stratégies préventives familiales pour mieux repérer les enfants à risque cardiovasculaire et ainsi mener des interventions précoces.

Parental precocious influences on offspring cardiovascular risk markers: an exploratory study in the STANISLAS Cohort

Familial history of cardiovascular disease is acknowledged as a risk indicator in offspring. The aim of this study was to assess whether the cardiovascular risk factors in parents predicted the risk of their children developing cardiovascular disease in a French population: the STANISLAS Cohort, in which Caucasian biparental families with at least two siblings were followed for 5 years. Silent risk factors (blood pressure, lipid traits, glycemia, BMI and waist circumference) of children were compared according to their parents' risk status in a subsample of 693 families. All of these traits, with the exception of glucose, were significantly higher in children who had parents at a high risk than in children with parents at a low risk at the first health examination, and these results were confirmed again 5 years later at the second health examination. Thus, silent cardio-metabolic risk factors can be screened in children according to the risk status of their parents for early prevention. The influence of parents' variants on their offspring underlined the need to initiate familial prevention strategies, with a particular follow-up of young individuals between childhood and adolescence.

Cardiovascular disorders are still the major cause of mortality and morbidity in Western countries, and the installation of its risk factors begin during childhood [1]. Moreover, familial influence in cardiovascular diseases can begin early, even in healthy families, and target-organ damage may occur in children with elevated risk factors [2]. This highlights the importance of studying both genetic and environmental factors in order to improve primary prevention strategies focused on young populations at high risk. Indeed, it seems important to identify silent cardio-metabolic risk factors in childhood.

In this study, we examined whether cardiovascular risk factors in parents predicted the risk of their children developing cardiovascular disease.

Methods

■ Study design

The STANISLAS Family Study consists of 1006 biparental families with at least two siblings over the age of 4 years. They were recruited between 1993 and 1995 at the Centre of Preventive Medicine of Vandoeuvre-lès-Nancy (eastern France) and underwent health examinations every 5 years [3]. Individuals suffering from acute or chronic disorders or with a previous personal history of cardiovascular disease were excluded. All participants gave their written informed consent and the study was approved by local ethics committees. This cohort was

designed to assess, in a healthy population, the role of genetics and environmental factors in the variability of cardiovascular risk factors.

Initially, we performed a preliminary unpublished study including the adults and adolescents of the STANISLAS Cohort using the Framingham prediction equation for coronary disease at 10 years [4]. However, since the Framingham equation was developed with an American population, it overestimates risk assessment in European populations [5]; in particular, the influence of age was too strong in the model, making the classification of individuals biased. Therefore, we chose to study the following cardiovascular risk factors in children: systolic and diastolic blood pressure (SBP; DBP), total cholesterol (TC), low-density lipoprotein cholesterol (LDL-C), high-density lipoprotein cholesterol (HDL-C), triglycerides (TG), glucose, BMI and waist circumference (WC) according to their parental risk status. Thus, the metabolic pathways highlighted in this study will allow the future integration of genetic and nongenetic information into medical decisions [6].

■ Study population

The current study includes cross-sectional and longitudinal analyses of data collected between 1993–1995 and 1999–2000 (corresponding to two health examinations) on

2580 individuals belonging to 693 biparental families (693 fathers and mothers, 585 sons and 609 daughters).

■ Data collection

Blood pressure was measured under standardized conditions (supine position) with a sphygmomanometer. Three readings were taken and the mean value was used for analysis.

Blood samples were collected between 8:00 and 9:00 am or 11:30 am and 12:30 pm by venipuncture after overnight fasting. TC, HDL-C, TG and glucose were assayed using enzymatic methods (AU640 [Olympus, Watford, UK]) and LDL-C was calculated using the Friedewald formula.

Weight and height were measured while the participants were standing in light clothing without shoes. BMI was calculated as weight in kg divided by height in m^2 , and the WC was measured at the level of the umbilicus.

■ Parental risk status definition

In the first step, parents at risk were determined according to thresholds defined by international guidelines and recommendations:

- SBP greater than 130 mmHg for pre-hypertension and above 140 mmHg for hypertension [7];
- DBP greater than 85 mmHg for pre-hypertension and above 90 mmHg for hypertension [7];
- TC of 6 mmol/l or more [8];
- LDL-C of 5.16 mmol/l or more [10];
- HDL-C of 1 mmol/l or less [10];
- TG of 2 mmol/l or more [10];
- Glucose greater than 6.2 mmol/l [9];
- BMI of 25 kg/m^2 or more;
- WC greater than 80 cm for fathers and 94 cm for mothers [10].

■ Child risk status

Children's blood pressure, lipid traits, glycemia, BMI and WC were analyzed in a second step according to their parent's risk status. Three groups of children were studied:

- Children with neither parent at risk – groups 0;
- Children with only one parent (father or mother) at risk – groups 1;
- Children with both parents at risk – groups 2.

■ Statistical analyses

Risk factors among children and parents were described by the mean \pm standard deviation.

Differences between groups were tested at the first health examination (t0) and 5 years later at the second health examination (t5) using the Student's t-test, and analysis of variance adjusted results for sex and age, taking into account possible interactions between sexes and groups. Variation between the two health examinations was also assessed among groups. Continuous variables were log-transformed to approach normality and the Levene test established the homogeneity of variance between groups. The SPSS® statistical software version 16.0 (SPSS Inc., IL, USA) was used and the level of significance (p-value) was 0.01.

Results

Phenotypic characteristics of the population studied at t0 and t5 and longitudinal variations are summarized in TABLE 1 (mean values \pm standard deviation of all variables assessed by family members). The mean age of fathers was 42.85 years, mothers 40.75 years, sons 13.35 years and daughters 13.58 years of age at t0. Fathers compared with mothers had significantly higher levels for all measurements with the exception of HDL-C. Among children, SBP, pulse pressure, mean blood pressure, TC, LDL-C, TG, glucose and WC were significantly higher in male versus female siblings at t0. A total of 5 years later, HDL-C became significantly lower in daughters and TG stabilized among genders.

■ Comparisons between children's groups

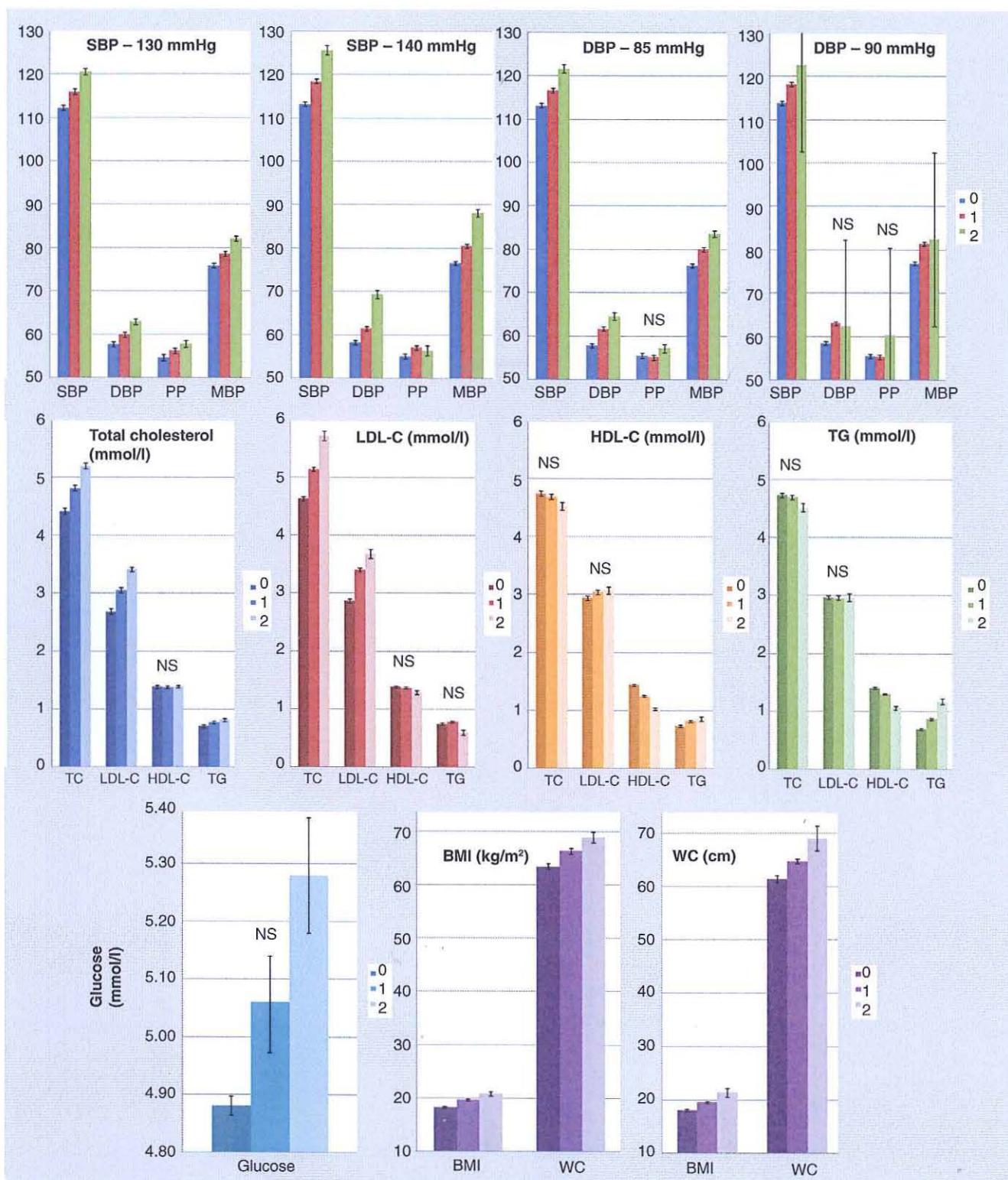


Figure 1. Investigation of 11 parental clinical parameters between children groups (0, 1 and 2) at t0. Comparisons between the three groups were all significant with $p \leq 0.001$, unless reported on the histograms as NS. Mean values in each group with 95% CI are represented.

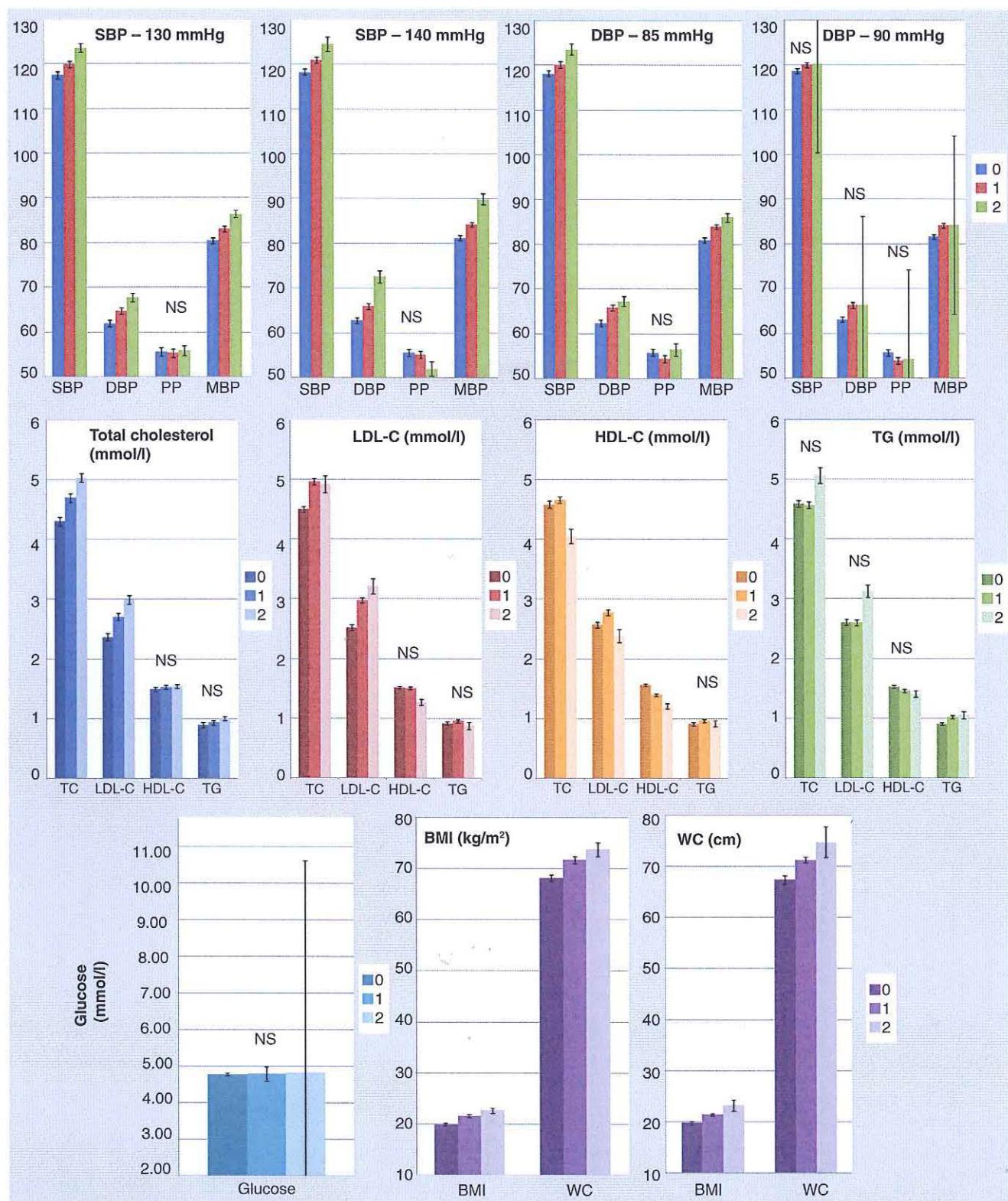


Figure 2. Investigation of 11 parental clinical parameters between children groups (0, 1 and 2) at t5. Comparisons between the three groups were all significant with $p \leq 0.001$, unless reported on the histograms as NS. Mean values in each group with 95% CI are represented.

Children's parameters significantly differed between groups ($p < 0.001$) at t0 and t5, except for DBP (hypertension threshold) and glucose (TABLE 2). Lower values for all parameters were observed in groups 0 and higher values in groups 2, except for HDL-C (FIGURES 1 & 2). No interactions between gender and groups were observed. Differences in blood pressure within groups were influenced by age and gender for SBP at t0 and t5. The gender effect was significant for TC and HDL-C at t5 and the age effect became apparent at the second examination for TC and LDL-C, but not for HDL-C. TG levels were modulated by age but not by gender. The age effect was also significant in BMI and WC, although gender modulated this last variable only. Longitudinal variations differed among groups for SBP and TG.

Discussion

It is now well established that cardiovascular disorders have roots in childhood [2], with both genetic and environmental components.

Thus, prevention efforts should begin precociously with the early detection of silent cardiovascular risk factors. In this respect, our results demonstrated associations between cardiovascular risk factors in children and their parental risk status in a healthy French population. These relationships were maintained through time and concerned almost all the cardiovascular risk markers studied: blood pressure, lipid traits, BMI and WC. This enables us to confirm that the different metabolic pathways implicated in the genesis of cardiovascular pathophysiology take asset early on through the combination of parental genetics and a shared environment, even in families without any personal history of cardiovascular disease.

The effect of gender on physiological traits related to the genesis of cardiovascular disorders was also confirmed, with a higher risk in male than in female adults [11]. Indeed, males and females represented two different targets for prevention strategies.

Differences between groups observed for blood pressure were in the same range as results generally obtained by prevention strategies using antihypertensive therapy [8]. Obviously, genetic variations also determine our phenotypic observations, since some evidence suggests that genetic contribution to blood pressure is approximately 30–50% [12].

The evolution of lipid traits over 5 years suggests that those traits are dependant on hormonal differences between sons and daughters [13]. We observed that the gender effect became significant for TC and LDL-C.

Since BMI and WC traits are strongly influenced by lifestyle, results on BMI and WC may blur the boundaries between genetics and environmental factors. However, the *FTO* polymorphism, previously associated with early-onset and morbid adult obesity [14,15], was recently linked to the interindividual variation of BMI within a subgroup of 391 adults aged 30–54 years and 430 children and adolescents aged 5–20 years extracted from the STANISLAS Cohort [102]. Other studies have also been conducted on this subject: the Quebec Family Study demonstrated that genes influenced the propensity to store fat in the abdominal area [16], and the cardiovascular component of the European Prospective Investigation into Cancer and Nutrition [17],

which is in progress and includes ten European countries, attempts to assess coronary mortality using several prominent dietary hypotheses.

It is also important to note that the validity of BMI, reflecting composite phenotype, varies across the life curve according to gender as a relevant cardiovascular risk marker. Some recent evidence suggests that adiposity is a better indicator of at-risk obesity [18]. Moreover, this trait should be closely monitored since BMI changes dynamically during childhood and adolescence [19].

Conclusion

Current prevention strategies are primarily based on adult populations and there is a relative consensus that individuals should be targeted at 20, 50 and 70 years of age [20,21]. Indeed, international guidelines did not address prevention in children, whereas pathological studies have demonstrated that both the presence and extent of atherosclerotic lesions at autopsy after the unexpected death of children and young adults correlate positively and significantly with LDL-C, TG, SBP, DBP and BMI [22,23]. The Bogalusa Heart Study underlined the familial nature of the insulin resistance syndrome [24] and the early natural history of Type 2 diabetes [25].

Since the cardiovascular disorder process begins in childhood and adolescence, early prevention in childhood is critically important. Thus, prevention strategies should be focused

on 'at risk' families and interventions should be undertaken in young individuals, a group for whom primary prevention should hold the most promise [26].

A recent study performed on 2720 German child-parent pairs affirmed that risk screening in children may serve for early prevention in high-risk families by targeting young parents [27]. On the contrary, our methodology supposes that children requiring early-risk screening should be targeted before any clinical manifestations of cardiovascular risk factors according to their parents' parameters.

Future perspective

With regard to public health practice, screening silent risk factors using the familial environment could be a cost-effective method of identifying children and adolescents needing intensive and early preventive care in the ambition to reduce the future burden of adult cardiovascular disease.

Executive summary

- » The persistent progression of cardiovascular disease morbidity and mortality in developing countries, in spite of the general effort in prevention, implies a better focalization is required in different target populations.
- » Cardiovascular disease processes begin early in childhood through a synergy of genetic factors and environmental exposure, all depending on the parents' risk status.
- » Parental variations of most cardiovascular risk markers (blood pressure, lipids and corpulence) influence their children's cardiovascular disease risk.
- » Silent risk factors in children should be screened according to their parental risk status in order to initiate early prevention strategies.

Une étude d'association pangénomique initialement effectuées sur 631 enfants non apparentés issus de la cohorte STANISLAS et suivie par une réPLICATION chez trois cohortes Européennes a permis d'identifier le SNP rs2000999 dans le gène *Haptoglobin Related Protein* expliquant une grande part de l'héritabilité génétique de l'haptoglobine ($P_{\text{méta-analyse}}=8.1\times10^{-59}$, 42 % de l'héritabilité génétique).

Ce même variant a récemment été associé chez l'adulte au cholestérol total et au LDL-C dans de larges GWAS. Nous avons répliqué ces résultats chez 8 946 enfants Européens et ainsi mis en évidence un lien putatif entre inflammation et ces facteurs de risque cardiovasculaire connus.

Contribution :

Cette étude pangénomique porte sur l'haptoglobine dont l'investigation a été initiée par l'EA4373. Nous avons effectué les analyses au sein de la 'discovery cohort' STANISLAS et sélectionné les variants génétiques à répliquer par SNPlex. Nous avons également effectué les analyses au sein des populations de réPLICATION en double aveugle avec un collaborateur statisticien de Lille. Deux méthodologies distinctes et deux logiciels différents avaient été utilisés pour ce faire. La méta-analyse a été effectuée à Lille et nous avons réalisé les régressions conditionnées nous permettant de déterminer l'indépendance des variants génétiques retenus.

Nous avons également construit les tables et rédigé la première version du manuscrit et les ‘supplementary data’.

Notez que l’haptoglobine est un trait rare qu’il a donc fallu doser dans les populations de réPLICATION sélectionnées. Nous avons participé à la préparation des échantillons à doser ainsi que de ceux à génotyper à Lille.

Abstract

A GWAS initially conducted in 631 French children followed by replication in three European pediatric samples, identified rs2000999 in the *Haptoglobin Related Protein* gene as a strong genetic determinant of Haptoglobin levels ($P_{\text{overall}}=8.1\times10^{-59}$, 42 % of its genetic variability). Recent GWAS meta-analyses have concluded that rs2000999 associates with cholesterol levels in adults, a finding we replicated in 8,946 European children. This study provides a putative biological link between inflammation and cardio-vascular risk factors.

Human haptoglobin (Hp) is an acute inflammatory protein, essentially synthesized by the liver, which is up-regulated by cytokines as the other acute phase proteins¹. Hp binds hemoglobin (Hb) released from the erythrocytes². Hp-Hb complexes are further eliminated from the circulation, mainly by the liver Kupffer's cells, preventing the generation of oxygen reactive species². Hp plasma levels can increase up to 200% during the ten days following acute inflammation onset¹.

In a prospective study (11.8 years follow-up), Holme et al³ demonstrated that Hp is a significant risk factor of acute myocardial infarction, stroke and heart failure in 342,125 individuals from the Apolipoprotein Mortality RISk study (AMORIS). Very recently, the same authors⁴ stressed the importance of a combination of commonly available inflammatory markers, Hp included, as predictors of major cardio-vascular events in a subset of 65,050 individuals, suggesting that these routinely assessed inflammation markers should be incorporated in daily medical practice to evaluate cardio-vascular risk.

Hp is composed of two pairs of an α and a β chains. A duplication of 1.7 kb in the Hp gene modifies Hp α -chain polypeptides causing three common gel migration protein profiles: Hp1-1, Hp2-2 and Hp2-1⁵. Several studies have shown that diabetic individuals with the Hp2-2 phenotype were at four to five times greater risk of cardio-vascular events⁶ and prone to carotid atherosclerosis⁷. The Hp2-2 phenotype was associated with reduced clearance of macrophage-Hp-Hb complex, favoring iron deposition, oxidative stress, and active macrophage accumulation in the atherosclerotic plaque⁸. A role for this Hp polymorphism was also proposed in the development of many other human diseases such as malaria, tuberculosis and HIV⁹.

We conducted a genome-wide association study (GWAS) in 631 children of the STANISLAS Family Study (SFS) cohort of French European origin, to identify DNA variations contributing to the inter-individual variability of Hp levels and to assess their putative associations with cardio-vascular risk factors. The GWAS strongest signal was located in a 218-kb linkage disequilibrium (LD) block on chromosome 16 that includes both the *Haptoglobin* (*Hp*) and the *Haptoglobin Related Protein* (*HPR*) genes. *HPR* shares more than 90% of nucleotide-sequence homology with *HP* and forms a 30-kb cluster with this latter gene on chromosome 16q22.3¹⁰.

With the squared root transformed haptoglobin measurement adjusted for gender, age and lnBMI, under the additive model, we identified in this region two genome-wide significant association signals distant of 90-kb: rs2000999 ($\beta=0.123$ with G as effect allele; $P=6.32\times 10^{-13}$) and rs10492825 ($\beta=0.0876$ with A as effect allele; $P=5.50\times 10^{-08}$) (Table 1). rs2000999 and rs10492825 polymorphisms display a moderate LD ($r^2=0.48$, HapMap CEU release 27). In order to assess the redundancy between these two signals, we run conditional regression analyses for both SNPs adjusted for each other and

found that rs2000999 is driving alone the association observed on the *HP/HPR* locus (rs2000999 $P_{\text{adjusted by rs10492825}}=1.9\times10^{-7}$, rs10492825 $P_{\text{adjust by 2000999}}=0.91$).

We further replicated the association between rs2000999 and Hp levels in three additional European cohorts including 2 pediatric cohorts: the GENDAI study from Greece and a subset of obese children from East of France ($N_{\text{tot}}=1,435$); and a familial subset ($N_{\text{tot}}=3,167$) of the SFS ($P_{\text{replication}}=3.5\times10^{-41}$, $P_{\text{overall}}=8.09\times10^{-59}$, Table 1). We estimated that adjusted squared root transformed Hp levels increase by 0.09 g/L per rs2000999 allele A in average.

We determined that 24.9% of the Hp variance components was under polygenic control in 656 nuclear families (2,680 individuals) from the STANISLAS cohort and that rs2000999 is the major genetic determinant of Hp levels explaining alone 10.5% of its global variance and thus controlling 42% of the polygenic variability of this trait (Supplementary Table 2).

SNP rs2000999 is located in the third intron of the *HPR* gene, 2.2 kb downstream of the *HP* gene. It is in the vicinity of the well known and frequent Hp1 polymorphism, causing three protein gel migration profiles (Hp1-1, Hp1-2 and Hp2-2). This polymorphism generates a short (Hp1:83 amino acids) and a long (Hp2:142 amino acids) α chain. Hp2 is caused by a duplication of 59 α chain amino acid residues resulting to an intragenic duplication of 1.7 kb⁵. To assess the degree of independency of rs2000999 from the Hp1 polymorphism, we genotyped this latter in a subset of 341 children from the GWAS first stage children sample. We found no evidence for high LD neither between Hp1 and rs2000999 ($r^2=0.135$) nor with the other SNPs that were genotyped by the Illumina array within the 218 kb LD block that includes both Hp1 and rs2000999 ($0.001 < r^2 < 0.137$; $N=31$ SNPs). In this subsample, we found that Hp1 polymorphism (MAF=0.46) and rs2000999 (MAF=0.20) are highly associated with Hp levels, as expected ($P=4\times10^{-7}$ and $P=1\times10^{-7}$ respectively). When both variants were included in the same regression model, we found that both variants are significantly and independently contributing to the association ($P_{\text{HP1}}=0.001$ and $P_{\text{rs2000999}}=5\times10^{-5}$). These data indicate that the association of rs2000999 we identified here is novel and not redundant with the well known Hp1 polymorphism.

In addition to Hp1, the homozygosity for a very rare deletion in Caucasians (~0.1%)¹¹ of more than 20 kb in this region causes the Hp0 anhaptoglobinemia phenotype with complete absence of serum Hp⁵. Importantly, rs2000999 is located in the region of the *HPR* covered by this deletion which suggests that the DNA sequence around this SNP is critical for Hp levels.

SNP rs2000999 has been recently reported to associate with total cholesterol in 4,200 adults from the EUROSPAN consortium¹² and to total cholesterol and LDL-cholesterol in more than 100,000 adults of European and non-European ancestry¹³, with a p-value that reaches genome-wide significant levels ($P=3\times10^{-24}$). This study did not assess the effect of rs2000999 in pediatric cohorts but

prompted us to do so in five independent pediatric cohorts gathering 8,946 European children. Total cholesterol was ln-transformed and we normalized the LDL cholesterol by computing the square root. Both measurements were adjusted for gender, age and ln-BMI and we tested the association under an additive model. Our data showed that rs2000999 was associated with total cholesterol. ($P_{\text{total cholesterol}}=0.002$, Table 2) and LDL cholesterol ($p=0.0008$, Table2).

Consistent and compelling evidence has already demonstrated the association between raised plasma levels of inflammatory markers with incidence of cardiovascular diseases, impaired cardiac function and worse prognosis. Among these inflammatory markers Hp has already been consistently linked to cardiovascular diseases and very recently it was demonstrated to give additive predictive information for risk of major cardiovascular events⁴. SNP rs2000999 is located on the *HP/HPR* cluster and influences lipid levels. This SNP thus represents a major biomarker linking inflammation via Hp and cardio-vascular risk. In the light of our findings, we hypothesize that rs2000999 effect on LDL and total cholesterol may be mediated by the regulatory function of *HPR* on circulating Hp levels. Hp binds apolipoprotein A-I¹⁴ and protects the Apo A-I effector domain for lecithin-cholesterol acyltransferase against oxidative stress, and consequently, impairs the high-density lipoprotein function. Hp also binds the Apo E and influences cholesterol esterification¹⁵. These structural characteristics confer to Hp a possible role in the reverse transport of cholesterol between peripheral cells and the liver for degradation which, with endothelial repair by progenitor cells and plaque neovascularization, is a preservation system of vessel wall integrity.

In summary, we identified rs2000999 as a strong contributor to Hp genetic heritability (explaining 42% of the global genetic heritability of Hp). We also demonstrated in childhood its role in the modulation of lipid levels, extending adults data. This study provides therefore a putative biomarker linking inflammation to major cardio-vascular risk factors. In clinical practice, rs2000999 genotyping could be used to correct Hp values for assessment of risk in different pathologies in which Hp is implicated, especially at younger age for early identification of individuals at cardio-vascular risk.

Study populations

The STANISLAS Family Study (SFS)

The SFS is a 10-year longitudinal survey involving, since 1993-1995, 1,006 volunteer families of European ancestry whose members were free of chronic disease (cardio-vascular or cancer)¹. The SFS samples and data are part of the Biological Resources Bank (BRC) “Interactions Gène-Environnement en Physiopathologie CardioVasculaire” (IGE-PCV) in Nancy, France. Genome-wide genotyping was performed on a subset of 685 unrelated lean children constituting the discovery cohort as described previously². The 3,145 remaining individuals after quality control (1,937 adults and 1,208 children) were involved in the replication studies. Hp levels, BMI and cardio-vascular risk traits were available for all participants.

Obese Children

We studied obese children (defined as BMI > 97th percentile for age and sex according to a French cohort ³) ascertained from 449 nuclear families with at least one obese offspring, recruited in the Paediatric Endocrine Unit of Jeanne de Flandres Hospital, Lille or through national media campaign. We analyzed 922 children with Hp, BMI and cardio-vascular risk related traits available.

The GeNe and Diet Attica Investigation (GENDAI)

The GENDAI pediatric cohort comprised children living in the Attica region of Greece ⁴. From November 2005 to June 2006, 1,138 peri-adolescent children (53% girls; mean age: 11.2±0.7 years) were recruited from randomly selected elementary schools of Attica. This research study was approved by the Institutional Review Board of Harokopio University, the Greek Ministry of Education and the Ethics Committee of Harokopio University. We analyzed 401 children with Hp, BMI and cardio-vascular risk related traits available.

The Northern Finland 1986 Birth Cohort (NFBC86)

The NFBC86 is a prospective birth cohort including all Finnish mothers of European ancestry with children whose expected date of birth fell between July 1, 1985 and June 30, 1986 in the two northernmost provinces in Finland ⁵. Clinical examination at 15–16 years follow-up was conducted between August 2001 and June 2002. All cohort members living in Finland with known address (n=9,215) were invited, and 6,798 participated (74%). We analyzed 5,285 adolescents successfully genotyped in the NFBC86 cohort with BMI and cardio-vascular risk related traits available.

The Verona cohort

Verona cohort are Italian children (43% girls; mean age: 10.75 ± 1.22 years) recruited from the general population of Verona, Italy, whose families were randomly extracted from the registry office database of the town, and contacted by post. We analysed 401 children successfully genotyped with at least BMI total and LDL-cholesterol available.

All the populations involved were recruited in accordance with the latest version of the Declaration of Helsinki. All participants and their parents gave a written informed consent. The study protocols were approved by the local ethics committees for the protection of subjects for biomedical research.

Genotyping

Genome-wide genotypes were generated in the 685 STANISLAS children using the Illumina Human CNV370-Duo array as described previously². Briefly; we used 750 ng of genomic DNA following Illumina's protocol and BeadStation genotyping solutions (Illumina), based on the GenCall software application (Illumina) to automatically cluster, call genotypes, and assign confidence scores using the GenTrain clustering algorithm (Illumina). We discarded 2,552 SNPs that had extreme Hardy-Weinberg HW disequilibrium ($P < 0.001$), low genotyping calling rates (<95%) or low minor-allele frequencies (<1%). We retained 318,237 SNPs for analysis. Genomic control λ_{GC} was 1.01.

We used the Applied Biosystems SNPlex™ technology to replicate the association of rs200099 in the SFS replication set, obese children, GENDAI, NFBC1986 and Verona cohort DNAs.

SNPlex is based on the Oligonucleotide Ligation Assay (OLA) combined with multiplex PCR target amplification (<http://www.appliedbiosystems.com>). Allelic discrimination was performed by capillary electrophoresis analysis using an Applied Biosystems 3730xl DNA Analyzer and GeneMapper 3.7 software. Genotyping call rate was above 95% in all populations studied and rs2000999 was in HW equilibrium ($p>0.001$).

We used the previously reported PCR based method⁶ to genotype Hp1 polymorphism in a sub-sample of the 685 children (N=341) to allow LD assessment between Hp1 and common variants at the *HP/HPR* locus. Only genotypes that were concordant following a double blind genotyping call by two independent readers were retained for statistical analyses.

Haptoglobin dosage

Hp was measured by high sensitivity immunophotometry analyses with BN™II Siemens analyzer and Siemens reagents. Levels in children were low (0.65 g/L \pm 0.39 in the SFS unrelated children) in accordance with reference distribution for Hp reporting significant fall of its levels during the first decade of life⁷.

Statistical analyses

Heritability estimate of Hp levels in the SFS

The relative contribution of genetic (G) and environmental (E) factors to the inter-individual variability of Hp (P) was assessed on a subsample of 656 nuclear families (2,680 individuals) ascertained from the SFS. This contribution is expressed, under a pure polygenic model, in terms of variance components: $\sigma^2P = \sigma^2G + \sigma^2E$. This yields to the determination of the genetic heritability of Hp defined as the proportion of the total phenotype variance due to additive polygenic effects ($h^2G = \sigma^2G / \sigma^2P$). The environmental component is decomposed into common familial (household sharing, C) and random non familial (individual-specific factors, R) environmental effects (i.e., $\sigma^2P = \sigma^2G + \sigma^2C + \sigma^2R$). Thus, the environmental heritability of Hp is defined as $c^2=\sigma^2C / \sigma^2P$. The analysis was conducted using a multivariate normal model for pedigree analysis^{8,9} with the FISHER software and the variance components were assumed to be normally distributed with mean equal to 0 and variance equal to σ^2G , σ^2C , and σ^2R respectively. Heritability estimate was assessed unadjusted, then adjusted for age and gender. The contribution of rs2000999 and Hp1-1 polymorphism to the genetic heritability of Hp levels were assessed using the same methodology aforementioned.

The Hp polygenic variance represented 24.9% ($P < 0.001$) of total variance. Shared (within families) and random environmental variances were 13 and 62.1% respectively (supplementary table 1).

Genome-wide association and replication analyses

We carried out genome-wide association (GWA) (Hp levels) and replication for rs2000999 (Hp and all metabolic quantitative traits) analyses using linear regression models under the additive genetic model with one degree of freedom, with adjustment for age, gender and BMI using PLINK¹⁰. The summary statistics were combined in the meta-analyses using the inverse normal method with equal weight for each population. In this method, P values of each study are transformed into their inverse normal z score and the weighted sum, over all studies, is compared to a normal $N(0,1)$, provided the sum of squared weights equals 1. The estimates of variants effect on Hp and their standard errors for each separate analysis were combined in the meta-analysis using the weighted inverse normal method, and the overall effect and its confidence interval were estimated using the inverse variance method implemented in ‘meta.summaries’ function of R RMETA package. No major heterogeneity in effects was observed ($P < 0.02$). We used mixed model to analyse the association of genetic variants with Hp levels and metabolic traits in related individuals in the SFS and the obese children.

Softwares

For general statistical analysis, we used SPSS 14.0, R statistical environment version 2.11.1 or PLINK1.07. To draw the LD map, we used Haploview software.

Les associations entre profils génétiques et données biologiques ou cliniques ne sont pas clairement établies, surtout en ce qui concerne les sujets supposés sains. Nous avons ainsi utilisé une analyse multivariée de 24 polymorphismes associés aux principales voies métaboliques des pathologies cardiovasculaires au sein de 1 551 sujets sains issus de la cohorte STANISLAS pour déterminer des profils génétiques à t_0 et t_5 .

Nous avons identifié six clusters génétiques permettant une assignation correcte de 99,6% des sujets dont un cluster impliquant le gène *SELE* qui pourrait avoir un rôle protecteur et le gène *APOC3* associé à une augmentation du risque cardiovasculaire.

Genetic profiling in healthy subjects from the Stanislas cohort based on 24 polymorphisms: effects on biological variables

Abstract

Background: The association of genetic profiles with biological or clinical assessments is not clearly established especially among apparently healthy subjects.

Methods: A multivariate statistical analysis was performed on 24 polymorphisms related to the main metabolic pathways involved in cardiovascular diseases (CVDs). They were collected among 1551 healthy subjects of the Stanislas cohort to obtain genetic profiles. Association with biological variables was then studied at baseline (t_0) and 5 years later (t_5). **Results:** Six genetic clusters were identified with relevant profiles and five polymorphisms from the selectin, apolipoprotein C3 and lipoprotein lipase genes (*SELE*-98G/T, *APOC3*-3175C/G, *APOC3*-482C/T, *APOC3*-1100C/T, *LPL*-93T/G) were sufficiently characteristic to associate 99.6% of the subjects with their corresponding cluster. A 5-year follow-up showed that clinical and biological measurements in relation to CVD risk factors already differ with triglyceride ($p=0.009$ for t_0 and $p=0.005$ for t_5) and high-density lipoprotein cholesterol ($p=0.014$ for t_0 and $p=0.003$ for t_5) for these previous genetic clusters.

Conclusions: This study presents the hypothesis that *SELE* could be protective, whereas *APOC3* could be associated with risk. It remains to be seen whether these polymorphisms will be predictive of CVD events among the selected clusters of different metabolic subtypes after a 10-year follow-up.

Introduction

For many years, we have investigated gene-environment interactions in healthy subjects, searching for

relevant genetic markers for cardiovascular risk prediction (1–3). A large number of single nucleotide polymorphisms, primarily based on case control studies, are identified in the literature, and this list must be updated regularly (4–6). Thanks to the Human Genome Project (7) and the International HapMap Consortium, comprehensive websites provide a wealth of readily accessible sequence and polymorphism data. Proteomics investigators are employing a similar approach. The simultaneous development of systems biology (8) and the accompanying systems literature analysis (9) has opened up a new era that is critical to the success of preventive medicine (10). Above all, cardiovascular diseases (CVDs) are especially complex, with multifactorial determinants in occurrence and aetiology. Factors may or may not correlate, and there is still no clear understanding of the role of genetic polymorphisms as a basis for differences and contradictions in outcome in genetic-based studies (11, 12).

The aim of this study was to identify genetic profiles among healthy subjects from the Stanislas cohort and then to study the usefulness of this profiling as a marker of clinic and/or biological differences or tendencies in the CVD domain.

A total of 24 polymorphic genes were selected from the main biological pathways involved in cardiovascular risk and disease: lipid metabolism, thrombosis, blood pressure, inflammation, adhesion and homocysteine cycle. These genes were measured in a large cohort of healthy families (13) constituted in 1993 and composed of initially apparently healthy subjects. Statistics included a combination of multivariate analysis performed using a similar strategy as described in a previous study (14).

Materials and methods

Study population

The Stanislas cohort was constituted in 1993 and designed to investigate factors related to CVD. Details of the Stanislas cohort have been previously described (1). Individuals were recruited during a detailed check-up examination, and informed consent was obtained from all participants. A total of 1551 individuals (772 men and 779 women), not under treatment with lipid-lowering, antihypertensive or anti-inflammatory drugs, were selected from the cohort. In this relatively young population, with a mean age of 40.5 years (SD 4.6 years), all women were premenopausal.

Data collection

Personal and medical history, medication, smoking habits and alcohol consumption were recorded using a standard-

ised questionnaire. Smokers were defined as those who were current smokers. Blood pressure (calculated as the mean of three measurements taken under standardised conditions, in a supine position with a sphygmomanometer) was also measured. All the biochemical measurements have been described in full in a previous paper (13). Blood samples were collected after an overnight fast. Serum glucose, cholesterol and triglyceride (TG) levels were measured using standard enzymatic methods (Merck, Darmstadt, Germany), automated on au5021 (Olympus, Rungis, France). Serum apolipoproteins AI (APOAI) and B (APOB) were determined by immunonephelometry on a Dade-Behring Nephelometer Analyser, using Dade-Behring reagents (Rueil-Malmaison, France). Serum APOE, which is a therapeutic target (15), was determined by turbidimetry and serum high-density lipoprotein cholesterol (HDL-C) by phosphotungstate precipitation on a Cobas-Mira (Roche Diagnostics, Meylan, France). Low-density lipoprotein cholesterol (LDL-C) was calculated by the Friedwald formula: LDL-C = TC - HDL-C - TG/2.18, where TC is total cholesterol. Genomic DNA was extracted from peripheral blood samples by the salting-out method (16), and then genotyping for 27 polymorphisms (Table 1) was performed by a multiplex assay, which has been described previously (17, 18).

Statistical strategy and methods

Multivariate analyses were used to avoid univariate multiple testing, to improve the statistical power and to take into account the genetic information as a whole. The ratio of the number of subjects/number of studied genetic polymorphisms (1551/27 = 57.4) gave statistical power to the analysis and made it possible to use a multivariate strategy. Given our aim, the study of genetic data is essentially descriptive and is not looking to give a general model by building an equation or suggesting coefficients. This is why the whole sample is analysed at one time and not by successive subsamples selected at random. The pertinence of the clusters was tested by a logistic regression able, in addition, to select the most discriminating genetic data. As only genetic information was considered to obtain the genetic clusters, results of multivariate analysis are not shaped by the biological results. The whole procedure took six steps: description and selection of genetic data, computation of factorial continuous data, identification of the clusters, evaluation of the pertinence and discrimination among variables, characterisation of the clusters, and biological comparisons among

clusters. Analysis was performed using SPSS statistical software version 14.0 (SPSS Inc., Chicago, IL, USA).

Step 1: Description and selection of genetic data A descriptive analysis was performed on the 27 genetic polymorphisms obtained for the 1551 subjects. The upper limit of 1549 subjects out of 1551 (99.87%) represented by only one occurrence was chosen to exclude the corresponding variable. Data with a very low variability were then excluded from the study. We did not exclude genotypes that had a high probability of correlation with one another, because the choice of a threshold to identify these correlations, and consequently the selection of the corresponding data would have been arbitrary.

Step 2: Computation of factorial continuous data To gather genetic variables that were closely linked together, factorial combinations were obtained by multiple correspondence analysis [HOMALS-SPSS: homogeneity analysis by means of Alternating Least Squares. HOMALS Version 1.0 by Data Theory Scaling System Group (DTSS), Faculty of Social and Behavioural Sciences, Leiden University, The Netherlands.]. These factorial combinations decrease the dimension of the information's subspace from its initial value (equal to the initial number of variables), and consequently reduce the number of data to be used in the following step of the analysis. As each variant had three possible genotypes, except for the *APOE* with six possible genotypes, a three-dimensional and then a six-dimensional multiple correspondence analysis was performed. Therefore, we obtained two sets of results, one with three factorial combinations and one with six factorial combinations, for each of the 1551 subjects. HOMALS was performed on initial nominal variables, but generated continuous factorial data enabling a hierarchical classification.

Step 3: Identification of the clusters An ascendant hierarchical classification using the squared Euclidean distance was performed on the factorial combinations previously obtained. This classification gave a dendrogram reflecting the proximities of the 1551 subjects. The optimum number of clusters was determined by the level of the cut-off in the tree structure of the dendrogram. A cut-off of six clusters was chosen for each dendrogram according to the main dimension of the factorial data injected in the classification. The two sets of factorial data previously obtained were separately

used and produced two separate dendograms. The coherence between the number and the composition of the clusters obtained for these two dendograms was a condition for the continuation of the study. A reasonable number of clusters with firm aggregations of subjects were necessary to enter the following step.

Step 4: Evaluation of the pertinence of the profiling and discrimination among variables Based on the identified clusters and using the initial nominative genetic variables, a multiple logistic regression was performed to identify among the genotypes which were the most useful for discriminating between clusters. The redundant information, difficult to select a priori, due to variables that were closely linked together was then removed to test the pertinence of this profiling. The total percentage of individuals correctly classified accepted here was not less than 95%.

Step 5: Characterisation of the clusters To label each cluster, confidence intervals (CIs) calculated on the whole sample were used as references and a graphical representation was proposed. The relative frequencies of each genetic polymorphism among the 1551 subjects and the corresponding 95% CIs were calculated for each allele. The sample size was large enough to obtain precision in the estimates and to provide ranges of plausible values likely to include the unknown population parameters. Width and confidence limits of these CIs calculated on the 1551 subjects were used as references. For each cluster, relative frequencies were calculated for each genetic allele and compared to the lower and the upper boundaries of the corresponding CI previously obtained from the whole sample. If the CI contained the relative frequency, a zero value was associated with the allele (called y-value here and equal to 0). If the relative frequency was greater than the upper bound, it showed an excess of subjects, and the difference between these two values was considered as positive (positive y-value). If the relative frequency was lower than the lower bound, it showed a lack of subjects, and the difference between these two values was considered as negative (negative y-value). A chart on two axes was then created for each cluster. On the y-axis, in percentages, are the y-values previously computed. The higher the absolute y-value, the greater the distance from the baseline (above or below according to the y-value sign). To characterise the profile/signature of each cluster, only the genotypes for which the absolute y-value of at least one allele was 20% or more in this cluster were taken into account. Thus, a list of genotypes was established for each cluster.

Step 6: Study of clinical and biological measurements between the clusters at t_0 and t_{+5} Clinical assessments and biological measurements were compared among the clusters at inclusion and 5 years later. According to the nature and the distribution of each variable, we performed parametric (Student's t-test or analysis of variance) or non-parametric (Mann-Whitney test, Kruskal-Wallis test or Friedman's test) comparisons. A p-value <0.01 was considered statistically significant, because many variables were potentially linked.

Results

Step 1: Description and selection of genetic data

Table 1 presents the genetic polymorphisms selected at the beginning of the study. *APOB*-Arg3500Gln, *CETP*-Asp442Gly, *LPL*-39T/C and *CBS*-Gly307Ser polymorphisms with a frequency of the rare allele $\leq 1\%$ were excluded.

Steps 2 and 3: Computation of factorial continuous data and identification of the clusters

The six clusters of the three-dimension solution were of the following sizes: 1465 subjects, 44 subjects, 24 subjects, 16 subjects, 1 subject and 1 subject. The six clusters of the six-dimension solution were of the following sizes: 1467 subjects, 56 subjects, 10 subjects, 16 subjects, 1 subject and 1 subject. Results are coherent (Table 2) and eight clusters can be clearly individualised. Only the six containing more than 1 subject each were analysed, and in reference to their respective sizes they will be called C_{1453} , C_{44} , C_{16} , C_{14} , C_{12} and C_{10} .

Step 4: Evaluation of the pertinence of the profiling and discrimination among variables

The multiple logistic regression selected *SELE*-98G/T ($p < 0.0001$), *APOC3*-3175C/G ($p < 0.0001$), *APOC3*-482C/T ($p < 0.0001$), *APOC3*-1100C/T ($p < 0.0001$) and *LPL*-93T/G ($p < 0.0001$). These five genetic polymorphisms were sufficient to classify 99.6% of the 1552 subjects in their group and, more importantly, 95.8% of the subjects in the smaller groups, (1451/1453 or 99.9% for C_{1453} , 8/12 or 66.7% for C_{12} , 44/44 or 100% for C_{44} , 14/14 or 100% for C_{14} , 10/10 or 100% for C_{10} , and 16/16 or 100% for C_{16}).

Step 5: Characterisation of the clusters

The CIs computed among the whole population (1551 subjects) provide ranges of plausible values in agreement with the Hardy-Weinberg equilibrium. In the graphical representation (Figure 1), only C_{12} , C_{44} , C_{14} , C_{10} and C_{16} are shown, because all of the allele relative frequencies of C_{1453} had zero y-values. As the crossing of the results predicted (Table 2), C_{12} and C_{44} are similar, as are C_{14} and C_{10} , C_{16} is definitely distinct. The numbers and the percentages of individuals observed in a cluster for the main genotypes of its list are presented below.

C_{12} is characterised by Heterozygosity for *LPL* and *SELE*: 100% (12/12) for the *LPL* polymorphism -93T/G; 58% (7/12) for *LPL*-Asp9Asn, *SELE*- 98G/T and Ser128Arg.

C_{44} is characterised by 1/Heterozygosity for *LPL* and *CETP*: 100% (44/44) for *LPL* -93T/G and *LPL* Asp9Asn; 59% (26/44) for *CETP* Ile405Val. 2/Homozygosity for the common allele for *SELE*: 100% (44/44) for *SELE* 98G/T and Ser128Arg.

C_{14} is characterised by 1/Homozygosity for the less frequent allele for *APOC3* (except the 3175C/G polymorphism) and *APOB*: 100% (14/14) of *APOC3* -482C/T, -455T/C, -1100C/T and -3206T/G polymorphisms; 35.7% (5/14) for the *APOB* Thr71Ile polymorphism. 2/Heterozygosity for the *APOC3* gene -3175C/G polymorphism: 78.6% (11/14). Additionally, a lack of homozygosity for the less frequent allele (0/14 or 0%) for the *AGT* Met235Thr polymorphism can be noted.

C_{10} is characterised by 1/Homozygosity for the less frequent allele for *APOC3*: 100% (10/10) for -482C/T, -455T/C, -1100C/T, -3175C/G and -3206T/G. 2/Homozygosity for the common allele for the Gln192Arg polymorphism of the *PON1* gene: 80% (8/10); and for the *AGT* Met235Thr polymorphism: 60% (6/10).

C_{16} is characterised by 1/Homozygosity for the less frequent allele of the *SELE* gene: 100% (16/16) of individuals for the 98G/T and for the Ser128Arg polymorphisms. 2/Homozygosity for the common allele of the Ile405Val polymorphism of the *CETP* gene: 75% (12/16); and for *GPIIIa* Leu33Pro: 93.8% (15/16); 3/Heterozygosity for *APOC3* polymorphisms.

As a whole, C_{12} and C_{44} have similarities (heterozygous) for the *LPL* gene and dissimilarity for the *SELE* gene. C_{14} and C_{10} have similarities (homozygous for the less frequent allele) for *APOC3* polymorphisms except for *APOC3*-3175C/G. C_{16} is characterised by individuals homozygous for the less frequent allele of *SELE* polymorphisms.

Step 6: Study of clinical and biological measurements between the clusters at t_0 and t_{+5}

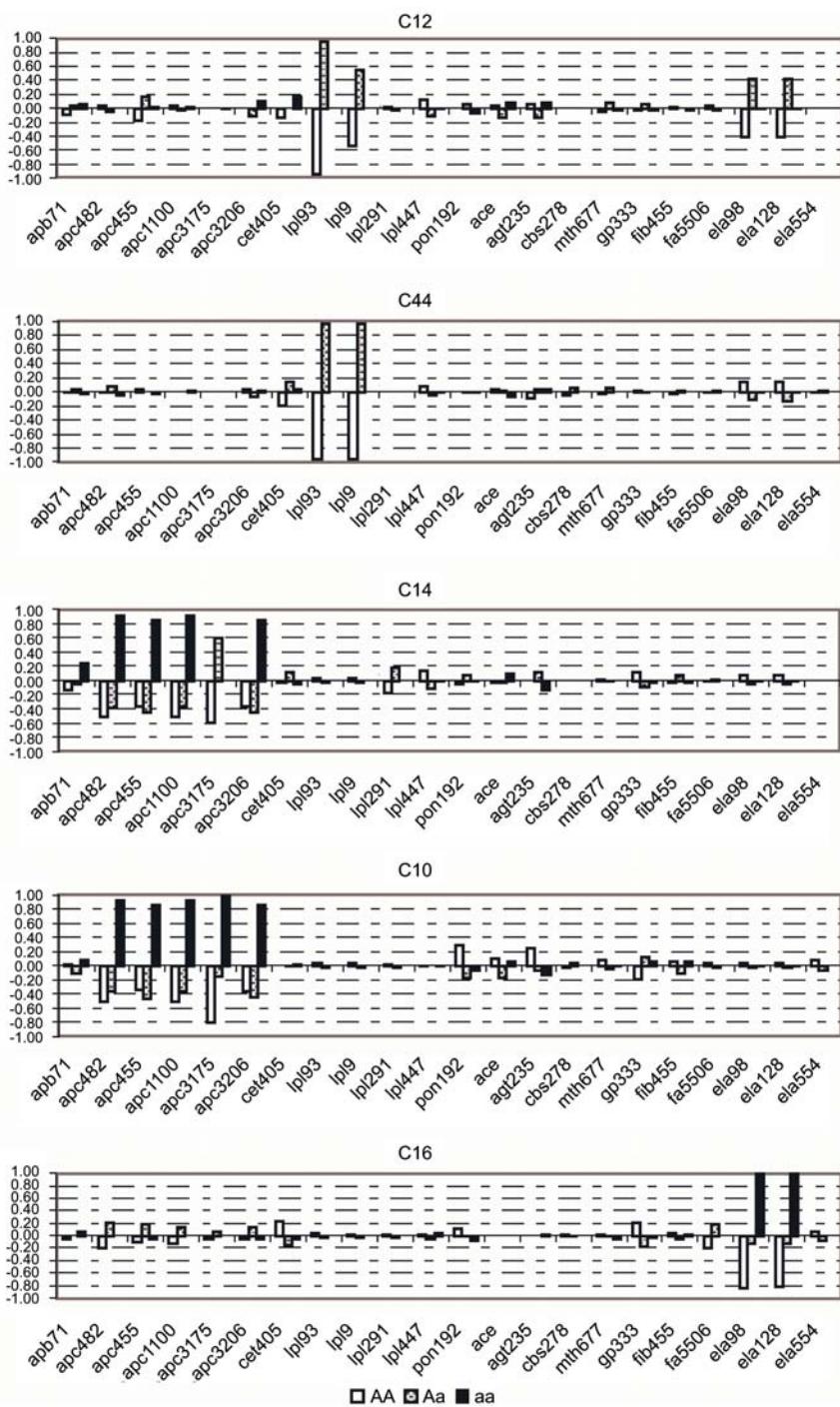
Results are summarised in Tables 3 and 4. Table 3 displays the results obtained at t_0 , whereas Table 4 displays results from 5 years later (t_{+5}). The given p-values are associated with statistical tests carried out on the six clusters. There was no difference for gender among the clusters ($p=0.22$, ns). At t_0 , the six clusters differ significantly for TG ($p=0.009$), HDL-C

($p=0.014$) and are nearly significant for diastolic blood pressure (DBP, $p=0.020$), APOB ($p=0.042$), TC ($p=0.059$) and LDL-C ($p=0.059$). At t_{+5} , the six clusters differ significantly for TG ($p=0.005$), HDL-C ($p=0.003$) and are nearly significant for APOAI ($p=0.054$). Overall, the results obtained at t_0 are in coherence with the results at t_{+5} . C_{10} presents the highest mean values for DBP and concentrations of TGs, TC, APOB and APOE (LDL-C at t_0) and the lowest mean values for APOAI and HDL-C concentrations. C_{16} presents the highest mean values for HDL-C and APOAI concentrations and the lowest mean values for concentrations of TC, APOB and LDL-C at t_0 and TG at t_{+5} . C_{44} is the least individualised cluster. It associates with the less addictive habits (alcohol consumption and smoking) at t_{+5} . C_{12} associates with the lowest mean values for waist, hip, body mass index (BMI), weight, and glucose level. The C_{12} group members are thinner, with the lowest glucose, TC and APOB concentrations at t_{+5} . The association of clusters with biological variables is independent of age.

Discussion

Considering the homogeneity resulting from inclusion and non-inclusion criteria of the 1551 initially apparently healthy subjects from the Stanislas cohort, we obtained a genetic homogeneity for most of the individuals (C_{1453}), but five other groups have clearly emerged at the same time. Despite the fact that these groups are relatively small, their genetic profiles can be clearly individualised and five genetic polymorphisms were sufficient to separate them. Clinical and/or biological differences already exist among these clusters. Some results are significant and others are of borderline significance, but it is important to note that most of them are coherent among the clusters at t_0 and 5 years later.

Considering the CVD marker values, two groups are especially interesting: C_{16} and C_{10} . The genetic signature of C_{16} consists of the E-selectin gene (*SELE* 98G/T and Ser128Arg) and the *CETP* gene (Ile405Val polymorphism). The genetic profile of C_{10} is characterised by the *APOC3* gene (-482C/T, -455T/C, 1100C/T, 3175C/G and 3206T/G), the *PON1* gene (Gln192Arg polymorphism) and the *AGT* gene (Met235Thr polymorphism). On the one hand, traditional risk factors for CVD are highest in C_{10} and the least high in C_{16} (significant for TC, APOB and LDL-C at t_0 and for TGs at t_{+5}). On the other hand, the biological parameters that are linked to a protective cardiovascular profile are observed in the reverse order for these clusters (HDL-C and APOAI concentrations at t_0 and t_{+5}). Therefore, individuals that belong to C_{10} present a risk profile for CVD, whereas individuals of C_{16} cluster seem to have a protective profile. In the C_{16} cluster, all the individuals are *SELE*-98TT and Arg128Arg and 75% are *CETP* 405VV. Information in the literature is sparse concerning the *SELE*- 98G/T polymorphism. Here, we confirm results from a previous study in

which the 98T (and by extension 128Arg, because it is in strong linkage disequilibrium with the 98G/T polymorphism) allele was associated with higher

HDL-C concentration in women only (13, 19). Moreover, our findings are in agreement with results from the EARS II study, which was performed on European

men and showed that individuals homozygous for the rare V405 allele had the highest HDL levels (20). Concerning the C₁₀ cluster, all the individuals are homozygous for the less frequent alleles of the *APOC3* polymorphisms studied. We demonstrated previously that APOB, LDL-C and TC concentrations were higher in women with the *APOC3* 1100TT genotype who do not smoke. Additionally, the T allele was related to higher TG, APOCIII and APOB-related traits, i.e., TC, LDL-C and APOB in men. The TT genotype was related to lower levels of APOAI and HDL-C only in male non-smokers (13). The genetic signature of this cluster was very close to that of C₁₄. The difference between the two groups came especially from an over-representation of *APOC3* 3175GG in C₁₀. Therefore, this polymorphism, in addition, but to a lesser extent to the other *CETP* polymorphisms, may be important in the pathophysiology of CVD. Previous studies have shown that the rare allele of the 3175C/G (also called SstI) polymorphism of the *APOC3* gene is associated with elevated TG and APOCIII concentrations (21, 22), higher blood pressure (23) and increased risk of myocardial infarction (24). In the Framingham Offspring Study, the 3175G allele was associated with elevated fasting insulin concentrations in men only (25). We observed that most of the subjects in C₁₀ are homozygous for the common allele of the *PON1* Gln192Arg polymorphism. The Gln192 allele is associated with low paraoxon activity (26). Moreover, low PON1 activity was suggested to be associated with coronary heart disease (27, 28). Conversely, subjects with the Arg192 allele were found to be at higher risk for CVD than subjects with the Gln/Gln genotype (29, 30). Other investigations, involving French and Irish (31), Finnish (32) and Japanese subjects (33) did not show any significant association between the *PON1* Gln192Arg polymorphism and CVD. Moreover, Gln homozygotes were found to be more advanced in age compared to Arg allele carriers in the Stanislas cohort (34), and being homozygous for 192 ArgArg was linked to enhanced survival (35). One possible explanation for the observed discrepancies could come from the incomplete concordance between PON1 phenotypes and PON1 genotypes (36). Finally, concerning the *AGT* Met235Thr polymorphism, results have suggested that the ThrThr genotype could be a genetic marker for arterial stiffness in patients with never-treated hypertension (37). The risk of developing hypertension is higher for MetThr and ThrThr genotypes compared to MetMet genotypes (38). Moreover, homozygosity for the angiotensinogen 235T variant was found to increase the risk of myocardial infarction in patients with multi-vessel coronary artery disease (39). On the other hand, results from a study by Gardemann et al. showed that blood pressure levels and the prevalence of high blood pressure did not vary according to M235T genotypes, and the M235T genotype distributions did not differ between survivors of myocardial infarction and controls (40). Other studies did not find that the 235T allele was a risk factor for coronary heart disease (41, 42). Our previous results on the *AGT* Met235Thr poly-

morphism did not show any association between this variant and carotid intima-media thickness (43).

In summary, the results of this study are in agreement with the literature, especially with studies involving confirmed CVD. Of course, this work concerns the CVD risk factor-related measurement and not the disease itself. We cannot show today, whether the gene clusters identified do really contribute to the confirmed disease, but we have produced strong evidence, according to biological results, that *SELE* may be linked to a cardiovascular protective profile, while *APOC3* polymorphisms, and 3175C/G in particular, may increase the CVD risk. This profiling allows accuracy in the description and in the follow-up of the cohort: analysis of future events according to previously identified genetic groups.

Notre objectif était d'étudier les interactions épistasiques de 100 variants génétiques appartenant à 65 gènes candidats de différentes voies métaboliques (pression artérielle, inflammation, métabolisme lipidique, métabolisme de l'homocystéine, adhésion cellulaire, thrombose).

Nous avons donc génotypé 1 912 adultes de façon à effectuer des études d'association individuelles.

Neuf SNPs ont montré une association significative avec la pression artérielle systolique, diastolique ou la pression pulsée. Cinq étaient fonctionnels : rs5742910 et rs6046 dans le *FVII* ($P \leq 0,024$), rs1800469 au sein du gène *TGFB1* ($P < 0,001$) et potentiellement responsables d'une diminution de la pression artérielle. Le rs1800590 dans le gène *LPL* ($P \leq 0,003$) et le rs2228570 dans le *VDR* ($P < 0,001$) avaient quant à eux une potentielle fonction d'altération de la structure protéique.

Nous avons également observé les interactions épistatiques suivantes : *LPL* (rs1801177)**PON1* (rs662) ($P \leq 0,032$) pour tous les traits de pression artérielle mais aussi des interactions spécifiques à la pression systolique: *VCAM1* (rs1041163)**APOB* (rs1367117) ($P \leq 0,04$), ou diastolique: *SCGB1A1* (rs3741240)**LPL* (rs1800590 et rs1801177) ($P \leq 0,031$).

Une étude *in silico* nous a permis de déduire la fonctionnalité de ces interactions.

Abstract

Objectives: To investigate epistatic interactions of 100 candidate genes from various biological pathways in regard to blood pressure.

Background: In spite of candidate gene and genome-wide association studies, only a small number of genetic variants regulating blood pressure have been identified. This could be partly due to gene-gene interactions: epistasis.

Methods: One hundred genetic variants in 65 candidate genes from various biological pathways (blood pressure regulation, inflammation, lipid metabolism, homocysteine metabolism, cellular adhesion, and thrombosis) were genotyped in 1,912 French middle-aged individuals in order to study their combined effects on blood pressure regulation.

Results: Among 9 SNPs significantly associated with systolic, diastolic blood pressure and pulse pressure, 5 were functional. rs5742910 and rs6046 in *FVII* ($P \leq 0.024$), rs1800469 in *TGFB1* ($P < 0.001$) may be responsible for blood pressure defects modifying their plasma protein levels, whereas rs1800590 in *LPL* ($P \leq 0.003$) and rs2228570 in *VDR* ($P < 0.001$) may act via altering protein structure. When combinatory analyses were performed, one epistatic interaction was common for the 3 blood pressure traits investigated: *LPL* (rs1801177)**PON1* (rs662) ($P \leq 0.032$). In addition, specific interactions were found for systolic blood pressure: *VCAM1* (rs1041163)**APOB* (rs1367117) ($P \leq 0.04$), as well as diastolic blood pressure: *SCGB1A1* (rs3741240)**LPL* (rs1800590 and rs1801177) ($P \leq 0.031$). An *in silico* search yielded functional roles for these epistatic interactions.

Conclusions: The present findings provide insight into pathways such as lipid metabolism which may act synergistically with genes in the same or other pathways to modify hypertensive risk. This

strategy reveals novel pathophysiologic mechanisms underlying hypertension and potential therapeutic targets.

Introduction

Blood pressure (BP) is a continuous, consistent and modifiable risk factor for cardiovascular diseases (CVD) such as ischemic heart disease (IHD) and stroke which are major causes of mortality and morbidity in the world (1). Population-based studies showed that 972 million adults worldwide were hypertensive in 2005 and it is predicted to increase by about 60% to 1.56 billion in 2025 (2).

Existing evidence suggests that BP heritability ranges from 30 to 60% (3). Despite the identification of specific causal genes involved in the regulatory pathways of rare familial forms of hypertension (4), both BP and hypertension are still considered polygenic traits involving a number of metabolic pathways (5,6).

The complex architecture of BP regulation may account for the numerous discrepancies found among studies of genetics underlying hypertension. Inflammation, thrombosis, cellular adhesion molecules and lipid metabolism all appear to play a role (7-9). While aspects of BP regulation may be the product of an inflammation stimulus (7,10,11), thrombin is also known to induce several intracellular pathways (8), modulate vascular tone (12) and have pro-inflammatory effects. Mounting evidence also suggests that cellular adhesion molecules and apolipoproteins are closely related to hypertension (9,13). All of these properties may be involved in initiating and maintaining elevated BP levels (8). Overall, however, genetic factors associated with BP are poorly characterized and these pathways remain unclear.

In the Genome-wide association studies (GWAS) era, technological advances facilitated the genotyping of more than two million single nucleotide polymorphisms (SNPs). Researchers have since attempted to identify susceptibility loci of BP (5,14) but limited progress has been made thus far (15,16). A possible explanation is the significant genetic and phenotypic heterogeneity for this phenotype and the modest effect size of risk alleles (17). Besides, GWAS have not incorporated epistatic interactions, though examining such interactions may be essential (18) in identifying the genes involved in BP regulation.

To our knowledge, no previous study has been conducted on European individuals in assessing the epistasis of cardiovascular candidate genes on BP regulation. Thus, the purpose of this study was to investigate 100 genetic variants in 65 cardiovascular candidate genes from various biological pathways in regard to BP traits, and their epistatic interactions. Based on previous findings (15,16,18), we hypothesize that epistatic interactions among candidate SNPs may be more informative than individual SNPs analyses in influencing BP regulation.

Methods

Ethics statement

The participants are part of a human sample storage platform: the Biological Resources Bank (BRC) "Interactions Gène-Environnement en Physiopathologie CardioVasculaire" (BRC IGE-PCV) in Nancy, East of France. Each individual involved gave his written informed consent and the project's populations were approved by the local ethics committee (*Comité Consultatif de Protection des Personnes se prêtant à une Recherche Biomédicale – Lorraine, France*).

Study population

The present study enrolled 1,912 middle-aged French subjects (51.3 % women) selected from the BRC IGE-PCV on the basis of the following criteria: (1) subjects were Caucasians born in France since three generations; (2) no antihypertensive drugs administration or, for hypertensive patients, the BP phenotypes were measured at baseline before drug administration; and (3) complete clinical and genotypic data available.

Clinical and biological data collection

Systolic blood pressure (SBP) and diastolic blood pressure (DBP) was measured under constant temperature (19°C to 21°C) and standardized conditions (supine position) with a manual sphygmomanometer by expert nurses. The values reported were the means of 3 readings at each examination on 20 min intervals. Pulse pressure (3) were calculated as the difference between SBP

and DBP. All individuals underwent complete medical examination including anthropometric and biochemical measurements collected with standardized methods(19).

Genotyping

Genomic DNA was extracted from peripheral blood samples by the salting out method (Miller SA, 1988). Genotyping was performed by using multilocus assay with an immobilized probe approach previously described(20) (Roche Molecular Systems, Pleasanton, California, USA).

After PCR amplification using pooled biotinylated primers and hybridization to sequence-specific oligonucleotide probes, genotype assignments were performed by two independent observers using proprietary Roche Molecular Systems image processing software.

Discordant results (< 3% of all scoring) were resolved by a third observer and if necessary, by a joint reading.

Blinded replication of the fragment analysis was performed with 10% of the selected samples on an automated high-performance liquid chromatography instrument (Wave system™; Transgenomics Inc. NC, USA), both sequencing and restriction analyses fully matched.

PolyPhen analysis of nonsynonymous SNPs

The prediction of possible impact of nonsynonymous (ns) SNPs on the structure and function of their specific protein was performed using PolyPhen(21).

Statistical analyses

Statistical analyses were performed using the SPSS® statistical software version 16.0 (SPSS, Inc, Chicago, Illinois).

Polymorphisms with minor allele frequencies (MAF) less than 2% were excluded from individual analyses. However, for interaction analyses we included all SNPs as low MAF may identify an epistatic phenomenon. HWE was tested using an exact method.

Separate models were constructed to determine the independent effect of each genetic variant on SBP, DBP, and PP assuming additive models with the common wild type (WT) as the reference group. Age, sex and body mass index (BMI)-adjusted linear regressions were performed for individual association analyses after ensuring that the gender did not interact with the genotype.

The variants individually associated in our study were compared to previous findings in the literature, notably on previous GWAS, by imputation analyses using plink(22).

Epistasis of variants that were independently associated with BP was established by interaction terms existing between genetic variants on linear additive models.

Power of all analyses ($1-\beta$) was determined a posterior and we considered significant associations only if it was greater than 80%. Type 1 error coefficient (α) was fixed at 5% and statistical significance was reached where p-values were less than 0.05 as we performed individual tests on each genetic variant.

Results

Phenotypic characteristics of the studied population

Phenotypic characteristics of the 1,912 French middle aged participants ($51.13 \text{ years} \pm 10.02$) are shown in Table 1. SBP, DBP, total cholesterol, low density lipoprotein-cholesterol (LDL-C) and glucose levels were higher in men compared to women ($P<0.001$). Women had higher PP and high density lipoprotein-cholesterol (HDL-C) levels ($P<0.001$). 18.5% of participants had normal BP (SBP<120 and DBP<80mmHg), 21.1% were prehypertensive (SBP and/or DBP between 120 and 139mmHg and/or 80 and 89mmHg), 25.9% had a stage 1 hypertension (SBP and/or DBP between 140 and 159mmHg and/or 90 and 99mmHg) and 34.5% were at stage 2 ($\geq 160/100\text{mmHg}$) according to the Seventh Report of the Joint National Committee (23).

Investigated genetic variants

Genotype and allele frequencies of all investigated genes of MAF quality control were consistent with Hardy-Weinberg equilibrium (HWE, data available upon request). The full details of investigated genetic variants are listed in Supplementary Table 1: the analysis included 100 SNPs that belong to 65 cardiovascular candidate genes selected according to our cardiovascular genetics background (19). Among the included SNPs, 50 were nonsynonymous, and according to Polyphen, 5 were damaging for their protein structure.

Individual association analysis

The results of individual association analyses of genetic variants with BP traits are shown in Table 2. Thirty SNPs in 25 genes including various metabolic pathways were significantly associated with SBP,

DBP or PP: *APOA4*, *APOB*, *APOC3*, *LIPC*, *LPL*, *PON1*, *PON2* and *LDLR* (lipid metabolism), *VCAM1* and *SELP* (cellular adhesion), *FVII* (coagulation factor), *GNB3*, *ATR1*, *AGT* and *NOS3* (BP regulation), *TNF*, *IL10*, *IL1B*, *C5*, *CSF2*, *TGFB1*, *CCL11*, *C3*, *LTA* and *VDR* (inflammatory pathways). Fourteen SNPs were associated with at least 2 or the 3 BP traits investigated. rs854560 in *PON1* ($P=0.047$) was associated with only SBP (Table 2A), and rs675 in *APOA4* ($P=0.024$), rs1367117 in *APOB* ($P=0.024$), rs2542052 and rs2854116 in *APOC3* ($P\leq 0.024$) respectively were specific for DBP (Table 2B). Nine SNPs rs1800590 in *LPL* ($P\leq 0.003$), rs5742911 in *LDLR* ($P\leq 0.009$), rs5742910 and rs6046 in *FVII* ($P\leq 0.007$ and $P\leq 0.024$ respectively), rs1800469 in *TGFB1* ($P<0.001$), rs1143634 in *IL1B* ($P\leq 0.005$), rs25882 in *CSF2* (<0.001), rsrs1129844 in *CCL11* ($P<0.001$) and rs2228570 in *VDR* ($P<0.001$) were associated with the 3 BP traits.

All genetic variants associated with a BP trait had an age and BMI cumulative effect ($P<0.001$, Table 2).

We performed imputation analyses in order to compare our results with the literature, but did not find any genetic variant in linkage disequilibrium with previous reports (all correlation coefficients $<80\%$).

Epistatic interaction with BP

Epistatic interactions with BP are shown in Table 3. All genetic markers previously associated with at least one BP trait showed epistatic interactions influencing BP. One epistasis was common for the 3 BP traits: *LPL* (rs1801177)**PON1* (rs662), and 2 were specific to SBP and DBP: *VCAM1* (rs1041163)**APOB* (rs1367117) and *SCGB1A1* (rs3741240)**LPL* (rs1800590 and rs1801177) (Tables 3A and 3B). Interestingly, rs3741240 in *SCGB1A1* and rs1801177 in *LPL* were not individually associated with SBP and DBP (*LPL* was initially excluded from individual analyses tables as its MAF

was 1.82 but was associated with PP), but their epistatic combinations significantly influenced SBP and DBP ($P = 0.013$ and 0.026 respectively, Tables 3A and 3B).

Discussion

Even at early stages, hypertension is a major cause of disabilities and death for millions throughout the world (1). Observational studies involving more than 1 million adults from 61 prospective studies have indicated that death from hypertension associated diseases (both IHD and stroke) increases linearly from levels as low as 115/75mmHg among middle and elderly age individuals (23). Therefore, isolating genetic variations that may influence BP at middle age might have major implications for public health; however, individual genes have so far shown a weak genetic effect (11,24). It is therefore essential that epistatic gene interactions be studied to identify gene combinations that synergistically influence BP regulation and, by extension, dysregulation.

In the current study composed of 1,912 French middle aged individuals, we identify 30 SNPs in 25 genes involved in various biological pathways including lipid metabolism (*LIPC*, *LPL*, *PON1*, *PON2*, *APOA4*, *APOB* and *LDLR*), cellular adhesion molecules (*VCAM1* and *SELP*), coagulation factors (*FVII*), BP regulation (*AGTR1*, *AGT* and *NOS3*) and inflammation (*IL10*, *IL1B*, *C5*, *CCR3*, *CSF2*, *CCL11*, *TNF*, *TGFB1*, *C3*, *LTA* and *VDR*) that were associated with at least one of the 3 BP trait investigated ($P<0.05$, Table 2). Whereas 14 SNPs were associated with at least 2 BP traits, rs854560 in *PON1* ($P=0.047$) was associated with SBP only (Table 2A) and rs675 in *APOA4* ($P=0.024$), rs1367117 in *APOB* ($P=0.024$), rs2542052 and rs2854116 in *APOC3* ($P\leq0.024$), and rs361525 in *TNF* ($P=0.01$) were specific for DBP (Table 2B). Interestingly, the following 9 SNPs were associated with the 3 BP traits (Table 2): rs1800590 in *LPL* ($P\leq0.003$), rs5742911 in *LDLR* ($P\leq0.009$), rs5742910 and rs6046 in *FVII* ($P\leq0.007$ and $P\leq0.024$ respectively), rs1800469 in *TGFB1* ($P<0.001$), rs1143634 in *IL1B* ($P\leq0.005$), rs25882 in *CSF2* ($P<0.001$) rsrs1129844 in *CCL11* ($P<0.001$) and rs2228570 in *VDR* ($P<0.001$).

It is noteworthy that all 25 genes associated with at least one of the 3 BP traits overlapped with loci previously reported in BP GWAS (25-30). For example, in a genome-wide linkage analysis study conducted on 2,259 Nigerian individuals (26), Cooper et al associated chromosome regions 5q and 7q

with DBP, whereas others showed the association of 19q with SBP (26). In addition, Camp et al (25) reported the importance of loci on chromosome 11q and 12q in PP regulation in American individuals (25). All these chromosome regions contain the genes identified here (Supplementary Table 1).

Genetic variation may be responsible for defective BP phenotypes by altering either the structure of encoded proteins or gene expression (15). Among genetic variants commonly associated with SBP, DBP and PP, 5 were functional SNPs. For rs1800469 in *TGFB1*, there is evidence to suggest altered gene expression (31,32) as this SNP has been reported to be associated with increased *TGFB1* gene transcription and plasma protein concentration (32). For rs5742910 and nsSNP rs6046 in *FVII*, we have previously reported that both are associated with a one third decrease in *FVII* levels (8). It is important to emphasize that for both rs6041 and rs5742910 in *FVII*, we have previously shown similar associations in another sample population of the BCR (8). Together with previous data, our finding that *FVII* and *TGFB1* polymorphisms are associated with BP may be due to modifications of gene expression and resulting alterations in plasma protein levels.

Another mechanism through which polymorphisms may affect gene expression is by disrupting microRNA binding (miRNA). MicroRNAs inhibit gene expression by base pairing with complementary mRNA sequences. SNPs located within such targets can affect this base pairing. For example in the present study, rs5186 (1166 A/C) in *AGTR1* is located in the 3'UTR, a region associated with both SBP and DBP ($P \leq 0.05$). The C allele polymorphism of *AGTR1* may disrupt binding of miR155 to its complementary *AGTR1* mRNA (33)—resulting in an overall increase in gene expression. In agreement with our finding, Wang et al (34) and Kobashi et al (35) reported this allele in case-control studies to be significantly increased in hypertensive patients compared to normotensive ones (34,35).

In contrast to the above *AGTR1*, *FVII* and *TGFB1* polymorphisms, other polymorphisms may also influence genetic variation through altered protein structure and resulting protein activity. For

example, it is reported that the rs1800590 polymorphism in *LPL* affects lipoprotein lipase enzyme function (36,37). Similarly, the coding nsSNP rs2228570 in *VDR* introduces an amino acid substitution (Met1Thr) that may be damaging for the structure of its encoded protein, according to Polyphen (21). Thus, the influences of *LPL* and *VDR* polymorphisms on BP may be the result of modifications in their protein structures and resulting changes in protein activities.

Epistatic interactions may also play pivotal roles in the discrepancies found across genetic studies. Numerous studies reported that these interactions may identify genetic markers that are not captured by individual marker analysis tests and/or revealed by the combinatory effect of loci in other pathways (14,38). Herein we showed that all genetic markers individually associated with at least one BP trait also had epistatic interactions influencing BP phenotypes (Table 3). Interestingly, among epistatic interactions, one was common for all BP traits: *LPL* (rs1801177)**PON1* (rs662) ($P \leq 0.032$, Table 3) and 2 were specific for SBP and DBP: *VCAM1* (rs1041163)**APOB* (rs1367117) and *SCGB1A1* (rs3741240)**LPL* (rs1800590 and rs1801177) (Table 3A and 3B), respectively.

A number of potential mechanisms mediating the observed genetic associations were identified with an *in silico* search. First, the *PON1* gene encodes the 355 amino acid protein paraoxonase, an enzyme that hydrolyzes paraoxon. The genetic variant rs662 (Arg192Gln) of *PON1* results from the replacement of Arg by Gln of amino acid 192; the protein has been shown to have lower paraoxonase activity (39) resulting in an increase of oxidative stress (40)—a characteristic closely linked to elevated BP (41).

The genetic variant rs1801177 in *LPL* is also a functional nsSNP, resulting from the conversion of aspartic acid to asparagine of amino acid 9 in the mature protein,. This SNP has been shown to partially affect LPL enzymatic activity (42). Putatively, oxidative stress coupled with partially inactivated LPL would result in elevated BP levels. The positive β coefficients for *LPL*

(rs1801177)**PON1* (rs662) (0.072 and 0.057 respectively) strengthened our hypothesis (data available on demand).

Another epistatic interaction was found between *SCGB1A1* (rs3741240) and *LPL* (rs1800590). rs3741240 in *SCGB1A1* is a nonfunctional SNP that has been shown to inhibit phospholipase A2 (43) and decrease plasma levels of HDL-C (44). Taken together, *LPL* and *SCGB1A1* may interact through HDL-C to influence BP. The present study also showed epistatic interactions between *VCAM1* (rs1041163)**APOB* (rs1367117). Whereas rs1041163 in *VCAM1* is a nonfunctional SNP, rs1367117 in *APOB* is possibly damaging for its protein structure. Human studies have reported significant correlations between *APOB*, the main component of LDL-C, and *VCAM1* in the context of hypertension. Hubel et al (45) have reported significant correlations between soluble levels of *APOB* and *VCAM1* in women with endothelial dysfunction and hypertension as a result of preeclampsia.

Importantly, previous candidate gene studies have revealed other epistatic interactions in modifying the BP phenotype (38,46). In a cross-sectional study conducted on 402 middle aged and elderly Japanese individuals, Misono et al (38) demonstrated that individuals carrying a combination of *ADRB2* Gly/Gly and *NOS3* Glu/Glu genotypes had higher hypertensive risk. Moreover, Kohara et al (46) replicated a case-control study conducted on 9,700 participants and reported that epistatic interactions are associated with increased risk of developing hypertension. Combined with our findings, there is clear evidence that numerous epistatic interactions involving multiple physiological pathways influence hypertensive risk.

Strengths and limitations

The present findings are strengthened by the fact that, compared with previous epistatic interaction studies, that the current investigation gives a biological validity in an ethnically homogenous population (French origin). However some limitations should be mentioned: (1) caution must be

taken in interpreting the identified epistatic interactions, as they were observed in the same population in which the genetic markers were discovered and results in different populations might be replicated; (2) consistency of our results should be underwent on a Genome-wide association study design on a large population; and (3) as the participants in this study are of French origin, our findings must be confirmed in different ethnic groups.

Conclusions and perspectives

In summary, we identify (1) susceptibility genes directly influencing BP including *LIPC*, *LPL*, *PON1*, *PON2*, *APOA4*, *APOB* and *LDLR* (lipid metabolism), *VCAM1* and *SELP* (cellular adhesion molecules), *FVII* (coagulation factors), *AGTR1* and *AGT* and *NOS3* (BP regulation), *IL10*, *IL1B*, *C5*, *CCR3*, *CSF2*, *CCL11*, *TNF*, *TGFB1*, *C3*, *LTA* and *VDR* (inflammation); (2) biologically validated pathways involved in lipid metabolism such as *LPL* (rs1801177) and *PON1* (rs662), *SCGB1A1* (rs3741240) which may modify the risk of hypertension through epistatic interactions. Our findings may provide insight into novel pathophysiologic mechanisms underlying hypertension and potential therapeutic targets. Confirmation in different ethnic groups is currently underway.

Le VEGF a un impact sur l'angiogenèse, l'athérosclérose et le cancer. Malgré sa forte heritabilité, sa génétique est peu connue. Notre objectif était donc d'identifier les variants génétiques associés aux niveaux circulants du VEGF par une approche pangénomique.

Dans un premier temps, nous avons effectué une GWAS sur 3 546 sujets issus de la troisième génération de la cohorte Framingham puis une réplication dans 1 727 sujets issus de deux populations indépendantes : la cohorte STANISLAS et la Prospective Investigation of the Vasculature in Uppsala Seniors study (PIVUS). Quatre variants génétiques situés dans trois régions chromosomiques distinctes avaient une association indépendante avec le VEGF au terme de la régression conditionnée : rs6921438 et rs4416670 (6p21.1, $p=6,11\times 10^{-506}$ et $p=1,47\times 10^{-12}$), rs6993770 (8q23.1, $p=2,50\times 10^{-16}$) et rs10738760 (9p24.2, $p=1,96\times 10^{-34}$). Ces variants expliquaient 48% de la variabilité génétique du VEGF.

Dans une étude transcriptomique, six variants genome-wide significant ont été associés aux ARN messager du VEGF dans les cellules mononucléaire de sang périphérique.

Ainsi, nous avons pu mettre en évidence des variants génétiques expliquant près de la moitié de l'héritabilité génétique du VEGF et donnant des pistes importantes sur les voies métaboliques régulant ce trait.

Cette étude a été effectuée en collaboration avec l'équipe Framingham et la cohorte STANISLAS était une population de réplication. Nous avons aidé à la sélection et à la

Background: VEGF impacts angiogenesis, atherosclerosis and cancer. Although the heritability of circulating VEGF levels is high, little is known about its genetic underpinnings. Our aim was to identify genetic variants associated with circulating VEGF levels using an unbiased genome-wide approach.

Methods and results: We undertook a genome-wide association study (GWAS) of serum VEGF levels in 3,546 participants of the Framingham Heart Study (FHS), with pre-planned replication in 1,727 participants from two independent samples, the STANISLAS Family Study (SFS) and the Prospective Investigation of the Vasculature in Uppsala Seniors study (PIVUS). One hundred and forty SNPs reached genome-wide significance ($p < 5 \times 10^{-8}$). We found evidence of replication for the most significant associations in both replication datasets. In a conditional GWAS 4 SNPs mapping to 3 chromosomal regions were independently associated with circulating VEGF levels: rs6921438 and rs4416670 (6p21.1, $p = 6.11 \times 10^{-506}$ and $p = 1.47 \times 10^{-12}$), rs6993770 (8q23.1, $p = 2.50 \times 10^{-16}$) and rs10738760 (9p24.2, $p = 1.96 \times 10^{-34}$). A genetic liability score including these four SNPs explained 48% of the heritability of serum VEGF levels. Six of the SNPs that reached genome-wide significance in the GWAS were significantly associated with VEGF mRNA levels in PBMCs.

Conclusions: Genetic variants explaining up to half the heritability of serum VEGF levels were identified. These new insights provide important clues to the pathways regulating circulating VEGF levels and could be used to study whether emerging VEGF and anti-VEGF based therapies should be tailored according to the genetic background.

Vascular endothelial growth factor (VEGF, also referred to as VEGFA in contrast to other members of the VEGF family) is pivotal in many physiological and pathological processes.¹ It is primarily known for its key role in the stimulation of angiogenesis, with a potent mitogenic effect on vascular endothelial cells from arteries, veins and lymphatics.² VEGF also promotes vasodilatation by inducing the production of nitric oxide and prostacyclin by endothelial cells.³ In addition, VEGF is involved in hematopoietic development and chemotaxis of monocytes, regulation of osteoclast differentiation, stimulation of surfactant production,¹ and has neurotrophic and neuroprotective effects on neuronal and glial cells.⁴ Elevated circulating VEGF levels have been observed in vascular disease (ischemic heart disease,^{5,6} heart failure,⁷ stroke⁸), and in various other disorders, including diabetes,⁹ cognitive decline and dementia,^{10,11} reproductive,¹²⁻¹⁴ immune-inflammatory disorders,^{15,16} and neoplastic diseases.^{17,18} Administration of VEGF promotes angiogenesis in patients with critical leg ischemia, as well as in animal models of coronary and limb ischemia.¹⁹ VEGF inhibitors such as bevacizumab and sorafenib have been successfully used to inhibit angiogenesis in several tumors,^{20,21} in macular degeneration²² and in rheumatoid arthritis.²³ However, despite the considerable toxicity associated with VEGF inhibitor drugs,²⁴ there have been no pharmacogenomic studies to identify potential subgroups of responders partly because the genetic determinants of VEGF concentrations remain poorly understood. Indeed, although the heritability of circulating VEGF levels is very high, ranging between 60 and 80%,²⁵⁻²⁷ few studies have assessed the relation between circulating VEGF levels and genetic variants, yielding inconsistent results. The aim of the present study was to identify genetic variants associated with circulating VEGF levels using an unbiased genome-wide approach in a large community-based sample.

Methods

Study populations

The Framingham Heart Study (FHS)

The FHS, initiated in 1948, is a three-generation, community-based, prospective cohort study conducted in Framingham, MA, USA.³³⁻³⁵ Serum VEGF levels were measured in third generation cohort participants (2002-2005) and genome-wide genotyping was performed on these individuals at Affymetrix (Santa Clara, CA) through an NHLBI funded SNP-Health Association Resource (SHARe) project. After excluding participants who had prevalent cardiovascular disease or failed to meet quality control standards, 3,546 participants were enrolled.

The STANISLAS Family Study (SFS)

The SFS is a 10-year longitudinal survey involving 1,006 volunteer families from Vandoeuvre-lès-Nancy, France, whose members were free of chronic disease (cardiovascular or cancer) between 1993-1995.²⁸ Plasma VEGF levels were measured at the second examination cycle (1998-2000) in a randomly selected subsample; of these 859 persons from 217 families, who also had DNA and met genotyping quality control criteria, were included.

Prospective Investigation of the Vasculature in Uppsala Seniors (PIVUS) study

The PIVUS study is a population-based study that enrolled 1,016 70-year old individuals living in the community of Uppsala, Sweden (2001-2004).²⁹ Of these, 999 persons provided DNA for genetic studies and after exclusions for prevalent cardiovascular disease and inadequate genotyping quality, 868 participants were eligible.

Further details of the study samples are available in the **Supplemental Methods**, section 1.

Laboratory measurements of VEGF levels

VEGF levels were measured in serum for the FHS and PIVUS and plasma for the SFS (**Supplemental Methods**, section 2).

Genotyping

FHS

Genome-wide genotyping in the FHS was performed on the Affymetrix GeneChip Human Mapping 500K Array Set® and 50K Human Gene Focused Panel®. Genotyping, quality control and imputation methods are detailed in the **Supplemental Methods**, section 3.

SFS

The SNPs were genotyped by Genoscreen using a Sequenom® iPLEX Gold assay – Medium Throughput Genotyping Technology.³⁰

PIVUS study

The SNPs were genotyped as part of a 96-plex assay at the SNP technology platform in Uppsala University (<http://www.genotyping.se/>) using the Illumina BeadXpress system from Illumina Inc.³¹ Genotyping calls were done with Illumina BeadStudio software.

Statistics

VEGF levels were natural log-transformed to normalize their distribution.

Genome-wide association analysis in the FHS

A linear mixed effects model accounting for familial relatedness was used to evaluate the association of each SNP with VEGF levels.³² An additive genetic model with one degree of freedom was used. In a first step (model A), analyses were adjusted for age, sex, familial structure and the ninth principal component (**Supplemental Methods**, section 4). In a second step designed to explore potential mechanisms, we additionally adjusted our most significant associations for covariates previously found to be associated with serum VEGF levels.²⁵ Compared to model A, model B was additionally adjusted

for hypertension; model C for smoking; model D for central obesity and model E for the presence of a metabolic syndrome (**Supplemental Methods**, section 5).

Genetic association study in the SFS and the PIVUS study

In order to confirm our findings in the FHS, we genotyped 25 SNPs in two independent samples. To select a parsimonious number of SNPs for replication we used criteria of strength of association (p-value), whether the SNP was genotyped or imputed, linkage disequilibrium (LD) between SNPs and functionality (**Supplemental Methods**, section 6). A linear regression model using the same covariates and analytic strategy as in the FHS was implemented.

Joint analysis of the FHS, SFS and PIVUS study

For SNPs that were successfully genotyped in the SFS and the PIVUS study we performed a meta-analysis of the SNP-phenotype associations, using a fixed effects inverse-variance meta-analysis technique (**Supplemental Methods**, section 7).

Genetic liability score

The methods used for computing a genetic liability score are detailed in the **Supplemental Methods**, section 8, and **Supplemental Table 1**. The phenotypic variance explained by this genetic liability score was separately calculated in the FHS, the SFS and the PIVUS study, using regression models that included age and sex as covariates.

VEGF gene expression analysis in peripheral blood mononuclear cells (PBMCs)

Sample preparation and quantification of the PBMC messenger RNA (mRNA) of VEGF spliced forms and statistical analyses of these data are described in the **Supplemental Methods** (section 10).

Biological pathway analysis

Methods for the biological pathway analysis are provided in the **Supplemental Methods**, section 9.

Results

Characteristics of the 5,273 study participants are presented in **Table 1**.

GWAS of VEGF levels in the FHS

The quantile-quantile plot showed an excess of extreme p-values but no evidence of systematic inflation of the genomic control inflation factor ($\lambda=1.02$) (**Supplemental Figure 1**). The genome-wide plot of p-values for the individual SNPs against their genomic position is shown in **Supplemental Figure 2**. A total of 140 SNPs cleared the threshold for genome-wide significance at 5×10^{-8} (**Supplemental Table 2**). These were located in three chromosomal regions: 6p21.1, 8q23.1, 9p24.2 (**Table 2**). The most significant association was found with rs6921438 on chromosome 6p21.1 ($p=6.11\times 10^{-506}$), at 171 kb downstream of the *VEGF* gene, and close to the *mitochondrial ribosomal protein L14* gene (*MRPL14*) and the *MCG45491* gene (*C6orf223*), encoding an uncharacterized protein. Sixty-seven other SNPs on chromosome 6p21.1 were also associated with VEGF levels at $p<5\times 10^{-8}$ (**Figure 1a**). When running a conditional GWAS adjusting for rs6921438, one other SNP in 6p21.1 (rs4416670) still yielded a genome-wide significant association, suggesting that two variants in this region independently modulate VEGF levels. In the 8q23.1 region the SNP yielding the most significant association with VEGF levels (rs6993770, $p=2.50\times 10^{-16}$) is located in the *zinc finger protein, multitype 2* (*ZFPM2*) gene and 980.4 kb away from the *low-density lipoprotein receptor-related protein gene* (*LRP12*). Forty-three SNPs in LD with rs6993770 were also associated with VEGF levels at $p<5\times 10^{-8}$ (**Figure 1b**). A conditional GWAS adjusting for rs6993770, rs6921438 and rs4416670 did not yield any other genome-wide significant association in chromosome 8q23.1. The most significant association on 9p24.2 was observed with rs10738760 ($p=1.96\times 10^{-34}$), located close to the *very low density lipoprotein receptor* (*VLDLR*) and *potassium voltage-gated channel subfamily V, member 2* (*KCNV2*) genes. Twenty-nine SNPs in LD with rs10738760 were also associated with VEGF levels at $p<5\times 10^{-8}$ (**Figure 1c**). None reached genome-

wide significance in a conditional GWAS adjusted for rs6921438, rs4416670, rs6993770 and rs10738760.

We computed a genetic liability score including the four SNPs yielding genome-wide significant associations with VEGF levels in the conditional GWAS (**Supplemental Table 1**). This score explained 47.6% of serum VEGF variability ($p=2.19 \times 10^{-644}$).

Replication studies

We sought to replicate our most significant results in two independent cohorts. Of the 25 SNPs selected for replication, 24 were successfully genotyped in the SFS and 20 in the PIVUS study (**Table 2**). Of these, 17 and 20 respectively reached nominal significance in association with VEGF levels (**Table 2**). When meta-analyzing the results of both replication cohorts for the 19 SNPs genotyped in both studies, all 19 SNPs were associated with VEGF levels at $p<0.05$ (**Table 2**). The joint meta-analysis of results from the discovery and replication cohorts is displayed in **Table 2**. The genetic liability score explained 16.6% ($p=1.75 \times 10^{-36}$) of observed plasma VEGF variability in the SFS and 48.4% ($p=3.31 \times 10^{-180}$) of observed serum VEGF variability in the PIVUS study.

The observed associations remained unchanged in each of the three cohorts after adjusting for hypertension, current smoking, central obesity and metabolic syndrome (**Supplemental Table 3**).

VEGF gene expression analysis

In order to better characterize the functional role of the SNPs identified in the GWAS we quantified mRNA expression of the two splice variants corresponding to the diffusible isoforms of VEGF, $VEGF_{121}$ and $VEGF_{165}$, in PBMCs of 220 SFS participants. The association of VEGF mRNA levels with the 24 SNPs successfully genotyped in the SFS was assessed.

At the nominal significance level, 1 SNP on chromosome 6p21.1, 4 SNPs on chromosome 8q23.1 and 1 SNP on chromosome 9p24.2 were associated with $VEGF_{121}$ mRNA levels (**Table 3**).

Biological pathway analysis

Using the Ingenuity Pathway Analysis software (IPA, Ingenuity Systems, www.ingenuity.com) we explored functional relationships between *VEGF* and the genes closest to the SNPs on chromosome 8q23.1 and 9p24.2 that were significantly associated with circulating VEGF levels. In each case we selected the genes closest to the identified SNPs, as in **Table 2**, to identify plausible biological pathways. We selected five focus genes: *VEGF*, *ZFPM2*, *LRP12*, *VLDLR*, *KCNV2*. The IPA network analysis identified relationships among three of these five focus genes (*VEGF*, *ZFPM2* and *VLDLR*) as part of a larger network. The presence of three of our five focus genes in this network was unlikely to occur by chance ($p=10^{-8}$). In **Figure 2** we present a subset of this network, including only interactions between *VEGF* and the two other focus genes in the network, with 2 or fewer intermediate nodes.

Discussion

Principal findings

In this first GWAS of circulating VEGF levels undertaken in 3,546 community individuals of European descent, we identified novel genetic associations: 140 SNPs reached genome-wide significance. Of these, 4 SNPs were independently associated with VEGF levels (rs6921438 and rs4416670 on chromosome 6p21.1, rs6993770 on chromosome 8q23.1 and rs10738760 on chromosome 9p24.2). We found evidence of replication for selected SNPs in 1,727 individuals of European descent from two independent community-based samples. The SNPs are located close to the *VEGF* and *MRPL14* genes (chromosome 6p21.1), within the *ZFPM2* gene (chromosome 8q23.1), and between the *VLDLR* and *KCNV2* genes (chromosome 9p24.2). In a subset of participants we found that 6 of 25 selected SNPs yielding genome-wide significant associations with circulating VEGF levels were also associated with *VEGF* mRNA levels (*VEGF*₁₂₁ splice variant) in PBMCs.

In the context of the current literature

Genetic association study

Candidate gene studies exploring associations between *VEGF* polymorphisms and circulating VEGF levels have yielded controversial results (**Supplemental Methods**, section 11; **Supplemental Table 4**). Eight studies have found significant associations with candidate polymorphisms (rs699947, rs1570360, rs833061, rs2010963, rs3025039 and -2549 18bp I/D) in the promoter, 5' and 3' untranslated region of the *VEGF* gene.³³⁻⁴⁰ However, several other studies did not identify any association with these and other *VEGF* SNPs (**Supplemental Table 4**). Using a hypothesis-free genome-wide approach, the present study revealed novel associations with 140 SNPs. Of these, 68 SNPs are located on chromosome 6 approximately 150 kb downstream from the 3' end of the *VEGF* gene, far from previously tested candidate SNPs. Although we do replicate previously described associations of 2 *VEGF* promoter

polymorphisms (rs699947 and rs833061) with serum VEGF levels at $p < 5 \times 10^{-7}$ (**Supplemental Methods**, section 11; **Supplemental Table 4**; **Supplemental Figure 3**), none of the SNPs that reached genome-wide significance in our analysis, on chromosome 6p21.1, 8q23.1 and 9p24.2, had been examined previously in relation with circulating VEGF levels.

Transcriptomic analysis

While several studies have examined the association of candidate genetic variants with *VEGF* gene expression in pathological tissues,^{41, 42} little is known about the genetic variants influencing *VEGF* expression in normal cells. Our data suggest that six of the SNPs associated with circulating VEGF levels in our GWAS also modulate the expression of the *VEGF₁₂₁* splice variant in PBMCs of community-based persons. The diffusible VEGF isoforms, *VEGF₁₆₅* and *VEGF₁₂₁*, are released by a variety of tumor and normal cells, including PBMCs.⁴³ *VEGF₁₂₁* lacks a heparin-binding domain and has a higher migration but lower mitogenic potency than *VEGF₁₆₅*.⁴⁴

Potential mechanisms mediating observed genetic associations

Our data suggest that almost half the inherited component of circulating VEGF levels is explained by genetic variants located downstream from the *VEGF* gene on chromosome 6p21.1. The conditional GWAS suggests that this region could harbor at least two distinct loci that are independently associated with circulating VEGF levels. Although located relatively far from the *VEGF* gene, results from our transcriptomic analysis indicate that this region could indeed contain functional variants modulating *VEGF* gene expression.

Genome-wide significant associations with circulating VEGF levels were also identified for SNPs located on chromosome 8q23.1 and 9p24.2. Although these *trans* effects explain a much smaller proportion of the heritability of VEGF levels, they provide important clues about the pathways involved in the regulation of *VEGF* expression. The SNPs on chromosome 8q23.1 are located in introns 4 and 5 of the *ZFPM2* gene. This gene encodes a widely expressed member of the Friend of GATA family of

transcription factors that modulate the activity of the GATA family proteins, which are important regulators of embryogenesis and also seem to play a significant role in endothelial cell biology.⁴⁵⁻⁴⁷ The second closest gene to the SNPs identified on chromosome 8q23.1 is *LRP12*, encoding a low-density lipoprotein receptor-related protein that interacts with proteins related to signal transduction pathways and is differentially expressed in many cancer cells. The SNPs on chromosome 9p24.2 are located between the *VLDLR* and *KCNV2* genes. *VLDLR* encodes a lipoprotein receptor involved in the metabolism of apolipoprotein-E-containing triacylglycerol-rich lipoproteins. Like *VEGF*, *VLDLR* appears to modify the risk of developing age-related macular degeneration,⁴⁸ and recent data suggest that *VLDLR* could play a central role in a network of interacting angiogenic genes activated in response to hypoxia.⁴⁹ *KCNV2* encodes a member of the potassium voltage-gated channel subfamily V involved in regulation of neurotransmitter release, neuronal excitability and heart rate. While the present data does not permit us to formally determine which of these genes underlie the observed SNP associations with circulating *VEGF* levels, our *in silico* biological pathway analysis suggests that *ZFPM2* and *VLDLR* are the most likely candidates. Further research is needed to explore the mechanisms underlying the associations of *cis* and *trans* acting genetic variants with circulating *VEGF* levels, such as modulation of gene expression, differential splicing or mRNA degradation.

Strengths and limitations

The findings from this first GWAS of circulating *VEGF* levels emphasize the importance of screening for genetic variation modulating biomarker levels not only within and in close proximity to the gene encoding the protein under investigation, but also in more distant potentially regulatory regions, including on other chromosomes. The strength of the observed associations and the fact that we were able to replicate our findings in two independent cohorts suggest that these associations are real. This is further supported by the association of several of these genetic variants with *VEGF* gene expression in PBMCs. Our study also had several limitations. Whereas focusing on white populations of European

descent has the advantage of minimizing potential population stratification issues, our findings cannot be generalized to other ethnic groups. We may not have identified the true causal variants but merely SNPs in LD with the latter. Plasma levels of VEGF were measured in one of the replication cohorts (SFS), while serum VEGF levels had been measured in the discovery cohort. Serum VEGF concentrations are higher than plasma concentrations due to the release of VEGF from platelets during the clotting process and may have partly distinct genetic susceptibility factors.⁵⁰ The vast majority of associations found in the FHS did however replicate in the SFS and explained a substantial proportion of plasma VEGF variability, suggesting an important overlap between genetic susceptibility factors of serum and plasma VEGF levels. Finally, although our transcriptomic analysis does provide some support for a functional role of SNPs associated with mRNA levels of VEGF₁₂₁, these results are exploratory and were not corrected for multiple testing. We may have been underpowered for this analysis due to limited sample size and also because VEGF expression was measured on PBMCs only, which are not the sole contributors to circulating VEGF levels. Further studies looking at the association of genetic markers with VEGF expression in other cell types, including endothelial cells, would be of great value.

Clinical Implications

VEGF plays a key role in various diseases including atherosclerosis, inflammatory and neurodegenerative disorders, and cancer.¹ Anti-VEGF and proangiogenic VEGF based treatments have recently been developed for several therapeutic indications.¹⁹⁻²³ The identification of polymorphisms linked to VEGF levels could help in identifying patients who are more likely to respond favorably to such treatments. These therapies can have major side-effects,²⁴ and optimizing the risk-benefit ratio of their administration could lead to substantial improvements in patient care. The discovery of *trans*-acting genetic variants influencing VEGF levels could also spur the discovery of new molecular targets for pro- or anti-angiogenic therapies.

Conclusions

In a large population-based sample of European ancestry we identified novel genetic variants associated with circulating VEGF levels, on chromosome 6p21.1, 8q23.1 and 9p24.2, which explain almost half of the observed phenotypic variation.

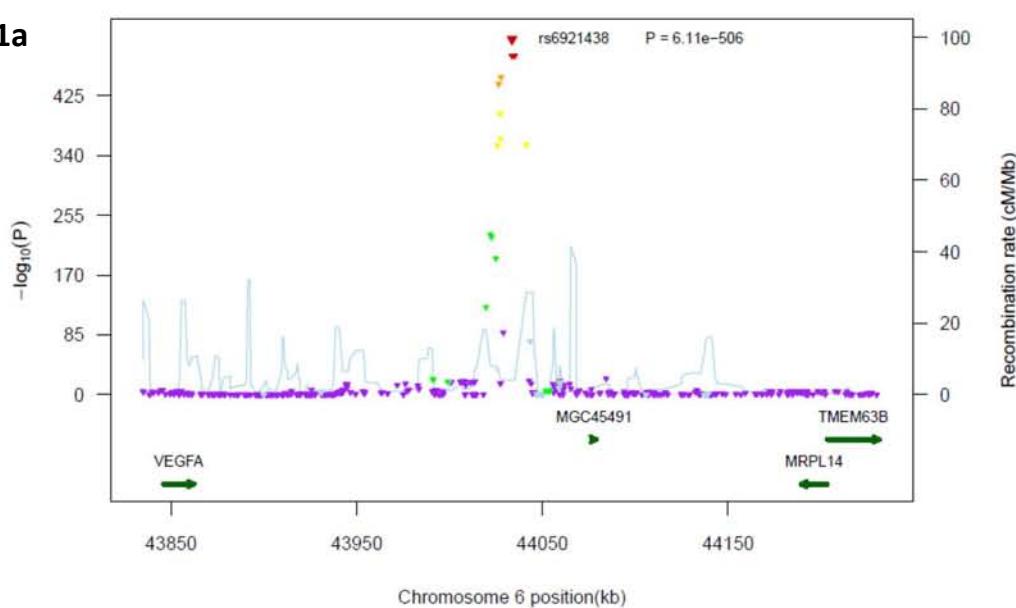
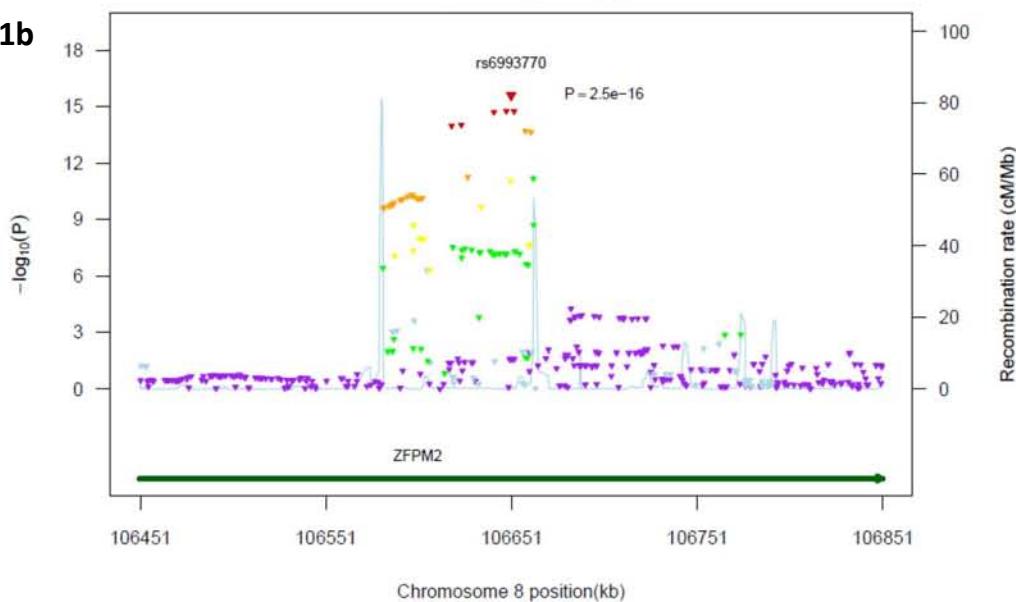
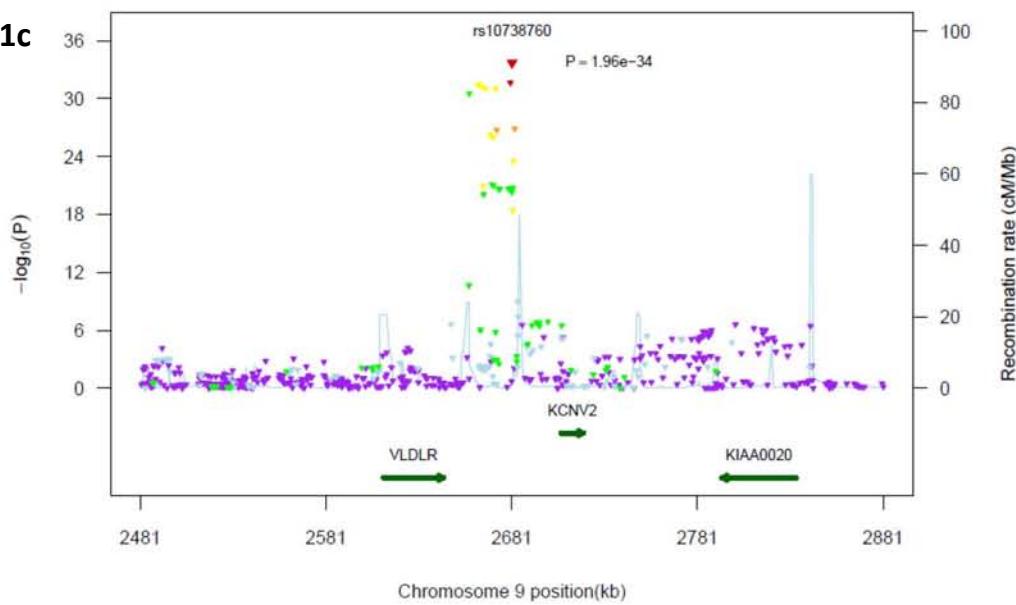
Figure 1a**Figure 1b****Figure 1c**

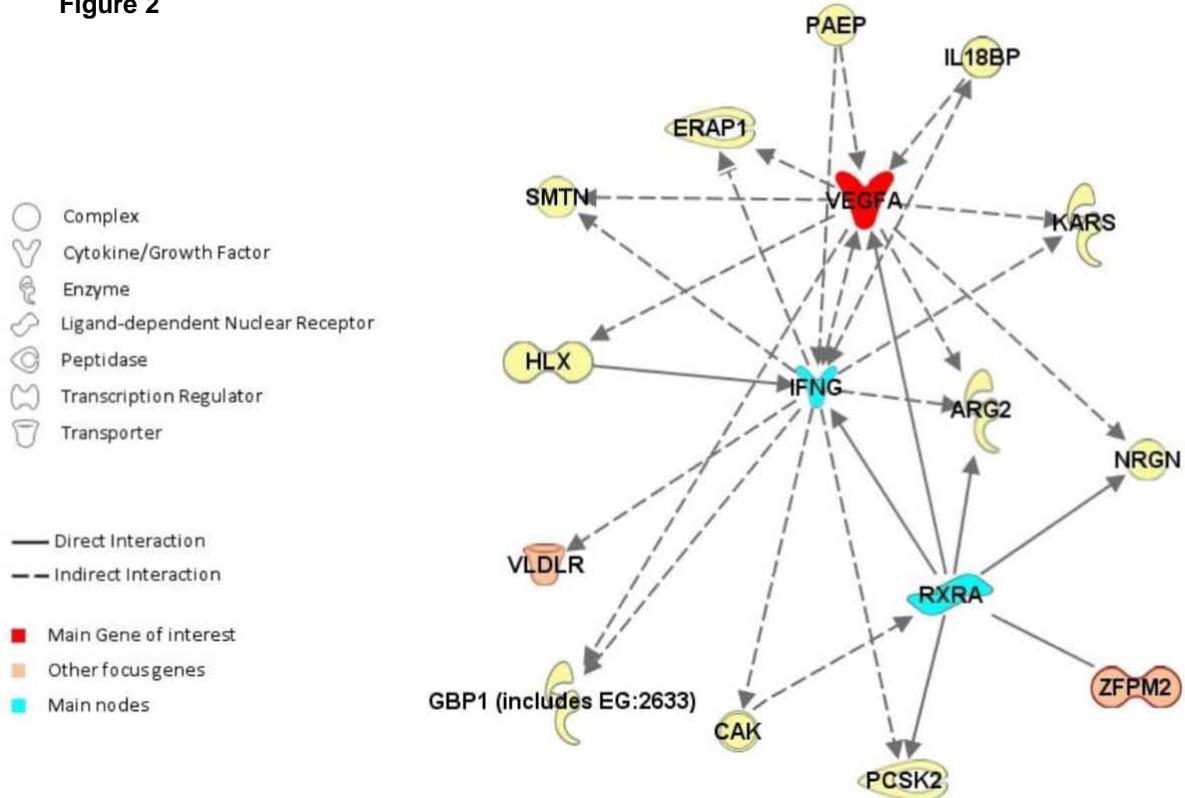

Supplemental Material

Identification of Cis- and Trans-acting Genetic Variants Explaining up to Half the Heritability of Circulating VEGF levels

A. Supplemental Methods

1. Cohorts

Framingham Heart Study (FHS)

The FHS is a three-generation, single-site, community-based, prospective cohort study that was initiated in 1948 to investigate risk factors for cardiovascular disease including stroke in Framingham, MA, USA. It now comprises 3 generations of participants: the original cohort followed since 1948 (Original, Gen 1)¹; their offspring and spouses of the offspring, followed since 1971 (Offspring, Gen 2),² and grandchildren of the Original cohort in 2002 (Gen 3).³ Vascular endothelial growth factor (VEGF) levels have at this time only been measured in Gen 3 participants. Starting in 2002, 4,095 participants with at least one parent in the Offspring cohort were enrolled in the Gen 3 cohort.³ At their first examination (2002-2005) Gen 3 participants underwent a targeted medical history, physical examination, anthropometry, and laboratory assessment of traditional cardiovascular risk factors. VEGF levels were available in 3,946 participants, among whom we excluded persons with prevalent cardiovascular disease (n=66), serum creatinine >2 mg/dl (n=1) and those in whom data for more covariates (n=125) were not available. Of the remaining 3,754 participants, 3,553 also had DNA extracted and genome-wide genotyping data available. Genome-wide genotyping was performed at Affymetrix (Santa Clara, CA) through an NHLBI funded SNP-Health Association Resource (SHARE) project and was successful in 3,546 persons. These 3,546 persons constitute the FHS sample for this study.

All study participants provided informed consent and the study was approved by the Institutional Review Board at the Boston University Medical Center.

STANISLAS Family Study (SFS)

Initiated in 1993, the STANISLAS Family Study is a 10-year longitudinal survey set up to seek out gene-gene and gene-environment interactions in the field of cardiovascular diseases.⁴ 1,006 volunteer families (2 parents and at least two siblings) were initially recruited between 1993 and 1995 during a free health check-up at the Centre for Preventive Medicine in Vandoeuvre-lès-Nancy, France. Individuals with chronic disorders (cardiovascular or cancer) or having a personal history of cardiovascular disease were not included, in order to assess the effects of genetic susceptibility factors on the variability of intermediate phenotypes in physiological conditions without the influence of any long term medication and disease. Biological and clinical measurements, health and lifestyle information were thus collected from 4,488 individuals belonging to 2 generations using appropriate, validated questionnaires and procedures as described previously.^{4,5} DNA was extracted from all participants and serum/plasma/DNA biobanks were constructed. In 1998–2000, 756 of the original families attended a second check-up and the same examination and biobanking protocols undertaken at the first examination were repeated. Using the plasma collected at this examination, specific measurements like VEGF plasma concentrations were measured on a random subsample of 1,000 subjects. A third check-up took place between 2003 and 2005 and at this visit mRNA and lymphocytes extract biobanks were constructed in addition to serum/plasma/DNA biobanks. Individuals with both VEGF plasma concentrations and DNA available were selected for the present study (919 individuals from 263 families). Some parents or children were secondarily excluded because DNA amplification was not successful (n=58), or results of genotyping were ambiguous (n=2). Finally, 859 individuals from 217 families met our selection criteria. Each subject gave written informed consent for participating in this study, which was approved by the Local Ethics Committee of Nancy.

Prospective Investigation of the Vasculature in Uppsala Seniors (PIVUS) study

All 70-year old individuals living in the community of Uppsala, Sweden, between April 2001 and June 2004 were eligible for the Prospective Investigation of the Vasculature in Uppsala Seniors (PIVUS) study, which

has been described in detail previously.⁶ The individuals were selected randomly, and were examined within one month of their 70th birthday in order to standardize for age. Of 2,025 individuals invited, 1,016 were investigated giving a participation rate of 50%, and 999 of these individuals provided DNA for genetic studies. For the purpose of the present investigation, we excluded participants with sample call rate <90% (n=11), prevalent myocardial infarction, stroke or congestive heart failure (n=116), serum creatinine >2 mg/dl (n=1), or missing data on VEGF (n=3). Thus, 868 participants (52% women) were eligible for the present study. The PIVUS study has been approved by the Ethics Committee of Uppsala University and the participants gave written informed consent.

2. Laboratory measurements of vascular endothelial growth factor

VEGF levels were measured in serum for the FHS and PIVUS and plasma for the SFS, at the first examination cycle (2002-2005) in the FHS, the second examination in the SFS (1998-2000) and the baseline examination (2001-2004) in the PIVUS study.

In all 3 studies venous blood samples were drawn after an overnight fast, immediately centrifuged and stored appropriately (at -80°C in FHS and PIVUS and at -196°C in liquid nitrogen in SFS) until VEGF measurements were undertaken. At FHS, serum VEGF was measured using a commercial ELISA assay (R&D Inc.). In SFS and PIVUS plasma VEGF and serum VEGF quantification respectively was performed by Randox Ltd (Crumlin, UK), using a biochip array analyzer (Evidence®).^{7,8} In all studies both diffusible VEGF isoforms (VEGF₁₂₁ and VEGF₁₆₅) were detected.

The average inter-assay coefficients of variation were 2.1% for serum VEGF in the FHS, less than 9% in the SFS and less than 15% in the PIVUS study.

Since serum VEGF had been measured in the FHS and PIVUS and plasma for VEGF in the SFS, we checked the correlation between the 2 types of specimens. VEGF was measured in a subset (n=18) of matched plasma and serum samples. Plasma VEGF was lower (42 ± 28 ng/L, mean \pm SD) than serum VEGF (361 ± 223 ng/L); There was a strong correlation between plasma and serum VEGF ($r=0.76$, $p=0.0002$) which strengthens our study.

3. Genotyping, quality controls, and imputation

Genome-wide genotyping in the FHS study was performed on the Affymetrix GeneChip Human Mapping 500K Array Set® and 50K Human Gene Focused Panel®.

The set of genotyped input SNPs used for imputation was selected based on their highest quality GWA data. From a total of 534,982 genotyped autosomal SNPs in FHS, we used 378,163 SNPs in the imputation after filtering out 15,586 SNPs for Hardy-Weinberg disequilibrium ($p<1\times 10^{-6}$), 64,511 SNPs for missingness >0.03 , 45,361 SNPs for a test of differential missingness yielding a $p<1\times 10^{-9}$ (mishap test in PLINK, <http://pngu.mgh.harvard.edu/purcell/plink/>), 4,857 SNPs for >100 Mendel errors, 67,269 SNPs for a minor allele frequency <0.01 , 2 SNPs due to strandedness issues upon merging data with HapMap, and a further 13,394 SNPs because they were not present on HapMap. We used the Markov Chain Haplotype (MaCH) package (<http://www.sph.umich.edu/csg/abecasis/MACH>, version 1.0.15 software) and imputed to the plus strand of NCBI build 36, HapMap release #22. For each imputed SNP, imputation quality was estimated as the ratio of the empirically observed dosage variance to the expected binomial dosage variance. After quality control and filtering, FHS had either genotyped or imputed data for 2,540,223 autosomal SNPs. From a total of 10,886 genotyped SNPs on the X chromosome, we used 7,795 SNPs in the imputation after filtering out 3,091 SNPs for Hardy-Weinberg $p<1\times 10^{-6}$ (n=159), missingness >0.03 (n=450), minor allele frequency <0.01 (n=1851), male heterozygote count >45 (n=12), and a further 619 SNPs because they were not present on HapMap. We used the IMPUTE package (<https://mathgen.stats.ox.ac.uk/impute/impute.html>, version 0.5.0) and imputed to the plus strand of NCBI Build 35, Hapmap release #21.

4. Screening for latent population substructure

FHS was screened for latent population substructure, including cryptic relatedness, using EIGENSTRAT.^{9,10} The ninth principal component was significantly associated with serum VEGF levels and was therefore included as a covariate in the GWAS.

5. Covariate definition

In all 3 studies, hypertension was defined as systolic blood pressure ≥ 140 , diastolic blood pressure ≥ 90 or use of anti-hypertensive treatment and smokers were identified based on current smoking status. Standing waist circumference (WC) was obtained at the level of the umbilicus and central obesity was defined as a WC ≥ 102 cm in men and ≥ 89 cm in women. Metabolic syndrome was defined as having any 3 of the following traits: (i) central obesity, (ii) hypertension, (iii) hyperglycemia defined as fasting glucose ≥ 100 mg/dL or use of anti-diabetic medications or insulin, (iv) hypertriglyceridemia defined as serum or plasma triglycerides ≥ 150 mg/dL or being on any lipid-lowering medication, (v) low HDL cholesterol (<40 mg/dL in men and <50 mg/dL in women).¹¹ These covariates were measured at the same time as VEGF levels, at the first Gen 3 examination cycle (2002-2005) in the FHS, at the second examination in the SFS (1998-2000) and at the baseline examination (2001-2004) in the PIVUS study.

6. Selection of SNPs for replication

From all SNPs associated with VEGF levels at a p-value $< 5 \times 10^{-8}$ in the discovery cohort, we excluded SNPs with minor allele frequencies (MAF) < 0.05 as well as those imputed SNPs with low imputation quality (ratio of the empirically observed dosage variance to the expected binomial dosage variance < 0.6). The remaining SNPs were grouped by “bins”, each bin comprising SNPs that are in very strong linkage disequilibrium (LD) with each other, i.e. with an $r^2 > 0.8$ with the most significant SNP in the bin. Within each bin we selected one SNP for replication (except for the bin with the most significant associations where 2 SNPs were selected). Typically, we selected the SNP with the lowest p-value within each bin. In 6 bins a SNP with a slightly higher p-value was chosen either because this SNP had been directly genotyped in the discovery cohort, whereas the SNP with the lowest p-value in the bin had been imputed (rs1776721 and rs1886979) or because there were stronger arguments for functionality for the SNP with the slightly higher p-value (rs16873291, rs1349319, rs6475920 and rs10967492).

7. Meta-analysis

For the meta-analyses we used a fixed effects inverse-variance meta-analysis technique. Beta estimates were weighted by their inverse variance and a combined estimate was obtained by summing the weighted betas and dividing by the summed weights. We undertook the meta-analyses at FHS using METAL software (<http://www.sph.umich.edu/csg/abecasis/Metal/index.html>).

8. Genetic liability score calculation

Step 1:

We selected SNPs with independent effects by running a conditional GWAS. This was done in a forward stepwise fashion. First we ran a GWAS adjusting for age, gender, the ninth principal component and the most significantly associated SNP (rs6921438). We then ran a GWAS additionally adjusting for the most significantly associated SNP in the aforementioned conditional GWAS. This process was repeated, by adding the most significantly associated SNP as a new covariate to the regression model, until all SNPs independently associated with VEGF level at a p-value $< 5 \times 10^{-8}$ were selected. All selected independent SNPs with a minor allele frequency $> 5\%$ were used to compute the genetic liability score (**Supplementary Table 1**). In the PIVUS study, as rs6921438 genotypes were not available, rs4513773 was used instead to compute the genetic liability score (r^2 with rs6921438 = 0.90)

Step 2:

Genotypes for the SNPs selected in step 1 were coded as 0, 1 or 2 for genotyped SNPs (according to the number of minor alleles) and the imputed allele dosage was used for imputed SNPs.

To compute the genetic liability score the genotype value was weighted by the effect size estimate from the GWAS (**Supplementary Table 1**):

Risk Score = SNP1_estimate * SNP1_genotype + SNP2_estimate * SNP2_genotype + SNP3_estimate * SNP3_genotype + SNP4_estimate * SNP4_genotype

Step 3:

We estimated the proportion of phenotype variance explained by each SNP incorporated in the risk score (h2q, see **Supplementary Table 1**).¹²

9. Biological pathway analysis

Genes located close to associated SNPs were investigated for relevant networks by the Ingenuity Pathway Analysis (IPA) software (Ingenuity Systems, www.ingenuity.com). To build networks, IPA queries the Ingenuity Pathways Knowledge Base for biological interactions between identified “focus genes”, in this case genes close to SNPs significantly associated with circulating VEGF levels in the GWAS, and all other gene objects stored in the knowledge base. It then generates a set of networks with a maximum network size of 35 genes. An underlying assumption is that highly-interconnected networks are likely to represent significant biological function,¹³ thus IPA optimizes for triangular relationships between genes, favoring denser networks over more sparsely connected ones. Networks are displayed graphically as “nodes” (corresponding to genes or gene products) and the biological relationships between the nodes, referred to as “edges”. IPA also computes a score, representing the -log (p-value), where the p-value is the probability of finding f or more focus genes in a set of n genes randomly selected.

10. VEGF gene expression analysis in peripheral blood mononuclear cells (PBMCs)

Sample preparation and quantification of the messenger RNA (mRNA) VEGF spliced forms

Two-hundred and twenty samples from the SFS were randomly selected for inclusion in the PBMCs transcriptomic study. Fresh whole blood (10mL) was collected by standardized venipuncture in EDTA tubes (VacutainerTM; Becton Dickinson, NJ, USA). PBMCs were isolated by centrifugation on a density gradient of Ficoll (Ficoll-PaqueTM PLUS; Amersham BioSciences) and stored at -80°C until RNA extraction according to a well-validated protocol,¹⁴ with high recovery of lymphocyte(97.5%). Total RNA was subsequently extracted with the MagNaPure automate, using the MagNA Pure LC RNA HP isolation kit and RNA HP Blood External lysis protocol (Roche Diagnostics, France). Reverse transcription of total RNA was performed using 200 units of M-MuLV Reverse Transcriptase with 0.25 µg of oligos(dt) (Promega, France) according to a previous described protocol.¹⁴ Quantification of the transcripts coding for the VEGF₁₂₁ and VEGF₁₆₅ isoforms, and the beta 2 microglobulin (B2M) control gene, was performed using TaqMan® and LightCycler technologies (LC TaqMan Master kitRoche Diagnostics, France). All experiments were performed in duplicate. The detection level for each transcript was between 1 and 10 copies for both transcripts and for B2M. RT-PCR optimization and specificity of RT-PCR products were examined using SYBR® Green technology (LC FastStart DNA Master^{PLUS} SYBR Green I kit, Roche Diagnostic, France), melting curves analysis and agarose gel electrophoresis of the PCR amplicons. Primers and probes were designed to specifically amplify the spliced forms of VEGF based on their splicing sites¹⁵ with specific reverse primers or hydrolyzation probes spanning the variant specific exon boundaries, which also avoids amplification of contaminating genomic DNA. Hydrolyzation probes were labeled with the reporter dye FAM (6-carboxy-fluorescein phosphoramidite) at the 5' end and the quencher dye TAMRA (5-carboxyl- tetramethyl-rhodamine) at the 3' end. For all assays, intra- and inter-run variability were 11% and 5% respectively. PCR products for each VEGF mRNA spliced variant amplification were purified with a PCR purification kit (QiaQuick, Qiagen, France). The product concentrations were measured in a spectrophotometer, the molecule concentrations were calculated, and a standard curve was generated for each transcript using serial dilutions of products ranging from 1 or 10 to 10⁷ molecules/µL. The copy number of unknown samples was calculated by setting their PCR cycle number (Crossing Point: CP) to the standard curve and normalized to the housekeeping B2M gene. Results are presented as copies of the target gene product per 10⁶ copies of B2M. Primer efficiencies were calculated according to the equation E = 10[-1/slope]. All investigated transcripts had real-time PCR efficiency rates above 1.9.

PBMCs VEGF protein measurements

PBMC VEGF (121 and 165) protein quantification was performed by Randox Ltd (Crumlin, UK), with a biochip array analyzer (Evidence®) using a high sensitivity kit as previously described.⁷ PBMC VEGF concentrations were log10-transformed in all analyses in order to improve normality, were adjusted for the effect of between-run variation and regressed on mean values of all samples measured in each run. Grubbs' test was applied for detection of the extreme values in the data (log transformed VEGF) and there were no outliers at the 5% level. The average inter-assay coefficient of variation was 5.7%.

Statistical analysis

A linear mixed effects model that accounts for within family correlation was used to evaluate the association of each of the SNPs successfully genotyped in the SFS with each of the two transcript levels (VEGF_{121} and VEGF_{165}) and with natural log-transformed PBMC VEGF concentration, assuming an additive genetic model. These analyses were adjusted for age and sex.

11. Candidate gene association studies

We searched Pubmed for original articles published before May 14 2010, which reported statistically significant associations between specific genotypes and circulating VEGF levels. We used the search terms VEGF, gene and polymorphism. We identified 14 candidate gene association studies,¹⁶⁻²⁹ who examined 11 different polymorphisms in the VEGF gene in association with plasma or serum VEGF levels (**Supplementary Table 4**). Of these, 8 studies reported a significant association of at least one polymorphism (rs699947, rs1570360, rs833061, rs2010963, rs3025039, -2549 18bp I/D) with circulating VEGF levels.²²⁻²⁹ In the FHS sample we replicated the association of rs699947 and rs833061 with serum VEGF levels at $p < 5 \times 10^{-7}$ (**Supplementary Table 4**). The other 4 polymorphisms (rs1570360, rs2010963, rs3025039, -2549 18bp I/D) had neither been genotyped nor imputed in the FHS GWAS. As these SNPs are not in the Hapmap database, we could not identify any proxy either to test their association with serum VEGF levels in the FHS dataset.

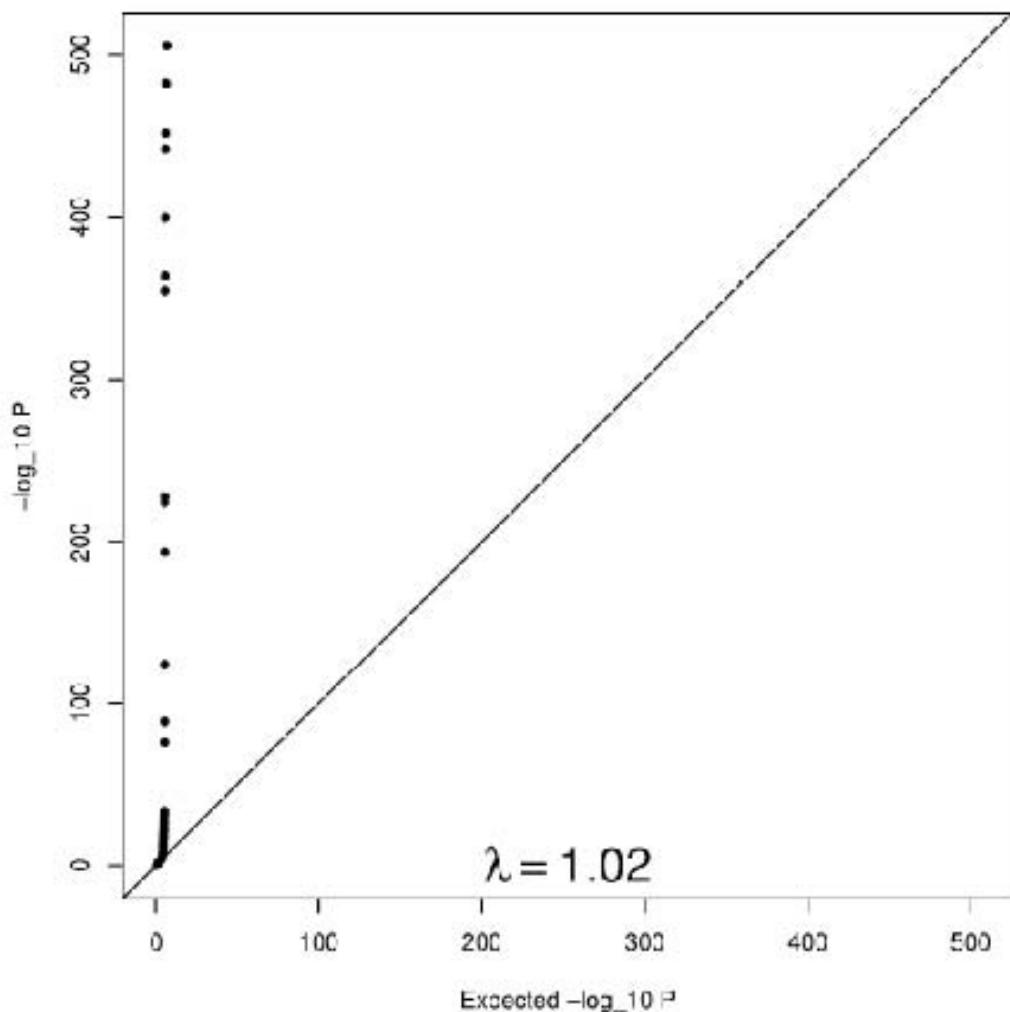

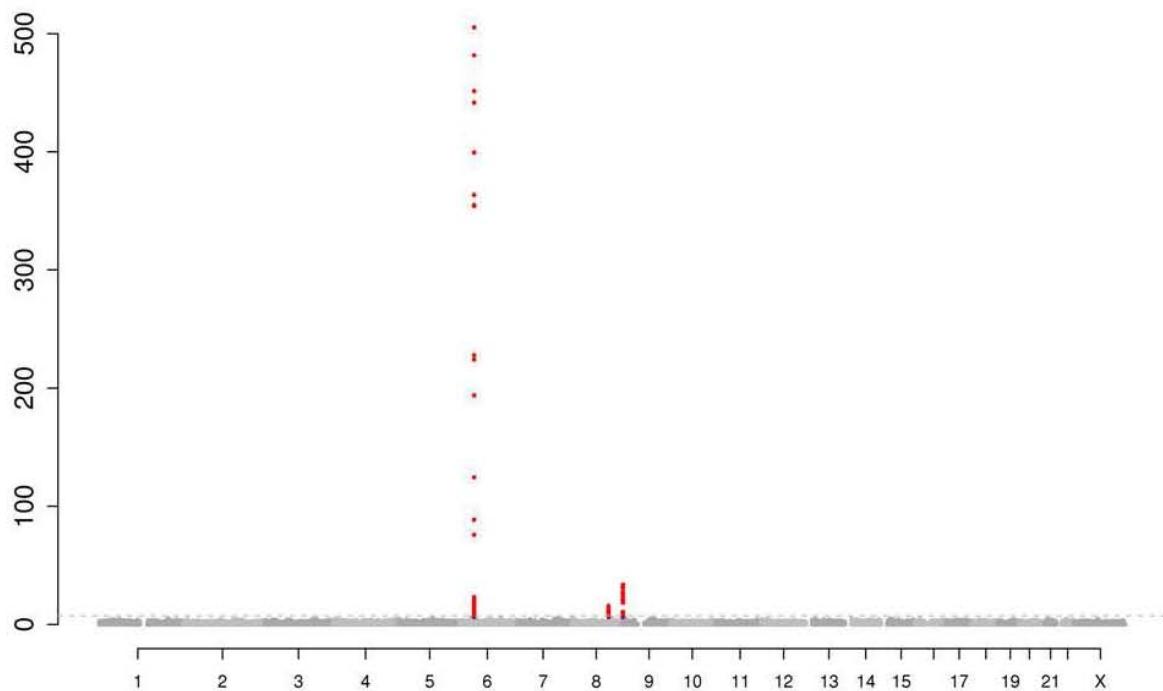

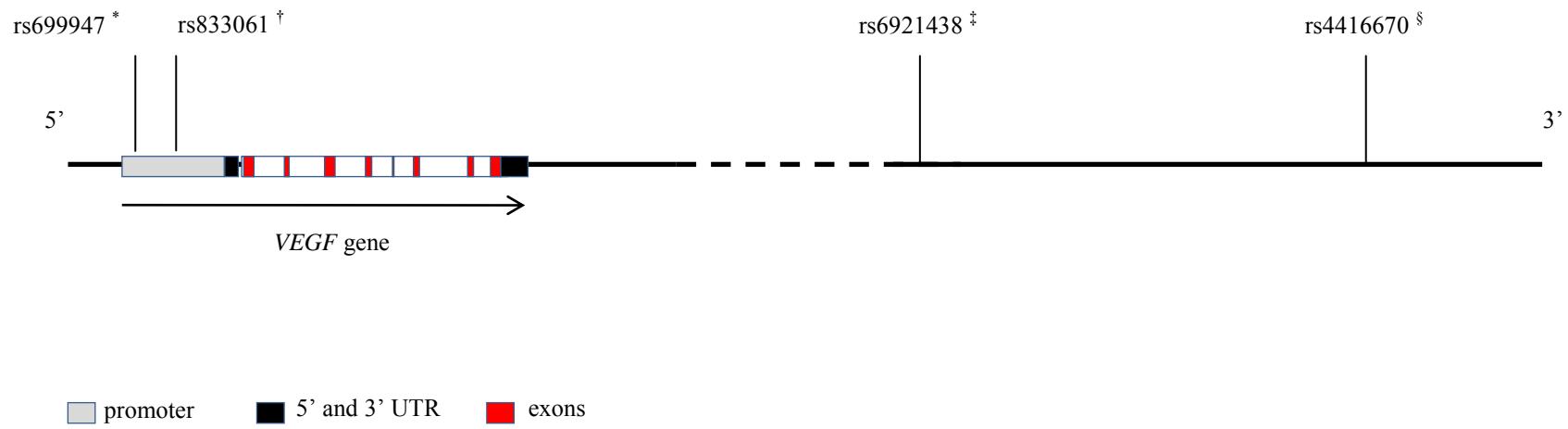
